This single/common judgment in the above captioned appeal,</p>

shall also dispose of appeal No. 552/2018 filed by Muhammad Zubair and appeal No.553/2018 filed by Dawood Faraz Khan being identical in nature.

3. The appellant has filed the present service appeal u/s 4 of the Khyber Pakhtunkhwa Service Tribunal Act 1974 for the release of monthly salaries w.e.f 30.01.2016 till 14.01.2017

4. Learned counsel for the appellants argued that the appellants were appointed as Class-IV vide order date 30.01.2016 and they also took charge of their posts and performed duties; that the process of appointments was challenged through civil suit which civil suit was ultimately dismissed in default due to lack of interest, vide order dated 09.01.2017; that due to the status-quo order passed in the above mentioned civil suit the appointment order of the appellants was held in abeyance vide order dated 10.02.2016; that after dismissal of civil suit the appointment order in respect of the appellants was restored vide order dated 14.01.2017; that the appellants filed departmental appeals/applications for the release of their salaries w.e.f 30.01.2016 till 14.01.2017 but to no avail; that withholding of salaries of the appellant w.e.f the date of his appointment i.e. w.e.f 30.01.2016 till 14.01.2017 is illegal, unwarranted, unjustified and of no legal effect; that the appellants have legal right to receive the salaries from 30.01.2016 to 14.01.2017.

5. As against that learned Assistant Advocate General argued that against the process of appointment of Class-IV, the inhabitants

of locality filed civil suit on the ground that the respondent department has no right to make appointments on political basis without advertisement in the newspaper and without prescribed manner; that the civil court issued status-quo order and as a result thereof the appointment order of the appellants was held in abeyance; that when the civil suit was dismissed in default the appointment order was restored; that the appellants had not performed duty therefore they are not entitled for the grant of salary w.e.f 30.01.2016 to 14.01.2017.

6. Arguments heard. File perused.

7. Nothing is available on record to suggest that the appointments of the appellants were made in the prescribed manner i.e. through publication in the newspaper or through employment exchange.

8. Inhabitants of the locality filed civil suit and challenged the process of appointments. In compliance with the order of civil court the appointment order of the appellants was held in abeyance. The civil suit was then dismissed in default.

9. The appellants were appointed as Class-IV vide order dated 30.01.2016 while the civil suit was instituted on 28.01.2016 i.e. prior to the issuance of appointment order of the appellants, hence at the relevant time the appellants had not yet gained the status of civil servants and as such the civil court had got the jurisdiction to entertain the suit/take cognizance of the matter.


10. As a sequel to above, the appellants have not been able to seek indulgence of this Tribunal. Consequently the present service appeal

*On acceptance of this Service appeal the impugned order dated 10/06/2016 of Respondent No.2 & act of Respondent No.4 regarding the withholding of monthly salary be declared as illegal, unwarranted, unjustified and of no legal effect and the Respondents be directed to release the monthly salary of the appellant w.e.f 30/01/2016 till 14/01/2014 along with allied benefits including seniority from the date of joining duty.*

*Any other remedy which this august tribunal deems appropriate may also be granted to the appellant*

**Respectfully Sheweth:-**

The brief facts leading up to the filing of this appeal are as under:-

1. That the Appellant was appointed on the post of Chowkidar (BPS-3) by the Respondent No.2 vide appointment order/notification No.1178-85 dated 30/01/2016 and was posted in the supervision of Respondent No.3. **(Copy of Appointment Order dated 30/01/2016 is attached as Annexure "A")**
2. That thereafter the Appellant took the charge of his service on 30/01/2016 in the supervision of Respondent No.3 and since

then performing his duty with great zeal and zest. **(Copy of Charge Report is attached as Annexure "B")**

3. That appointment order of the petitioner along with others were challenged through Civil Suit title Tiamur Khan v/s Government etc which was dismissed vide order dated 09/01/2017 by the learned civil judge Dir Payan at timergarah. It is pertinent to mention here that due to status quo order service of the appellant was held abeyance vide order dated 10/02/2016 **(impugned)** by the Respondent No.3. However during pendency of civil suit the appellant also performed his duty regularly which is evidence from the attendance register. It is pertinent to mention here that the appellant was not impleaded as Respondents, therefore any sort of order passed against the interest of appellant is not applicable to the appellant **(Copy of Civil Suit, Office Order 10/02/2016 & Attendance Register are attached as Annexure "C, D & E")**

4. That after dismissal of civil suit the Respondent No.2 vide office order dated 14/01/2017 restored the service of the appellant without any back benefits and monthly salaries. **(Copy of Office order dated 14/01/2017 is attached as Annexure "F")**

5. That the appellant also filed so many departmental representation / applications to the Respondents but was not replied accordingly. **(Copy of Departmental Representation is attached as Annexure "G")**

6. That as the appellant had regularly performed his duty during pendency of civil suit, therefore the appellant is entitle for the monthly salary w.e.f 30/01/2016 till 14/01/2017 but the Respondents No.2 & 4 without any legal & lawful justification refused to pay the same to the appellant, therefore the appellant filed a civil suit before the Civil Judge-XI/IQ Dir Lower at Timergara which was returned in original to the appellant on the ground of jurisdiction vide order dated 20/03/2018 for presenting before the proper forum. **(Copy of Civil Suit along with Judgment dated 20/03/2018 is Annexure "H")**
7. That now the appellant is approaching this honorable tribunal for redressal of his grievance and request for the release of his salary from 30/01/2016 to 14/01/2017 and seeking declaration of the impugned order to be illegal, without jurisdiction, without lawful authority and of no legal effect on the rights of the appellant being not party in the civil suit as such all the action & inaction of Respondents are liable to be struck down and the Respondent No.4 be directed to release all the salary along with back benefits from the date of stoppage / withholding on the following grounds:-

#### **GROUND**

- A. That the impugned action / inaction of Respondents by not releasing the monthly salary of the appellant for the period w.e.f 30/01/2016 to 14/01/2017 is illegal, unwarranted,

unjustified and of no legal effect, therefore liable to be struck down.

- B.** That the impugned action & inaction of Respondents by not releasing the monthly salary of the appellant for the period w.e.f 30/01/2016 to 14/01/2017 is based malafidie intention, ulterior motive and biasness.
- C.** That the Appellant had regularly attended his duty which fact is evident/clear from the attendance register maintained by Respondent No.4 but even then the Respondent No.3 on the behest of Respdent No.2 stopped and withheld the monthly salary for the period w.e.f 30/01/2016 to 14/01/2017 of the appellant which is clear violation of the Constitutional of provision of Islamic Republic of Pakistan 1973.
- D.** That stoppage of monthly salary of the appellant by the Respondents is also amount to deprive the appellant from his livelihood as the appellant is the sole bred earner of his family, therefore the impugned action of Respondents is not only illegal, unjustified but also in violation of fundamental rights guaranteed under article 9 of the Constitution of Islamic Republic of Pakistan 1973 and section 17 of the Civil Servant Act 1973.

- E. That the appellant has been discriminated in matter of service & salary which has earned by the appellant by performing his duty to which the appellant was rightly appointed on his post of laboratory attendant.
- F. That the civil court has no jurisdiction to stop the salary in service matter as under Article 212 of the constitution bared the jurisdiction of all the forum including civil court, therefore the stoppage of salary of the appellant was illegally stopped.
- G. That after the dismissal of suit mentioned above the alleged order of stoppage of pay also crumbled down to the ground & not sustainable in the eye of law.
- H. That the appellant has legal & lawful rights to receive his salary alongwith all benefits of the period of which the appellant had performed his duty and the deprivation of the appellant from his salary in violation of law & justice.
- I. That any other ground will be raised at the time of final arguments with the permission of the court.

**It is therefore prayed that on acceptance of this Service appeal the impugned order dated 10/06/2016 of Respondent No.3 regarding the withholding of monthly salary be declared as illegal, unwarranted, unjustified and of no legal effect and the Respondents be directed to**

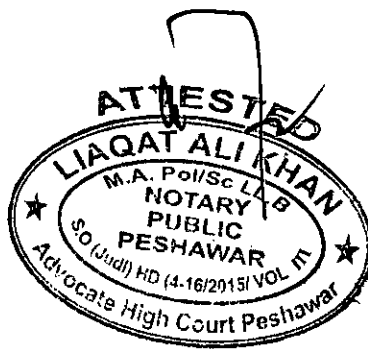

TERMS & CONDITIONS:

1. They would be on probation for a period of one year extendable for another one year.
