Respectfully Sheweth.

1. That the Appellant has been initially appointed as Lecturer on contract basis on 28.11.2005 and was posted at GDC, Alpuri Shangla latter on the service of the appellant has been regularized on 2009. Ever since his appointed, the appellant has performed his Duty with full devotion and hard work and no complaint whatsoever has been made against the appellant.

2. That the appellant was lastly posted at GDC, Khan pur Nizam Pur vide order dated 24.07.2015 and took over the charge of his post on 01.11.2015.
3. That the attitude of respondent No.4 in general towards his staff members has been very inhuman, cruel and he is in habit of using unparliamentary language with his subordinate, Due to his attitude, many of the staff members are constrained to transfer their services to other college/place.
4. That through out the service career of the appellant, the appellant was never given any adverse ACR which shows the outstanding and unblemished service of the appellant.
5. That the appellant was surprised to received the ACR for the period from 01.01.2018 to 18.04.2018 vide Letter No. 787/AD (ACR) dated 11.02.2020 whereby the adverse remarks in the PER of the period 01.01.2018 to 18.04.2018 passed by the reporting officer on 21.09.2020 as well as recovery of salary communicated to the appellant on 09.11.2020 which is based on malafide and passed without fulfilling the

codal formalities. (Copy of impugned order dated 21.09.2020 is attached as annexure "A").

6. That against the said impugned order dated 21.09.2020 the appellant submitted departmental appeal on 10.11.2020 which has been rejected on 12.11.2021 communicated to the appellant on 20.12.2021. (Copy of departmental appeal and rejection order is attached as annexure "B" & "C").

7. That feeling aggrieved the Appellant, prefers the instant service appeal before this Hon'ble Tribunal on the following grounds inter alia:-

GROUNDS:-

A. That the impugned orders dated 21/09/2020 & 12.11.2021 are illegal, void and ab-initio order because it has been passed against the law and rules.

B. That the appellant has never remain absence from law full duty and regularly perform his duty with respondent department.

C. That the respondent department are under legal obligation to called the appellant for counseling however the opportunity of counseling has not been provided to the appellant hence the impugned remarks are liable to be expunged being contrary to law and rules.

D. That throughout the service of the appellant, no complaint or explanation, has been called from the appellant which negate the stance of the respondent.

E. That no opportunity of defense and personal hearing has been provided to the appellant hence the appellant has been condemn unheard.

F. That even no show cause notice no charge sheet has been served or issued to the appellant.

G. That any other ground not raised here may, graciously be allowed to be raised at the time full of arguments on the instant service appeal.

It is therefore, most humbly prayed that on acceptance of the instant service appeal the impugned orders dated 21.09.2020 & 12.11.2021 of respondent may kindly be set aside and the adverse remarks may kindly be expunged in the best interest of justice along with all back benefits.

Any other relief not specifically asked for may also graciously be extended in favour of the Appellant in the circumstances of the case.







Respected Sir,

The appellant submits as under.

1. That the Appellant is initially appointed as Lecturer in 2005 by the Respondent department and was posted at Government Degree College Alpuri, District Shangla and lastly posted at Government Degree College Khan Kohi, Nizampur. (Copy of appointment order is attached)
2. That the appellant performed his duty with hard work and full devotion and no complaint has ever been made against the appellant.

3. That attitude of the Principal of college in general towards appellant as well as his staff members has been very inhuman and cruel.
4. That throughout the service career of the appellant, the appellant was never given any adverse ACR which shows the outstanding and unblemished service of the appellant.
5. That the appellant was surprised to received the ACR for the period from 01/01/2018 to 18/04/2018 vide Letter No: 787/AD(ACR) dated 11/02/2020 whereby the adverse remarks in the PER of the period 01/01/2018 to 18/04/2018 passed by the reporting officer on 21/09/2020 communicated to the appellant on 09/11/2020 which is based on malafide and passed without fulfilling the codal formalities.
6. That in response of aforementioned letter, the appellant submitted his reply in which stated that the appellant has always performed his duty to the best of his abilities and even served under the principle-ship of Prof. Sher Bahadar Khan and got PERs of the year 2013 at GDC Khanpur, Haripur and 2015 at GDC Khan Kohi, Nizampur Nowshera with satisfactory and good remarks.

7. That in meanwhile Prof. Sher Bahadar Khan developed misunderstanding with the appellant and started teasing with one way or the other. The Principal submitted an application for lodging of FIR against the appellant on dated 27/09/2016 which was rejected by the concerned SHO and after that the Principal concerned / reporting officer also submitted application U/S 22-A Cr. PC on 18/01/2017 to the August Court of Session Judge/ Justice of Peace Nowshera, which has been rejected with remarks i.e. "It is the failure of your administration to bring the internal matters to the court".
8. That it is also pertinent to mention here that the principal concerned also tries to pressurize, torture and blackmail the appellant through his relatives and outsiders.
9. That the appellant also submitted a complaint against the Principal on 16/08/2017 to Director Higher Education Khyber Pakhtunkhwa Peshawar in which the appellant stated that upon the order of the Principal concern, the guards of the college stopped the appellant to enter into the

College. The said illegal act of the principle, the appellant lodge a Roznamcha in PS Nizampur. (Copy of application is attached)

10. That the appellant also submitted another complaint against the same to the Secretary Higher Education Department on dated 28/09/2017, in the presence of one Dr. Shahzad Assistant Professor. (Copy is attached).

11. That the order of adverse remarks and recovery of salary on dated 21/09/2020 is illegal, void ab-initio and ineffective upon the rights of the appellant on the following grounds inter-alia:-

GROUNDS:

A. That the Respondents are under legal obligation to call the appellant for counseling, however, the opportunity of counseling has not been provided to the appellant.

B. That throughout the service of the appellant no complaint or explanation has been called from appellant which negate the stance of the Respondent.

C. That no charge sheet, no statement of allegation and neither show-cause notice has been served/ issued to the appellant. Even though no inquiry has been conducted against the Appellant.

D. That there is committed no disobedience & absentee on the part of the appellant.

E. That the punishment is harsh one and comes under the definition of double jeopardy.

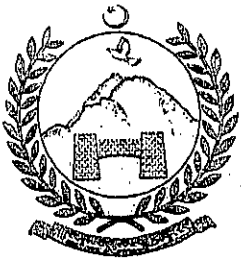
It is, therefore most humbly prayed that the Departmental appeal of the appellant may very graciously be accepted as prayed for, in the best interest of justice.

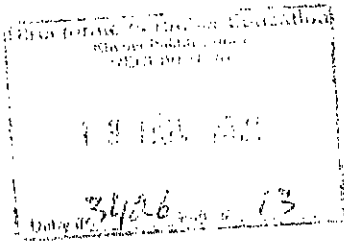




