

Respected Sheweth:

1. That appellant is serving the department since 09-04-2021 as Assistant Engineer Agriculture Engineering Department.
2. That since the date of appointment of appellant in service, dedicated performances were given to the department without any complaint and his services were highly appreciated in this respect.

3. That Khyber Pakhtunkhwa Association of Government Engineers (KPAGE) put forth demand before the Government of KP to allow them Technical Allowance along with other benefits to the Graduate Engineers of Agricultural Engineering Wing working in Agriculture Engineering Department. The Director Agriculture Engineering KP Peshawar forwarded the said demand of Technical Allowance and other benefits before R. No. 03 vide letter dated 08-05-2018 for necessary action, followed by subsequent letter of R. No. 01 dated 28-05-2018 for the said purpose. (Copies as annex "A")

4. That on 11-06-2018, R. No. 03 forwarded the said request to R. No. 01 for the reason that his demand was approved by the Cabinet in its meeting held on 24-05-2018 as under:-

"The Cabinet approved the Technical Allowance @ 1.5 times of the initial Basic Pay Scale to All Engineers working in Provincial Government Department with effect from 1st July 2018".

Finance Department was requested to issue Notification regarding Technical Allowance to the Government Engineers. (Copy as annex "B")

5. That on 19-10-2018, R. No. 01 sanctioned Technical Allowance to Engineers holding Engineering qualification registered with the Higher Education Commission and Pakistan Engineering Council to C & W, Irrigation, Public Health Engineering and Local Government Department KP with effect from 01-11-2018 by leaving aside other departments for no legal reasons. (Copy as annex "C")

6. That on 29-10-2018, appellant submitted representation before R. No. 02 to also treat him at par with the employees of the aforesaid departments regarding grant of Technical Allowance. (Copy as Annex "D")

7. That on 30-05-2019, the Government of Punjab also benefited Engineers of Agricultural Department with Technical Allowance to various categories. (Copy as annex "E")

8. That on 03-07-2020 and 25-11-2020, the Engineers of Gilgit Baltistan and Azad Jammu Kashmir were also granted the benefit of Technical Allowance but deprived the Engineers of KP in Agricultural Department for no legal reason. (Copies as annex "F")
9. That on 07-07-2021, R. No. 03 modified Notification dated 19-10-2018 to the extent of Engineers of Mines & Mineral Department again by leaving aside the Agricultural department of the petitioners. (Copy as annex "G")
10. That on 06-01-2022, appellant filed Writ Petition for the aforesaid benefit which came up for hearing on 22-03-2022 and then the hon'ble court allowed appellant to approach before the proper forum. (Copies as annex "H" & "I")
11. That on 10-01-2022, appellant submitted subsequent representation before the authority but of no avail. (Copy as annex "J")

Hence, this appeal, inter alia on the following grounds:


GROUND S.

- a. That in the Meeting of the Provincial Government dated 24-05-2018 circulated vide letter dated 11-06-2018, Technical Allowance was allowed to ALL Engineers working in the Provincial Government Department with effect from 01-07-2018. No classification, whatsoever, was made to allow the said benefit to particular departments.
- b. That no reason in Notification dated 19-10-2018 was given to allow the benefits of Technical Allowance only to four departments, C & W, Irrigation, Public Health Engineering and Local Government Department and to let the Engineers of the other departments.
- c. That it is also against the law and the verdicts of the apex court to classify similarly and equally placed employees, Engineers working in the same department were benefited, while Engineers working in other departments were deprived. Such act is based on malafide.

It is, therefore, most humbly prayed that on acceptance of the Appeal, Notification dated 19-10-2018. of R. No. 01 be altered / modified / set aside and Technical Allowance @ 1.5 times of the initial basic pay scales be awarded / allowed to appellant, with effect from 01-07-2018 with all consequential benefits, with such other relief as may be deemed proper and just in circumstances of the case.



2. That since the date of appointment of petitioners in service dedicated performances were given to the department without any complaint and their services were highly appreciated in this respect.
3. That Khyber Pakhtunkhwa Association of Government Engineers (KPAGE) put forth demand before the Government of KP to allow them Technical Allowance along with other benefits to the Graduate Engineers of Agricultural Engineering Wing working in various grades in Agriculture Engineering Department. The Director Agriculture Engineering KP Peshawar forwarded the said demand of Technical Allowance and other benefits before R.
