**APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 AGAINST THE IMPUGNED ORDER DATED 08-12-2020 WHEREBY JUNIOR COLLEAGUES i.e. PRIVATE RESPONDENT NO. 4 & 15 TO THE APPELLANT HAS BEEN GIVEN PROMOTION TO THE POST OF SCT (BPS-16) BY COMPLETELY IGNORING THE APPELLANT AND AGAINST NOT TAKING ANY ACTION ON THE DEPARTMENTAL APPEAL OF THE APPELLANT WITHIN THE STATUTORY PERIOD OF NINETY (90) DAYS**

**PRAYER:**

**That on acceptance of this appeal the impugned order dated 08-12-2020 may very kindly be set aside and the appellant may kindly be promoted to the post of SCT (BPS-16) w.e.f. the date junior colleagues has been given promotion. Any other remedy which this august Tribunal deems fit that may also be awarded in favor of the appellant.**

**R/SHWETH:**  
**ON FACTS:**

1. That appellant is the employee of the respondent Department and is initially appointed as Certified Teacher (BPS-15) vide order dated 14-03-2015 on adhoc basis on contract basis with the terms & condition mentioned therein in the appointment order and since from the date of appointment the appellant is working quite efficiently, whole heartedly and up to the entire satisfaction of his high ups. Copy of appointment order is attached as annexure ..... **A.**
2. That Government of Khyber Pakhtunkhwa promulgated an Act the Khyber Pakhtunkhwa Employees of the Elementary and Secondary Education Department (Appointment and Regularization of Services) Act, 2017 in light of the said Act the services of the appellant was regularized from the date of initial appointment vide notification dated 19-03-2018. Copy of Notification is attached as annexure ..... **B.**
3. That seniority list for the post of SCT/CT by the respondent No. 3 whereby according to the seniority list the appellant was placed at serial no. 379, respondent No. 4 to 15 was placed senior to the appellant. Copy of the seniority list is attached as annexure ..... **C.**
4. That respondent No. 2 issued a notification dated 05-08-2020 whereas a pre-Departmental Promotion Committee was constituted for scrutinizing the documents which has to commence on various dates till the pre-DSC on 09-09-2020 and the Departmental Selection Committee date was fixed on 11-09-2020. Copy of the notification dated 05-08-2020 is attached as annexure ..... **D.**
5. That the scheduled Departmental Selection Committee meeting dated 11-09-2020 was postponed to 19-10-2020 vide letter dated 12-10-2020 just to accommodate their blue eyed persons as at time of scheduled DPC dated 11-09-2020 the private respondents no. 4 & 15 was not eligible according to the promotion criterion of 5 years. Copy of the letter dated 12.10.2020 is attached as annexure ..... **E.**
6. That, the respondents without conducting pre-DSC for the scrutiny of documents conducted Departmental Selection Committee on 19-10-2020 and as such recommended private Respondent no. 4 & 15 to the post of SCT BS-16 vide notification dated 08-12-2020 by completely ignoring the appellant being eligible in all respect as per criterion of 5 years and subsequently issued the posting order dated 30-12-2020 in respect of respondent no. 4 & 15. Copy of Notification dated 08.12.2020 & 30.12.2020 is attached as Annexure ..... **F & G.**
7. That feeling aggrieved from the notification dated 08-12-2020 the appellant filed Departmental Appeal dated 15-12-2020 as being eligible according to criteria but no response has been received to the appellant within the statutory period. Copy of ..... & Departmental Appeal is attached as annexure ..... **H** ..
8. That appellant feeling highly aggrieved and having no other remedy but to file the instant appeal on the following grounds amongst the others.

**GROUND:**

- A- That the impugned order dated 08-12-2020 of the respondent by not promoting the appellant having all the requisites is against the law, facts and norms of natural justice hence not tenable.
- B- That appellant has not been treated by the respondent Department in accordance with law and rules on the subject noted above and as such the respondents violated Article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.
- C- That all the requisites required for promotion to the post of SCT (BS-16) is available with the appellant but even then the respondent did not promote the appellant to the post of SCT (BPS-16) and delayed the Departmental Promotion Committee meeting just to accommodate their blue eyed persons in the shape of private respondents.
- D- The respondents acted in arbitrary and Malafide manner by not promoting the appellant to the post of SCT (BPS-16) is against the norms of natural justice.
- E- That the appellant has a sufficient experience since from the date of appointment and accordingly to the notification the appellant is fully entitled for promotion to the post of SCT (BPS-16).
- F- That act of the respondents by not promoting the appellant to the post of SCT (BPS-16) is against the prevailing Law & Rules.
- G- That inaction and action of respondents by not promoting the appellant to the post of SCT (BPS-16) is against Section-9 of the Civil Servant Act-1973 read with Rule-7 of the (Appointment, Promotion and Transfer) Rules-1989.
- H- That appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that appeal of the appellant may be accepted as prayed for.

TERMS & CONDITION

1. NO. TA/DA etc is allowed
2. Charge reports should be submitted to all concerned in duplicate.
3. Appointment is purely on temporary & contract basis initially for one year with effect from 14.03.2015 to 13.03.2016.
4. They should not be handed over charge if they exceed 35 years or below 18 years of age.
5. Appointment is subject to the condition that the certificates/documents must be verified from the concerned authorities by the DEO (concerned). Anyone found producing bogus Certificate will be reported to the law enforcing agencies for further action and his appointment will stand withdrawn.

AND CONDITIONS.

1. The regularization will not be in favour of those, who have not taken over charge Or his remained absent from duty are resign from service and also not for those who are under disciplinary proceedings.
2. Their Services shall be governed by the Khyber Pakhtunkhwa civil Servant Act 1973, the Khyber Pakhtunkhwa (Appointment, Deputation, Posting and transfer of teachers, Lecturers, Instructors' and Doctors) regularity Act 2011 and such rules and regulations as may be issued from time to time by the Government.
3. Their Pay shall be released subject to the verification of Academic and professional documents and testimonials from the concerned Boards/Universities by this Office.
4. Their services will considered regular and they shall be eligible for pension / deduction of GP Fund and terms of the Khyber Pakhtunkhwa Act 1973 as amended in 2013.
5. Their services is liable to termination on one month notice from either side .In case of resignation without notice, their one month pay/allowance shall be forfeited to the Government.
6. They shall possess the same Qualifications and experience required for the subject post on regular basis.
7. Their regularization shall not effect the promotion quota of the existing holders of posts in respective service cadre.  
They shall rank Junior to all civil Servants belonging to the same service Or cadre, as the case may be, who are in Service on regular basis on the Govt. of the Khyber Pakhtunkhwa employees on the Elementary and Secondary Education (Appointment in regularization of Services) Act, 2018 (Khyber Pakhtunkhwa Act No.1 2018) and shall also rank Junior to such other persons, if any, who in pursuance of the recommendations of the Khyber Pakhtunkhwa Public service commission made before the commencement of the Act, are to be appointed to the respective Service Or cadre, in respective of their actual Date of appointment.
8. Their Seniority shall be Determined on the basis of their continues services in cadre, Provided that if the date of continues Service in case of Two Or more as the same, the employee elder in age shall rank Senior to the younger one.

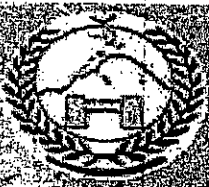

**SUBJECT: DEPARTMENTAL APPEAL AGAINST THE IMPUGNED ORDER DATED 08.12.2020 WHEREBY THE JUNIOR TO THE APPELLANT HAS BEEN PROMOTED TO THE POST OF SCT (BPS-16) WHILE THE APPELLANT HAS BEEN IGNORED UNJUSTLY.**

Respected sir,

With due submission It is stated that the appellant is the employee of your good-self Department and is serving as Certified Teacher (BPS-15) and since appointment the appellant is performing his duty quiet efficiently and up to the entire satisfaction of his superiors. Initially the appellant was appointed as Certified Teacher (BPS-15) vide order dated 14-03-2015 on adhoc basis on contract basis, and subsequently Government of Khyber Pakhtunkhwa promulgated an Act the Khyber Pakhtunkhwa Employees of the Elementary and Secondary Education Department (Appointment and Regularization of Services) Act, 2017 in light of the said Act the services of the appellant was regularized from the date of initial appointment vide notification dated 19-03-2018. That during service the respondents issued seniority list for the post of SCT/CT by the respondent whereby according to the seniority list the appellant was placed at the bottom of seniority list and junior colleagues of the appellant were made senior in the said seniority list. That after that respondent issued a notification dated 05-08-2020 whereas a pre-Departmental Promotion Committee was constituted for scrutinizing the documents which has to commence on various dates till the pre-DSC on 09-09-2020 and the Departmental Selection Committee date was fixed on 11-09-2020. That the scheduled Departmental Selection Committee meeting dated 11-09-2020 was postponed to 19-10-2020 vide letter dated 12-10-2020 just to accommodate their blue eyed persons as at time of scheduled DPC dated 11-09-2020 the juniors to the appellant were not eligible according to the promotion criterion of 5 years' service. That, the respondents without conducting pre-DSC for the scrutiny of documents conducted Departmental Selection Committee on 19-10-2020 and as such recommended juniors to the appellant to the post of SCT (BS-16) vide notification dated 08-12-2020 by completely ignoring the appellant being eligible in all respect as per criterion of 5 years' service and subsequently issued the posting order dated 30-12-2020 in respect of juniors to the appellant and adjusted them against the said posts while respondents ignored the appellant deliberately.

It is therefore most humbly prayed that on acceptance of this departmental appeal impugned order dated 08.12.2020 may very kindly be set aside and the appellant be promoted to the post of SCT (BPS-16) w.e.f the date junior colleagues has been given promotion to the post of SCT (BPS-16).

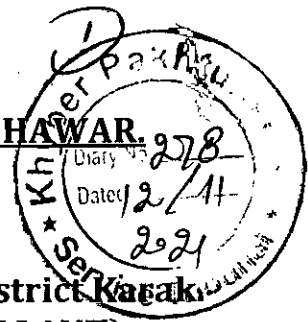

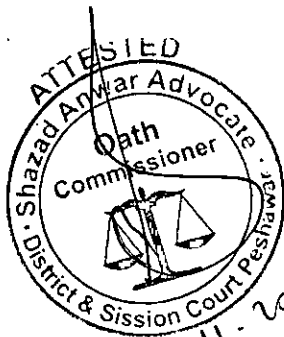

The letter not only addressed to District, Karak but also addressed to all the District Education Officer (M/F) that DPC already fixed dated 11/09/2020 was extended to 19/10/2020. So for the question of respondents No. 4 & 5 are non-eligibility is concerned, in this respect it is stated that in Regularization Notification dated 19/03/2018 (Annexure-B) it has been clearly mentioned at S. No. 7 of Terms & Condition that "*their regularization shall not affect the promotion quota of the existing holder of posts in respective service cadre. They shall rank Junior to all civil servants belonging to the same service or cader, as the case may be, who are in service on regular basis on the Govt: of the Khyber Pakhtunkhwa employee on the Elementary and Secondary education (Appointment in regularization of Services) Act, 2018 ( Khyber Pakhtunkhwa Act No. 1 2018 (Annexure-C) and shall also rank junior to such other persons , if any, who in pursuance of the recommendation of the Khyber Pkhtunkhwa Public Service Commission made before the commencement of the Act, are to be appointed to the respective Service or cadre in respector of their actual date of appointment*". In light of the condition No. 7 the appellant is not entitled for promotion on the ground of completion of 5 years service for the post of S.C.T.

6. Para No. 6 is incorrect and wrong. The letter dated 05/08/2020 and schedule attached with the aforesaid letter (Annexure-D) clearly shows that Pre-DPC commencing from 17/08/2020 upto 10/09/2020 and submit the promotion case by 10/09/2020, complete in all respects for further necessary action to the competent authority, whereas the date of DPC is fixed as 11/09/2020 , however, the date was extended by the respondent No. 2 with the directions to respondent No. 3 to include all those cases in the already submitted working papers which fall on the criteria of seniority cum fitness, possessing the prescribed qualifications and length of service as mentioned in policy. So far the question of completion of 5 years service is concerned, the appellant has accepted the term & conditions of Regularization Notification dated 19/03/2018. The private respondents No. 4 & 5 being eligible have been recommended for promotion to S.C.T BPS-16 on 08/12/2020 and then subsequently adjusted on 30/12/2020 as per law (Annexure-C).
7. Para No. 7 as stated is incorrect and wrong. The appellant is not fulfilling the eligibility criteria for promotion, therefore, the appellant has not been recommended for promotion to SCT.
8. The appellant have no cause of action and locus standi to file the subject appeal.
