### **JUDGMENT**

ROZINA REHMAN, MEMBER (J): The appellant has invoked the jurisdiction of this Tribunal through above titled appeal with the prayer as copied below:

"On acceptance of instant appeal, the impugned Notification dated 13.08.2021 may kindly be set aside to the extent of appellant and the respondents be graciously directed not to compel the appellant to hold on the charge of the post of Lecturer in English at Government Degree College Sherwan, with further





directions that the impugned notification dated 13.08.2021 may be modified by retaining the appellant on his previous position at Government Postgraduate College No.1 Abbottabad".


- 2. Brief facts of the case are that appellant was appointed as Lecturer in English through Public Service Commission. He was transferred from Government Degree College, Boi to Government Postgraduate College No.1, Abbottabad, wherefrom, he was transferred once again to Government Degree College Sherwan, Abbottabad vide order dated 28.08.2018. He filed Departmental appeal which was not responded to, hence the present service appeal.
- 3. We have heard Muhammad Faisal appellant and Kabir Ullah Khattak, learned Additional Advocate General for respondents and have gone through the record and the proceedings of the case in minute particulars.
- 4. Appellant Muhammad Faisal, inter-alia, argued that transfer order dated 13.08.2021 is against law, transfer/posting policy, being discriminatory and premature, therefore, is liable to be cancelled; that the impugned Notification was passed without lawful authority and in sheer violation of the transfer posting policy of the Provincial Government which is contradictory to the E-Transfer System Notification issued on 14.07.2021. He contended that the good governance demands that whatever is provided in law is to be followed stricto-senso and that the transfer of the appellant being





issued in utter violation of law is therefore, liable to be cancelled being arbitrary and antithetical.

- 5. Conversely, learned AAG submitted that appellant was transferred to Government Postgraduate College No.1, Abbottabad vide Notification dated 25.11.2016 but later on, vide office order dated 28.08.2018, he was temporarily adjusted in Government Degree College Boi, Abbottabad under Rationalization Policy and that his permanent posting was at Government Postgraduate College No.1, Abbottabad. He contended that appellant is bound to serve anywhere where competent authority transfers under Section-10 of the Civil Servants Act, 1973 and that he was transferred on need basis and in the best public interest.
- 6. From the record it is evident that appellant was appointed as Lecturer in English through Public Service Commission in Higher Education Department. Vide Notification dated 25.11.2016 appellant was transferred from GDC Nathiagali to GPGC No.1, Abbottabad. It was on 28.08.2018 when appellant was transferred from GPGC No. 1, Abbottabad to GDC Boi on temporary basis under rationalization policy. He was again transferred to GPGC No.1 Abbottabad on 29.09.2019 and lastly, vide impugned transfer order dated 13.08.2021, he was transferred from GPGC No.1, Abbottabad to GDC Sherwan Abbottabad. Admittedly, as per transfer posting policy, he had not completed his tenure at GPGC No.1, Abbottabad. Admittedly, traditional/manual posting transfer exercise has been stopped by the Government of Khyber Pakhtunkhwa Higher Education Department and in this regard, proper instructions were issued to the concerned



authorities to direct aspiring staff to use the web application for posting/transfer requests. Despite implementation of E-Transfer/Posting System in General and Commerce Colleges in Khyber Pakhtunkhwa, the impugned order was passed as per traditional/manual exercise. The appellant was transferred before completion of his tenure, whereas, other teaching staff posted at GPGC No.1, Abbottabad has been serving there for the last ten to thirteen years and they are not being disturbed. In this regard, proper record was produced by the appellant which is placed on file showing the tenure of different teaching staff which record was not denied/rebutted by the respondents.

7. Keeping in view the above discussion, this appeal is allowed in the terms that E-Transfer/Posting System be implemented in case of the appellant by giving him option and then to transfer him in view of his options according to law. Parties are left to bear their own costs. File be consigned to the record room.

APPEAL UNDER SECTION 4 OF KPK SERVICE TRIBUNAL, ACT 1974, AGAINST THE OFFICE ORDER VIDE NOTIFIFICATION NO. SO(C-II)/HED/2-5/POSTING/TRANSFER DATED 13/08/2021 WHEREBY, THE APPELLANT HAS BEEN TRANSFERRED FROM GOVT. POSTGRADUATE **COLLEGE** NO.1ABBOTTABAD TO **GOVT** DEGREE **COLLEGE** SHERWAN BEFORE COMPLETION OF HIS SERVICE TENURE WHICH IS ILLEGAL, UNLAWFUL, AGAINST THE TRANSFER POSTING POLICY OF PROVINCIAL GOVERNMENT 2003, THE APPELLANT WAS NOT SURPLUS UNDER ANY DEFINITION OF SERVICE LAWS, THE TRANSFER ORDER OF THE APPELLANT

IS ARBITRARY, MALAFIDE, PERVERSE AND BASED ON FAVOURITISM, DISCRIMINATION AND VICTIMISATION, CONSEQUENTLY HAVING NO LEGAL EFFECT UPON THE RIGHTS OF THE APPELLANT.

#### PRAYER:-

ON ACCEPTANCE OF INSTANT APPEAL, THE SO(C-II)/HED/2-IMPUGNED NOTIFICATION NO. 5/POSTING/TRANSFER DATED 13/08/2021 MAY KINDLY BE SET-ASIDE TO THE EXTEND OF THE APPELLANT (NAMED AT SERIAL NO.43) AND THE RESPONDENTS BE GRACIOUSLY DIRECTED NOT TO COMPEL THE APPELLANT TO HOLD ON THE CHÂRGE OF THE POST OF LECTURER IN ENGLISH, AT GOVT. DEGREE COLLEGE SHERWAN. WITH FURTHER DIRECTIONS THAT THE**IMPUGNED** NOTIFICATION DATED 13/08/2021 MAY BEMODIFIED BY RETAINING THE APPELLANT ON HIS PREVIOUS POSITION AT GOVT. POSTGRADUATE COLLEGE NO.1, ABBOTTABAD. ANY OTHER RELIEF DEEMED FIT AND PROPER IN THE CIRCUMSTANCES OF THE CASE MAY ALSO BE GRANTED IN FAVOUR OF THE APPELLANT.

#### Respectfully Sheweth:-

That the appellant is Lecturer in English
 (BPS-17) appointed through Public Service
 Commission in Higher Education Department
 KPK.

- 2. That the appellant was transferred recently from GDC BOI to GPGC No.1 Abbottabad. It was hardly two years passed since he joined this college but he has been transferred once again to GDC SHERWAN, Abbottabad. (Copy of the transfer order Dated 28.08.2018 with office order 19/09/2019 is attached as annexure "A")
- 3. That the appellant has been serving in G.D.C. Nathiagali in 2015/2016 & GDC BOI during session 2018-19, both are far flung remote and hard areas. (Copy of the transfer order dated 25.09.2016 is attached as annexure "B")
- 4. That the appellant has been transferred before completion of his service tenure which is sheer violation of rules of Transfer/Posting Policy of Provincial Government 2003. (Copy of Transfer /Posting Policy of Provincial Government 2003 is attached as Annexure "C")
- 5. That the appellant is also a research supervisor of BS Students at GPGC NO.1 Abbottabad besides taking six classes a day with diligence and honesty. His qualification, performance and results are much better than his colleagues, and there has never been lodged any complaint against him from any quarter.
- 6. That the impugned NOTIFICATION NO S(C-II)/HED/2-5/POSTING/TRANSFER DATED

13/08/2021, is discriminatory and malafide, and is liable to be set aside because there are nine other faculty members in the department of the appellant whose transfer is overdue because they have been serving constantly in the same college for many years. Whereas, the appellant has been transferred in premature service tenure, before completion of his legal tenure. (Copy of impugned office order Dated 13/08/2021 is attached as Annexure "D")

- 7. That the appellant was neither surplus in his department nor his work, performance & qualification is any lesser than other faculty members.
- 8. That the appellant filed departmental appeal on 20/08/2021. (Copy of departmental appeal is attached as Annexure "E").
- 9. That departmental appeal of the appellant has not been replied/ entertained by the competent authority. The appellant has no other forum to seek justice except the Honorable Service Tribunal.

Therefore the appellant seeks indulgence of this Honorable Tribunal for setting aside the impugned order dated 13-8-2021 inter-alia on the following amongst many others:-

### **GROUNDS:-**

That the transfer orders of the appellant vide Notification NO. S(C-II)/HED/2-5/POSTING/ TRANSFER DATED 13/08/2021 is malafide, discriminatory, premature, unlawful, and illegal, against the rules of Posting/Transfer Policy 2003 of Government of Khyber Pakhtunkhwa, and the said transfer order is liable to be cancelled.

- 1. That the impugned notification dated 13/08/2021, passed without lawful authority and sheer violation of Transfer & Posting Policy of the provincial Government 2003 and consequently of no legal effects upon the rights of the appellant.
- 2. That the impugned order dated 13-08-2021 is contradictory to the E-Transfer system notification issued on 14-07-2021. Hence, the said impugned order is unlawful, perverse, antithetical, and is liable to be set aside. (Copy of E-transfer Notification is attached as annexure "S"

- 3. That the good governance demands that whatever is provided in the law to be followed stricto-sensu. Hence, the transfer order of the appellant, the way it has been issued is utterly unknown to the law as well as jurisprudence. Therefore, the impugned order 13/08/2021 may be cancelled.
- 4. That, no order can be passed in violation and contravention of law and rules of policy, and every citizen is to be dealt in accordance with law which is one of the most fundamental rights of the appellant as a citizen of Islamic republic of Pakistan.
- 5. That the impugned order dated 13-08-2021 is violation of the General Clauses (amendment) Act 1997, 24A section 1&2 that is arbitrary, antithetical & contradictory to the law, and is liable to be set aside. (Copy of General Clauses amendment Act 1997 is attached as annexure "")
- 6. That there is no other prompt and efficacious remedy available to the appellant except the invocation of jurisdiction of this Honorable Tribunal.
- 7. That the appellant seeks consent of this Honorable

  Tribunal to raise additional grounds during the

course of arguments with the permission of Honorable Tribunal.

8. That the instant service appeal is well within time

9. That the addresses of the parties are correctly

mentioned in heading of the appeal.

It is therefore, very humbly prayed that on acceptance of impugned instant appeal, office vide the order NOTIFICATION NO S(C-II)/HED/2-5/POSTING/ TRANSFER DATED 13/08/2021 may kindly be set aside and the respondents be graciously directed not to compel the appellant to hold on the charge of the post of lecturer in English at Govt. Degree College Sherwan, Abbottabad, with further direction that the Impugned Notification DATED 13/08/2021 may be modified by retaining the appellant on his previous position at Govt. Postgraduate College No.1 Abbottabad. Any other relief deemed fit and proper in the circumstances of the case may be granted.

#### Subject: POSTING /TRANSFER POLICY OF THE PROVINCIAL GOVERNMENT.

I am directed to refer to the subject noted above and to say that in supersession of all policy instructions issued in this behalf, the competent authority has approved the following posting Transfer Policy.

- i. All the postings /transfers shall be strictly in public interest and shall not be abused misused to victimize the Government servants.
- ii. All Government servants are prohibited to exert political, Administrative or any other pressures upon the posting /transfer authorities for seeking posting /transfers of their choice and against the public interest.
- . iii. All contract Government employees, appointed against specific posts, cannot be posted against anyother post.
  - officers /officials posted in unattractive areas, the tenure shall be two years and for hard areas the tenure shall be one year. The unattractive and hard areas will be notified by the Government.
  - v.Months of March and July are fixed for posting /transfer of the officers /officials excluding the officers in B-19 and above in the Province. Posting /transfer in Education and Health Departments shall be made in March while the remaining Departments shall make posting /transfers in July. There shall be a ban on posting/transfers throughout the year excluding the aforesaid two months. However, there shall be no restriction in cases where posting /transfer of Government employees become inevitable in other months due to promotion /retirement /creation of new posts/return from long leave/involvement in



disciplinary proceedings and adjustment of surplus staff for which specific relaxation shall be obtained from the Chief Minister.

- vi. While making postings transfers from settled areas to FATA and vice versa specific approval of the Governor, NWFP needs to be obtained.
- vii.Officers may be posted on executive /administrative posts in the Districts of their domicile except District Coordination Officers (D.C.Os) and Superintend of Police (SP). Similarly Deputy Superintendent of Police (DSP) shall not be posted at a place where the Police Station (Thana) of his area /resident is situated.
- viii. No postings /transfers of the officers/officials on detailment basis shall be made.
- ix.Regarding the posting of husband /wife, both in Provincial services, efforts where possible would be made to post such persons at one station and this will be subject to the public interest.
- x.All the posting /transferring authorities may facilitate the postings /transfers of the unmarried female Government Servants at the station of the residence of their parents.
- xi.Officers /officials except DCOs and SPs who are due to retire within one year may be posted on their option, on posts in the Districts of their domicile and be allowed to serve their till the retirement.
- xii.In terms of Rules-17 (1) and (2) read Schedule-III of the Government of NWFP Rules of Business 1985, transfer of officers shown in column 1 of the following table shall be made by the authorities shown against.

4. I am directed further to request that that above noted policy may be strictly observed implemented.



xiii. While considering postings /transfers proposals all the concerned authorities shall keep in mind the following:

- a. To ensure the posting of proper persons on proper posts,. the annual confidential reports, past and present record of service, performance on post held presently and in tile past and general reputation with focus on the integrity of the concerned officers/officials be considered.
- b. Tenure on present post shall also be taken into consideration and the posting transfers shall be in the best public interest.
- ix) Governments servants including District Govt. employees feeling aggrieved due to the orders of ,posting/transfers authorities may seek remedy from the next higher authority/the appointing authority) as the case may be through an appeal to be submitted within seven days of the receipt of such orders. Such appeal shall ,be disposed of within fifteen days. The option of appeal against posting /transfer orders could be exercised only in the following cases:-
- i) pre-mature posting/transfer or posting/transfer in violation of the provisions of this policy.
  - ii) Serious and grave personal (humanitarian) grounds.

To streamline the postings /transfers in the District Government and to remove any irritant/confusions in this regard the provision of Rule 25 of the North- West Frontier Province District Government Rules of Business 2001 read with schedule -IV thereof is referred. As per schedule -IV the posting/transferring authorities for the officers /officials against each are as under:-

I am extremely grieved at this arbitrary transfer which has disturbed my whole family as well. I am neither surplus in my department nor any other valid reason of transfer thereof.

Therefore, I humbly request to your honor to revoke this transfer orders in the best interest of students.




