Prayer:-

On acceptance of this Appeal the Appellant shall be paid the pay of three months and if any order adversely effecting the rights of the Appellant in respect of his service benefits is issued it may be declared null and void and against the law with no effect upon the rights of the Appellant.





Respectfully Sheweth: - The need for the instant Appeal before the Tribunal arises due to the following facts:

Facts:

- 1. That the Respondents advertised the post of Medical Officer in the province of Khyberpakhtunkhwa through advertisement No---05/2018 serial No 41(a) with last date of submission of application 07.08 2018 and the Appellant being qualified and eligible applied against the post. (The advertisement is attached as Annexure A).
- 2. That the interviews were held as per prescribed manner and on 7.11.2019 through office letter no 821/E-I from the Director General Health Services the Appellant was informed that your name is under consideration for appointment as Medical Officer BPS-17 in the Health Department on regular basis and you may appear before the Medical Board within a week's time and the Appellant did it accordingly. (The office letter dated 7.11.2019 is attached as Annexure B).
- **3.** That on 26th March 2020 the Government of Khyberpakhtunkhwa through Notification No SO(H)-II/3-18/20/638 the Appellant was appointed on the recommendation of the KP Public Service Commission at serial No- 243 with all the terms and conditions mentioned therein with a direction to the Appellant to submit his arrival within 15 days. (The Notification dated 26.3.2020 is attached as Annexure C).
- **4.** That with reference to the above Notification, the Appellant submits his arrival report to the Director General Health Services for onward order...(The arrival Report is attached as Annexure D)
- 5. That despite the fact there was COVID-19 and the Appellant was impatiently waiting for posting the Respondents in continuation of order dated 26.3.2020 through Notification dated 1st July 2020 posted the Appellant w.e.f 1.7.2020 which the Appellant obeyed. (The Notification dated 1.7.2020 and arrival to duty is attached as Annexure E).



- **6.** That the appellant was surprised when he was given the pay w.e.f. 1st July with no payment of earlier months..(The pay slips are attached as Annexure F)
- 7. That the Appellant filed a departmental Appeal before the competent Authority for the release of arrears of pay and became under impression that the competent Authority is not counting his service towards seniority and pension but on visit to the office was informed that there is no such entitlement of arrears for the Appellant. (Copy of Department Appeal is attached as Annexure G)

Being aggrieved and no other forum available under the law hence an Appeal is preferred on the following grounds:

Grounds:-

- A. That the Appellant when submitted his Arrival Report before the competent Authority then the onus is on the Respondents to post him anywhere in the province and particularly in such circumstances when there was a dire need of doctors due to COVID-19 the actual duty of the Appellant was need of the time but the Respondents failed to post him in time which is not the fault of the Appellant.
- B. That as per service Regulations and Rules whenever any civil servant submits an Arrival, then he is considered on duty and being on duty is entitled to all such allowances ,pay and emoluments.
- **c.** That it is held in numerous judgments of the Supreme Court of Pakistan that no one shall suffer due to pathetic and negligent attitude of the government officials.
- **D.** That the Appellant has a legitimate expectancy to receive all the benefits w.e f. the date he submitted his Arrival Report before the competent authority.





- **E.** That the Appellant has completed all the requirements for regular appointment and as per APT Rules 1989, the seniority counts from the date of regular appointment which is the date of submission of arrival after appointment..
- F. That the mandate of Constitution of Islamic Republic of Pakistan is that every person shall be treated in accordance with law and no act shall be done which is detrimental to his health, body and property.
- **G.** When law permits an act to be done in a particular manner then that act must be done as such and not otherwise.
- H. That Section 24-A of the General causes Act provides that the state functionaries must act fairly, justly and in transparent manner but it transpires that the functionaries of the Respondents departments are malafide and non transparent.

Therefore this Appeal may be accepted as prayed above.




