CONSOLIDATED JUDGEMENT

KALIM ARSHAD KHAN CHAIRMAN. Through this single judgment this and the connected service appeal No.4273/2021titled "Aashi Bibi versus Government and others", both being similar are decided.

2. This appeal is filed by the appellant Mir Anbas, Sweeper, against the order bearing No.993-96 dated 16.02.2021 issued by Respondent No.4, whereby the Appellant of this appeal, was dismissed from service. It is also against the order No.6581-82 dated 04.03.2021 passed by Respondent No.2/Appellate Authority, on the departmental appeal of the Appellant.

3. The facts gathered from the file of this appeal are that while being in service, Respondent No.4 tried to compel the Appellant for immorality in 2018; that owing to protest of the Christian Community in 2018, Respondent No.4 was transferred but he was again posted to Bannu Jail; that due to the above facts, the Respondents were annoyed/inimical and passed the impugned order; that aggrieved of the same, the appellant filed departmental appeal to Respondent No.2, which was dismissed and the instant appeal was filed.

The connected appeal is of Mst. Aashi Bibi, wife of the appellant of 4. this appeal, who was also Sweeper in Bannu Jail. Her appeal is against the

order bearing No.998-100 dated 16.02.2021 issued by Respondent No.4, whereby the Appellant of the connected appeal, was dismissed from service. It is also against the order No.6584-85 dated 04.03.2021 passed by Respondent No.2/Appellate Authority, on the departmental appeal of the Appellant.

5. The facts gathered from the connected appeal file are also the same as those of this appeal, therefore, there is no need of reproducing the same.

6. The grounds taken in both the appeals are same. It is urged in both the appeals that the impugned orders were against law, facts, circumstances of the case and thus not tenable rather liable to be set aside; that the impugned orders were passed against the principles of service laws and policy as no charge sheet, statement of allegations, opportunity of replication, hearing, first show cause notice, final show cause notice, in short no formal enquiry was conducted; that the appellants were punctual and on duty, never absented and the alleged proceedings were on the basis of annoyance, malafide, revenge due to the above stated facts.

7. On receipt and admission of the appeals, the respondents were put on notice. On their putting appearance, they filed joint para-wise comments, wherein it was contended that the appellants were not performing their duties efficiently and remained absent from the duty leaving the jail premises on their sweet will without taking permission of the competent authority and the Jail Authority issued various notices for resuming duty but the appellants always turned deaf ear upon all the notices. The absence period of both the appellants was given as under:

i. from 04.10.2020 to 11.10.2020
ii. from 16.10.2020 to 21.10.2020
iii. from 07.11.2020 to 16.11.2020
iv. from 23.11.2020 to 28.11.2020
v. from 07.12.2021 to 10.12.2021

That the appellants held unlawful press conference leveling baseless allegations against the Superintendent Jail/Administration without any proof/witness; that the said complaint was totally groundless because a well versed Muslim Officer could not do the immoral act with a Christian Sweeper even amongst 342 employees; that the appellant had brought no solid proof during enquiry proceedings in 2018, hence, the case was rejected and decided in favour of Superintendent Jail/Administration; that suspected guests would meet the appellant at unusual night hours, which was quite undesirable from security and moral point of view; that the appellant held the press conference in 2018 but was not proceeded against under the rules in 2018 because of his belonging to minority community; that the impugned orders were based on rules & regulations and prolonged absence of the appellants on the report of the Deputy Superintendent Jail as well as the complaints of immoral and rude behavior of the appellants; that prior to dismissal the appellants were issued various notices but these notices were responded with cold shoulder; that enquiries were initiated by the Respondents, wherein the appellants were recommended for dismissal from service, hence, dismissed vide the impugned orders; that the appellants failed to defend themselves before the departmental appellate forum; that the orders were based on complaints received against the appellants, absence periods and threats to the Jail Authorities after issuance of various notices

and enquiry proceedings purely under the Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011.

9. We have heard the learned counsel for the appellants and learned Additional Advocate General for the respondents and have also gone through the file.

10. The learned counsel for the appellants reiterated the grounds urged in the memorandum and grounds of appeals and prayed for acceptance of the appeals while learned Additional Advocate General refuted the arguments of the learned counsel for the appellants and supported the impugned orders with the prayer for dismissal of the appeals.

11. The both impugned orders of dismissal show that these were based on the following two grounds:

a. The alleged threats of the appellants to the Deputy Superintendent Jail for holding press conference against the Jail Administration and second

b. Absence from duty.

12. When confronted with the situation that mere threat of holding press conference, if any, and not doing that would constitute a misconduct within the meaning of rule 2(1)(1) of the Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011, to which the learned Additional Advocate General submitted that the act could be a misconduct under rule 2(1)(1)(i) (ii) & (iii) as such a conduct was prejudicial to good order or service discipline as well as contrary to the Khyber Pakhtunkhwa Province Government Servants (Conduct) Rules, 1987 and unbecoming of Government Servant and a gentleman. Be that as it may there is no evidence of holding a press conference or for that matter any such threat is also not

proved nor the appellants were confronted in true sense about the above provisions of the rules. The reply submitted by the respondents, however, shows that no departmental action was taken on holding of the alleged press conference in 2018 because the appellants belong to minority. There is no record of any other press conference to hold the appellants guilty of any misconduct on such charge.

13. Next ground for dismissal is the alleged absence of the appellants for a few days. Few days' alleged absence of the appellants, even if proved, would not result in major penalty of dismissal from service especially when the procedure, provided in Rule 9 of the Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011, was not followed by the respondents. The punishment of dismissal does not commensurate with the quantum of the period of absence and for which the appellants could have been awarded any of the minor penalties.

14. As to the allegations, detailed in the para-wise comments of the respondents, regarding the alleged involvement of the appellants in the immoral activities, such allegations were neither made part of the statement of allegations bearing No.708 dated 04.02.2021 nor in the final show cause notices or for that matter the impugned orders of dismissal from service, so the reply cannot be considered regarding such allegations.

15. For what has been discussed above, we accept both these appeals and set aside the impugned orders of dismissal as well as the orders passed on the departmental appeals dismissing the departmental appeals and convert the same into minor penalties of "censure" under rule 4(1)(a)(i) of the Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline)

Rules, 2011. The appellants are reinstated in service along with consequential benefits. The period of their absence shall be deemed to be leave of the kind due.

The accused official threatened the Deputy Superintendent Jail for holding press conference against the Jail administration and left the station without taking prior permission of the competent authority. Consequently, Inquiries were initiated against him and the Inquiry Officer Mr.Farmanullah Network Administrator CP Bannu & Mr. Binyamin Khan Superintendent CP DI Khan vide his No. 770 dated 10.02.2021, wilfully recommended his dismissal from Services.

Previously, the accused official remained absent from his assigned duties without taking prior permission of the competent authority and as such various notices for resuming duties were also issued to him by the Jail authority from time to time vide No.5768-69 dated dated 2838-41 No.7139-40 dated 31.10.2020, 09.10.2020,01.12.2020, No.7985 dated 11.12.2020 & No.608 dated 01.02.2021.

AND WHEREAS, a fair chance of hearing was given to him in front of Line Officer, Psychologist, Incharge Class-IV employees but he refused to receive his Show Cause Notice and did not bother to furnish reply and challenged the chair of competent authority.

AND WHEREAS, the undersigned being competent authority issued various show cause notices for taking ex-parte action against him and granted opportunity of personal hearing on 16-02-2021 as provided for under rules ibid. The accused official completely failed to defend his case with documentary proof/evidence.

AND therefore, further retaining him in such a sensitive Prison on account of his rebellious attitude may lead to any untoward security situation.

NOW therefore, in exercise of power conferred under Rule-14(5) of Khyber Pakhtunkhwa Government Servants (Efficiency & Disciplinary). Rules 2011, having considered the charges, evidence on record and after affording the opportunity of personal hearing, the undersigned being competent authority, hereby award major Penalty of "Dismissal From Service" to Sweeper (BPS-03) Mir Anbas attached to Central Prison Bannu for his misconduct with immediate effect.





Muslim officer can turpitude a Sweeper of Christian community even amongst more than 342 employees which is not only beyond human sense but also of justice. As the appellant had brought no solid proof during Inquiry Proceedings in 2018, hence, the case was rejected and decided in favour of Superintendent Jail/administration. It is worth mentioning that suspicious guests would meet the appellant at unusual night hours, which was quite undesirable from security and moral point of view.

- Incorrect. In fact only the appellant held press conference illegally without following the Civil Servant rules while no other person of the Christian Community accompanied with him. However, being minority of the country, the appellant was not proceeded under the rules in 2018 as no Government Servant can hold press conference without bringing the issue in notice of higher authorities.
 - Incorrect. The orders of the respondent were based on rules & regulations and on the basis of the prolong absentia as mentioned in Para-02 above. The appellant not only remained absent from the allotted duty but also threatened the Deputy Superintendent Jail for allotment of duty according to appellant own wishes and was reluctant to perform the duty as per rules (copy of report of Deputy Superintendent is attached as Annexure-B). Similarly, various complaints were also received to the Superintendent Jail regarding the immoral and rude behaviour in Jail colony (copies attached as Annexure-C1,C2,C3...). Prior to the dismissal, the appellant was issued various notices but these notices were responded with cold shoulder and hence the misconducts was reported to the higher authority i.e. Inspector General of Prisons, Khyber Pakhtunkhwa Peshawar vide No.634/WE dated 02.02.2021 (copy attached as Annexure-D) and Inquiry initiated both by the Inspector General of Prisons & Superintendent Jail. The Inquiry Officer recommended the Dismissal from service.
 - In reply, it is stated that the appellant also failed to defend at appellate forum i.e. office of the Inspector General of Prisons, Khyber Pakhtunkhwa Peshawar, therefore, the order of Superintendent Jail was upheld and the appeal was dismissed as per Law (copy attached as Annexure-E#).
 - That the order was based on complaints received against the appellant, the absence 7. periods, threats to the Jail authorities and after issuance of various notice and inquiry proceedings purely under Efficiency & Discipline Rules-2011. (Copies of notices are attached as Annexure-F1,F2,F3).
 - Reply on Grounds.

Incorrect. Initially the Superintendent Jail initiated inquiry Proceedings vide No.708 dated 04.02.2021 and Mr. Farman Ullah Network Administrator (BPS-17) of Central Prison Bannu conducted inquiry inside the Jail. However, the appellant failed to defend and the Inquiry Officer recommended the Dismissal fron* Government Service (copy of Statement of Allegations & Inquiry report are attached as Annexure-G1&G2). Similarly, the Worthy Inspector General of Prisons, Khyber Pakhtunkhwa Peshawar also ordered inquiry proceedings vide No. 3834 dated 03.02.2021 and the Superintendent Circle Headquarter Prison DI Khan was nominated as Inquiry Officer who conducted inquiry in Central Prison Bannu and recommended the Removal from Service (copy of I.G Prisons letter & Inquiry Report of Superintendent Circle Headquarter Prison DI Khan are attached as Annexure-H1&H2). After that Final Show Cause notice for personnel hearing under rule-12 of Efficiency & Discipline Rules-2011 was issued by the Superintendent jail vide No.867 dated 10.02.2021 but the appellant refused to receive the Show Cause notice in front of Psychologist (BPS-17) & Line Officer (BPS-16) who are witnesses and resultantly the Superintendent Jail, find no other way, issued Order of Dismissal. (Copy of Show Cause notice vetted on back side by Female Psychologist & Line Officer is attached as Annexure-I)

- Incorrect. The orders of the respondents are based on Efficiency & Discipline Β. Rules-2011 and after receiving of complaints against the appellants & Inquiry report of the Inquiry Officers as stated above in Para-05.
- Incorrect. The appellant not only remained absent from the allotted duty but also C. created administrative problems for the smooth administration of Jail and was proceeded against as per rules & regulations as mentioned above in Para-02 & 05.
- In reply, it is stated that the instant appeal is devoid of merits, barred by Law and D. liable to be dismissed.
- The respondents may graciously be allowed to raise additional grounds during E. arguments.

PRAYER:

Keeping in view the above Joint Para-wise comments, ground realities & documentary proof, it is humbly prayed that the instant appeal may graciously be dismissed with cost, please.



When I refused, she said that few months back Superintendent Jail forwarded application against me for which I am going to hold press conference against him. The undersigned asked for proof/evidence but she hurled threats of holding press conference against the Superintendent and Jail administration.

After that the Line Officer informed me that both Sweeper Ashi Bibi along with her husband Mir Anbas left Jail premises and absented themselves from assigned duties in Jail. It is also to mention that Female Sweeper Ashi Bibi was earlier allotted duties in the house of Female Psychologist Shukria Nawaz attached to this Jail but due to her misbehavior with the Psychologist Shukria, she was removed from duties. Furthermore, the accused Sweeper Ashi Bibi is not taking interest in her duties and no one is ready to accept her. She is a characterless woman and uses abusive language against Jail Staff and its administration. Due to her misbehavior, the Jail Administration is facing difficulties in allotment of duties to female Sweepers Staff.

It is submitted that today on 02.01.2021, female Sweeper Aashi came to the office of Deputy Superintendent Jail and said that my husband duty should be changed and duty hours should be according to her choice. On refusal of Deputy Superintendent Jail she threatened the Deputy Superintendent Jail for holding press conference against the Jail administration and blamed that the Superintendent Jail has submitted application to the worthy Inspector General of Prisons against her. Holding press conference by government servant is against the rules and do come in official misconduct.

Later on both the spouse left the Jail and compound without permission of Deputy Superintendent Jail and Line Officer and without grant of any leave. Report of Deputy Superintendent Jail is attached as **Annexure-A** and similar report of Line Officer is also attached as **Annexure-B**.

Previously, she used same tactics against the undersigned but she could not prove anything against me during inquiry. Again she is blaming the undersigned without any reason and her such action is beyond understanding.

Moreover, she was allotted duties at Psychologist Quarter inside the Jail compounds but she also misbehaved with said Psychologist while she does not take interest in her assigned duties. In this regard report of Psychologist is attached as Annexure-C. In addition: other, staff members residing inside the Jail compounds also submitted their statements regarding misbehaviour of said female sweeper which are enclosed as Annexure-D1,D2,D3&D4.

Further added that from her previous dark service history, it is crystal clear that she is quite malingerer and her further retention in this Jail is quite dangerous from security point of view.



I, Samiullah Khan, Superintendent Central Prison, Bannu as a competent authority, am of the opinion that Sweeper Mir Anbas & Aashi Bibi have rendered themselves liable to be proceeded for committing the following act of misconduct within the meaning of Section 3 of the Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules-2011.

STATEMENT OF ALLEGATIONS.

"Sweeper (BPS-03) Mir Anbas & Aishi Bibi attached to Central Prison, Bannu, willfully refused to perform their assigned duties and disobey the lawful orders of the superiors. They both threatened the Deputy Superintendent Jail for holding Press Conference against the Jail administration and left the Jail premises without permission of the competent authority. Hence rendered themselves to be proceeded against you under the Rules".

Mr. Farmanullah Network Administrator is hereby nominated as Inquiry Officer

The Inquiry Officer shall, in accordance with provisions of the Ordinance, provide reasonable opportunity of hearing to the accuseds, record its findings and make, within fifteen days of receipt of this order, recommendations as to punish or to take other appropriate actions against the accused officials.

The accused and a representative of Central Prison Bannu shall join the proceedings on the date, time and place appointed by the Inquiry Officer.

R/Sir,

As per your directions vide office memo: No. 708 dated 04.02.2021, 1 proceed into the matter and issued a notice to the accused officials through Incharge Class-IV employees/Line Officer for appearance in Head Clerk Office for inquiry proceeding and submission of written statement in defense on 08.02.2021 as well as asked the Incharge Class-IV Employee for provision of relevant record.

FACTS:

- (i) On fixed date and time, the Jail authority provided all relevant records/ documents, however, the accused employees Mir Anbas & Aashi Bibi were neither appeared in person nor submitted any written statement in defense.
- (ii) As per report of the Incharge Class-IV Employees, they both refused to receive the notice for appearance before the Inquiry Officer.
- (iii) I thoroughly checked the relevant record i.e. Duty Register, show cause notices and explanation letter issued by the Deputy Superintendent Jail & Superintendent Jail.
- (iv) I also inquired some of the Class-IV employees about the duties and conduct of the above named accused. They stated that the above named Sweepers remained out of Jail and are not taking interest in their duties while usually remained absent from their duties.
- (v) During the course of Inquiry Proceedings, I also thoroughly read the statements/reports submitted by staff members residing in Jail compound to the Jail authority against the above named accused officials.

FINDINGS: -

After checking the available record, it was observed/ pointed out that: -

 Due to non appearance for Inquiry Proceedings and their refusal from receiving the Notice, it is crystal clear that both the accused official considered the Inquiry Proceedings as a joke-and challenged the Inquiry as well as Jail authority that the Jail authority can do nothing against them.

- 2. As per duty Register they remained absent from their allotted duties on various dates in each and every months and as such they also refused from performing duties inside the Jail.
- 3. Moreover, it is also evidence from the perusal of various statements submitted by Psychologist, Deputy Superintendent as previously they threatened him for holding press conference that their conduct are not satisfactory and are not taking interest in their duties.
- 4. During the inquiry proceedings, it was also observed that they have habit of pressurizing the Jail administration by means of lodging complaints and holding press conference against the Jail administration as such previously they both hold a press conference which is quite against the Civil Servants hierarchy.
- 5. Although, the both are deserted from Jail premises and as such it is crystal clear that they are not taking interest in their allotted duties.

CONCLUSION/RECOMMENDATION: -

Keeping in view the above submissions, their previous dark history and prolong absentia, I am of the opinion that they may be dismissed from their Services as per rules 4 of the Efficiency & Discipline Rules-2011.

Subject: - FACTS FINDING INTO THE MATTER OF CENTRAL PRISON BANNU

Respected Sir.

As per your directions vide office memo: No. 3834/WE dated 03.02.2021 & No.3868/WE dated 04.02.2021, I proceeded to Central Prison Bannu on 09.02.2021 in order to find out the factual position of the subject cited case and asked the accused officiats for appearance before the Inquiry Officer in the office of Deputy Superintendent Central Prison Bannu for inquiry proceedings and for submission of defense reply (if any). I also asked the Bannu Jail authority for provision of relevant record and duty register. When I reached there, the Superintendent Jail as well as other staffs were found present. I discussed the matter with the Superintendent Jail who debriefed me about the case. The Superintendent Jail also produced his detailed report/statement comprising with supporting documents i.e. statement of Psychologist, other staff members residing in the Jail colony which are attached herewith for kind perusal and ready reference.

FACTS:

- (i) Both the accused officials namely Sweeper Mir Anbas & Aashi Bibi were appeared before the Inquiry Officer and recorded their statements. They were inquired without any stress/pressure in friendly environment. The Jail authority also provided relevant records/ registers, during, the inquiry proceedings,
- (ii) The duty register was thoroughly checked wherein both the officials were marked absent from their allotted duties on various dates. They both were asked about their absence periods, but they produced no justification for their periods of absentia.
- (v) During the Inquiry proceedings, the Line Officer as well as other staff members were also inquired in order to find out the grounds reality of the case. The Line Officer stated that they both usually refused to perform their duties anywhere inside the Jail. They want in allot duties to them according to their own wishes. They do not obey the orders of their superior and pressurizing the Jail administration through various means.
- (iv) I thoroughly checked the relevant record i.e. Duty Register, files etc and observed that they were issued various show cause notices and explanation letters by the Deputy Superintendent Jail & Superintendent Jail as and when they found absent. (Copies of notices are attached with statement of Superintendent Jail as Annexure B1, B2 & B3).
- (v) I also inquired some of the Class-IV employees who duly confessed and stated that both the sweepers always remained absent and are not taking interest in their duties.
- (vi) During the course of Inquiry Proceedings, I also paid visit to residential colony but^[7] found that they both had created nuisance for colony staff by their vulgar activities, which speak volume that statements/reports so received to Jail administration are correct:

FINDINGS: -

During the Inquiry proceedings, the following findings were pointed out: -

1. That previously, one tube well operator namely Taj Ali was detailed to Central Prison Bannu for operating tube wells by C&W Department Bannu. The said tube well operator usually stayed at the residential quarter of above named sweepers which is an immoral attitude/behavior/due to which the neighboring staff members of the Colony

complained to the Superintendent Jail against the said tube well operator. Even in night hours most oftenly visitors; who were not their relatives would pay visit to her quarter and stayed there which is not only immoral but also poses a great security risk for such a sensitive Jail. When such visitors were banned in odd hours she would create disturbances and threatened blatantly for holding press conference against the Jail administration.

- 2. Further due to their various absence periods during short time, it is clear that both the accused officials are not taking interest in performance of their allotted duties and they considered their jobs merely a joke.
- 3. As they both usually refused from their assigned duties and want their duties according to their own wishes for which they are trying to put pressure on Jail administration. Both the husband and wife are acting such like they are solely running the Jail affairs and hijacking the authorities of Superintendent Jail & Deputy Superintendent Jail. Hence they are also joking with the Jail Department as they did not obey the lawful orders of their superior, which is quite illegal and against the Civil Servant rules.
- 4. It is also evident from the perusal of various statements submitted by Deputy Superintendent Jail, Psychologist, other staff members residing in Jail colony that their conduct inside the Jail is not satisfactory as such Aashi Bibi misbehaved with Psychologist and her husband is stood with her. Further as per statement of the colony staff members they both are not taking interest in their duties.
- 5. Most importantly, they both are trying to pressurize the Jail administration by various means as such previously they had hold press conference and lodged various allegations against the Jail administration but put no proof during the Inquiry Proceedings for which they were required to be penalized according to rules. But they were not penalized for their illegal action that is why they are again trying the same factics.

CONCLUSION/RECOMMENDATION: -

Keeping in view the above submissions, I Mr. Muhammad Binyamin Khan recommend that both the *Spouse Sweeper namely Mir Anbas & Aushi Bibi shall be dismissed immediately from their Services* and directed the Superintendent Central Prison Bannu to issue Direct Shów Cause Notice to both the Sweepers for their Dismissal from Services.
