




IN NON COMPLETION OF DEPARTMENTAL INQUIRY INITIATED

ON DATED 23/12/2019 VIDE NOTIFICATION NO CS
(F)/N/4-KHASADAR/ MOHMAND 1551 OF RESPONDENT NO
4.

Prayer in appeal:

On acceptance of this appeal, the impugned order for termination and retirement whatsoever, existed in the field may kindly be set aside and the appellant be re-instated in service with all back benefits, whereas after merger the Khasadari has been converted into Police Service, the appellant may kindly be posted on the equivalent post under the control of respondent No 4.

Respectfully Sheweth:-

1. *That the appellant has been appointed and posted as Khasadar in Mohmand Force on 01/08/2004.*
2. *That the appellant was performing duties diligently, honestly, devotedly and to the entire satisfaction of his superiors.*
3. *That all of a sudden on dated 09/05/2017 the then Political Agent Mohmand Agency passed the first impugned order for termination of the appellant and recruitment of respondent No 8 as Khasadar against his post. (Copy thereof is hereby placed as annexure "A").*

4. *That the appellant enquire about his grounds of termination and reasons thereof where no background of his misconduct was shown whereafter appeal before the departmental authority was filed. (Copy thereof is hereby placed as annexure "B").*
5. *That it is very astonishing that on dated 12/12/2019 through Secretary Home of Tribal Affairs vide Notification No CS (F)/:&K/4-Khasadar Appeal No 01/2019 it was ordered by departmental authority that the appellant has been considered retired as per rule of the Khasadar rules being due to superannuation at the age of 50. (Copy thereof is hereby placed as annexure "C").*
6. *That it was found during the pendency of the departmental appeal before the office of respondent No 4 that the services of the Khasadar Hashmat Khan has been transferred vide secret found record to respondent No 8 by the then Political Agent, (Copy thereof is hereby placed as annexure "D"). In this respect proper inquiry was initiated by respondent No 4 vide Notification CS (F)/N/4-Khasadar Mohmand 1551 dated 23/12/2019. (Copy of the initiated inquiry notification is hereby placed as annexure "E").*
7. *That during the course of inquiry, it was found that the respondent No 8 through some unknown persons namely*

Shaheen has placed a separate application before the respondent No 6 for his appointment as Khasadar instead of the present appellant, then the Political Agent and Assistant Political Agent through their secret official correspondence have acted malafidely and the impugned order dated 09/05/2017 has been passed whereby the appellant has been treated terminated.

8. *That so much so, after initiation of the inquiry against the respondent No 8, it was found that the respondent No 8 was not legally eligible for appoint as Khasradar due to non belonging to the then Mohmand Agency domiciled areas. (Copy of order passed by respondent No 4 to the same effect in inquiry is hereby placed as annexure "F").*
9. *That the appellant then on dated 25/05/2021 has filed an application before the Inspector General of Police Khyber Pakhtunkhwa, Peshawar for final result of the inquiry matter before the respondent No 4 initiated on his suo-moto vide dated 23/12/2019 vide notification no CS (F)/N/4-Khasadar/Mohmand 1551, which failed to prove effective, even after ~~with~~ of three months, after filing of a grievance before the final authority of IGP upto 25/08/2021, no favorable action for reinstatement has been taken, hence for accruing the cause of action before this Honourable Tribunal, instant appeal is hereby filed alongwith an application for*

condonation of delay if proved to have occurred on the part of the appellant on the following ground inter alia:- (copy thereof is herby placed as annexure "G")

Grounds:-

- A. That both the impugned termination orders dated 09/05/2017 the then Political Agent Mohmand Agency & FATA Secretariat Home & Tribal Affairs dismissal of first department appeal dated 12/12/2019 are illegal, void, unlawful, without lawful authority and ineffective upon the rights of appellant, hence needs to be set aside.
- B. That neither in the termination order any misconduct has been mentioned nor any show cause thereof has been referred, despite of pension-able performance of duties on the basis of permanent cadre.
- C. That when the matter was called into question into departmental appeal upto the disposal of departmental appeal, no matter of misconduct has been pointed out, rather termination order has been termed retirement from service on superannuation at the age of 50.
- D. That it was after the suo-moto notification of respondent No 4 vide Notification No CS (F)/N/4-Khasadar/ Mohmand 1551 dated 23/12/2019, when the clue of conspiracy was

found and the document (annexure "D") was digout, where the person Shaheen has been shown in the said application omitted where the name of respondent No 8 has been entered for transposition of service of the appellant and then a chain of conspired documents were brought on record, where even the person (respondent No 8) was found non-domiciled at Mohmand Agency.

E. That whereas, the inquiry and the conspiracy has been dig-out with written materials about letters of the then Political Agent, applications etc and now where all of the Khasadar force personnel have been transposed as Police Force with their changed nomenclatures, then the departmental head is definitely the Inspector General of Police Khyber Pakhtunkhwa Peshawar, who vide the filed petition has been failed to take any action for reinstatement of the appellant and vide the last document (annexure "G") the grievance has been matured.

F. That the impugned orders are illegal, non speaking orders, ambiguous as the appellant was not served with any Show Cause Notice nor proper/regular inquiry was conducted, so the appellant was condemned unheard.

G. That the appellant has served the department for more then 13 years, while the appellant is deprived from his bread and

butter alongwith his family on the basis of defunct P.A & APA Offices, crystal malafide while dig-out by respondent No 4 with documents and letters.

- H. That all the proceedings initiated against the appellant, based on malafide and malicious and purportedly were initiated in order to displace the appellant from his post and appoint any other blue-eyed.
- I. That it is well settled principle of natural justice enshrined in the precedents of superior courts as well that where the competent authority is going to impose any penalty etc the regular inquiry to that effect is necessary.
- J. That the appellant reserves the right to agitate any other ground at the time of arguments.

It is, therefore, respectfully prayed that on acceptance of this appeal, the impugned order for termination and retirement whatsoever, existed in the field may kindly be set aside and the appellant be re-instated in service with all

back benefits, whereas after merger the Khasadari has been converted into Police Service, the appellant may kindly be posted on the equivalent post under the control of respondent No 4.

Respectfully Submitted as under:

1. That the appellant has been appointed/posted as Khasadar in Mohmand Agency on 01/08/2004. Since my inception in the service I have been performing my duties honestly, diligently, devotedly and to the entire satisfactions of my superior, and my service record has all along been neat and clean.
2. That now on 09/05/2017 the Political Agent vide office order 2067-70/KC terminated the appellant from service without any negligence, ineffectively or misconduct, without issuing a Show Cause Notice, statement of allegation, charge sheet and holding proper inquiry and in the same single order Waqar Khan S/o Dilawar Khan was appointed as Khasadar against my vacant post, without waiting for appeal/representation etc. (Order attached).
3. That the impugned order is discriminatory, arbitrary, illegal, unlawful, malafide and void-ab-initio having no effect on the right of the appellant.

4. That the impugned order of removal from service has been passed without due application of mind and without observing the legal procedure laid down in service rules for Khasadar in FATA. Hence the same is violative of service rules, Khasadar rules as well as constitution and natural justice.
 5. That the impugned order was passed as a result of ex-parte proceeding, which is illegal in the eye of law, hence liable to be set aside.
 6. That it is also a well settled law that maxim "audi alteram partem" is deemed to be part of every statute, therefore the appellant cannot be deprived of his statutory right of being heard before passing of removal order.

It is, therefore, respectfully prayed that the appellant be reinstate into service with all back benefit and the illegal appointment of Waqar Khan S/o Dilawar Khan may kindly be withdrawn/terminated.

Any other relief which this Hon'ble Forum deem fit may kindly be granted.

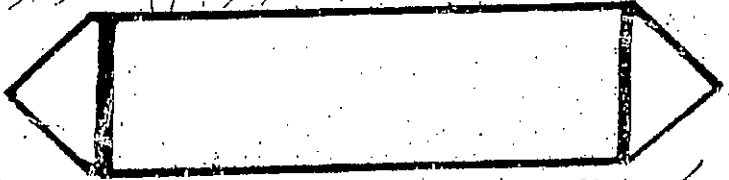
