

Notification dated 24.04.2018 is attached as Annexure .....В.
- **3-** That respondents held the meeting of Departmental Promotional Committee on 11.06.2020 and excluded the name of the appellant for promotion to the post of Inspector Physical Education BPS-17 due to lack of degree of Bachelor of Education. Notification of the minutes of the Departmental Promotional Committee is attached as **Annexure......C.**
- 4-That the appellant passed Master degree Health & Physical Education from Sarhad University of Science and Information Technology which is attached as Annexure......D.
- 5-That the appellant passed two semesters of B.Ed and remaining 01 semester.
- **6-**That the respondents vide a notification of DPC meeting held on 31.01.2017 allowed female SPETs for promotion to the post of IPE BPS-17 subject to the condition that they should pass the

- 7-That the Government of Khyber Pakhtunkhwa E&SE Department do away with Professional Qualification like B.Ed, M.Ed in C.T etc, even in initial recruitment in E&SE Department.
- **9-**That the appellant feeling aggrieved from action and inaction of the respondents regarding not promoting the appellant to the post of IPE (BPS-17) preferred a departmental appeal which is not responded to promote the appellant to the post of IPE (BPS-17). Departmental appeal is attached as **Annexure...G.**
- **10-** That thereafter the appellant waited for the statutory period of 90 days but reply has been received from the respondents and therefore the appellant has no remedy but to file this service appeal.

and as such the same is violative of the principle of natural justice.


