



**ON FACTS:**

**Brief facts giving rise to the present appeal are as under:-**

- 1-That the appellant is serving in E&SE Department as Senior Physical Education Teacher SPET (BPS-16) presently in GHS No. 02 Tordher District Swabi quite efficient and upto the entire satisfaction of the superiors. Payroll of the appellant is attached as **Annexure.....A.**
- 2-That the Government of Khyber Pakhtunkhwa E&SE Department in consultation with Establishment and Finance Department under notification dated 24.04.2018 amended the previous notification of E&SE Department No. SO(PE)4-5/SSRC/Meeting/2012 dated 13.11.2012 through which the respondents directed that the promotion to the post Inspector Physical Education (BPS-17) will be made from 70% percent by promotion on the basis of seniority cum-fitness from amongst SPETs BPS-16 with at least 05 years service as SPET and with the qualification of Bachelor of Education. Notification dated 24.04.2018 is attached as **Annexure.....B.**
- 3-That respondents held the meeting of Departmental Promotional Committee on 11.06.2020 and excluded the name of the appellant for promotion to the post of Inspector Physical Education BPS-17 due to lack of degree of Bachelor of Education. Notification of the minutes of the Departmental Promotional Committee is attached as **Annexure.....C.**
- 4-That the appellant passed Master degree Health & Physical Education from Sarhad University of Science and Information Technology which is attached as **Annexure.....D.**
- 5-That the appellant passed two semesters of B.Ed and remaining 01 semester.
- 6-That the respondents vide a notification of DPC meeting held on 31.01.2017 allowed female SPETs for promotion to the post of IPE BPS-17 subject to the condition that they should pass the

B.Ed examination within 03 years. Notification is attached as **Annexure .....E.**

7- That the Government of Khyber Pakhtunkhwa E&SE Department do away with Professional Qualification like B.Ed, M.Ed in C.T etc, even in initial recruitment in E&SE Department.

8- That on the recommendation of the DPC meeting dated 16.06.2020 the respondents issued promotion order dated 20.10.2020 by excluding the appellant from promotion to the post of IPE (BPS-17) and promoted a junior to the appellant. Promotion notification dated 20.10.2020 is attached as **Annexure .....F.**

9- That the appellant feeling aggrieved from action and inaction of the respondents regarding not promoting the appellant to the post of IPE (BPS-17) preferred a departmental appeal which is not responded to promote the appellant to the post of IPE (BPS-17). Departmental appeal is attached as **Annexure...G.**

10- That thereafter the appellant waited for the statutory period of 90 days but reply has been received from the respondents and therefore the appellant has no remedy but to file this service appeal.

#### **GROUND:**

A- That the impugned notifications dated 16.06.2020 & subsequent notification dated 20.10.2020 by not promoting the appellant to the post of IPE (BPS-17) is against the law, facts, norms of natural justice and materials on the record hence not tenable and liable to be amended to the extent that the name of the appellant included in the above notifications for promotion.

B- That appellant has not been treated in accordance with law and rules by the respondent Department on the subject noted above and as such the respondents violated Article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.

C- That the impugned notifications dated 16.06.2020 & 20.10.2020 by not promoting the appellant on the post of IPE (BPS-17) has been issued on the basis of mala fide and arbitrary intentions

and as such the same is violative of the principle of natural justice.

D- That as per Rules and regulation the appellant is entitle to be promoted to the post of IPE (BPS-17) with all back benefits.

E- That appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed for.
