Respectfully Sheweth,

**PRELIMINARY OBJECTIONS:**

1. That the appellant has got no cause of action as well as locus standi to file the instant Service appeal.
2. That the instant appeal is incompetent in its present form, hence liable to be dismissed.
3. That the instant Service appeal is badly time barred.
4. That the Service appeal is not maintainable in its present form.
5. That the appellant has not come to this Honorable Tribunal with clean hands.
6. That the appellant is estopped by his own conduct.
7. That the appellant has concealed the material facts from this Honorable Tribunal hence the Service appeal liable to be dismissed.
8. That the instant Service appeal is liable to be dismissed for non-joinder / mis-joinder of unnecessary parties.
9. That the instant appeal is based on malafide intention, hence liable to be dismissed.
10. That the instant Service appeal is against the prevailing law and rules.
11. That the respondents on the recommendation of Departmental Promotion Committee the answering Respondent promoted the appellant to the post of S-PET vide Order No 549-55 dated 05-09-2017, who is place on Serial No 71 in the Promotion Order.

12. That the respondents on the recommendation of Departmental Promotion Committee the answering Respondent Adjusted the appellant to the post of S-PET vide Order No 9640-43 dated 23/09/17 in the GGHS Mohib Ullah Banda Mardan who is place on Serial No 06 in the Adjustment Order. **(Copy of Adjustment Order is attached as Annex-B)**
13. That the respondents being the responsible government officers acted in accordance with the law, followed the rules & regulation for selection and promotions of the appellant and others S-PETs.
14. That the appellant failed to submit her charge Report to the respondents and the appellant has not taken over charge on the GGHS Mohib Ullah Banda Mardan in the

post of S-PET, BPS-16 and the appellant is not attending/ teaching at GGHS Mohib Ullah Banda Mardan in the post of S-PET, BPS-16.

**FACTS:**

1. Para No 1 pertains to record, hence needs no comments
2. Para No 2 pertains to record, hence needs no comments.
15. Para No 3 pertains to record, to the extent of the promotion order while, the appellant concealed the real facts from this honorable Tribunal and the recommendation of Departmental Promotion Committee, the respondents has promoted the appellant to the post of S-PET vide Order No 9640-43 dated 23/09/ 17 in the GGHS Mohib Ullah Banda Mardan who is place on Serial No 06 in the Adjustment Order and the appellant failed to submit her charge Report to the respondents and the appellant has not taken over charge in the GGHS Mohib Ullah Banda Mardan in the post of S-PET, BPS-16, furthermore the appellant has not obeyed her promotion order vide No 9640-43 dated 23/09/ 17 and the appellant is not attending/ teaching at GGHS Mohib Ullah Banda Mardan in the post of S-PET, BPS-16, hence denied.

16. Para No 4 is incorrect, baseless against facts and law as the appellant has not taken over charge in the GGHS Mohib Ullah Banda Mardan in the post of S-PET, BPS-16 and the appellant has not obeyed her promotion order vide No 9640-43 dated 23/09/ 17 therefore the appellant is not entitled pay fixed in BPS-16, because the appellant is performing her duty in BPS-15 at GGMS Shakiray baba Mardan and the appellant is not attending/ teaching at GGHS Mohib Ullah Banda Mardan in the post of S-PET, BPS-16, hence denied.

**GROUND:**


- I. Para No I is incorrect, as the appellant has not obeyed her promotion order vide No 9640-43 dated 23/09/ 17 due to which the respondents are not legally liable to fix the salary of the appellant according to her promotion of BPS-16 from the relevant dates and the appellant is not performing her duty as S-PET, BPS- 16, at GGHS Mohib Ullah Banda Mardan, so the appellant is not entitled financial benefits, hence denied
- II. Para No II is incorrect, baseless against facts and law, as the cogent reason is that the appellant is performing her duty in BPS-15 at GGMS Shakiray Baba Mardan and She is not attending/ teaching at GGHS Mohib Ullah Banda Mardan as a S-PET, BPS-16, therefore the respondents are not legally liable to fix the salary of the appellant according to her promotion of BPS-16 from the relevant date and the appellant is not entitled financial benefits, because the appellant has not obeyed her promotion order vide No 9640-43 dated 23/09/ 17 hence denied.
- III. Para No III is incorrect, baseless against facts and law, as the appellant has submitted her documents for promotion and from time to time visited to the office of DEO (Female) Mardan regarding her promotion and the appellant along with other Promotee well

known about the promotion order. The respondent has fixed the promotion order in Notice Board in the Office of DEO (Female) Mardan, at Public Place, hence denied.


- IV. Para No IV is incorrect, baseless against facts and law, as the appellant has not written the reliving chit regarding GGMS Shakiray Baba and has not applied for reliving from GGMS Shakiray Baba, Mardan. The appellant herself has not interested to leave GGMS Shakiray Baba, Mardan, and the reliving chit which is at page 14 in the Service Appeal is regarding her transfer order and has not identical the promotion order, hence denied.
- V. Para No IV is incorrect, baseless against facts and law, as the appellant failed to submit her **charge Report** to the respondents and the appellant has not taken over charge in the GGHS Mohib Ullah Banda Mardan in the post of S-PET, BPS-16 and the appellant is not attending/ teaching at GGHS Mohib Ullah Banda Mardan in the post of S-PET, BPS-16, therefore the appellant is not entitled financial benefits, and the appellant has no cause of action regarding pay fixation of every month because she is teaching as a PET, grade and is not S-PET grade, hence denied
- VI. The respondents seek permission to raise additional grounds at the time of arguments.

Therefore it is humbly prayed that keeping in view the above mentioned facts the instant Service appeal may kindly be dismissed with cost.


