APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 AGAINST THE IMPUGNED OFFICE ORDER / NOTIFICATION DATED 17.02.2022 (ANNEX-A) PASSED RESPONDENT NO. 02 HEREIN CCPO PESHAWAR WHEREBY THE APPELLANT HAS NOT BEEN CONSIDERED FOR CONFIRMATION IN THE RANK OF SI, BEING AGGRIEVED WITH THIS OFFICE ORDER / NOTIFICATION, THE APPELLANT HAS BEEN PREFERRED DEPARTMENTAL APPEAL / REPRESENTATION DATED 02.03.2022 VIDE (ANNEX-B) WHICH WAS RECEIVED BY THE OFFICE OF 3871/ DATED 03.03.2022 RESPONDENTS VIDE C.R NO. REDRESSAL OF GRIEVANCES BUT THE SAME HAS BEEN REMAINED UN-RESPONDED TILL THE EXPIRY OF STATUTORY PERIOD OF 90 DAYS, AND THE AUTHORITY IS RELUCTANT APPROPRIATE ORDER ON HIS PENDING APPEAL, HENCE, ALIA ON THE FOLLOWING CIRCUMSTANTIAL GROUNDS.

ON FACTS:

Brief facts giving rise to the present appeal are as under:-

- 1. That the appellant was appointed as Constable (BPS-02) on 26.03.1988 accordingly. Since his inception in the service he has been performing his duties, devotedly and to the entire satisfaction of his superiors. The appellant has been rendering meritorious service record of more than 30 years for the organization at his credit.
- 2. That the appellant is the law abiding citizen of the Islamic Republic of Pakistan serving presently as \$1 Sub Inspector in the prestigious force Police Department of Khyber Pakhtunkhwa and there is no stigma on his performance whatsoever.
- 3. That due to the gantry performance of appellant, the Authority has been pleased to promote the appellant to the post of ASI w.e.f. 16.06.2008 as recommended by the DPC accordingly. (Copy of office order dated 16.06.2008 is attached as annexure C, page No_13_).
- 4. That the respondent department has been issued office order dated 24.02.2011 whereby the appellant was awarded punishment of Time Scale for a period of three years under RSO by SSP (ops) Peshawar vide OB No. 710 dated 24/02/2011 and was deprived for the due promotion. The said penalty was assailed by the appellant by way of departmental appeal to the Authority whereupon the speaking and comprehensive order was passed and thus the aforesaid harsh penalty was set aside and allowed accordingly vide office order dated 11/03/2013. (Copy of office order dated 11/03/2013 is attached as annexure D, page No 14).
 - 5. That after wards i.e. 01 year, 08 months and 29 days by the office order dated 10.12.2014 the respondent-department has been issued REVISE SENIORITY OF CONFIRMATION IN THE RANK OF ASI

AND PROMOTION TO LIST "E" and upon the recommendation of DPC, the are hereby confirmed in the Rank of ASI shown at serial No. 2 whereas date of confirmation and list E is 27/09/2011 vide seniority was granted with their colleagues i.e. SI Noor Rehman and Zafar Ali herein Respondent No. 3. But is very nitty and gritty that the appellant was not granted anti-dated seniority and placed him in the seniority "list E" and thus he was not promoted to the post of Sub Inspector. (Copy of Notification / Revised Seniority of Confirmation in the rank of ASIs and Promotion to List E vide dated 10.12.2014 is attached as annexure E, page

- 6. That other colleagues namely Noor Rehman & Zafar Ali (respondent No. 03 and junior to appellant) were confirmed to the post of ASI by the office order dated 24.02.2011 and their names were shown in the "list E" whereas the appellant was not promoted along-with their colleagues. That the aforesaid colleagues Noor Rehman Sub Inspector and Zafar Ali / respondent No. 03 were later on promoted on offg. \$1 by the office order dated 10/03/2012 shown at serial No. 21-22 and subsequently, were confirmed in their ranks to the post of Sub inspector \$1 by the office order in respect of Confirmation in the Rank of \$1s\$ wherein shown at serial No. 19-20 vide dated 13.07.2015. (Copy of office order dated 10/03/2012 & 13.07.2015 is attached as annexure F-G, page 16 To 18.
 - 7. That the appellant was declared innocent and the punishment was set aside by the respondent No. 2 / CCPO by the office order dated 11.03.2013 stated above and despite this fact the appellant was not granted ante dated seniority and confirmation in the various ranks at par as was granted to aforestated colleagues which was his due and fundamental right.

The actual position of appellant in respect of Seniority is after wards the Noor Rehman SI and above the Respondent No. 3.

- 8. That the appellant was promoted to the post of <u>Sub Inspector</u> Offg SIs as approved by DPC by the office order / Notification / Promotion to the Rank of Offg; Sis vide dated 03/03/2017 wherein shown at serial No. 3. (Copy of office order/ Notification apropos to promotion to the rank of Offg; SIs dated 03/03/2017 is attached as annexure H, page No. <u>20</u>.
- 9. That the appellant filed departmental appeal to the authority for revise / correction / modification of seniority, whereby the authority has been issued OFFICE ORDER / NOTIFICATION IN RESPECT OF REVISED PROMOTION TO THE RANK OF OFFG; SI as recommended by DPC and the same was allowed by the Departmental Authority, the aforesaid office order dated 03/03/2017 is hereby Revised w.e.f. 10/03/2012 instead of 03/03/2017 with his colleagues with his "E" Colleague stated above. (Copy of office order / Notification dated 05/07/2021 is attached as annexure-I, page No 25.
- 10. That the appellant also filed another departmental appeal in favour of CCPO / respondent No. 02 in respect of confirmation of Sub Inspector treating him at par, whereby the authority / CCPO has been passed the impugned office order dated 17/02/2022 wherein his application was disallowed due to non-completion of mandatory period in other unit as per amended Police Rules 13.10 (2), thus, by not granting confirmation to the rank of SI w.e.f. 15.07.2015 which is against the law, rules, constitution and regulation, without lawful authority and the same is liable to be set aside.

11. That feeling aggrieved by the impugned office order dated 17/02/2022 passed by the CCPO / respondent, the appellant have no other remedy but to file the instant service appeal on the following grounds amongst other.

GROUNDS:

- A-That by not including the name of the appellant in the seniority list at par is illegal, against the law and facts, rules and norm of natural justice.
- B- That appellant has not been treated in accordance with law and rules by the respondent Department on the subject noted above and as such the respondents violated Article 4, 25 & 38 of the Constitution of Islamic Republic of Pakistan 1973.
- C-That the appellant was penalized for the offence twice which is the violation of Article 13 (a) of the Constitution of Islamic Republic of Pakistan, 1973.
- D- That the department has not been dealt the case of appellant fairly and justly as was ordain in the constitution and under article 10 (a) of the constitution vehemently violated.
- E- That acts of Respondents are against the settled principle of Law and Rules the Hon'ble Court may interfere under extraordinary constitutional jurisdiction. That the appellant being well qualified, fulfill the required criteria and rules and also entitled for due promotion which is the due, fundamental and legitimate right of him

but due to mala-fide intention of the respondents, he has been deprived of the legitimate promotion in hand and other benefits.

- F- That the claim of the appellant is in consonance with law as since anti-date promotion he has not been given to appellant has been ignored for no reasons. This approach on the part of Respondents is highly condemnable and this Hon'ble Tribunal being a custodian of the institutions may issue strict directions to Respondents to act in accordance with Law and Rules.
- G-That action and inaction of the respondents are violation of Article 24-A of General Clauses Act and rules applicable to the matter because while giving promotion no rim and reasons were given for delayed promotion and depriving the appellant from back benefits. The competent authority acted in mechanical way and influenced by extraneous considerations. The impugned office order is therefore, violative of Section 24-A of General Clauses Act, 1897 which provides that an authority vested with a power to make any order is bound to exercise that power reasonably, justly, fairly and for the advancement of the purpose for which such power is vested in him. The authority is further bound to mention the reasons for passing the adverse order.
 - H- That but unfortunately, with the passage of time, the behavior of the respondents have changed and biased because he was not allowed with regard to ante dated promotion although he is eligible, well qualified, well experienced. They have adopted pick and choose policy and violates the rules and regulations clearly, illegally and unlawfully on the basis of favoritism and nepotism, hence, granting promotion to other juniors/ colleagues whereas ignored the present appellant despite most senior one and fulfilling the requisite terms conditions and criteria for the said promotion and





hence, liable to be reversed and set aside. The respondents have also overlooked the FR-17 which is reproduced herein below;-

"provided that the (appointing Authority) may, if satisfied that a civil servant who was entitled to be promoted from a particular date was, for no fault of his own, wronafully prevented from rendering service to the Federation in the high post, direct that such civil servant shall be paid the arrears of pay and allowance of such high post through pro forma promotion or up-gradation arising from the antedated fixation of his seniority".

I- That appellant seeks permission to advance other grounds and proofs at the time of hearing.

PRAY.ERS

It is therefore, most humbly prayed that on acceptance of this appeal, the impugned office order dated 17/02/2022 may graciously be set aside, declared illegal and without lawfu authority and the appellant may kindly be granted promotion / confirmation in their ranks at, par as was granted to the above said colleagues from the back and due date along-with all back benefits, arrears, and consequential relief etc.

It is further added that the appellant may also be granted antidated seniority and directed the respondent to issue revise seniority list wherein the appellant was placed after Noor Rehman and above Zafar Ali / respondent No. 03 in the interest of justice.

ORDER

This office order will dispose off departmental appeal of ASI Mohammad Sher who was awarded the punishment of time scale for a period of 03 years under RSO by SSP (Ops) Peshawar vide OB No.710 dated 24/2/2011.

The allegations levelled against him were that he while posted as Moharrar ASI at PS Kotwali called complainant Amjad Ali to PS and threatened him not to contract marriage with Mst: Robama. Besides, the appellant also developed illicit relation with mother-in-law of Amjad Ali (compit:). He illegally and unlawfully raided the house of Amjad Ali on the day of Walima and misused his official Authority.

After departmental proceedings and Issuance of SCN he was awarded the above punishment.

Being aggrieved with the order passed by SSP/Ops, he preferred departmental appeal and denied the allegations. The appellant stated in his appeal that a complaint was made in PS Kotwali by Chand Bibi mother of Mst: Rubama against Amjad Ali that for kidnapping of her daughter along with cash and ornaments. The complaint was marked to SI Muhammad Ilyas on 13.10.10 for inquiry and after conducting inquiry a case was registered against Amjad All vide FIR No. 495 u/s 379/109 and he was also arrested.

He was called in O.R. on 6/3/2011 and heard him in person. The relevant record was perused. The appellant has 23 years long service at his credit with no major/minor punishment. The punishment awarded to him is harsh and there is heavy financial loss on monthly pay due to which his family is badly

In view of the position explained above, the punishment order passed by SSP-Ops: is hereby set-aside.
