SERVICE APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA 1974 SERVICE TRIBUNAL ACT, AGAINST THE ORDER ENDST: NO. 6578-6703/PROMOTION/PSHT/2021-2022 DATED 13-04-2022 WHEREBY THE APPELLANT WAS PROMOTED AND SUBSEQUENTLY POSTED AT GPS BELA KARIN AGAINST THE CLEAR POLICY OF THE GOVERNMENT. FEELING AGGRIEVED FROM THESAME TOTHE **EXTENT** OF *ADJUSTMENT* THE APPELLANT **PREFERRED** DEPARTMENTAL. APPEAL, BUT THE SAME WAS NOT

RESPONDED TO DESPITE THE LAPSE OF STATUTORY PERIOD OF TIME.

PRAYER:

That on acceptance of this appeal the order impugned may very kindly be modified to the extent of posting / adjustment of the Appellant from GPS Beal Karin to his own Union Council i.e. UC Shalpin as per the policy of the department.

Respectfully Sheweth:

Facts:

- i. That the appellant joined the education department as PST and has regularly been performing his duties to the satisfaction of the authorities, as result the Appellant got promoted to the post of PSHT.
- ii. That the Appellant was performing his duties as SPST (Senior Primary School Teacher) at GPS Faqira.
- iii. That vide order Endst: No. 6578-6703/Promotion/PSHT/2021-2022 dated 13-04-2022 the Appellant got promoted to the post of PSHT (Primary School Head Teacher) BPS-15. Copy of the order dated 13-04-2022 is enclosed as Annexure "A".
- iv. That strange enough the Appellant was posted at GPS Bela Karin, outside the Union Council to which the Appellant belongs i.e. UC Shalpin.

- That as per the policy of the Provincial Government a teacher whose post is available in his own union Council so he will be adjusted / posted on the same, whereas in case of the Appellant the same has been ignored. Copy of the Policy is enclosed as Annexure "B".
- vi. That feeling aggrieved the Appellant preferred a departmental appeal for the redressal of his grievance, but the same was not responded to despite the lapse of statutory period of time.

 Copy of the Departmental Appeal is enclosed as Annexure "C".
- vii. That feeling aggrieved and having no other option this Honourable Tribunal is approached for the redressal of the grievance on the following grounds.

Grounds:

- a. That treatment in accordance with the law is the vested right of the Appellant, but the same has been denied to the Appellant bald of reasons. The Respondent Department has itself devised a policy and now has bulldozed the same in case of the Appellant, thus the Appellant has not been treated in accordance with the law.
- b. That Appellant has been made to suffer to his utter detriment only to please the blue eyed and under

political influence in utter negation of the law and rules on the subject.

c. That the Appellant has been discriminated to his utter detriment. Moreover the Appellant had legitimate expectations to be posted in his own UC as per the policy, but alas the same denied to the Appellant.

It is, therefore, very respectfully prayed that on acceptance of this appeal the order impugned may very kindly be modified to the extent that the Appellant be ordered to be adjusted at his own union council as per the policy of the department.

Any other relief deemed appropriate in the circumstances and not specifically prayed for may also very kindly be granted.




