**SERVICE APPEAL UNDER SECTION-4 OF KPK SERVICE TRIBUNAL
ACT 1974 AGAINST NON-FIXATION OF APPELLANT'S SENIORITY
WITH HIS COLLEAGUES/BATCH-MATES AND NON-GRANT OF
PROMOTION AS HEAD CONSTABLE SINCE WHEN HIS JUNIORS WERE
PROMOTED.**

**PRAYER: ON ACCEPTANCE OF INSTANT SERVICE APPEAL
RESPONDENTS MAY GRACIOUSLY BE DIRECTED TO FIX APPELLANT'S
SENIORITY WITH HIS COLLEAGUES/BATCH MATES AND PROMOTE
HIM AS HEAD CONSTABLE WHEN HIS JUNIORS WERE PROMOTED
WITH GRANT ALL CONSEQUENTIAL SERVICE BACK BENEFITS.**

Respectfully Sheweth:

1. That appellant was enlisted as Constable in the District
police Haripur on 18-02-2002 thus have rendered more
than 18 years service.

2. That after passing A-1 and B-1 Departmental
Examinations, appellant was deputed for Lower Class
Course at Police Training College Hungu for the term
ending 20-09-2012.

3. That appellant was expelled from the course by the then Commandant Police Training College Hungu vide his order dated 05-09-2012 and was also not allowed to appear in the examination.
4. That aggrieved of above order, the appellant preferred an appeal before the then Honourable Inspector General Police, KPK, Peshawar while accepting his departmental appeal vide order dated 25-06-2013 the Commandant PTC Hungu was directed to allow appellant to appear in forth Coming Examination. **(Copy of IGP's order 25-06-2013 is attached annex-"A")**.
5. That though appellant was allowed to appear in the examination yet the Commandant being biased declared him failed in a paper which subject appellant had taught the trainees for 03 years as an INSTRUCTOR at PTC. Hungu. However, no sooner Commandant was transferred from PTC Hungu in 2014, than appellant was declared passed by successor Commandant in the paper. **(Copy of certificate attached as Annex- "B"). 30-7-14**
6. That because of this the appellant has been made junior to his juniors in the seniority list-C. Appellants juniors have been promoted as Head Constable. As a token of proof, Notification of List B-1 where in his name stands at Serial No.1, while the others at S/No.2 to 12 have been promoted. Promotion orders of FC Mohammad Afzal and LFC Robina Bibi are also attached.**(Copies of the list B-1, ~~07~~4-2012 and orders dated 31-7-17 and 31-8-17 are attached as Annex-"C-1/2 & 3")**.

7. That appellant filed a service appeal before this Honorable Service Tribunal KPK Peshawar on 15-04-2016 seeking seniority in list-C. This Honorable Tribunal in para-7 of its judgment dated 19-08-2019 has opined as under that:

"In the judgment of Punjab Service Lahore relied upon by the learned counsel for the appellant, it has been held that seniority has to be determined on the basis of length of service and not from the date of passing examination and that passing of examination only makes a civil servant eligible for promotion. It was also held in the said judgment that if more than one person have passed required examination on different dates and are considered ultimately eligible for promotion they will have to be allowed seniority in accordance with their length of service or order of merit if they were recruited directly". It is has been further held in the last para of judgment "Needless to mention that the seniority position of the appellant vis-à-vis has other colleagues in List-C shall be determined on the basis of criteria of length of service". (Copy of Judgment is attached as "D"). 19-8-19

8. That in the light of aforementioned judgment dated 19-08-2019, the appellant submitted an application dated 02-12-2019 to the District Police Officer Haripur for fixation of his seniority with his colleagues and his promotion as Head Constable when his juniors were promoted. But the said application of the appellant despite of his repeated requests was not decided/replied by the District Police Officer Haripur. **(Copy of application dated 02-12-2019 attached Annexure as "E").**
9. That appellant aggrieved of the act of the District Police Officer Haripur preferred a departmental appeal dated 30-06-2020 before the Regional Police Officer, Hazara Region, Abbottabad which was also not decided or replied within statutory period of 90 days. Appellant is running from pillar to post for his legitimate

right but of no avail. Appellant's case is one of hardships case. **(Copy of departmental appeal dated 30-06-2020 attached as Annexure- "F")**. Hence instant service appeal, inter alia, on the following:-

GROUND:

- a) That act of the respondents is illegal, unlawful against the facts, departmental rules and regulations and principle of natural justice as they never responded appellant's requests and appeals.
- b) That appellant's eligibility for seniority and promotion as Head Constable is not being considered despite the facts the he fulfills all terms and conditions according to law and departmental rules regulation governing his service.
- c) That respondents have not treated the appellant in accordance with law, departmental rules & regulations and policy on the subject and have acted in violation of Article-4 of constitution of Islamic Republic of Pakistan 1973 and deferring appellant's seniority and promotion which is unjust, unfair hence not sustainable in the eyes of law.
- d) That appellate authority has also failed to abide by the law and even did not take into consideration the grounds taken by appellant in the memo of appeal and has filed the appeal. Thus act of respondent is contrary to the law as laid down in the KPK Police Rules 1934 read with section

5

24-A of General Clause Act 1897 and Article 10-A of the Constitution of Islamic Republic of Pakistan 1973.

- e) That appellant has always discharged his assigned duties with devotion, dedication and honesty to the entire satisfaction of his superiors and never provided them with a chance of reprimand and has meritorious service record. He has been granted commendation certificates and cash reward for his tremendous services by police High-ups.
- f) That appellant deserves to be considered for seniority and his promotion as Head Constable as his far juniors have been promoted ignoring the appellant without any reason and justification in serious violation of law, department rules and regulations. Appellant has been seriously discriminated.
- g) That since long appellant has been running from pillar to post for his legitimate right of seniority and promotion but no heed is given to his legitimate right despite order dated 19-08-2019 of this Honourable to consider the appellant for promotion according to seniority.
- h) That instant appeal is well within time and this honorable Service Tribunal has got every jurisdiction to entertain and adjudication upon the same.

PRAYER:

It is, therefore, humbly prayed that on acceptance of instant Service Appeal respondents may graciously be directed to fix appellant's seniority with his colleagues/batch-mates and promote him as Head Constable when his juniors were promoted with grant of all consequential service back benefits. Any other relief which this Honorable Service Tribunal deems fit and proper in circumstances of the case may also be granted.

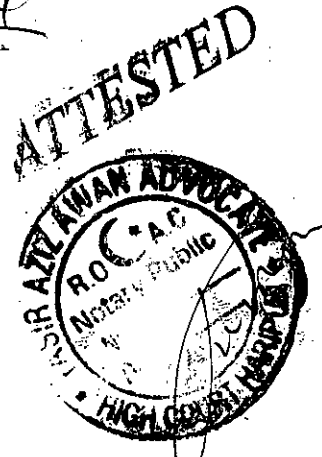

ORDER

The District Police Officer Haripur forwarded an application of constable Muhammad Yousaf No.258 on deputation to Police Training College Hangu, wherein the said constable prayed for:-

- i. Cancellation of °Cominandant PTC Hangu order No.599/EC dated 04.09.2013.
- ii. Restoration of Lower Course.
- iii. Release of Pay.

Record was summoned and perused. It revealed that constable Muhammad Yousaf No.258 of district police Haripur was transferred to PTC Hangu. Later-on, he was reverted to his parent district for unfounded complaint. Subsequently his salary was stopped and he was awarded a harsh punishment. His absence period was treated as leave without pay by the Commandant PTC Hangu, while two years forfeiture of approved service by the DPO Haripur on the grounds of absence.

After going through all facts and figure, it was found that action against Constable Muhammad Yousaf No.258 was not based on facts. For sake of justice, appeal of Constable Muhammad Yousaf No.258 is hereby accepted. He is allowed to appear in the forth coming examination of Lower College Course and also his salary be released without any further delay. The punishment awarded to the constable of leave without pay by Commandant PTC and forfeiture of approved service by DPO Haripur is also set aside.

The appellant has filed the present service appeal against the order dated 16.02.2016 whereby his departmental appeal was decided in terms that he was not found entitled for seniority in List-"C" from Lower College Course for the term ending 20.09.2012 rather he was allowed seniority for the term ending 31.07.2014.

3. Learned counsel for the appellant argued that the appellant was deputed for Lower College Course at Hangu for the term ending 20.09.2012 however he was illegally expelled from the course by the





Commandant Police Training College Hangu vide order dated 05.09.2012; that the application of the appellant to the Provincial Police Officer was accepted vide order dated 25.06.2013 and the punishment awarded to the appellant was not only set aside but he was also allowed to appear in the forth coming examination of Lower College Course; that the appellant appeared in the Lower College Course Examination in the year 2013 but was declared failed due to the biasness of Commandant PTC Hangu; that no sooner the said Commandant was transferred from PTC Hangu, the appellant appeared in the Lower College Course Exam in the year 2014 at PTC Hangu and was declared passed vide Notification dated 28.08.2014. Learned counsel for the appellant while relying upon the judgment of Punjab Service Tribunal Lahore reported in PLJ 2006 Tr.C. (Services) 254 argued that since the appellant was prevented from appearance in the examination of Lower College Course held in 2012 without any of his fault and has also passed the said examination subsequently in the year 2014 hence he is entitled to be granted seniority in List-"C" from the Lower College Course for the term ending 20.09.2012.

4. As against that learned Deputy District Attorney argued that the appellant committed several misconducts and was also awarded punishments; that the appellant was selected for Lower College Course on 09.04.2012 but during the course he committed misconduct by harassing Lady Constable and that the appellant also absented himself from PTC Hangu on 05.09.2012 hence the appellant was rightly expelled from the course in the year 2012. Further argued that the appellant passed the Lower College Course in the year 2014 hence the seniority of the appellant was rightly reckoned from 30.07.2014 when he qualified the

Lower College Course.

5. Arguments heard. File perused.

6. Through the present service appeal, the appellant seeks his seniority in List-"C" from the Lower College Course for the term ending 20.09.2012 from which course he was expelled. The appellant ultimately qualified Lower College Course for the term ending 30.07.2014.

7. In the judgment of the Punjab Service Tribunal Lahore relied upon by the learned counsel for the appellant, it has been held that seniority has to be determined on the basis of length of service and not from the date of passing of examination and that passing of examination only makes a civil servant eligible for promotion. It was also held in the said judgment that if more than one person have passed required examination on different dates and are considered ultimately eligible for promotion they will have to be allowed seniority in accordance with their length of service or order of merit if they were recruited directly.

8. In view of the above mentioned legal proposition, the appellant has not been able to demonstrate that his seniority should be counted from the Lower College Course for the term ending 20.09.2012. Consequently, the present service appeal is dismissed. Needless to mention that the seniority position of the appellant vis-à-vis his other colleagues in List-"C" shall be determined on the basis of criteria of length of service. Parties are left to bear their own costs. File be consigned to the record room.

As a token of proof, appellant has attached herewith Notification of List B-1 where in his name stands at Serial No. 2, while the others at S/No. 3 to 12 have been promoted as Head Constable. **(Copy of the list B-1 is attached as "C")**.

7. That appellant filed an appeal before the Honorable Service Tribunal KPK Peshawar on 15-04-2016 seeking seniority in list-C. The H/able Tribunal in para-7 in its judgment dated 19-08-2019 has opined as under that:

Respectfully Sheweth.

PRELIMINARY OBJECTIONS:-

1. That the instant Service Appeal is not maintainable in the present form.
2. That the appellant is estopped by his own conduct.
3. That the appellant has not come to the Honorable Tribunal with clean hands.
4. That the appellant has suppressed material facts from the Honorable Tribunal.
5. That the instant Service Appeal is bad for mis-joinder and non-joinder of necessary and proper parties.
6. That the instant Service Appeal is badly barred by law and limitation.
7. That the appellant has filed the instant service appeal just to pressurize the respondents.
8. That the order passed by the authorities are based on facts & rules, after fulfilling all the codal formalities, hence, the appeal is liable to be dismissed without any further proceeding.
9. The matter has already been adjudicated by this honorable Tribunal in service appeal No.402/2016 filed by the appellant on the same ground decided on 19.08.2019. Therefore, the matter being Res Judicata cannot be agitated in the instant service appeal once again.

OBJECTIONS ON FACTS:-

1. Correct to the extent that the appellant was enlisted in police department on 18.02.2002, as constable.
2. In reply to this para, it is submitted that the name of appellant was brought on list B-1, having qualified B-1 examination for the year 2012, vide notification No.4428 dated 07.04.2012. (Copy of notification is attached as annexure "A"). Consequently, he was deputed for lower school course at Police Training College, Hangu for the term commencing on 10.04.2012 and which was to end on 20.09.2012. During the lower school course at Police Training College, Hangu the appellant was complained against by a lady constable namely Sadia Mehboob No.696 (Copy of application is attached as annexure "B"). After inquiry, the commandant Police Training

College, Hangu returned the appellant to the home district as unqualified vide notification No.2631/S/RESULT dated 28.11.2012. (Copy of notification is attached as annexure "C"). Later on the appellant qualified lower school course with the term qualifying on 31.07.2014 vide commandant Police Training College, Hangu notification No.1523/S/RESULT dated 28.08.2014. (Copy of notification is attached as annexure "D").

3. Brief facts of the appellant case are that the appellant while undergoing lower school course at Police Training College, Hangu was complained against by a trainee lady constable Sadia Mehboob No.696 at Police Training College, Hangu for harassing her, the matter was probed by the commandant Police Training College, Hangu through inquiry officer. Beside this, the appellant was also on deputation at Police Training College, Hangu as instructor, when he was complained against by the above mentioned lady trainee constable, the appellant left Police Training College, Hangu on 05.09.2012, without prior leave or permission from the competent authority.

The matter was referred by the commandant Police Training College, Hangu to the District Police Officer, Haripur for initiation of departmental action against the appellant vide commandant Police Training College, Hangu letter No.599/EC dated 05.09.2012. (Copy of letter is attached as annexure "E"). Consequently, proper departmental inquiry was conducted the appellant was issued charge sheet with statement of allegations by the then District Police Officer, Haripur vide his office Endst No.1393-95/PA dated 08.10.2012. (Copy of charge sheet / statement of allegations are attached as annexure "F"). Deputy Superintendent of Police, Hqrs Haripur, was appointed as inquiry officer, who conducted proper departmental inquiry and submitted his findings vide his office Memo No.208 dated 13.11.2012. (Copy of inquiry is attached as annexure "G"). Therefore, the appellant was awarded minor punishment of warning by the then District Police Officer, Haripur vide OB.No.738 dated 07.12.2012. (Copy of order is attached as annexure "H"). Moreover, commandant Police Training College, Hangu vide letter No.15/EC dated 09.01.2013 recommended the appellant for major punishment on basis of preliminary inquiry conducted by him at Police Training College, Hangu, Consequently the appellant was issued final show cause notice by the then District Police Officer, Haripur vide office memo No.925/PA dated 08.05.2013. (Copy of final show cause is attached as annexure "I"). Therefore, being found guilty of gross misconduct, the appellant was awarded minor punishment of forfeiture of 02 years approved service by the then District Police Officer, Haripur vide OB.No.208 dated 30.05.2013. (Copy of order is attached as annexure "J"). The appellant filed a departmental appeal against the punishment before the Provincial Police Officer Khyber Pakhtunkhwa, Peshawar. The Provincial Police Officer Khyber Pakhtunkhwa, Peshawar vide order Endst No.15156-59/E-II dated 25.06.2013 accepted the departmental appeal of the appellant and he was allowed to appear in the forth coming examination of lower school course. (Copy of order is attached as annexure "K"). Hence, the

appellant re-appeared in the lower school course examination on 20.03.2013 and the appellant failed in several subjects, he appear again in the lower school course examination and qualified the same with the term ending 20.03.2014.

4. As stated above.

5. Incorrect, the appellant appeared in lower school course examination with the term 20.03.2013 in which he failed in several subjects i.e. PPC, LSL/QS, PR, MJ, FPT, PPWP, PPWT, Ist, PFW, FCT, AC. (Copy of result notification No.2472/S/RESULT PTC Hangu is attached as annexure "L"). The appellant once again appeared in examination of lower school course and qualified lower school course examination with the term qualifying on 31.07.2014. The appellant is adducing false stories for undue advantages.

6. Incorrect, the appellant had committed gross misconduct during the lower school course at Police Training College, Hangu. He left Police Training College, Hangu without prior permission from the competent authority. Being member of discipline force, his conduct should be exemplary and up to the mark. However, the appellant was complained against for harassing a trainee lady constable at Police Training College, Hangu. Therefore, the allegations were probed and appellant was held guilty of misconduct and he was also awarded appropriate punishments by the competent authority. It is pertinent to mention that the appellant name was brought list B-1 under notification No. 4428 dated 07.04.2012. However, he qualified lower school course with the term ending on 31.07.2014. Unless a candidate does not qualify lower school course, his name cannot be brought on list C as per police Rules 1934 chapter 13 Rule 13-8.

The appellant passed/qualified lower school course with the term 31.07.2014, therefore, his seniority shall commence with the candidates who qualified the lower school course with the term 31.07.2014 and not the term in which the appellant was firstly sent for the lower school course with the ending term 20.09.2012.

The appellant could not qualify/pass the lower school course until with the term qualifying on 31.07.2014. Therefore, the appellant cannot claim for the seniority with the officials who were brought on list B-1 in year 2012 with the appellant.

Moreover, lady constable Robina No.523 qualified lower school course on 20.09.2012 and Muhammad Afzal No.555 qualified lower school course on 20.03.2013. Therefore, LFC Robina No.523 was promoted as officiating Head Constable by the District Police Officer, Haripur vide order Endst No.4280-82 dated 31.07.2017 and Muhammad Afzal No.555 was promoted as officiating Head Constable by the District Police Officer, Haripur vide order Endst No.4761-63/OASI dated 31.08.2017.

The appellant did not qualify/pass the examination of lower school course with the term ending on 20.09.2012 so, he was junior to the officials mentioned above and others, who qualified/passed lower school course before the appellant. The seniority for list C-1 of the appellant shall commence with lower school course qualifying term 31.07.2014 and not earlier, as his status was of failed candidate. The claim of appellant for back

date seniority in which he had not qualified/passed the examination of lower school course is devoid of any legal force.

- 7. Correct to the extent that the appellant filed service appeal No.402/2016 before the honorable Khyber Pakhtunkhwa, Service Tribunal, which was dismissed by this honorable tribunal. It is of worth mentioning that the appellant is misinterpreting the judgment. This honorable tribunal has not given the relief claimed by the appellant.

The appellant qualified/passed lower school course on 31.07.2014, therefore, his seniority shall take effect from the date of his qualifying lower school course. So long a person does not qualify requisite mandatory examination/training he cannot claim incentive of any course/training. A failed/unqualified candidate cannot be granted benefit of course/training under the law/rules. Police Rules 1934 chapter 13-8 is quite clear, which states that **“In each district a list shall be maintained in card index form {Form 13-8(I)} of all constable who have passed the lower school course at Phillaur and are considered eligible for promotion to head constable”**. Similarly, chapter 13 Rule 8 (2) states that **“promotions to head constable shall be made in accordance with the principle described them sub rule 13-1(1) and (2). The date of admission to list C shall not be material, but the order of merit in which examinations have been passed shall be taken into consideration in comparing qualifications”**. In the instant rules it has been held mandatory the passing of lower school course for promotion to head constable, provided seniority of candidates to the rank of head constable shall be considered as per merit in the examination in which the candidate passed/qualified the lower school course.

Therefore, the appellant is not entitled for the seniority as claimed by him on basis of admission of his name in list B-1 with other officials. He failed/unqualified in lower school course until 31.07.2014. The appellant shall be considered for the rank of officiating head constable subject to the fulfillment of all legal requirements and on his own turn when he qualified/passed lower school course with the term qualifying on 31.07.2014.

Moreover, this honorable Tribunal has dismissed the service appeal of the appellant. Similarly, the above mentioned rules are quite clear, the seniority of the appellant is with his colleagues, who passed/qualified lower school course with the term qualifying on 31.07.2014, and not the term when the appellant was sent for lower school course. So long the appellant did not pass/qualify the lower school course, he is not entitled for back date seniority, as it is against the law, rules and judgment of this honorable Tribunal.

- 8. Incorrect, the appellant is taking unjustified stance. He is cheating the authorities and wants to get undue advantage. He was not eligible for the rank of officiating head constables with other officials, as he passed/qualified lower school course not in year 2012 but with the qualifying term on 31.07.2014. His seniority shall take effect with the term when he qualified/passed lower school course from 31.07.2014. The claim of appellant for grant of seniority for lower school course for the period in which remained failed/ unqualified is against the law/rules.

9. Incorrect, the appellant is not entitled for the relief/seniority claimed by him, as it is against the law/rules. The instant service appeal is not maintainable under the law as the appellant has no locus Standi to file the instant service appeal. Moreover, service appeal No.402/2016 with the same grounds was also dismissed by this honorable Tribunal on 19.08.2019.


- a. Incorrect, the respondents have acted in accordance with law, rules and principles of natural justice. The appellant is adducing concocted stories to gain undue advantages.
- b. Incorrect, the appellant is not entitled for promotion to the rank of officiating head constable, as he will be considered for the said rank on his own turn subject to fulfillment of all legal requirements. The claim of appellant is premature at this stage as he qualified lower school course on 31.07.2014 and not before. Therefore, any back date seniority claimed by the appellant for the period in which he remained failed/unqualified is against the law/rules and principles of natural justice.
- c. Incorrect, the respondents have treated the appellant strictly in accordance with law, rules and principles of natural justice. He is seeking relief for which he is not entitled under the law/rules.
- d. Incorrect, as stated in preceding paras.
- e. Incorrect, the appellant does not possess meritorious service record, he was awarded several punishments during his past service:-
 - 1) 04 days leave without pay vide OB.No.69 dated 05.03.2003.
 - 2) Censure and fine Rs.150/- vide OB.No.261 dated 06.08.2005.
 - 3) Fine Rs.150/- with warning vide OB.No.227 dated 19.06.2006.
 - 4) 06 days leave without pay vide OB.No.393 dated 04.05.2012.
 - 5) 01 day leave without pay vide OB.No.248 dated 04.07.2006.
 - 6) Forfeiture of 01 year annual increments vide OB.No.417 dated 12.12.2006.
 - 7) Reversions to lowest pay scale in his rank vide OB.No. 86 dated 12.04.2007.
 - 8) Quarter guard for 03 days vide OB.No.416 dated 24.06.2009.
 - 9) Period of absence with effect from 34.09.2012 to 12.03.2013 treated as leave without pay vide OB.No.350 dated 27.04.2013.
 - 10) Forfeiture of 02 years approved service vide OB.No.208 dated 30.05.2013.
 - 11) Censure vide OB.No.261 dated 22.08.2013.
 - 12) Warning vide OB.No.262 dated 23.08.2013.
 - 13) Warning vide OB.No.212 dated 06.06.2013.
 - 14) Censure vide OB.No.492 dated 16.09.2015.
 - 15) Forfeiture of approved service for 02 years vide OB.No.494 dated 16.09.2015. (The punishment was converted into minor punishment of stoppage of 02 years increments without cumulative effect, which was set aside by honorable Khyber Pakhtunkhwa, Service Tribunal on 21.08.2017).
 - 16) Stoppage of increments for 02 years vide the Regional Police Officer, Hazara Region, Abbottabad order No.1240/PA, dated 29.02.2016.
 - 17) Reversion in rank from LHC to FC OB.No.182 dated 16.03.2018. (The punishment was set aside and he was censure vide OB.No.596 dated 18.10.2019.





- f. Incorrect, the appellant is cheating the authorities. He was failed candidate of lower school course until 31.07.2014. The constables who were promoted to the rank of officiating head constable had qualified/passed lower school course before the appellant, therefore, the appellant is not senior to them. Rather, the seniority of appellant with other colleagues shall take effect with the term he qualified/passed lower school course on 31.07.2014 and not before this.
- g. Incorrect, the appellant is producing false claims. He is not entitled for the seniority to the rank of officiating head constable, who qualified/passed lower school course before the appellant. Moreover, this honorable tribunal has also dismissed the service appeal No.402/2016 of appellant, and its judgment has become Resjudicata. If, the appellant felt himself aggrieved with the cited judgment in service appeal No.402/2016 he ought to have avail the remedy of appeal before the apex court. Hence, the instant service appeal is devoid of any legal force.
- h. Incorrect, the instant service appeal is not maintainable under the law.

PRAYER:-

In view of above stated facts it is most humbly prayed that the instant service appeal with prayer does not hold any legal force, may kindly be dismissed with costs, please.




The reply to application for condonation of delay of service appeal on behalf of respondents No. 1,2 & 3, is submitted as under:-


1. Incorrect, the appellant/applicant is not eligible for promotion to the rank of officiating head constable, as the appellant qualified/ passed lower school course on 31.07.2014. Therefore, the claim of appellant for back date seniority is not maintainable under the law. The same matter has already been adjudicated by this honorable tribunal while dismissing service appeal No.402/2016 of the appellant. Therefore, the issue being decided by the competent forum i.e. this honorable tribunal has become Resjudicata cannot be agitated again and again.
2. Incorrect, the appellant/applicant qualified lower school course with the term 31.07.2014, therefore, any claim for back date seniority i.e. when the appellant joined the lower school course on 10.04.2012. During the course the appellant/applicant committed misconduct and he was expelled from Police Training College, Hangu as unqualified. Later on in year 2014 he qualified/passed lower school course on 31.07.2014. Therefore, the seniority in list C-1 of the appellant shall start when he qualified/passed mandatory lower school course and not earlier. The appellant/applicant has no case of action to file the instant service appeal/application.
3. Incorrect, the appellant's claim is illegal, without any justification. The appellant wants to cheat the authorities on different pretexts to get the advantages not warranted under the law. His seniority for officiating head constable shall start with the colleagues when he qualified the mandatory lower school course on 31.07.2014 and not earlier from this date. The claim of appellant/applicant for giving seniority when he was deputed for lower school course on 10.04.2012 is against the facts, rules and law. He failed in lower school course, and qualified the said course on 31.07.2014, so, his seniority for the rank of officiating head constable shall be calculated from 31.07.2014 subject to the fulfillment of other legal requirements for the said rank.

On the written complaint of Lady Constable Badia Mehtab, a preliminary enquiry was ordered and on finding the result positive the case was referred to you alongwith a detailed report on his general conduct vide this office Memo No. 899/EC dated 05.09.2012.

Keeping in view, the serious nature of the complaint he was expelled from the Lower School Course till the decision of the case by you. Now he, on finding guilty, has been punished by you vide Memo No. 8383/SRC dated 21/12/2012.

As a reaction to my decision, he became absent with effect from 04.09.2012 and has not reported back as yet.

To cover his misdeed, he launched a propaganda campaign against certain staff members of PTC to malign them.

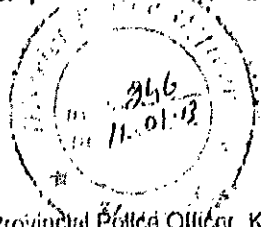
In the meantime one copy of his application (which was addressed to a number of High ups in K.P.K) was received from the office of Provincial Police Officer. It was marked to Inspector Nazar Hussain for enquiry which he did not join.

He was charge sheeted by the undersigned (full case enclosed) and Inspector Ghulam Sadiq was appointed enquiry officer. Charge sheet etc and later Final Show Cause Notice was served on him through SHO Khan Pur District Haripur on 25.10.2012 and 30.11.2012, but he did not bother to clarify his position.

The latest development was that he appeared before you and wanted to join at Haripur without transfer or being relieved from PTC. In this application he also mentioned that he has filed a petition in Peshawar High Court at Abbottabad against us ----- what a level of discipline!

On the other hand, his service record stands as testimony that misconduct in his way of life.

In the light of the above and with references to the enclosed departmental proceeding consequent of which he has been found guilty, I recommend the imposition of major punishment to purge the department from a black sheep of unmatched stature.



- ii. Restoration of Lower Course.
- iii. Release of Pay.

Record was summoned and perused. It revealed that constable Muhammad Yousaf No.258 of district police Haripur was transferred to PTC Hangu. Later-on, he was reverted to his parent district for unfounded complaint. Subsequently his salary was stopped and he was awarded a harsh punishment. His absence period was treated as leave without pay by the Commandant PTC Hangu, while two years forfeiture of approved service by the DPO Haripur on the grounds of absence.

After going through all facts and figure, it was found that action against Constable Muhammad Yousaf No.258 was not based on facts. For sake of justice, appeal of Constable Muhammad Yousaf No.258 is hereby accepted. He is allowed to appear in the forth coming examination of Lower College Course and also his salary be released without any further delay. The punishment awarded to the constable of leave without pay by Commandant PTC and forfeiture of approved service by DPO Haripur is also set aside.

This order is hereby passed to dispose off departmental appeal under Rule 11-A of Khyber Pakhtunkhwa Police Rules 1975 submitted by *Constable Muhammad Yousaf No: 598* Haripur District against the order of punishment i.e. *Reversion in rank from LHC(C-I) to Constable* awarded to him by the DPO Hariur vide OB No: 182, dated 16.03.2018.

Facts leading to punishment awarded to him are that he while posted as I/C Guard Lower Court, the DPO Haripur noticed the following indisciplined activities which has been conducted by him:-

1. He uploaded a baseless objectionable post leveling false and frivolous complaints against senior officer.

3. He also moved an application to the DPO with some allegations which could not be proved and substantiated.

After receiving his appeal, comments of DPO were obtained, which were perused. The undersigned called appellant in O.R on 09.05.2018 and heard in person where he failed to explain any plausible reason in his defence. Therefore the punishment awarded to him by DPO Haripur i.e. *Reversion in rank from LHC (C-I) to Constable* seems to be genuine, hence his appeal is *filed*.

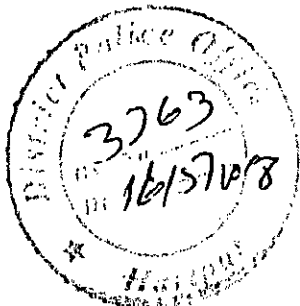

ORDER

This is an order on the representation of *LHC Muhammad Yousaf No.598* of Haripur District against the order of minor punishment i.e. *forfeiture of 2 years approved service* awarded by the District Police Officer, Haripur vide his OB No.496 dated 16-9-2015.

Facts leading to his punishment are that he while posted as Incharge Lower Court Guard, Haripur, Constable Zahid No.36 & Constable Riaz Khan No.176 also performing duty on given guard, one Muhammad Awais s/o Niaz Muhammad r/o Andra Doga Tehsil & District, Haripur submitted written application before the undersigned that on 3-3-2015, that he entered in the court & deposit the 30 bore pistol along-with arms license, with the deployed Guard. After coming back from the court, he demanded the same but the accused officials denied to return his pistol along-with license.

Proper departmental enquiry was conducted by Mr. Aziz Khan DSP Investigation Haripur. After conducting a detailed enquiry, the E.O proved him guilty. On the recommendation of E.O, the District Police Officer Haripur awarded him minor punishment of forfeiture of 2 years approved service.

After receiving the appeal, the comments of DPO Haripur were obtained. The enquiry file, appeal & the comments of the DPO were perused. The appellant was also heard in person in the orderly room. The allegation leveled by the accused has not been substantiated.

However the punishment awarded to him i.e. forfeiture of 2 years approved service by DPO Haripur is too harsh, therefore due to extenuate circumstances I take lenient view and convert the punishment awarded by DPO Haripur into minor punishment of *"stoppage of 2 years increment without cumulative effect"* and also reprimanded with a warning to be careful in future.
