JUDGMENT

ATIQ-UR-REHMAN WAZIR MEMBER (E):- Brief facts of the case are that the appellant while serving as Deputy District Attorney (DDA) BPS-18 was transferred from Peshawar against the post of DDA Kurram in his Own Pay & Scale vide order dated 15-10-2021. Feeling aggrieved, the appellant filed departmental appeal, which was not responded, hence the instant service appeal with prayers that the impugned order dated 15-10-2021 may be set aside and the respondents may be directed not to take any adverse action against the appellant.

02. Appellant has contended that the impugned transfer order is based on political pressures being exerted by respondent No. 3, hence is illegal and is liable to be set aside; that the impugned order is based on malafide, as one post of

DDA was already vacant in Peshawar, but respondent No. 3 was posted against the post of the appellant; that respondent No. 3 has recently been transferred from Peshawar to Kohat and was again re-transferred in the impugned transfer order; that the appellant has a genuine and compelling reason that his mother is seriously ill and lying on bed since long and no one is there to take care of him; that the impugned order has not been issued in public interest; that the appellant has been pre-maturely transferred in violation of posting/transfer policy of the provincial government; that the impugned transfer order is against the basic norms of natural justice, which is liable to be set aside; that the appellant has been posted against the post of DDA BPS-19 in his own pay & scale, which is violation of the august Supreme Court of Pakistan judgment reported as 2014 SCMR 1184.

03. Learned Additional Advocate General for the respondents has contended the appellant has been transferred in the interest of public service on administrative grounds, as there was a dire need of Law Officer in District Kurram, hence keeping in view exigency of service coupled with administrative needs, the appellant was posted in Kurram as District Attorney; that the appellant has been working in Peshawar since long against various posts in different times, hence his transfer outside Peshawar was not made on political considerations; that the transfer is in accordance with law, rules and posting/transfer policy of the provincial government; that under section 10 of the Civil Servants Act, 1973, a civil servant can be posted anywhere within province at the discretion of the competent authority.

04. We have heard both the parties and have perused the record.

05. The appellant having been aggrieved from his transfer made by impugned order submitted his departmental appeal to respondent No 1, which was not responded with in the statutory time period, hence the appellant filed the instant service appeal. We have observed that transfer of the appellant is pre-mature as

he has not completed his tenure against the post. Moreover we have also observed that transfer of the appellant and adjustment of respondent No. 3 against his post smacks malafide on part of the respondents as in presence of a vacant post, which was also requisitioned by District Attorney vide his letter dated 17-09-2021. The impugned order is shown to has been issued in the public interest but learned counsel for the respondents, when confronted with the question as to what public interest was involved in the impugned transfer order could not satisfy this Tribunal. Clause (i) of the posting/transfer policy states that all posting/transfers shall be made strictly in public interest and shall not be abused/misused to victimize the government servants. The situation as explained above shows that the impugned transfer order was not made in the public interest, rather was made to adjust respondent No 3. Contention of the appellant to the effect that his mother is seriously ill and nobody except him is available to take care of her also hold force and respondents were required to take a sympathetic view of the situation. The appellant agreed to the extent that he is not interested in that particular post, but he may be retained in Peshawar against any post for the sake of look after of his ailing mother.

06. In view of the foregoing discussion, the instant appeal is accepted as prayed for. Parties are left to bear their own costs. File be consigned to record room.

Counsel for the appellant present. Preliminary arguments have been heard. The Memorandum of Appeal alongwith copies of record annexed therewith have been perused.

The appellant having been aggrieved from his transfer made by impugned order submitted his departmental appeal to the next higher authority i.e. respondent No. 1 which so far has not been responded. Among other grounds in the departmental appeal, it has been submitted that the transfer of the appellant is premature as far as transfer/posting policy is concerned. Moreover, the transfer of the appellant is politically motivated when adjustment of other transferee in the impugned order has been made against the post of the appellant at Peshawar despite the fact that another post was vacant. If there was any dire need for transfer of Mr. Zubair Ahmad from Kohat to Peshawar, he could have been adjusted against vacant post; particularly according to the copy of the letter dated 17.09.2021 annexed with the appeal, the District Attorney made a request to the Director General Law and Human Rights Department Khyber Pakhtunkhwa, Peshawar for transfer of some law officers to the vacant posts. The impugned transfer order is shown to has been issued in the interest of public service but in view of attending circumstances as discussed before, the point of public interest is arguable. Let the respondents be heard in regular proceedings. This appeal is admitted for regular hearing. The appellant is directed to

deposit security and process fee within 10 days. Thereafter, notices be issued to the respondents for submission of written reply/comments in office within 10 days after receipt of notices, positively. If the written reply/comments are not submitted within the stipulated time, or extension of time is not sought through written application with sufficient cause, the office shall submit the file with a report of non-compliance. File to come up for arguments on 30.11.2021 before the D.B.

An application has been filed alongwith Memorandum of Appeal seeking suspension of the impugned order dated 15.10.2021. Notice of the application be also given to the respondents. The operation of impugned order is suspended till date fixed.

- 2. That the appellant preferred Departmental Appeal against the impugned order to worthy Chief Secretary (Respondent No. 1) but to no avail. Copy of the Departmental Appeal is attached as Annexure "**B**".
- 3. That the appellant feeling aggrieved from the above impugned order, the instant service appeal before this Hon'ble Tribunal, on the following grounds:

GROUNDS:

- A. That the petitioner has been transferred vide order dated 15.10.2021 from the post of Dy District Attorney Peshawar (BPS-18) to District Attorney Kurram (BPS-19) in his own pay scale.
- B. That the impugned order dated 15.10.2021 is totally based on political pressures / influence, hence liable to be set aside and recalled.
- C. That the impugned order is based on malafide intentions. In fact, one post of the Dy. District Attorney is already lying vacant in the office of District Attorney Peshawar but

despite of fact, the respondent NO. 3 has been placed on the appellant's post.

- D. That the respondent No. 3 has recently been transferred from Peshawar to District Attorney office Kohat 9 months ago.
- E. That the genuine problem of the appellant is that his mother is an old aged and lying on bed since 6 months in unconscious conditions and there is no one to lookafter her except the appellant.
- F. That the interest of public service has not been explained in the impugned order, hence the impugned order dated 15.10.2021 is liable to be set aside and recalled.
- G. That the petitioner has been prematurely transferred in violation of the posting and transfer policy of the provincial government.
- H. That the impugned transfer order is against the basic norms of justice which required to be set aside.
- I. That impugned order is the result of political manipulation.
- J. That the District Attorney Peshawar has already requested to the competent authority through letter No. Cor-3/DA/Pesh/564-65 dared 17.09.2021 to fulfill the vacant

post which is lying vacant form the last one year. (Copy of the letter is attached as Annexure "C").

- K. That the appellant has been posted against the post of District attorney BPS-19 in his own pay scale which is violation of the Supreme Court judgment reported in 2014 SCMR Page 1184 which amounts to contempt of Supreme Court judgment.
- L. That the order dated 15.10.2021 is illogical and based on surmises.
- M. That any other ground in respect of the instant appeal will be raised at the time of arguments with permission of the worthy Tribunal.

- 2. That the instant appeal is not maintainable in its present form.
- 3. That the present appeal is not maintainable due to non-joinder and mis-joinder of necessary parties.
- 4. That this Hon'ble Tribunal has got no jurisdiction to entertain the instant appeal.
- 5. That the appellant is estopped by his own conduct.
- 6. That the appeal of the appellant is badly time barred.

<u>On facts:</u>

- 1. Para-01 is correct. The appellant has been transferred in the interest of public service.
- 2. Para-01 is incorrect, hence, denied.
- 3. Incorrect, hence denied. In terms of Section-10 of Civil Servant Act, 1973, a civil servant may be posted anywhere in the Province. Therefore, the appeal is liable to be dismissed.

Grounds:

- A) Para-A is correct. The appellant has been transferred in the interest of public service.
- B) Incorrect, hence, denied. The appellant has been transferred in the interest of public service and on administrative ground. Bar Association of District Kurram has approached different administrative hierarchies for posting of a permanent law officer in the District. Keeping in view the exigency of services coupled with administrative needs the petitioner was posted in Kurram as District Attorney. The officer has been working in Peshawar for 10 years & 9 months on different posts in different years out of his 13 years service as such the transfer notification has not been issued under political pressure or influence.

- C) Incorrect, hence denied. Malafide intentions cannot be attributed to the Competent Authority. The transfer is in accordance with law, rules and posting/transfer policy of Provincial Government. The department is facing acute shortage of law officer; recruitment through Khyber Pakhtunkhwa Public Service Commission in pipeline, however, because of aforementioned administrative needs & exigency of services the petitioner was posted.
- D) Pertains to record.
- E) Incorrect. In terms of Section-10 of Civil Servant Act, 1973, a civil servant may be posted anywhere in the Province. Moreover, the petitioner has been serving in Peshawar for last 02 years & 9 months and complete his tenure according to transfer policy enclosed.
- F) Incorrect, hence denied. The department makes its own administrative arrangement time to time and in accordance with the Appointment, Promotion and Transfer Rules, 1989. Therefore, the transfer notification was issued in the interest of public service.
- G) Incorrect, hence denied. The Petitioner had been serving in Peshawar for 02 years & 9 months.
- H) Incorrect, hence denied. The impugned order was issued in accordance with law & rules.
- I) Incorrect, hence denied. The appellant has been transferred in the interest of public service and as such the transfer notification has not been issued under political manipulation.
- J) Pertains to record.
- K) Incorrect. The petitioner was transferred to District Kurram on purely administrative grounds. The Department is facing acute shortage of officer. Khyber Pakhtunkhwa Public Service Commission is processing pending requisition of this department. As a stop gap arrangements the department has given additional charge to different District Attorneys viz-a-viz numerous Law Officers are posted as District Attorneys in their own pays scales to overcome the shortage of officer and for smooth flow of official business.

- M) That the respondents also seek permission of this Honourable Tribunal to agitate further grounds at the time of arguments.
