

1. That, respondent NO.1, being Government Servant of the Province is vested within the authority of governance, administration, control, and other allied matters, and for the exercise of such authorities, the respondent NO.4 has effected the Legislation and in addition to such legislation, it has also further delegated its certain authority to the department to further exercise the making of rules and policies and the aim and purpose of all such is to provide, protect, the rights of the citizens and all concerns as well as smooth functioning of the governance and administration of the Government and its Department in the interest of public. ***(The KPK (Appointment, Deputation, Posting and transfer of teachers, lectures, instructors and doctors) Regulatory Act, 2011 is annexed as Annexure "A" while the department policy is annexed as Annexure***

"B" and SOR-I(S&GAD)1-1/85(Vol-I), dated 22.12.1999 is annexed as Annexure "C")

2. That, it is the Government's primary and basic duty to adhere with and to follow the law, as it is legislated and to follow the policies formulated and the same duty of the Government/respondent No.4 continues and extended as to check that the same laws and policies must be followed by the officers and Govt. servants of the department and in case if any violation of laws, rules and policies, the officers and Govt. servants be dealt for such violations in order to remove the apprehensions of anarchy, red tapism, nepotism, favoritism and mal-administration. The appellant, being Government servant as teacher in BPS-15 deserves to be treated as per law, rules and policies of the Department, but instead of that, has been made rolling stone and is being victimized for no fault, as the repeated transfer orders have been made against the rights of the appellant and the appellant each time submitted appeals, applications, but all in vain. Copies of transfer order dated 25.02.2013 is annexed as **Annexure "D"**, whereby the appellant was transferred from GPS No.1 Kutchery, Abbottabad to GPS Riala Bandi, transfer order dated 23.07.2013 from GPS Riala Bandi to GPS Chimiali is annexed

as *Annexure "E"*, and copy of transfer order dated 09.01.2014 from GPS Chimiali to GPS Drairr is annexed as *Annexure "F"*, copy of departmental representation through proper channel is annexed as *Annexure "G"*.

3. That, the appellant seeks his redressal mainly on the grounds amongst other grounds requirement, violation of law, rules, policies, discrimination and lack of efficacious remedy:-

GROUND S:-

- a) That, the appellant's native village is Dhamtour which is also Union council, while since more than 40 years back the appellant's family has shifted his place of abode/residence to Abbottabad city and appellant is now residing near Shahzada Masjid and this area is known as the Lower Malik Pura and this area comes within the Union Council Malik Pura Urban, Abbottabad.
- b) That, as per law and policy the appellant being school teacher in BPS-15 could not be transferred beyond to the area of his union council and as the appellant has been transferred in such a short period of about one year from GPS No.1

Kutchery, Abbottabad to the schools of (A) GPS Riala Bandi, (B) GPS Chimiali (C) GPS Drairr and such area is not only adjacent to Azad Kashmir but also comes under Boi Union Council and that area is away more than 60 Kilometer from Abbottabad which is hilly area and it takes about 4 hours of one side to reach there from Abbottabad to school of posting.

- c) That, the appellant has served the department for about 29 years and is aged about 56 years, alongwith is heart patient since 7 years back and doctors have seriously restrained the appellant to avoid the journey to hilly area and hard foot step and it is astonishing to note that when appellant was transferred from Abbottabad to GPS Riala Bandi and when fact of heart ailment was brought to the notice through appeal of respondent No.1 and respondent No.1 assured the appellant that on medical ground appellant would be transferred to Abbottabad City, but on receipt of the transfer order it was found that appellant has been transferred to GPS Chimiali at about 5 Km further away from GPS Chimiali, such type of orders could not be termed as made in good faith rather speaks otherwise, which does not suite either to

respondent NO.4/Govt. or other respondents i.e responsible officers of Govt.

d) That, the malafidies are not having spoken words, rather could be gathered from the circumstances such as under:-

A. In case of appellant's transfer from GPS No.1 Kutchery, Abbottabad to GPS Riala Bandi (area near to Azad Kashmir approachable in about 4 hours in one side from Abbottabad where appellant and his family reside) has not been intentionally addressed to.

B. The tenure period rules, policy and law have been defeated.

C. When the teachers who are residents near-by areas of the concerned area Riala Bandi, Bandi Chimiali and Drairr having similar status and qualification are available why they are transferred to Abbottabad or other areas and teachers like appellant having residence at Abbottabad are being transferred to the areas like Drairr.

D. That, why certain group of teachers are being kept posted in same school of Abbottabad City

for throughout their period of service extending to more than 20 years on the basis of different pretexts and the other teachers like the appellant is facing such like discrimination as mentioned in the petition including the appellant is being forced to file present petition as there is no way left for the redressal.

- E. There is also patent lacunae in the concerned law, as if the appellant is forced to wait for the decision of appeal of higher authority for 3 months and in this period generally the higher authority fails to reply while the officer who passed the impugned order takes the coercive measures for leaving the charge and if charge is given and taken then the intent and purpose of seeking relief is usually failed under the garb of technicalities and if the charge is not given due to the filling of departmental appeal then this step is taken as disobedience and orders of coercive nature such as stoppage of pay, issuance of show cause notice for removal of service and before the passing of period of 3 months appellant under the law is denied to approach learned Service Tribunal and if during such period if same files service appeal, the

learned Service Tribunal dismissed the same as immaturely filed.

- F. That, sufficient increase in daily passing of orders in Government offices, the fact of violation of concerned laws, rules and policies.
- G. That, instant appeal is well within time.

It is, therefore, humbly prayed that instant appeal may please be accepted to the extent that the appellant is entitled to be dealt in accordance with law, rules and policy in vogue and accordingly the appellant be transferred in the area of Union Council Malik Pura Urban where the appellant and his family is residing with or be transferred to the Union Council Dhamtour, Abbottabad the native village of appellant, alongwith any other order which ever is deemed appropriate for the redressal of the appellant, including the passing of order to meet the redressal of appellant in conformity of law requiring the transfer in conformity the law further more the respondent No.4 be directed to console the lacunae in legislation as mentioned above to meet the ends, aims and purpose of legislation for the purpose of redressal of difficulties of

appellants and other Government servants of the
province.

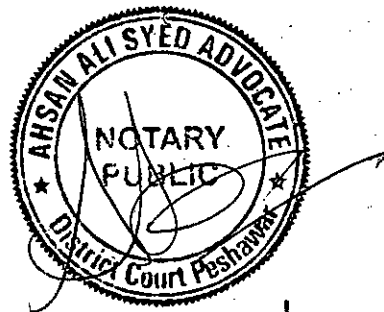

Khyber Pakhtunkhwa (Appointment, Deputation, Posting and Transfer of Teachers, Lecturers, Instructors and Doctors) Regulatory Act, 2011

AN ACT to regulate by law appointments, postings and transfers of teachers serving in primary, middle, secondary and higher secondary schools, lecturers in colleges and instructors in technical institutions and doctors in health facilities.

Preamble.---WHEREAS it is expedient to regulate by law appointments, postings and transfers at local level, of teachers serving in primary, middle, secondary and higher secondary schools, lecturers in colleges and instructors in technical institutions and doctors in health facilities and to ensure the availability of teachers in schools, lecturers in colleges and instructors in technical institutions and the doctors in health facilities, and to regulate deputation of doctors abroad, and to provide for matters connected therewith or ancillary thereto;

It is hereby enacted as follows:

1. Short title, application and commencement.---(1) This Act may be called the Khyber Pakhtunkhwa (Appointment, Deputation, Posting and Transfer of Teachers, Lecturers, Instructors and Doctors) Regulatory Act, 2011.

(2) It shall apply to teachers serving in primary, middle, secondary and higher secondary schools, lecturers in colleges as well as commerce colleges and instructors serving in technical institutions and doctors serving in the health facilities in the Province of the Khyber Pakhtunkhwa.

(3) It shall come into force at once.

2. Definitions.---(1) In this Act, unless the context otherwise requires, the following expressions shall have the meanings hereby respectively assigned to them that is to say:

- (a) "Commission" means the Khyber Pakhtunkhwa Public Service Commission;
- (aa) "college" means a degree college;
- (b) "doctor" means a doctor serving in the health facility;
- (c) "Government" means the Government of the Khyber Pakhtunkhwa;
- (d) "health facilities" mean all health facilities established and managed by Government to provide medical facilities to general public;
- (e) "lecturer" and "instructor" respectively means a lecturer or an instructor serving in a Technical Institution as well as in a college, as the case may be;
- (f) "prescribed" means prescribed by rules made under this Act;

- (g) "rules" mean the rules made under this Act;
- (h) "school" means school in the public sector including primary, middle, secondary school, higher secondary school or an institution of equivalent level imparting education through any system or medium of instruction in the public sector;
- (i) "teacher" means a teacher of primary, middle, secondary or higher secondary school; and
- (j) "technical institution" means and includes a Commerce College or Government College of Management Sciences or Technical Institute or Technical and Vocational Training Center or Skill Development Center in the public sector imparting technical education to students leading to the award of a degree or a diploma or a certificate.

(2) Words and phrases used in this Act, but not defined, shall have the same meanings as respectively assigned to them under the relevant federal law or provincial law or any other statutory order or rules for the time being in force.

3. Appointment, posting and transfer of primary school teachers.

(1) The vacancy of primary school teacher shall be filled in from the candidates belonging to the Union Council of their permanent residence mentioned in their Computerized National Identity Card and domicile, on merit and if no eligible candidate in that Union Council is available where the school is situated, such appointment shall be made on merit from amongst eligible candidates belonging to the adjacent Union Councils:

Provided that on availability of a vacancy, a primary school teacher, appointed from adjacent Union Council, as referred to in this sub-section, shall be transferred against a vacant post in a school of the Union Council of his residence within a period of fifteen days.

(2) Upon marriage, the primary school teacher on request may be transferred to the school in the Union Council, where his spouse, ordinarily resides, subject to the availability of vacancy.

(3) The primary school teacher shall be transferred to other school within the Union Council on completion of tenure as may be prescribed or before completion of tenure, subject to the policy of rationalization for maintaining certain students teachers ratio, if any.

(4) Government shall, within a period not exceeding one year of the commencement of this Act, make arrangement for posting of all the primary school teachers appointed prior to coming into force of this Act, to the schools of their respective Union Councils or adjacent Union Councils, as the case may be.

4. Appointment of doctors, lecturers, instructors, subject specialists and teachers on adhoc basis.---(1) Government may, through the competent authorities make adhoc appointment on merit against the vacant posts of doctors, lecturers, instructors, subject specialists and teachers, falling within the purview of Commission, in a district concerned from the domicile holders of that district for a period of one year or till the arrival of recommendees of Commission, whichever is earlier after fulfilling the pre-requisites

of giving wide publicity in the press. On assumption of charge of post by recommendee of the Commission, the services of such ad hoc appointee shall stand automatically terminated.

Provided that if no suitable and eligible candidate is available in the district concerned for appointment, then the candidates belonging to the neighbouring districts shall be considered for appointment in the order of their merit.

(2) Save as the appointment made under proviso of this section, "ad hoc appointee" shall serve in the district of his domicile.

(3) The post of a doctor, lecturer, instructor, subject specialist or teacher who proceeds on training or long leave may be treated as vacant post for the purpose of contract or contingent appointment till the return of such employee from training or long leave and assumption of charge of the post.

Provided that the period of such training or long leave shall not be less than one year and no appointment on contract or contingent shall be made on the post which may fall vacant for a period less than one year.

5. **Initial posting.** --- (1) The doctors, lecturers, instructors subject specialist or teachers, upon their appointment shall be first posted in the periphery of the zone against whose quota they have been recruited, and they shall not be transferred for a period of at least three years.

(2) Upon expiry of the tenure as referred to in sub-section (1), transfer shall be made only upon the availability of substitute.

6. **Deputation of Doctors.**---(1) Government may allow deputation abroad for all categories of doctors only once in their entire service, for a period not exceeding three years.

(2) Deputation to "Foreign Service" within Pakistan shall be permissible only in respect of medical officers for a period not exceeding three years:

Provided that no further extension on expiry of agreed tenure shall be given to the doctors who are already on deputation abroad or within Pakistan.

7. **Postgraduate Medical Education.**---(1) The Health Department, on the basis of objective need assessment and analysis, shall determine the intake number of Trainee Medical Officers (TMOs) in Postgraduate Medical Institute (PGMI) and Junior Registrars in Tertiary Care Hospitals every year. This stipulated number shall not exceed in any case.

(2) Any doctor selected or permitted for postgraduate medical training shall be treated on leave without pay and may be entitled only for stipend fixed by Government from time to time for such training.

(3) A doctor selected or permitted for postgraduate medical training shall provide surety bond prescribed by Government ensuring that upon completion of his studies for which he was initially selected, shall compulsorily serve for three years in the district of

his domicile and in case of non-availability of a post in the district of domicile he shall serve for three years in the rural area.

(4) For the purpose of sub-section (3), the doctor shall also provide guarantee of two government officers.

(5) In case of violation of sub-section (3), Government shall serve one-month notice upon the doctor for resumption of duty, failing which the amount shall be recovered from him or from the guarantor, as the case may be.

8. **Provisions relating to doctors apply to lecturers and instructors.** --- The provisions relating to doctors in section 7 of this Act shall mutatis mutandis apply to lecturers and instructors.

9. **Act to over-ride other laws.**---The provisions of this Act shall have effect notwithstanding any thing contained in any other law for the time being in force.

10. **Jurisdiction barred.**---Save as provided under the Khyber Pakhtunkhwa Civil Servants Act, 1973 (Khyber Pakhtunkhwa Act No. XVII of 1973), the Khyber Pakhtunkhwa Civil Servants (Appeal) Rules, 1986 and the Khyber Pakhtunkhwa Service Tribunal Act, 1974 (Khyber Pakhtunkhwa Act No. I of 1974), no order made or proceedings undertaken under this Act, or the rules made there under or any officer authorized by it shall be called into question in any Court, and no injunction shall be granted by any Court in respect of any decision made, or proceedings taken in pursuance or by any power conferred by or under this Act or the rules.

11. **Removal of difficulties.**---Government may, by order, provide for the removal of any difficulty which may arise in giving effect to the provisions of this Act.

12. **Power to make rules.**---Government may make rules for carrying out the purposes of this Act.







The appellant is serving as PST BPS 15 in education department at Abbottabad District and the appellant served the department for the period more than 29 years and it is further submitted that the appellant's native Village Dhamtour is situated at the distance of about 08 Kilometers and the appellant age is about 55 years and the appellant is residing, alongwith his family now at Abbottabad City at Malikpura and all the children of appellant are students of respective classes i.e 3rd Class to B.A and unfortunately the appellant is also a heart patient since many years and has suffered heart attack once and the concerned doctors are repeatedly advising the appellant to avoid traveling, to such hilly stations which are situated at high altitude because shortage of oxygen may cause me complications and appellant income is only the salary alone, but it is sorry to mention that the appellant is made a rolling stone and escape goat as the following certain detail may reveal as such.

- i) Throughout the service period of more than 29 years the appellant has been posted once in Abbottabad for the period of less than 03 years in Govt. Primary School No. 1 Abbottabad.
- ii) The appellant was transferred on 25/02/2013 from GPS No. 1 Abbottabad to GPS Riala Bandi Boi, although situated in District Abbottabad, but away from District Mansehra, one have to cross District Mansehra to reach the Bandi Riala School and State of Azad Kashmir is situated at some Kilometers from this place and the appellant being head of my family and father of younger children and being heart patient has to return home situated at Abbottabad after

journey of more than 150 Kilometers each day with spending of amount about Rs. 200/- per day more so the hardships of journey, tension and others problems which the appellant is facing because of no fault, particularly being heart patient and also remained in ICU, CCU, in Ayub Teaching Complex.


- iii) It is also submitted that against said transfer mentioned above i.e from G.P.S No. 1 Abbottabad to Riala Bandi (Boi), the appellant was further transferred to G.P.S Bhuraj Khass (Sherwan), being considered as "Senior" through corrigendum /office order No. 2242-50 dated 31/05/2013 (mentioned at Serial No. 23 and Seniority list as 756) but this order was not allowed to be acted upon and after couple of days it was withdrawn.
- iv) That now impugned order dated 23/07/2013 has been passed and vide which the appellant has been transferred from GPS Riala Bandi Boi to GPS Chamiali of same Circle Boi but more away than earlier school.

It is, therefore, submitted that on acceptance of the present appeal/ representation the appellant may graciously be transferred and posted at Abbottabad City or its surroundings keeping in view appellants seniority, age and of being heart patient and serious advises of doctors to avoid journey and more particularly of hilly areas where the shortage of oxygen is a serious question for heart patients like appellant and more so the journey of each and every day twice, the appellant's medical prescriptions and concerned transfer orders are attached herewith.

No.SO(PE)4-5/Meeting/2013/Transfer/Posting: In continuation of this Department Notification of even No. dated 10-9 2014, posting and transfer at primary level will be done in the following manner:-

2. There shall be a committee at each district, with the following composition:
 - i. DEO concerned as chairperson.
 - ii. Representative of Directorate of E&SE not below BS-17
 - iii. Concerned SDEO.
3. The committee will hold meetings in December, March, June and September. First meeting will be held in December 2014.
4. The committee will be able to recommend a maximum of 3 (three) transfers and postings at each quarterly meeting.
5. The committee will base all its deliberations on the need of the students in its jurisdiction, and this will be the primary determining factor.
6. Compassionate grounds do not include medical grounds, for which medical leave or retirement on medical grounds may be sought as provided for under the relevant rules. No transfer from a school will be considered if it violates a teacher student ratio of 1:40. If the ratio at a school is already worse than 1:40, no teacher will be considered for transfer from that school. The only exception will be the commissioning of new schools, for which teachers from the most favorable teacher student ratio in the vicinity may be considered.
7. Teachers returning from leave or deputation will be considered against a post in only those schools which have the worst teacher student ratio in the district.
8. Any aggrieved party may put in an appeal through proper channels and the concerned DEO will forward this appeal alongwith detail comments and clear cut recommendations to the Director E&SE, who will constitute a committee to consider the appeal and pass a suitable order within the parameters specified above.
9. Violation of these instructions will be punishable under the government servant (Efficiency and Discipline) Rules 2011.
