

APPEAL UNDER **SECTION** OF KHYBER PAKHTUNKHWA SERVICE TRIBÚNAL ACT 1974 AGAINST THE IMPUGNED ORDER DATED 07.3.2014 BYRESPONDENT ISSUED WHEREBY RESPONDENT NO.5 WAS ILLEGALLY PROMOTED AGAINST THE POST OF FORESTER. IGNORING THE APPELLANT BEING SENIOR IN THE **CADRE** OF **FOREST** GUARD, DEPARTMENTAL APPEAL OF THE APPELLANT AGAINST THE **IMPUGNED** ORDER REJECTED BY RESPONDENT NO.3 VIDE ORDER DATED 25.4.2014.



#### Respectfully Sheweth:

#### **FACTS OF THE CASE**

- 1. That the appellant is a regular member of Provincial Civil Service of Forest Department, holding the post of Forest Guard. The entire service career of the appellant is spotless and about 35 years meritorious service is at h-is credit.
- 2. That the appellant joined Forest Department on 24.5.1979 and as per seniority list, name of the appellant has been shown at Serial No.10, while name of respondent No.5 is at Serial No.11. Thus the appellant is senior than his rival colleague (respondent No.5). (Annex: A).
- 3. That on 07.3.2014 respondent nO.4 issued an order whereby respondent No.5 was illegally promoted against the post of Forester, disregard of the rules and seniority criteria. (Annex: B). The appellant is senior to respondent No.5 as he was ineligible on merit as well as seniority competence, therefore, the order passed by respondent No.4 is unwarranted by law, ultra vires of the rules and void.
- 4. That feeling aggrieved from the order of respondent nO.4 dated 07.3.2014, the appellant filed his departmental appeal dated 31.3.2014 before respondent No.3, but to his utter dismay that his appeal was rejected by respondent No.3 vide order dated 25.4.2014. (Annex: C & D).
- 5. That the appellant is senior most incumbent and his name has been shown at Serial No.10 of the Seniority List, relating to Forest Guard Cadre, whereas the name of respondent No.5 is at Serial No.11. Evidently the appellant is senior and illegally ignored from promotion. The service record of the appellant is better than respondent No.5 and it is astonishing as to what criteria has been adopted for promotion of respondent No.5, who is neither senior nor possess any privilege of worthy of recognition.

- 6. That from the dates of initial appointment of appellant and respondent No.5 it revealed that the appellant joined the department on 24.5.1979, while respondent No.5 was initially appointed on 24.11.1980, thus it is abundantly clear that respondent No.5 is junior to appellant and not eligible for promotion against the post of Forester, hence the conduct of respondents is not above board, and undue favour has been extended to respondent No.5 due to certain under ground reasons.
- 7. That respondent No.3, while rejecting departmental appeal of the appellant altogether misinterpreted and misconstrued the significance of F.R 14(b), which is quite technical, therefore, he reached to the wrong conclusion, which defeat the ends of justice.

In view of the aforesaid facts and circumstances of the case it is humbly prayed that the impugned order dated 07.3.2014 passed by respondent No.4 and final order dated 25.4.2014 passed by respondent No.3 may graciously be set aside being illegal and void, directing the respondents to consider the appellant for promotion against the post of Forester from the date when his junior rival colleague (respondent No.5) was promoted.

Any other relief though not specifically asked for to which the appellant is found entitled in the circumstances of the case may also be granted to the appellant.
