



Counsel for the appellant submitted that the appellant has been working as Video Camera Operator in BPS-10 since the Agriculture Extension Department. The 5.5.2004 in Government of Khyber Pakhtunkhwa vide notification dated 11.10.2010 introduced upgradation policy. The appellant filed an appeal on 14.5.2012 by referring pay scale of Video Cameraman BPS-13 working in the Provincial Assembly. The department made a quarry that the Provincial Assembly is an autonomous body and the appellant was directed to provide reference of the department under the control of Administration Department. The appellant on 27.6.2012 provided the reference of the Khyber Pakhtunkhwa Information Department, wherein the post of Camera Operator has been upgraded from BPS-10 to 13. The respondent department prepared the working paper and placed before the upgradation committee for consideration. However, vide order dated 11.4.2014, the appellant was informed that his appeal for upgradation was considered and filed. The impugned order was communicated to appellant on 29.4.2014, hence the present appeal.

The learned AAG conversely contended that the Tribunal has no power to issue directions as contemplated in Section 7 of the KPK Service Tribunal Act, 1974; that the appeal is not maintainable under Section 4(b)(i) of the KPK Service Tribunal Act, 1974 and that the appellant has preferred two departmental appeals one on 14.5.2012 and the other on 27.6.2012, however, there is no provision of second departmental appeal under the law. He requested that the appeal may be dismissed in limine.

In rebuttal, the learned counsel for the appellant contended that there is one departmental appeal dated 14.5.2012 whereas the other one dated 27.6.2012 is the information given by the appellant with reference to the quarry of the department dated 21.5.2012. He further contended that Section 4 (b)(i) of the Service Tribunal Act, 1974 is not application in the instant case because yet it is to be decided by the Tribunal as to whether the appellant has a case or otherwise as per upgradation policy. 

THE RESPONDENTS FURTHER MAY PLEASE BE DIRECTED TO UP-GRADE THE APPELLANT TO BPS-13 WITH ALL BACK AND CONSEQUENTIAL BENEFITS ON THE BASIS OF PARITY AND BY TREATING THE APPELLANT AT PAR WITH THE OTHER GOVERNMENT DEPARTMENTS CAMERAMEN. ANY OTHER REMEDY WHICH THIS AUGUST TRIBUNAL DEEMS FIT THAT MAY ALSO BE AWARDED IN FAVOUR OF APPELLANT.

#### **RESPECTFULLY SHEWETH:**

- 1. That the appellant joined the Bureau of Agriculture Information, Agriculture Extension, Khyber Pakhtunkhwa, Peshawar as Video Camera Operator (BPS-10) against the vacant post.
- 2. That the appellant has also Bachelor in Arts in Mass Communication subject. Copy of Order and DMC are attached as Annexure-A and B.
- 3. That the Government of Khyber Pakhtunkhwa has promulgated Policy and Criteria of Up-gradation of Posts on 11.10.2010 wherein up-gradation has been allowed in the cases of re-organization / restructuring of the department, hardship case having no promotion, on the principle of parity etc. The said policy fully covered the case of the appellant of upgradation. Copy of Policy is attached as Annexure-C.
- 4.

That as the Cameraman in other departments are working in BPS-13 like Information Department, Wildlife Department, therefore, the appellant submitted his appeal for up-gradation through proper channel on 14.5.2012 on which the appellant was informed that he should submit Rules of the KPK Department. The appellant in pursuance to the said letter submitted his case again by quoting the references of other departments on 27.6.2012 which was forwarded to the Director General, Agricultural Extension, KPK on 4.7.2012. Copy of Application and letter are attached as Annexure-D, E, F and G respectively.

That on basis of that correspondence, the appellant case was submitted to Finance Department on 10.2.2014 along-with 8 sets of the working paper in which the appellant's up-gradation was fully justified Copies of Working Paper of Information Department, Rules of Wildlife Department and Rules of Agriculture Department are attached as Annexure-H, I, J and K respectively.

That then the matter was discussed by the Upgradation Committee but the same was refused to the appellant for no good grounds on 11.4.2014. The said refusal communicated to the appellant on 29.4.2014. Copies of Letters are attached as Annexure-L and M respectively.

That the now the appellant comes to this Honorable Tribunal on the following grounds amongst the others.

#### <u>GROUNDS:</u>

- A) That the refusal order dated 11.4.2014 communicated to the appellant on 29.4.2014 is against the norms of justice, material on record, discriminatory and hence not tenable.
- B) That the rejection order is not a speaking order which is the violation of Section-24-A of the General Clauses Act as well as the Supreme Court Judgment reported as 1991 SCMR, Page-2330.
- C) That it is surprising to note that there is no chance of promotion to the appellant to the next higher scale in the Rules which means that the appellant

will work in BPS-10 till his retirement; therefore, the appellant case is also covered under hardship cases.

D) That even the treatment of the respondents in refusal the up-gradation, the appellant has also discriminated because Cameraman in other Departments are in BPS-13 while the appellant is in despite BPS-10 having graduation in Mass Communication. This proves discrimination on the part of the respondents against the appellant.

- E) That the appellant's case is also covered on the basis of parity and therefore, the parent department of the appellant completely favours the case of the appellant before the up-gradation committee.
- F) That the appellant has not been treated as per Upgradation Policy of the Government and has been discriminated which caused serious disadvantageous to the terms of conditions of the appellant.

- iv. Proposed changes in method of recruitment, as part of re-organization proposed; Provided that before submitting proposals of upgradation of posts to the Finance Department in such cases, the Administrative Department will do proper consultation with Establishment Department for developing a practical and modest Re-organization proposal.

#### (II). <u>UPGRADATION OF POSTS</u> PROPOSED DUE TO INDIVIDUAL HARDSHIP CASES:

(a) Proposals for upgradation of certain posts due to the reasons that some civil servants do not have further promotion chances and have stayed on one position for reasonably long time, will be placed before the committee for consideration only if the proponent departments provides following information:-

- (i) Reasons due to which concerned Government servant is unable to be promoted in normal procedure.
- (ii) All requisite details about creation of such posts and formulation of service rules with particular reference to the reasons as to why the service rules cannot give career progression to the holders of these posts.

- (iv) The steps taken by the department concerned to resolve such hardships on permanent basis.

While processing the cases where the proponent department seeks upgradation of certain posts to a higher pay scale on the analogy of similar posts in some other department in this province created with same nomenclature, the committee shall take into account following parameters:

(i). Ascertainment of full details about all such posts created with same nomenclature by any other department in addition to those departments whose analogy has been quoted by proponent department.

- (ii). Nomenclature shall not be the sole criterion for determining parity/comparability of posi(s). Other details i.e. the job description and prescribed qualification would necessarily be examined.
- (iii) In case of difference of prescribed qualification or the job description (or both) as the case may be, the committee may direct change of nomenclature of post(s) in any department to avoid confusion on this ground.

(iv) The committee may associate with all such departments having same nomenclature of ceredin post(s) with same responsibilities and same qualifications to ascertain as to what were reasons for creation of same posts in different departments with different pay scales, and thus make recommendations in respect of all such posts in all concerned departments, whether they took up the case or otherwise, to bring uniformity in pay scales in all departments to avoid future references.

> Provided that the committee shall not recommend such proposals for uniformity where prescribed qualifications as well as the qualifications possessed by existing incumbents is not at par with the post(s)/ incuminents cited as precedence.

> Provided further that in such cases the committee may recommend change of nomenclature of either those post(s) having higher prescribed qualifications or those having lesser prescribed qualifications as may be deemed appropriate by the committee.

#### (IV). <u>UPGRADATION PROPOSED FOR RETENTION OF AN OFFICER ON SAME</u> <u>POST AFTER HIS PROMOTION TO HIGHER PAY SCALE.</u>

Retention of an officer on the same post after he has been promoted to next higher position by the competent authority, is against the spirit of the promotion policy, hence shall not be ording illy allowed. However, in case due to peculiar exigencies of services if it becomes unavoidable to retain a promoted officer on the same position than the concerned department shall move a summary for the Chief Minister, mentioning therein the detailed reasons and justifications in support of their such proposal and route it through the Establishment Department and the Finance Department for obtaining orders of the Chief Minister, Khyber Pakhtunkhwa.

Provided that in such cases the post will be up-graded personally for the incumbent till his stay as such and shall automatically stand downgraded to its original position thereof.

#### (V). <u>UPGRADATION OF A POST PROPOSED ON THE ANALOGY OF</u> SOME OTHER PROVINCE

Any order made by any other Province regarding creation of a post with certain nomenclature in certain pay scale does not have any binding effect on any other Province to follow the same. Therefore, in such cases the committee shall examine the proposals totally on its own ment keeping in view the above mentioned guidelines, in general, and shall furnish its recommendations independently.

3. The committee may, however, take any other point into consideration while examining proposed upgradation to ensure effective running of a department/ organization in public interest.

4. The recommendations of the above committee shall be submitted for approval of the competent authority as per table given below: -



- (i). Objectives set forth for Re-organization.

- (iii). Why upgradation of some posts are essential for re-organization.

(iv). Proposed changes in method of recruitment as part of re-organization proposed; Provided that before submitting proposals of upgradation of posts to the Finance Department in such cases, the Administrative Department will do proper consultation with Establishment Department for developing a practical and modest Re-organization proposal. II. <u>UPGRADATION OF POSTS PROPOSED DUE TO</u> INDIVIDÜAL HARDSHIP CASES:

(a) Proposals for upgradation of certain posts due to the reasons that some civil servants do not have further promotion chances and have stayed on one position for reasonably long time, will be placed before the committee for consideration only if the proponent departments provides following information:-

(i) Reasons due to which concerned Government servant is unable to be promoted in normal procedure.

- (ii). All requisite details about creation of such posts and formulation of service rules with particular reference to the reasons as to why the service rules can not give career progression to the holders of these posts.
- (iii). Whether organizational structure as well as service rules need revision to avoid recurring of the hardship to the future entrants.

The committee may associate with all such departments having same nomenclature of certain post(s) with same responsibilities and same qualifications to ascertain as to what were reasons for creation of same posts in different departments with different pay scales, and thus make recommendations in respect of all such posts in all concerned departments, whether they took up the case or otherwise, to bring uniformity in pay scales in all departments to avoid future references.

Provided that the committee shall not recommend such proposals for uniformity where prescribed qualifications as well as the qualifications possessed by existing incumbents is not at par with the post(s)/ incumbents cited as precedence.

Provided further that in such cases the committee may recommend change of nomenclature of either those post(s) having higher prescribed qualifications or those having lesser prescribed qualifications as may be deemed appropriate by the committee.

#### UPGRADATION PROPOSED FOR IV. RETENTION OFFICER ON SAME POST AFTER HIS PROMOTION HIGHER PAY SCALE.

Retention of an officer on the same post after he has been promoted to next higher position by the competent authority, is against the spirit of the promotion policy, hence shall not be ordinarily allowed. However, in case due to peculiar exigencies of services if it becomes unavoidable to retain a promoted officer on the same position than the concerned department shall move a summary for the Chief Minister, mentioning therein the detailed reasons and justifications in support of their such proposal and route it through the Establishment Department and the Finance Department for obtaining orders of the Chief Minister, Khyber Pakhtunkhwa.

Provided that in such cases the post will be up-graded personally for the incumbent till his stay as such and shall automatically stand downgraded to its original position thereof.

In case of termination without notice by the employer or two months notice from the employee for resignation two months pay and allowances shall be paid by the Government or refunded by the employee as the case may be.

His services under the present post shall not qualify for pension / gratuity.

### REVISED POLICY AND CRITERIA FOR UPGRADATION OF POSTS.

All proposals regarding upgradation of any post in any Provincial Department or office shall be placed before the following committee for sorubinization and recommendations: -

- Secretary 12 Gover of Khyber Pakhtunkhwa, Chairman Finance Department.
- ii. Secretary to Govt: of Khyber Pakhtunkhwa. Member Establishment Department.
- Additional Finance Secretary (Regulation) Member-cum-Secretary Finance Department.
  - Additional Secretary of the concerned . Member Department
  - Le case the post of Additional Secretary is not sanctioned in concerned department, the Deputy Secretary of the concerned department will represent as member of the up-gradation committee for scrutiny and recommendations of the upgraded posts.
- 2. No proposal request for up-gradation of post(s) to higher pay scale shall be entertained except in following cases: -
- I. <u>UPGRADATION OF POSTS PROPOSED AS PART OF</u> <u>RE-ORGANIZATION/ RE-STRUCTURING OF</u> <u>DEPARTMENTS</u>:-

Proposals for upgradation of certain posts as a sequel to the re-organization/ re-structuring of the department organization will be considered/ scrutinized by the committee on following parameters: -

(i). Objectives set forth for Re-organization.

- (iii). Reasons, factors and impediments in the existing structure which led to Re-organization process.
- (iii). Why upgradation of some posts are essential for re-organization.

(iv). Proposed changes in method of recruitment as part of re-organization proposed; Provided that before submitting proposals of upgradation of posts to the Finance Department in such cases, the Administrative Department will do proper consultation with Establishment Department for developing a practical and modest Re-organization proposal. II.

## UPGRADATION OF POSTS PROPOSED DUE TO INDIVIDUAL HARDSHIP CASES:

(a) Proposals for upgradation of certain posts due to the reasons that some civil servants do not have further promotion chances and have stayed on one position for reasonably long time, will be placed before the committee for consideration only if the proponent departments provides following information:-

(i). Reasons due to which concerned Government servant is unable to be promoted in normal procedure.

- (ii). All requisite details about creation of such posts and formulation of service rules with particular reference to the reasons as to why the service rules can not give career progression to the holders of these posts.
- (iii). Whether organizational structure as well as service rules need revision to avoid recurring of the hardship to the future entrants.
- (iv). The steps taken by the department concerned to resolve such hardships on permanent basis.

(b) The committee after proper scrutiny of case in terms of above paramete and if satisfied that the upgradation of certain post(s) is the only solution, mamake its recommendations to the competent authority for upgradation on persona basis provided that:

- (i). There shall be no upgradation of post beyond BPS-19 in such cases.
- (ii). Such recommendations will only be made in case where there are absolutely no promotion prospects in the service structure for incumbent of said post(s).
- (iii). No such recommendations will be made in a case where the incumbent has less than 10 years of stay on one and the same position;
- (iv). The incumbent has not been earlier elevated in the existing pay scale by personal upgradation.
- (v). The proposed upgradation will be personal to the incumbent and the post shall stand downgraded as and when vacated by such incumbent.

## III. UPGRADATION OF POSTS PROPOSED ON GROUNDS ( PRINCIPLE OF PARITY.

While processing the cases where the proponent department se upgradation of certain posts to a higher pay scale on the analogy of similar posts in so other department in this province created with same nomenclature, the committee s take into account following parameters:

(i).

Ascertainment of full details about all such posts created with same nomenclature by any other department in addition to those departments whose analogyhas been quoted by proponent department

- (ii). Nomenclature shall not be the sole criterion for determining parity/ comparability of post(s). Other details i.e. the job description an qualification would necessarily be examined. description and prescribed
- In case of difference of prescribed qualification or the job description (or both) as the case may be, the committee may direct change of nomenclature of post(s) in any department to avoid confusion on this ground.

and the second s The committee may associate with all such departments having same nomenclature of certain post(s) with same responsibilities and same qualifications to ascertain as to what were reasons for creation of same posts in different departments with different pay scales, and thus make recommendations in respect of all such posts in all concerned departments, whether they took up the case or otherwise, to bring uniformity in pay scales in all departments to avoid future references.

Provided that the committee shall not recommend such proposals for uniformity where prescribed qualifications as [ well as the qualifications possessed by existing incumbents is not at par with the post(s)/ incumbents cited as precedence.

Provided further that in such cases the committee may recommend change of nomenclature of either those post(s) having higher prescribed qualifications or those having lesser prescribed qualifications as may be deemed appropriate by the committee.

#### IV. UPGRADATION PROPOSED FOR RETEN OFFICER ON SAME POST AFTER HIS PROMOTION TO HIGHER PAY SCALE.

Retention of an officer on the same post after he has been promoted to next higher position by the competent authority, is against the spirit of the promotion policy, hence shall not be ordinarily allowed. However, in case due to peculiar exigencies of services if it becomes unavoidable to retain a promoted officer on the same position than the concerned department shall move a summary for the Chief Minister, mentioning therein the detailed reasons and justifications in support of their such proposal and route it through the Establishment Department and the Finance Department for obtaining orders of the Chief Minister, Khyber Pakhtunkhwa.

Provided that in such cases the post will be up-graded personally for the incumbent till his stay as such and shall automatically stand downgraded to its original position thereof.

## <u>UPGRADATION OF A POST PROPOSED ON THE ANALOGY</u> OF SOME OTHER PROVINCE.

V.

Any order made by any other Province regarding creation of a post with certain nomenclature in certain pay scale does not have any binding effect on any other Province to follow the same. Therefore, in such cases the committee shall examine the proposals totally on its own merit keeping in view the above mentioned guidelines, in general, and shall furnish its recommendations independently.

3. The committee may, however, take any other point into consideration while examining proposed upgradation to ensure effective running of a department/ organization in public interest.

4. The recommendations of the above committee shall be submitted for approval of the competent authority as per table given below: -
