**APPEAL UNDER SECTION 4 OF THE KHYBER
PAKHTUNKHWA SERVICE TRIBUNAL ACT,
1974, AGAINST**

**A) THE PROMOTION ORDERS ISSUED VIDE
NO. ESTT:1/26-11338 DATED 04/06/2013
AND DATED 18/06/2013. WHEREBY
RESPONDENTS NO.4 TO 55 WERE
PROMOTED ILLEGALLY, AGAINST THE
RULES AND ARBITRARILY DESPITE THE
FACT THAT THEY WERE NOT ILLEGIBLE
TO BE CONSIDERED FOR PROMOTION
UNDER TEHSILDARS, NAIB TEHSILDARS
AND SUBORDINATE REVENUE STAFF
SERVICE RULES, 2008 ;AND**

**B) AGAINST THE AMENDMENTS CARRIED
OUT IN THE RULES IBID WHEREBY
TWICE WITHIN ONE YEAR THE
PROMOTION QUOTA OF NAIB
TEHSILDARS WERE REDUCED WITHOUT
ANY JUSTIFIABLE REASON.**

Prayer;

On acceptance of this appeal the illegal promotion orders may be set aside and the respondents be ordered to reconsider the promotion case strictly in accordance with law and rules on the subject on the basis of Joint Seniority List. Furthermore, the unjustifiable amendments carried out in the Rules be declared null and void.

Respectfully Sheweth:

The Appellant submits as under:

- 1) *That the Appellant was recruited as Naib Tehsildar in 2009 as a result of competitive examination conducted by Provincial Public Service Commission Khyber Pakhtunkhwa.*
- 2) *That according to Tehsildar, Naib Tehsildar / Subordinate Revenue Service Rules, 2008, originally the Post of Tehsildar was to be filled in Under Clause (a) to the extent of 20% by initial recruitment, Under Clause (b) to the extent of 60% by promotion from Naib Tehsildars and Under Clause (c) to the extent of 20% from the officials working in various branches of Revenue Administration but for all the categories the minimum educational qualification was second class Graduation from a recognized university. (Copy of the Rules is at Annexure "A").*
- 3) *That two amendments were introduced in the said Rules within one year i.e. 2011 whereby District Qanungos, District Revenue Accountants, Head Clerks and Sub-Registrars were included in the 60% Quota henceforth exclusively meant for Naib Tehsildars, thereby jeopardizing the chances of career-development of the Appellant as a result of malafide on the part of respondents. These amendments were neither the result of felt-needs nor were for the improvement in service-efficiency of the revenue administration.*


- 4) *That the respondents have issued the seniority list of Naib Tehsildar as stood on 31/12/2013. This seniority list was never circulated nor processed in accordance with law. It is apparent from the rules ibid that promotion to the post of Tehsildars can be processed only on the basis of a **Joint Seniority List.** The respondents have issued promotion orders on the basis of this seniority list which is against the rules. (Copy of the seniority list is Annexure "B" with a better copy attached)*
- 5) *That throughout all these amendments column No.5 of the Rules was not touched with the result that for promotion as well as for initial recruitment to the post of Tehsildar, the educational qualification required remained as 2nd Class Graduation from recognized University.*
- 6) *That respondent No.4 to 52 were promoted as Tehsildars by the respondents, vide order No. Estt:1/26-11338 dated 04/06/2013 and 18/06/2003. Out of these, That respondents No.1 to 3, through the impugned orders, have promoted Respondent No.4 to 42 against the rules without ensuring the basic qualification of graduation required for promotion to the post of Tehsildar as required by the entries in column No.5 of the Rules, as these stand today, with the result that respondents No.6,7,9,10,13,14,18,19,20,21,22,23, 24,28, 29,30,32,33,35,36,38 &42 were non-graduates while*

some of the Respondents had been promoted as Naib Tehsildars through Administrative Orders and were not eligible to be considered for promotion to the post of Tehsildar as their promotion as Naib Tehsildar through Administrative Orders was by itself illegal, against the rules as the method of promotion through Administrative Order is not recognized by the Rules above quoted. (Copy of the orders is at Annexure "C").

7) *That the Appellant challenged the order by filing Writ Petition No. 1720-P/2013 in Hon'ble Peshawar High Court, Peshawar. Since the question of eligibility was involved, therefore, the Hon'ble Court was pleased to send the said Writ Petition to the Respondents for considering the same as Departmental Representation vide order dated 05/11/2013. (Copy of the Writ Petition is at Annexure "D" while copy of the order is at Annexure "E").*

8) *That in pursuance of the same, respondent No.2 summoned the Appellant, along with others, to his office on 29/11/2013 and discussed the matter wherein he appreciated the legal points raised in the writ petition and sent the case to respondent No.1 for reversion of those officials who were not qualified to be promoted as Tehsildars.*

- 9) That the Appellant and other petitioners were expecting that respondents would adopt a legal course to alleviate the grievances of the appellant but instead of that, Respondent No.2 issued a corrigendum on 03/01/2014 in an effort to do away with the clause of graduation required for promotion with retrospective effect. (Copy of the corrigendum is at Annexure "F").
- 10) That the Appellant filed a departmental representation against the impugned corrigendum under the relevant law but the Appellant apprehended that the period of compulsory wait for 90 days will be used to give benefit to those blue-eyed persons for whom this illegality was committed. (Copy of the departmental representation is at Annexure "G").
- 11) That the appellant also filed a writ petition against the said corrigendum in order to stop the respondents from granting promotion illegally to ineligible officials which writ was heard by a Divisional Bench of the Hon'ble High Court and a notice was issued to the respondents. (Copy of the writ petition is annexed as Annexure "H")
- 12) That on receipt of the notice from the Hon'ble High Court, Respondent No.1 through his order dated 06/07/2014 cancelled /withdrew the said corrigendum. (Copy of order is annexed as Annexure "I").

- 13) That vide order dated 23/01/2014 respondent No.2 also reverted those respondents not having the prescribed qualifications. (Copy of the order is annexed as Annexure "J").
- 14) That in utter disregard of Law and Rules on the subject and with a view to perpetuate the traditional arrogance of the beaucarcy, the same reverted ineligible officials have been ordered to enjoy the same posts of Tehsildar on Current Charge basis on the very next day. Such like orders speak volume of the attitude of respondents No 1to3 .(copy of order dated 24 01 2014 is at Annexure "K")
- 15) That the Hon'ble Peshawar High Court, Peshawar, on receipt of above two orders decided the said writ petition vide order dated 19/02/2014. (Copy of the order is annexed as Annexure "L").
- 16) That according to the Rules, as these stand today, Promotion to the post of Tehsildar, under clause (b) of Column 7 ,can only be processed on the basis of a Joint Seniority List of all those officials who are eligible to be considered for promotion for this 60% quota. Admittedly no Joint Seniority List has been prepared in the letter and spirit of this Rule so far. This non- existence of joint seniority list is being used as a pretext to keep blue-eyed but ineligible officials on preferred posts.

- 17) *That the petitioner is running from pillar to post to convince respondents No. 1 to 3 to process the promotion case in accordance with law but, as is evident from the above, their attitude is arrogant, retrogressive and person-specific.*

- 18) *That respondents No.54&55 have been promoted clandestinely through administrative orders as both of them were Patwaries in the year 2007-08 but are now working as EACs in District Buner. According to Letter No.Estt: 1/1/7270 dated 02/03/2012, issued by respondents addressed to Director Land Record, wherein the designation of both these respondents was mentioned as District Kanungo. It is amazing that an official, who was **District Kanungo** in the year of 2012, received three promotions i.e. as **Naib Tehsildar, Tehsildar and EACs in one year**. This could have happened only in the revenue Deptt: (Copy of the Letter is as Annexure "M").*

- 19) *That the seniority list has been issued at the back of the petitioners as the same has not been circulated amongst the petitioners as required by law.*

- 20) *That the seniority list shows that promotions have been ordered every 2/3 days which tells upon the working of one of the most important department of the province.*

- 21) *That in the light of the above, the promotions ordered by the respondent No.1 to 3 are illegal, malafide and are liable to be cancelled as in the absence of a Joint Seniority List as envisaged by*

the rules, no promotion could be processed. Similarly Rules cannot be amended arbitrarily and to the benefit of blue eyed officials and to the detriment of the appellant. Also no person ineligible to be considered for promotion can be allowed to enjoy the post of Tehsildar for unlimited period. All these actions of Respondents No.1 to 3 are liable to interfered by this Hon'ble Tribunal on the following, amongst others;

GROUND:

- A) That amendments carried out in the rules to accommodate favoured person is malafide, arbitrary and retrogressive.
- B) That processing the promotion cases without the Joint Seniority List as required by the rules ibid is illegal, malafide and arbitrary.
- C) That the keeping the ineligible officials as Teshsildar on current charge basis for indefinite period is against the merits and in violation of the Courts orders.

It is, therefore, humbly prayed that on acceptance of this appeal:-

- i) The impugned amendments in the service rules may be set aside;


- ii) That the promotions of officials as Naib Tehsildar through administrative order may be declared illegal and set aside;
- iii) That the officials ineligible to be considered for promotion to the post of Tehsildars may be barred from holding the said post in any manner;
- iv) That respondent No.1 to 3 be ordered not to process promotion cases without finalizing a joint seniority list as envisaged by clause (b) of Column 7 of the amended Tehsildar, Naib Tehsildar / Subordinate Revenue Service Rules 2008.

Any other relief deemed fit by this Hon'ble Tribunal may kindly be granted.



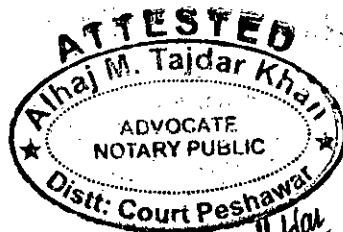

Prayer:

On acceptance of this writ petition the impugned notification and the illegal promotions may be set aside and respondents No.1 to 3 be directed to reconsider the entire case strictly in accordance with the Rules in vogue.

Respectfully Sheweth:

The petitioners submit as under:

- 1) That the petitioners were recruited as Naib Tehsildars through a competitive examination conducted by the Khyber Pakhtunkhwa Public Service Commission and the petitioners were accordingly appointed as Naib Tehsildars by the Respondents vide appointment order No. 1782-1907/Admn./VPSC dated 22/01/2009. (Copy of the appointments order are at Annexure "A").
- 2) That according to Tehsildar, Naib Tehsildar / Subordinate Revenue Service Rules 2008, Notified vide No.32102/Admn./1/135/SSRC dated 26/12/2008, the post of Tehsildar was to be filled in under clause-(a) to the extent

of 20% by initial recruitment, under clause (b) to the extent of 60% by promotion from Naib Tehsildars and under clause (c) to the extent of 20% from the officials working in various branches of Revenue Administration, but for all categories minimum Qualification was 2nd Class graduation from a recognized University as per column 5 describing minimum qualification for appointment by promotion. The condition of graduation was to be made applicable after 5 years of the date of notification to the promotion quota of 60% under clause (b). (Copy of the Rules is at Annexure "B")

3) That these Rules were further amended vide Notification No.12390 - 12429/ Admn: 1/1/296/Amendment dated 30/03/2011. Through this notification clauses (b) and (c) of column 7 were substituted and officials like District Kunongos, District Revenue Accountants and Head Clerks (Revenue) were made eligible for the 60% Quota meant for the Naib Tehsildars. The non-application of the condition of graduation for 5 years was also done away with. (Copy of the Amendment Notification is at Annexure "C").

4) That yet another amendment was made in the said rules vide Notification No.Estt:1/1/296/Amendment /29174 dated 02/12/2011 where again for the post of Tehsildar changes were introduced in the 60% Quota meant for promotion of Naib Tehsildars to the post of Tehsildars. This time Sub-Registrar were included in the list of eligible officials. (Copy of this Notification is at Annexure "D").

5) That it will be easy to conclude that the minimum qualification for recruitment to the post of Tehsildar is

Second class Graduation as throughout these amendments, the entries in column No.5 have neither been deleted nor changed and the non-application of the condition of graduation for five years was also deleted.

- 6) That it can be easily concluded that all the amendments introduced in the 60% Quota originally meant only for Naib Tehsildars, are meant to reduce the chances of directly recruited Naib Tehsildars to become Tehsildars under mala fide intention of the authorities.
- 7) That respondents No.1 to 3, through the impugned orders, have promoted Respondent No.4 to 42 against the rules without ensuring the basic qualification of graduation required for promotion to the post of Tehsildar as required by the entries in column No.5 of the Rules, as these stand today, with the result that respondents No.6,7,9,10,13,14,18,19,20,21,22,23,24,28,29,30,32,33,35,36,38 &42 have been promoted despite the fact that they are not graduates. (Copy of the impugned order No.Esst:1/26-11338 dated 04/06/2013 is at Annexure "E").
- 8) That respondent No.43&44 have been promoted clandestinely through administrative orders as both of them were Patwaries in the year 2007-08 but are now working as EACs in District Buner. According to Letter No.Esst: 1/1/7270 dated 02/03/2012, issued by respondent No.1 addressed to Director Land Record, wherein the designation of both these respondents was mentioned as District Kanungo. It is amazing that an official who was District Kanungo in the year of 2012, received three promotions i.e. as Naib Tehsildar, Tehsildar and EACs in one year. This could have happened only in the revenue Deptt. (Copy of the Letter is as Annexure "F").

- 9) That these promotions have been ordered in haste and without due process of law as no joint seniority list has been prepared in accordance with law regarding those officials who were to be considered for promotion to the post of Tehsildar. Such a joint seniority list is the basic requirement for any promotion process.
- 10) That the so-called final seniority list issued vide Office No. Estt-V/S.1/927 dated 26/04/2013 contains the name of those officials who have been shown as promoted to the post of Naib Tehsildars through the Administrative order of SMBR. Such like administrative order is neither a process recognized by the Rules on the subject nor is logical because in the presence of Departmental Promotion Committee, no authority, even the Chief Secretary, cannot promote any person to any post without the process of approval by a Departmental Promotion Committee. (Copy of the Seniority List is at Annexure "G").
- 11) That the seniority list has been issued at the back of the petitioners as the same has not been circulated amongst the petitioners as required by law.
- 12) That the seniority list shows that promotions have been ordered every 2/3 days which tells upon the working of one of the most important department of the province.
- 13) That the respondents No. 1 to 3 are busy in processing further cases of promotion without adopting the proper procedure in accordance with rules on the subject. Any such orders, if issued, during the pendency of this writ

14) That the attitude of the Respondents No.1 to 3 is arbitrary, arrogant, motivated by favouritism, against the law and facts and liable to be stopped through interim order to save the career of the petitioners who are young and are likely to suffer irreparable loss.

15) That feeling aggrieved, the petitioners have no other adequate remedy under the existing law of the land but to approach this Hon'ble Court through this writ petition with the request to set aside the impugned promotion orders on the following, amongst others;

Grounds:



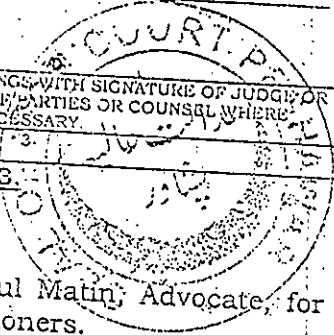

Respectfully Sheweth:

- 1) That the applicant / appellant has filed an appeal in this Hon'ble Tribunal.
- 2) That the date of hearing is yet to be fixed in the same.
- 3) That Respondents No.1 to 3 are about to process the case of promotion without finalizing a Joint Seniority List as required by column 7 Clause (b) of Entry No.1 in the Tehsildar / Naib Tehsildar / subordinate Revenue Staff Service Rules 2008 as last amended on 02/12/2011.
- 4) That the respondents are ignoring the basic qualification of graduation required for promotion to the post of Tehsildar.
- 5) That the respondents are also bent upon keeping ineligible officials on the post of Tehsildar for reasons other than merit as is evident from notification No.Estt:I/26/2271-79 dated 24/01/2014. (Copy attached as Annexure "K").
- 6) That the respondents are required to be stopped through an injunction order from committing illegalities resulting in injustice to the applicant /appellant.

- 7) That the applicant /appellant being qualified and eligible for consideration for promotion to the post of Tehsildar is being kept at bay through the illegal orders of respondent No.1 to 3.
- 8) That the balance of convenience also lies in favour of the applicant / appellant.
- 9) That if respondents No.1 to 3 are not stopped from this illegality, the applicant / appellant is going to suffer irreparably.
- 10) That the action of respondents No.1 to 3 is not only illegal but also malafide, person-specific and the result of favouritism.

It is, therefore, humbly prayed that on acceptance of this application an injunction be issued against respondents No.1 to 3 not to process promotion cases in the absence of a Joint Seniority List and not to give charge of the post of Tehsildar to those officials who are not eligible to be considered for promotion to the said post.

1/296/AMENDMENT DATED: - 03.01.2014

Respected Sir,

The following few lines are submitted for kind consideration:-

- 1) That the petitioner was recruited as Nibe Tehsildar on the recommendation of Public Service Commission Khyber Pakhtunkhwa as a result of competitive examination in 2009.
- 2) That as per Tehsildar, Naibe Tehsildar/Subordinate Revenue Service Rule, 2008, the post of Tehsildar was to be filled in to the extent of 20% by initial recruitment, 60% from amongst Nibe Tehsildars and 20% from officials of various branches of Revenue Administration but for all categories the minimum qualification was 2nd class graduation from a recognized university.
- 3) That in the year 2011, these rules were amended twice making officials like District Qanungo, District

Revenue Accountant, Head Clerk (Revenue) and Sub-Registrar eligible to be considered for the post of Tehsildar against the 60% quota henceforth exclusively reserved for Nibe Tehsildar thus greatly jeopardizing their career prospects.

- 4) That the minimum qualification for promotion still remained 2nd class Graduation throughout these amendments as column No. 5 of the appendix to the Rules was not touched.
- 5) That despite this legal position, about 38 officials were promoted as Tehsildars vide order No. Estt 1/26-11338 dated 04/06/2013, majority of whome were not Graduates.
- 6) That the petitioner felt aggrieved by this illegality and filled a Writ Petition challenging the said promotion order on various grounds, including the consideration of non-graduates. Since the question of eligibility was raised therefore, the Hon'ble High Court was vide order dated 05/11/2013 pleased to send the write petition to this Department for Consideration and processing the same as Departmental Representation. (Copy of the order is attached herewith as Annexure "A")
- 7) That your kind self was pleased to grant an audience to the aggrieved Naib Tehsildars, including the petitioner, in November 2013 and was more

gracious to appreciate the legal position regarding educational qualification and directed the office to send the case to the Chief Secretary KPK for withdrawal of the impugned promotion order.

- 8) That to the dismay of the petitioner, instead of appreciating all the legal points raised in the writ petition and correcting the wrongs done, this corrigendum has been issued practically with drawing the graduation clause with retrospective effect. (Copy of corrigendum is attached as Annexure "B")
- 9) That the corrigendum was never conveyed to anyone of the affected person and the petitioner only come to know of it two days back.
- 10) That nobody knows it better than you good self that an amendment can be made in existing Rules only by adopting the set procedure meant for promulgation of the Rules under the law.
- 11) That according to the Appointment, Transfer & Promotion Rule 1989, amendment can be introduced in existing Rules through the forum of Standing Service Rules Committee only. It is apparent from this notification that the desired deletion of graduation was not processed through the said SSRC.

12) That as is apparent from the notification, 'if this deletion was approved by SSRC back in 2011, but was not notified then legally it cannot be incorporated in the existing Rules without having resort to the same forum.

13) That there is no gain saying that, as held by the Apex court in many cases, even the introduction of a "full stop" or "comma" would need the adoption of the set procedure of legislation both for principal as well as subordinate legislation.

14) That due to the above anomalies, the corrigendum is illegal, arbitrary, ultra vires and person specific, hence not tenable in the eyes of law on the following, amongst other:-

Grounds:

a) That the corrigendum amounts to introducing subordinate legislation with retrospective effect which the Constitution of the country and the law on the subject does not allow, hence is not only ultra vires but illegal as well.

b) That the corrigendum is an effort to circumvent and by pass the legal procedure put forth by law and followed since decades for making service Rules for transparent administration.

- c) That the Corrigendum has been issued in violation of the Rules of Business as the Law Department has not approved the same in its present form and the present phrase and words;
- d) That the so called Corrigendum is meant to block the way of ensuring the progress of Educated persons and is against the policy of merit and encouragement of Higher Education.

It is therefore, humbly prayed that the said Corrigendum at 03.01.2014 may be immediately withdrawn to save the career of Educated officials.

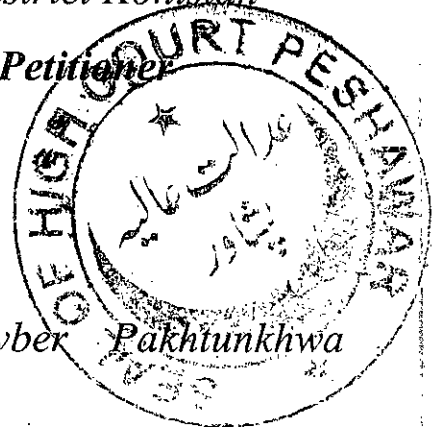

The petitioner submits as under:

- 1) That the petitioner was recruited as Naib Tehsildar in 2009 as a result of competitive examination conducted by Provincial Public Service Commission Khyber Pakhtunkhwa.
- 2) That according to Tehsildar, Naib Tehsildar / Subordinate Revenue Service Rules 2008 originally the Post of Tehsildar was to be filled in Under Clause (a) to the extent of 20% by initial recruitment, Under Clause (b) to the extent of 60% by promotion from Naib Tehsildar and Under Clause (c) to the extent of 20% from the official working in various branches of Revenue Administration but for all the categories the minimum educational qualification was second class Graduation from a recognized university. (Copy of the Rules is at Annexure "A").
- 3) That two amendments were introduced in the said Rules within one year i.e. 2011 whereby District Qanungos, District Revenue Accountants, Head Clerk and Sub-Registrars were included in the 60% Quota henceforth exclusively meant for Naib Tehsildar's, thereby jeopardizing the chances of career-development of the petitioner as a result of malafide on the part of respondents.

- 4) That 38 officials were promoted as Tehsildars by the respondents, vide order No. Estt:1/26-11338 dated 04/06/2013. Majority of these were non-graduates while some of them were promoted through administrative orders against the rules. (Copy of the order is at Annexure "B" while copy of the seniority List is at Annexure "C").
- 5) That the petitioner challenged this order by filing a writ petition No. 1720-P/2013 in this Hon'ble Court. Since the question of eligibility was involved, therefore, this Hon'ble Court was pleased to send the said Writ petition to the respondents for considering the same as Departmental Representation vide this Court order, dated 05/11/2013.
