Through the instant appeal under Section-4 of the Khyber Pakhtunkhwa Service Tribunal Act 1974, the appellant has prayed for released of his monthly salary which has been allegedly with held by the respondents. Against the said act of the respondents the appellant filed departmental appeal on 09.05.2013 which has not been responded and thereafter the appellant filed Civil Suit in the Court of Senior Civil Judge. The respondents contested Civil Suit and submitted written statement whereas respondents admitted that the appellant was appointed as PST, however his salary was stopped due to non verification of his documents. Civil Suit was eventually returned by the learned Senior Civil Judge under ⁰⁻⁷ Rule 10 CPC. The learned counsel for the appellant argued before the Court that since salary of the appellant stopped without any justification, therefore, no limitation runs in such matter. In this respect he relied on 2009 PLC (C.S) 178. ~~Since~~ The appellant has continues cause of action, as his salary has been with held, in view of Section-23 of limitation Act 1908.

PRAYER.

On acceptance of the instant appeal, the respondents may kindly be directed to release the monthly salaries along with other allowance and other benefits , if any, from the date of his taking over the charge of the above said post and on ward too.

INTERIM RELIEF.

To release the monthly salary of the appellant till the disposal of the above subject Service Appeal.

RESPECTFULLY SHEWETH.

1. *That, the appellant is a bonafide resident of Tajazai Tehsil and District, Lakki Marwat. Copy of CNIC is annexed herewith as ANNEXURE-"A".*
2. *That, the appellant was appointed as PST vide appointment order No.498-502/DO (F/S) PST (F) dated 21/01/2013. Copy of the appointment order of the appellant is also annexed as ANNEXURE-"B".*
3. *That, after obtaining medical fitness certificate, the appellant had taken over the charge of the post of PST at G.P.S. Saddique Abad Tajazai District, Lakki Marwat. Copies of Medical Fitness Certificate and Charge Report are annexed as ANNEXURE-"C" & "D", respectively.*
4. *That, after taking over the charge of the above said post, the appellant is performing his duty at the above said post, so honestly and regularly but even then his monthly salaries have been stopped by the respondents without any cogent reason. Copy of the attendance register of P.S.Ts of the above said school is ANNEXURE-"E".*
5. *That, the appellant then filed a Departmental Appeal for the release of his monthly pay to the respondent No.2, on*

20/05/2013, through Registry of Post Office but till yet the said departmental appeal has not been disposed off and is still pending without any proceedings. Copy of the Departmental Appeal is ANNEXURE-"F".

6. That, on 11/09/2013, the appellant filed a Civil Suit No.246 /1 of 2014 along with an application for temporary injunction, in the Court of learned Civil Judge-VI, Lakki Marwat. Copy of the said Civil Suit and an application for temporary injunction are annexed as ANNEXURE-"G", & "G/1", respectively.
7. That, on 01/02/2014, the representative of the respondents submitted their statement along with reply statement to the learned trial Court wherein the respondents had taken the plea for the stoppage of salary of the appellant only the verification of the documents of the appellant. Copies of the written statement and "Jawab-ul-Darkhwast" are annexed as ANNEXURE-"H" & "H/1", respectively.
8. That the learned Civil Judge-VI, Lakki Marwat vide order dated 25/03/2014 declared that the Proviso of salary to the civil servant has been laid down in N.W.F.P.(KPK) Civil Servant Act, 1973, as such the matter relating to the salary of the civil servant has a directed nexus with the terms and conditions of his service and that the Service Tribunal alone is appropriate forum having jurisdiction to deal with matters relating to the terms and conditions of civil servants. The learned Civil Judge-VI, Lakki Marwat returned the Suit under O.7, R.10 C.P.C to the appellant with the direction to

file the Service Appeal before the proper forum. Copy of the said order is annexed as ANNEXURE-"I".

9. *That now the appellant approaches this Honourable Tribunal for the release of his monthly salary and allowances etc, interalia, on the following grounds:*

GROUND:

- a) *That, the stoppage of the monthly salaries of the appellant by the respondents is based on malafide.*
- b) *That, the appellant is performing his duty regularly and so honestly. That the appellant is a Civil Servant within the meaning of NWFP (KPK) Civil Servant Act, 1973 and is performing his duty hence entitle to receive the salary. It is well established principle borrowed from the Islamic Law that an employee be paid his salary before his sweat is dried.*
- c) *That, the appellant continuously performing his duty till yet and his post as PST is still in existence, therefore, the government is bound to pay the salary and other allowance to him from the date of his taking over the charge i.e. from 01/03/2013 as provided U/S 17 of the Civil Servants Act, 1973 and also by virtue of Articles 212 of the Constitution of the Islamic Republic of Pakistan read with N.W.F.P.(K.P.K) Civil Servant Act, 1973.*
- d) *That, the ADO (Education) had conducted the usual inspection of the above said school from time to time who found the duty and performance of the appellant to be satisfactory. The ADO also found the P.S.Ts and other staff to be present at their duties; the ADO inspected the above said*

school on 13/03/2014 and found the students busy in solving their papers of Annual Examination. Copies of the Log Books are also annexed as ANNEXURE-"J"

- e) That, there is no complaint against the appellant on record which can be made a base for stoppage of his monthly salary.
- f) That, there is no Rules in any Government / Non-Government Department etc to stop the monthly salary or other payable dues of any employee without any cogent and valid reason.
- g) That, the only plea of the respondents which they have taken in their written statement for the release of the monthly salary was subject to verification of the documents of the appellant but till yet they are not releasing the monthly salary of the appellant which is questionable.
- h) That, the appellant's Counsel may kindly be allowed to explain further the facts and grounds of the instant appeal during its hearing..

In wake of the above submissions it is respectfully prayed that on acceptance of this appeal, the respondents may kindly be directed to release the monthly salary and other dues etc of the appellant from the date of taking over the charge of his post and onward too.

(a) Service Tribunals Act (LXX of 1973)---

---S. 4---Appeal---Limitation---Appeal by appellant was resisted on ground that the same was time-barred as appellant had prayed for move-over w.e.f. 1-12-1996 whereas appeal had been filed on 13-9-2000---Validity---Appellant had a continuing cause of action as he had been deprived of extension of his pay by move-over---Every month appellant was getting lesser pay, a fresh cause of action was accruing in his favour every month---In view of provisions of S.23 of Limitation Act, 1908 which dealt with cases of continuing causes of action, appeal by appellant was not barred by time as he had a continuing cause of action and wrong done to him had not been redressed.

(b) Civil service---

---Move-over, entitlement to---Effect of minor penalty imposed on employee---Authorities had not allowed move-over to employee for the reason that penalty of recovery of amount had been imposed on him---Minor penalty was not a hurdle in promotion of civil servant---When minor penalty was not a hurdle in promotion of a civil servant, it could never be a hurdle in grant of move-over to him because move-over was simply an extension in his pay scale---Imposition of penalty of recovery of amount from him, was not a ground for refusing move-over---Authorities stated that the facility of mover-over had been discontinued by Federal Government vide its notification---Said Notification did not have retrospective effect---Claim of employee was for a period much prior to issuance of said Notification---On basis of said letter/ Notification, Authorities were not justified in refusing grant of move over to employee from date it was due---Authorities were directed to grant move-over to employee from date it was actually due to him---Penalty of recovery of amount would not be a hurdle in grant of move-over to him.

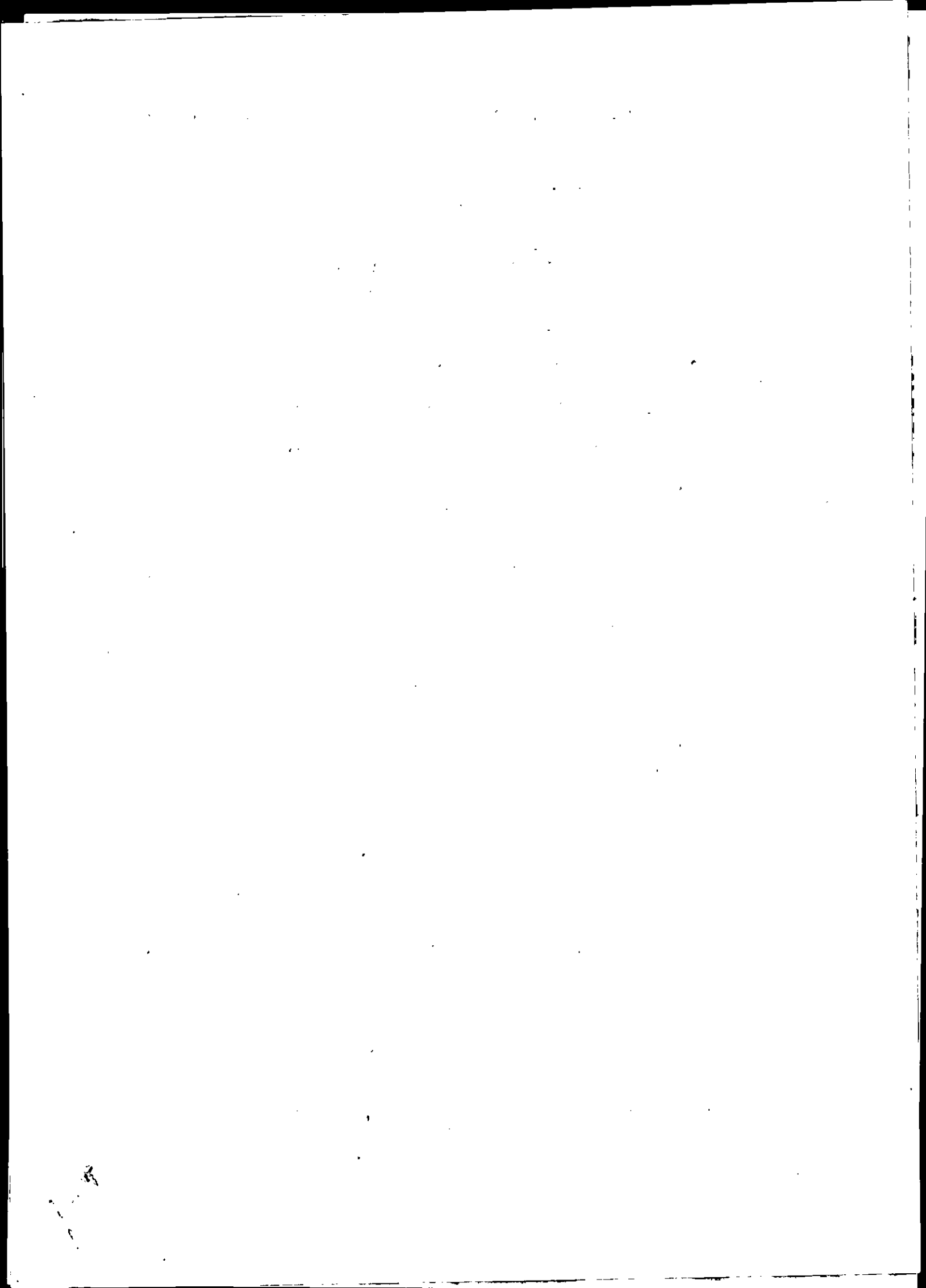

JUDGMENT



had been imposed upon him which had even been maintained by the Federal Service Tribunal in the earlier appeal filed by him. It is settled law that a minor penalty is not a hurdle in the promotion of a Civil Servant. When minor penalty is not a hurdle in the promotion of a Civil Servant it can never be a hurdle in the grant of move-over to him because move-over is simple an extension in his pay scale. Reliance is placed on 1996 PLC (C.S.) 986. We accordingly hold that imposition of penalty of recovery of Rs.6,000 was not a ground for refusing move-over to the appellant.

7. According to the respondents the facility of move-over has been discontinued by the Federal Government vide its notification dated 30-1-2002. This notification does not have retrospective effect. The claim of the appellant is for a period much prior to the issuance of this letter by the Federal Government. On the basis of this letter the respondents were not justified in refusing the grant of move-over to the appellant from the date it was due.

8. No further argument has been advanced.

9. For the foregoing reasons we accept the appeal and direct the respondents to grant move-over to the appellant from the date it was actually due to him. The penalty of recovery of Rs.6,000 shall not be a hindrance in the grant of move over to him.

10. There shall be no order as to costs. Parties be informed.
