



RESPONDENTS, VIDE WHICH THE APPELLANT WAS TRANSFERRED IS CLEAR VIOLATION OF LAW, EXCESS OF JURISDICTION, DISCRIMINATORY, ILLEGAL AND VIOD.

**Prayer.**

ON ACCEPTING OF THIS APPEAL, ORDER DATED 12.02.2014 OF RESPONDENT NO.2 AND ORDER DATED 17.04.2014 OF RESPONDENTS, VIDE WHICH THE APPELLANT WAS TRANSFERRED MAY PLEASE BE DECLARED CLEAR VIOLATION OF LAW, EXCESS OF JURISDICTION, DISCRIMINATORY, ILLEGAL AND VIOD AND WITHDRAWN.

Respectfull sheweth,

Appellant submits as under,

- 1 That the petitioner is a govt. servant and appointed as junior clerk in education department.
- 2 That lastly the appellant was posted to DEO Female Office Haripur through order no.5151-57 dated 08.05.2013 where he was performing his duties efficaciously.

- 3 That the petitioner was posted to said seat on medical grounds as due to accident the appellant got disability.
- 4 That after formation of present Govt: the local MPA PK.50 and his supporter threatened the appellant and compelled to get transfer from the said seat and the appellant did not admitted the said order as he was unable to travel to a far area due to disability so as to save his skin from continuous threats of MPA PK.50 and his allies, the appellant approached DC Haripur and after going through due process DC Haripur attached the appellant with the office of Additional Assistant Commissioner-I on detailment through order no.1359-62 dated 11.02.2014.
- 5 That the appellant worked in Office of Additional Assistant Commissioner –I till 07.04.2014 and on that date he receive a letter from the said office in back dates order of appellant was made to GGHS Sarai Nehmat khan and he was relieved in back dates and it was also came to knowledge of

appellant that his salary in AAC office was issued from Sarai Nehmat Khan School.

- 6 That the entire game was planned with the appellant only to stop his right of stay from court and to shatter his right of appeal.
- 7 That the appellant preferred departmental appeal before authority which was rejected on 7.04.2014 hence this appeal is filed interalia on the following grounds.

### **Grounds of appeal**

- (a) That the order of respondents is without legal force due to violation of law indirectly effecting the petitioner hence challenged by petitioner and liable to set aside.
- (b) That the orders made by the respondents are discriminatory and a part of political campaign of Govt: MPA PK.50.
- (c) That the tenure on the said post was not completed and order was made due to

colourful exercise of power by authority as in proof of the same it is submitted that impugned transfer order copy was forwarded to MPA PK.50.

- (d) That the order of rejection of departmental representation of appellant is clear that in it is clearly written that it was mad on political interference.
- (e) That the appellant is deserving candidate for posting at near place of home as the Govt: has signed the convention on person with disability (medical certificate annexed.
- (f) That the wife of appellant is also Govt: servant and appellant is entitle to posted in location near her.
- (g) That the rights of petitioner have been violated only due to promote relationing and politics and no criteria and legal way have been adopted to make these orders and these orders seems command of a dictator.

- (h) That the impugned order are against the norms of justice and equity and law hence liable to setaside.
- (i) That the impugned orders are made in sheer violation of transfer policy.
- (j) That the office order has been passed in haste and following the political command and will without adhering to the precedent laid down by this Honorable court, , hence liable to be reversed.
- (k) That the office order passed by the Respondents is against the principles of natural justice and norms settled by the law that every decision will be passed in the administration of justice and nothing should be arbitrary.
- (l) That the office orders of the Respondents are based on mala fide, hence, lay no effect on the valuable rights of the Petitioner.
- (m) That the orders of the Respondents are arbitrary in nature and violation of the provisions of Constitution which clearly provides that every citizen must be dealt with according to the provision of constitution and rule of law must prevail instead of personal aspiration and inspirations.

(n) That the appeal is well in time and this honourable court has jurisdiction in the matter.

In the light of above mention averments it is submitted that while accepting this appeal the impugned orders may graciously be setaside with cost throughout and any other relief which has not been specifically pleaded may also be given.
