ON FACTS:

The appellant submits are as under:-

- 1** That the appellant joined the respondent Department vide order dated 25-11-1974. That right from appointment till date appellant has served the respondent Department for more than 39 years quite, efficiently and upto the entire satisfaction of his superiors. Copy of the service book is attached as annexure **A.**
- 2** That later on the appellant was promoted /confirmed in the rank of Sub-inspector (BPS-14) vide order dated 12-12-2007 & was brought on list "F". Copy of the order is attached as annexure **B.**
- 3** That appellant while working as officiating Inspector (BPS-16) was confirmed as Inspector vide order dated 23.12.2011. Copy of the order is attached as annexure **D.**
- 4** That recently the respondents has issued final seniority list of inspector vide notification dated 15-3-2013 due to which the appellant date of birth and appointment order has wrongly been enlisted as I.e .21-11-1954 which is Infact 1-5-1957 and first appointment order has 1-12-1976 which is Infact 25-11-1974. Copies of the seniority list of 28-8-1986, CNIC, School leaving certificate and date of birth are attached as annexure**E, F, G & H.**

- 5 That feeling aggrieved appellant filed Departmental appeal against the impugned seniority list dated 15-3-2013, communicated to the appellant on 6-4-2013 but the same was regretted by respondent No 1, on no good grounds, vide order dated 13.6.2013 communicated to the appellant on 24.7.2013. Copies of the Departmental appeal and rejection order are attached as annexure

I & J.

GROUND:

- A- That the impugned orders dated 15-3-2013 and 13-6-2013 are against law, facts, norms of natural justice and material on record, hence not tenable and liable to be set aside.
- B- That the appellant has not been treated by the respondent Department in accordance with law and rules on the subject noted above and as such the respondents violated Article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.
- C- That inspite of clear entries in the CNIC and appointment order the respondent Department acted in un-educated manner while enlisting the appellant date of birth and appointment order in the impugned seniority list dated 15-3-2013.
- D- That the respondent Department treated the appellant not in accordance with law and rules and as such the respondent Department acted in arbitrary and malifide manners while issuing the impugned seniority list dated 15-3-2013.

- E- That according to A.P.T., rules 1989 seniority shall always be reckoned from the date of first regular appointment, therefore the appellant is entitled for his seniority with effect from 25-11-1974 under the above cited rules.
- F- That the appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore most humbly prayed that that the appeal of appellant may be accepted as prayed for.

PARAWISE COMMENTS ON BEHALF OF RESPONDENTS:-

Preliminary Objections

1. That the appeal is not maintainable in the present form.
2. That the appellant has got no cause of action.
3. That the appellant is estopped by his own conduct to file the present appeal.
4. That the appellant has not come to this Honorable Tribunal with clean hands and has concealed material facts.
5. That the appeal is bad for joinder and misjoinder of necessary parties.
6. That the appeal is barred by law.

Facts

- 1) Correct to the extent that appellant was enlisted in Police department as Constable with effect from 25/11/1974, rest of the Para is irrelevant as it has got no concern with the impugned entry of date of birth and the service record of appellant. Furthermore, according to page first of service document of the appellant, his date of birth was recorded 21/11/1954. The entry has been allegedly corrected with no proper Order/certificate of competent authority to this effect. (Copy of first page of service record is enclosed as Annexure "A").

Again the Medical Officer has given the age of appellant 20 years at the time of enlistment which commensurates with the entry date of birth in service book i.e. 25.11.1954.

- 2) This Para of the facts of the appeal is irrelevant as it does not relate to the impugned entry of date of birth of appellant.
- 3) This Para of the facts of the appeal is irrelevant as it does not relate to the impugned entry of date of birth of appellant.
- 4) Incorrect. Seniority list of Police Officers is circulated each year and his date of birth was recorded 21.11.1954 in previous seniority list of the year 2010 & 2011. **(Copies of seniority lists are enclosed as Annexures B & B1)**. Furthermore, according to Police Rules 9-7 and GFR 116, correction in date of birth is allowed within two (02) years of entry into service. Appellant remained silent for long period of more than 30 years, therefore his belated contention is neither justified nor tenable. **(Extracts of Police Rules 9-7 and GFR 116 are enclosed as Annexures (C) & (D))**
- 5) Incorrect. There was no force and substance in the representation of appellant, therefore it was correctly filed.


Grounds


- A. Incorrect, the seniority list is prepared from the service record of the appellant wherein date of birth of the appellant has been recorded 21.11.1954. Moreover, the appellant had applied for correction of date of birth after long period of more than 30 years, therefore his representation was rightly filed.
- B. Incorrect, respondents have prepared the seniority list from the record and appellant was treated in accordance with law and rule. Appellant has not pointed out any instance of his ill-treatment.


- C. Incorrect. The date of birth of appellant has correctly been recorded in service record and alteration at belated stage is against the law and rules on the subject.
- D. Incorrect. This Para is mere repetition of Para B of the ground of appeal and appellant has been treated in accordance with law and rules.
- E. Incorrect. Seniority of Inspector/DSP is not reckoned from the date of enlistment as Constable. Appellant was enlisted as Constable, therefore he is wrongly contending seniority from the date of appointment.
- F. That the respondents may also be allowed to raise additional points and produce record during hearing of the appeal.

Prayer

It is therefore prayed that the appeal may be dismissed with costs.

9.7 Alteration in age

(1) The date of birth shown in the character roll or corresponding record, can be altered only with the sanction of the Inspector General of Police, on production of proof to his satisfaction. If the recorded age does not tally with that certified by an invaliding medical officer, board or committee, and the discrepancy affects the title to pension or liability to superannuation, the matter should be reported and the officer should not be discharged till the orders of the Inspector-General have been received. In the case of an officer whose year of birth or year and month of birth only is known, but not the exact date, the 1st July of the year or 16th of the month, respectively, should be treated as the date of birth for the purpose of calculation of pension, -vide note under Article 283 of the Audit Code, Volume I. The date of birth of all officers enrolled before the 1st October, 1933, may be allowed to remain as already recorded.

(2) Further orders as to the conditions under which alterations of age may be sanctioned are contained in letter No. 20076 (Home Gazette) of 4th July, 1928, from the Chief Secretary to Government, Punjab. According to these orders, an alteration may only be made, after special enquiry, if applied for within two years of the applicant's entry into Government service. The Provincial Government may, however, make a correction in the recorded age of a Government servant at any time, if it is, satisfied that age has been incorrectly recorded with the object that the Government servant may derive unfair advantage.

9.8 Classes of pensions.

Pensions admissible to police officers and menial servant are detailed below

9.9 Invalid pensions

An invalid pension proportionate to the length of service is awarded to a police officer who by bodily or mental infirmity is permanently incapacitated for further service in the police. If the incapacity is directly due to irregular or

115 In cases in which the transfer of charge involves assumption of responsibility for cash, stores, etc., the following instructions should be observed :---

i) The cash book or imprest account should be closed on the date of transfer and a note recorded in it over the signature of both the relieved and the relieving officers, showing the cash and imprest balances, and the number of unused cheques, if any, made over and received by them respectively.

ii) The relieving officer in reporting that the transfer has been completed should bring to notice anything irregular or objectionable in the conduct of business that may have come officially to his notice. He should examine the accounts, count the cash, inspect the stores, count, weight and measure certain selected articles in order to test the accuracy of the returns. He should also describe the state of the account records.

iii) In the case of any sudden casualty occurring or any emergent necessity arising for an officer to quit his charge, the next senior officer of the department present will take charge. When the person who takes charge is not a gazetted officer, he must at once report the circumstances to his nearest departmental superior, and obtain orders as to the cash in hand if any.

Note 1. The special procedure to be followed when there is a change in the incumbency of independent charge of a treasury is laid down in Rule 44 of the Treasury Rules.

Note 2. The additional procedure to be followed by an Accountant General, etc., in making over charge of his function in connection with the Charitable Endowments and other Trust Accounts is laid down in Appendix 16.



DATE OF BIRTH

116 Every person newly appointed to a service or a under Government should at the time of the appointment declare the date of his birth by the Christian era with as far as possible confirmatory documentary evidence such as matriculation certificate, municipal birth certificate and so on. If the exact date is not known, an approximate date may be given. The actual date or the assumed date determined under Para 117 should be recorded in the history of service, service book, or any other record that may be kept in respect of the Government servant's service under Government and once recorded, it cannot be altered, except in the case of a clerical error, without the previous orders of the Local Administration.

Note:-1 Ministries/Division of the Federal Government exercise the powers of a Local Administration for the purpose of this rule.

Note:-2 Heads of departments are authorized to exercise this power in the case of non-gazetted Government servants under their control.

117 1) If a Government servant is unable to state his exact date of birth but can state the year, or year and month of birth, the 1st July or the 16th of the month, respectively, may be treated as the date of his birth.

2) If he is only able to state his approximate age, his date of birth may be assumed to be the corresponding date after deducting the number of years representing his age from his date of appointment.

3) When a person who first entered Military employ is subsequently employed in a Civil department, the date of birth for the purpose of the Civil employment should be the date stated by him at the time of enrolment, or if at the time of enrolment he stated only his age, the date of birth should be deduced with reference to that age according to the method indicated in sub Para (2) above.

Note:-Cases in which the date of birth has been deduced from the age at appointment or enrolment by any other method, need not be reopened.

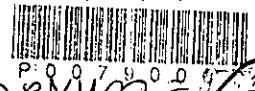



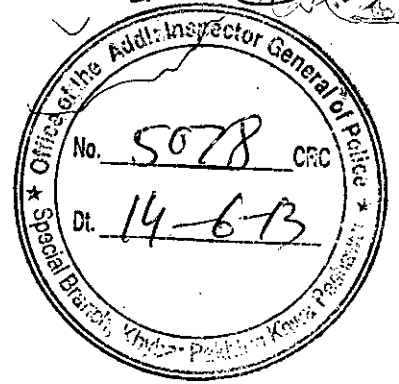
