






APPEAL U/S 4 OF THE KHYBER PAKHTUNKHWA SERVICES TRIBUNAL ACT -1974 AGAINST THE IMPUGNED RULES PERTAINING TO SERVICE STRUCTURE, SHEER DISCRIMINATION, INDISPENSING JUSTICE & MODIFICATION OF RULES ON THE BASIS OF PARITY & FOR PROMOTION, WHERE AGAINST THE APPEALS OF THE APPELLANT WENT FUTILE.

Respectfully Sheweth,

1. That the Appellant is a naturally born *bona-fide* citizen of the Islamic Republic of Pakistan and hails from a respectable family.
2. That after going through the mandatorily required written examination and interview, and after being envisaged with the ordeals & inquisitions of selection process, the Appellant got selected, recommended and appointed as Director Physical

Education (DPE) BPS-16 (It is pertinent to mention here that the same post of DPE had already been upgraded from BPS-16 to BPS-17 back in the year 2008, but even then the Appellant was issued appointment order in BPS-16 instead of BPS-17 which matter is already been impugned by the Appellant and is already pending before the Apex Court of the country in CPLA) via the Khyber Pakhtunkhwa Public Service Commission on the office Order No. **DGTE&MT/ADMIN/7-1(VIII)/4301(1-7)** Dated: **10-09-2011** of the office of the Director General Technical Education & Manpower Training, Peshawar. (Copy of the Appointment Order Dated: **10-09-2011** is annexed here as Annexure "A")

3. That soon after issuance of the Appointment Order of the Appellant, the Respondent rose from their deep slumber & issued a corrigendum bearing No. **DGTE&MT/ADM/7-1(VIII)/4430(1-7)** Dated: **21-09-2011** whereby the place of posting was substituted by the then Khyber Agency to Dir (Upper). (Copy of the Corrigendum Dated: **21-09-2011** is annexed here as Annexure "B")
4. That thus the Appellant is serving as DPE in the Respondent Department since 2011, without any widened prospect of promotion. The grievances, the solace, and the redressal of which the Appellant is seeking from this Hon'ble Tribunal is multi-facet, commencing from the very appointment of the Appellant to this department is inevitably been envisaged with formidable and sheer discrimination initially on the basis of granting BPS-16 instead of BPS-17, with the minimized scope of promotion to next higher scale of BPS-18 and lastly but not the least one, having a discriminative service structure or rather no service structure as compared to their brothers in the same Higher Education Department & the other sibling Departments/Directorate of the same Department i.e., Directorate of Higher Education (Colleges) wherein a **4-tier** formula is prevalent and the brothers of the Appellant i.e. DPEs are called as Lecturers in Physical Education, are being similar to that of their colleagues and ways are paved for them to reach BPS-20 the same way as the colleagues of the General cadre. But, when it comes to the Appellant, the situation is *volta-facie*. Besides, the sister department of General colleges there is yet another department of education under the nomenclature of Elementary & Secondary Education wherein there used to be the same post of DPE. But now, they have applied the same *four-tire* formula since the year 2017 by calling them respectively as Instructor of Physical Education (BPS-17),

Senior Instructor (BPS-18), Chief Instructor (BPS-19) and Principal (BPS-20). More so, in the same Directorate of the Appellant i.e., Directorate of Commerce Education & Management Sciences, there is implemented the *4-tier* formula since 2017 wherein even the cadre of the Appellant is mentioned in that of teaching cadre and the cadre is thus reflected in the same notification of *4-tier* formula but still only the two-tier formula is made applied to the cadre of the Appellant for all intents & purposes and thus the Appellant and all colleagues of the cadres are being envisaged to the repeated episodes of sheer discrimination. **(Copy of the Notification No. SO(CE&MS)HED/1-8/:28(1-13) Dated: 02-02-2017, FD/SO(FR)10-22/2017-18/Vol-I-II/6260 Dated: 29-11-2017, Colleges Elementary & Secondary Education & Notification No. SO(B&A)1-18/17/DPEs Dated: 14-11-2017 are annexed here as Annexure "C" , "D" & "E")**

5. That not only the Appellant is being faced with the above-mentioned different spades of discriminative action, but as well as not has been promoted to the next pay scale of BPS-18 for no good reasons or rather no reasons at all. There has been a formula of 25% quota reserved for promotion of DPEs the same way as that of the librarians. The posts of librarians were enhanced in their quota reserved for promotion from 25% to 33% in 2015 whereafter work is going on to apply the same *4-tier* formula to the post of Librarians, but at present the magnitude of 33 percent is applied now. But the amount of sheer and unfettered discrimination can be gauged from the simple fact that now the quota of librarians was enhanced from 25 percent as to 33 percent while at the same time the DPEs are steering their ways for equal treatment. **(Copies of Notification No. (CE&MS)/1-27/2015:3946 Dated: 08-12-2017 is annexed here as Annexure "F")**
6. That the story did not end here but rather it went much beyond. Some of the colleagues of the Appellants have been promoted to BPS-18, even without applying the formula of 25% and that too solely on the ground of having experience of 5 years. But on the other hand, the Appellant is having the experience of more than 11 years but has been kept at abbey from any prospect of promotion. **(Copies of the Notification No. SO(G-IV)/HE/17-30/2012 Dated: 21-09-2015 is annexed here as Annexure "G")**

7. That this is how the appellant has repeatedly been stripped off and flayed off his due rights; in the form of non- promotion at due time and non- modification of rules, of structure pertinent to his cadre which constraint the appellant to knock door of competent forum for redressal of his grievances, but every effort on part of appellant went futile and ended in fiasco. **(Copies of the Application & Reminders are annexed here as Annexure "H")**
8. That feeling highly aggrieved, the Appellant approaches this Hon'ble Tribunal for service structure, 4 tier formula and his due promotion with all back benefits, upon the following grounds, inter-alia:

GROUND:

- A. That the Appellant is a naturally born *bona-fide* citizen of Islamic Republic of Pakistan and is fully and equally, on equality basis, entitled to and basic and fundamental rights on enshrined in the fundamental law of the land, interpreted, acknowledge, and enforced by the law of the land and any discrimination or unfettered exercise of discretionary powers public functionaries is always chucked away and chucked down by law and law court of the land.
- B. That it also a cherished principle of law that where law requires a thing to be done in a manner, the same is to be done in that vary manner and not otherwise.
- C. That discrimination and particularly, unfettered, and sheer discrimination in any form is highly deplorable and has always been depreciated, deprecated and has always been discouraged by the law.
- D. The before going to vent out spleen and jotted down further grounds, it would be noteworthy to mention here that in commerce colleges there are two types of cadres, one pertaining to Management and the other is teaching. The appellant and his cadre fall in teaching cadre and thus is equally entitled to be treated the same way as the members of the teaching cadre and thus the **4-tier** is applicable to the appellant for all intends and purpose. In the management cadre of the management colleges there comes Principal, Account Officers, Ministerial staff and their subordinates, and they have no nexus with the Appellant or his cadre which exclusively falls in the teaching cadre.

- E. That is also pertinent to mention here that, Commerce colleges are affiliated with both Boards in term of conducting and carrying examination and issuing certificates i.e., Board of Intermediate and Secondary Education as well as Board of Technical Education. In fact, in Commerce colleges, these are taught as subjects of Inter-Science which is carried by general Boards of Elementary and Secondary Education while for the rest of Commerce subjects the examinations are carried by Technical Board.
- F. That it is also of worth to note here that the subject of Health & Physical Education is now taught as a subject and examination via the written papers are carried in all colleges and Commerce Colleges and even in Higher Secondary Schools. In this respect, a notification is also issued vide dated: **13-09-2018** from BISE Kohat which is an ample proof that Health & Physical Education is a discipline, and its teachers/instructors/directors/lecturers are liable to be & entitled to be meted out with the same treatment as being extended, sanctioned & granted to the teachers/lecturers of any discipline or subject. **(Copy of subject Notification Dated 13/09/2018 is annexed here as Annexure here-with)**
- G. That where the nature of the job and manner and mode of selection of all DPEs are the same i.e., DPEs in general colleges, DPEs in Elementary and Secondary Department & DPEs in Commerce Colleges all have to come through Public Service Commission; all are in BPS-17; Nature of the job, duty hours and nature of responsibilities are all the same. But not only the nomenclature nowadays assigned to DPEs in general colleges, that of the Lecturer in Physical Education, Physical Instructors in Elementary & Secondary Education, while the same former nomenclature to the DPEs of Commerce colleges, which all of them had formerly been called as DPEs where it may be. So, any discrimination in the perks & privileges amongst these three types of DPEs would be a sheer discrimination which cannot be justified under any cannon of law.
- H. That where the DPEs of Commerce colleges are standing on the same footings as that of the Lecturer in Physical Education in general colleges as well as the Physical Instructor in the Higher Secondary Schools and where the *4-tier* formula is applied to rest both DPEs, then how come the Appellant is deprived of the same *4-tier* formula?

- I. That, besides above the same 4-tier formula is prevalent in the directorate of the Appellant, which is prevalent since the year 2017. Interestingly, in the Notification No. (CE&MS)/1-27/2015;3946(i-i) Dated:08-12-2017 the subject/cadre/post of the Appellant has been mentioned as the teaching cadre for all intents & purposes, but when it comes to the perks & privileges, only a two-tier formula is made applicable to the Appellant and his cadre, which is yet another episode of unjustified discrimination.
- J. That the story did not end here. There used to be 25 percent promotion posts reserved for the DPEs as well for Librarians. The same 25 percent was reserved for the Librarians which was later enhances to 33 percent and almost all the Librarians working in Commerce Education Directorate are having chances of the further promotion wherein 33 percent. But on the other hand, the DPEs who are standing on the pedestrian, being integral part of teaching cadre are not only kept at abbey from 4-tier formula, but are given only the same, the previously allocated quota of 25 percent, which has halted the way of Appellant from any promotion from the last 11 long years, nor there is any future prospect of any promotion as because of the narrow mechanism provided for promotion.
- K. That even so many colleagues of the Appellant who joined the Directorate of colleges and of Elementary & Secondary Education and are quite juniors from the Appellant are now working in BPS-19 as against BPS-17 of the Appellant which as fact for the self is sufficient to prove the deprivation and despondency of the Appellant of his due and fundamental rights.
- L. That it is also pertinent to mention here that even some of the colleagues of the Appellant have bene promoted to BPS-18 without applying the formula of 25 percent and that too on the sole ground of having 5 years' experience on their part, while at the same time the Appellant has simply been shunt down without any rim or reasons inspite of having long 11 years of experience on his part.
- M. That from all prospective, the Appellant and his colleagues of the cadre of Health & Physical Education are equally entitled to be applied 4-tier formula as prevalent to their colleagues in the directorate of colleges and directorate of Elementary & Secondary Education as well as in his own directorate of Commerce Education and that too with the retrospective effect

w.e.f the same date when all the colleagues were brought under the umbrella of the 4-tier formula.

N. That any other ground not raised here may graciously be allowed to be raised at the time of arguments.

It is, therefore, most humbly prayed that on acceptance of the instant Service Appeal,

- (i)** *The Appellant and his cadre be provided and extended a service structure by applying the 4-tier formula as applicable and applied in the directorate of higher education (General Colleges) and to bring at par with their colleagues in the general college under Directorate of Higher Education for all intents and purposes and to modify rules in this respect and to that effect;*
- (ii)** *It is further prayed that the Respondent Directorate of Commerce be directed to modify its rules by bringing the Appellant and his cadre at par with the DPEs of the Elementary & Secondary Education KPK by applying their 4-tier formula to the appellant. (If the first part of the prayer is not feasible in these circumstances);*
- (iii)** *It is further prayed that in case both the prayers above are not feasible (which although is not acceptable to the Appellant) then the same 4-tier formula Dated 2017 prevalent in the very Directorate of the Appellant and even the cadre of the Appellant has been mentioned as teaching cadre, then the same 4-tier formula be applied to the Appellant and his cadre for all intents and purposes and to direct the Respondents to carry necessary amendment and modification in the relevant notifications;*
- (iv)** *It is further prayed that the Appellant be promoted to the next pay scale BPS-18 by bringing necessary modification*

in the notification applied with all back benefits and in alternative to promote the Appellant by enclosing the quota reserved from 25 to 33% or on the same way as the colleagues of the Appellant the promoted without applying 25% quota system.

- (v) *Any other relief not specifically asked for may also graciously be extended in favor of the appellant in the circumstances of the case.*

- 3- Their services shall be liable to termination on one month's notice from either side. In case of resignation without notice, their one-month's pay shall be forfeited to the Government.

- 5- They will be governed by such rules and regulations as may be issued from time to time by the Government for the category of Government Servants to which they belong.
- 6- They will not contribute to G. P. Fund and shall not be entitled to pension, Gratuity benefits. They will for all intents and purposes be Civil servants except for the purpose of Pension and gratuity. In lieu of the same, they will be entitled to receive C.P. Fund. For the said fund 10% contribution will be made by the Provincial Government and 10% by the Civil servants concerned in the prescribed manner.

- 8- They should join the post within 30 days of the issue of this order otherwise the offer of appointment will be treated as cancelled.
