The departmental appeal against the impugned order dated 12.05.2020 was filed on 05.06.2020, which was rejected on 27.07.2020, and the present appeal was filed on If the limitation is reckoned from the date of 27.08.2020. decision of appellate authority, it is time barred; because the appeal was required to be preferred within 30 days from the said date. However, it has been filed one day beyond the 30 days. In view of particular legal position to be next discussed herein-after, the bar of limitation for the time-being is immaterial. In wake of COVID, 19, the Government of Khyber Pakhtunkhwa for the first time declared Public Health Emergency in March, 2020 for three months which was extended from time to time for further term and presently it has been extended by the Government vide Notification No. SOG/HD/1-102/Covid-19/2020/3062, dated 30.06.2021 for the period from 01.07.2021 to 30.09.2021. # PARAWISE REPLY BY RESPONDENTS NO 1,2,3 & 4

**RESPECTFULLY SHEWETH:** 

#### Preliminary Objections:-

- 1. That the instant service appeal is not maintainable under the law.
- 2. That the appeal is not based on facts.
- 3. That the appellant has got no cause of action and locus standi.
- 4. That the appellant has concealed the real facts from the honorable Tribunal.
- 5. That the service appeal is bad for miss-joinder and non-joinder of necessary and proper parties.
- 6. That the appellant is estopped to file the service appeal by his own conduct.
- 7. That the appeal is barred by law & limitation.

#### **REPLY ON FACTS:-**

- 1. Pertains to record of ex Political Agent, Mohmand Agency and record is not available with answering respondents.
- 2. Pertains to record of ex-Political Agent Mohmand. Appellant has not

performed duty with answering respondents and remained deserter from official duty during active service.

- 3. Incorrect, Khasadari was in the name of the appellant but due to militancy in District Mohmand, the appellant deserted himself from khasadar service and never personally performed duties as Khasadar/Police. In facts duty was performed by substitute (Iwazi) khasadar on behalf of appellant and salary were paid to the Iwazi Khasadar who actually performing duty. The term "Iwazi" was defined in THE KHYBER PAKHTUNKHWA KHASADAR FORCE (AMENDMENT) ACT, 2020 dated 12<sup>th</sup> August, 2020, Clause (e-i) (Annexure A) is enclosed. When Khasadar Force was merged in KP Police the District Scrutiny Committee recommended Iwazi Khasadar (who performed duties in time of insurgency) for absorption in KP Police, copy of Report/Statement of SDPO Khwaizi (Respondent No.8) (Annexuer B)
- 4. Correct to the extent that the petitioner approached the office concern and the judgment of Honorable Peshawar High Court in writ petition No 5944p/2019 titled Murad Khan and others vs Govt of KPK, dated 13-02-2020, but the appellant failed to provide any cogent justification regarding remaining silent for such a long period pertaining to their restoration of Khasadar Service, hence declared unfit for absorption in KP Police service.
- 5. Incorrect, Respondent No.3/ DPO Mohmand always obeyed the law and directions of Honorable High Court and the case of appellant was decided according to rules/ laws and policies and direction of Honorable Peshawar Highcourt, because the appellant deserted from his services during peak of militancy in Mohmand Tribal district. Hence, in order to maintain peace and

security, the then Political Agent Mohmand Agency arranged "Iwazi" Khasadar, who actually performed duties in place of the appellant in time of insurgency and salaries were paid to the Iwazi Khasadar. The appellant remained silent and never performed duties during militancy in the area, but when peace and order restored and Mohamand tribal district was merged in Khyber Pakhtunkhwa Province and Khasadar Force were merged in KP Police, the appellant filed application to get permanent Police job, for which he was found ineligible and iwazi Khasadar was absorbed in KP Police.

- Pertain to record, both the orders were convincing, based on cogent reasons and in accordance with rules/Policy of Government and the Departmental Appeal being unsatisfactory, hence rejected.
- Appellant has got no cause of action, therefore, the instant appeal may kindly be dismissed on the following grounds.

#### **REPLY ON GROUNDS:**-

- <u>A.</u> Incorrect, both orders of the respondents are based on facts, justice an in accordance with law/ rules and Policy of Government.
- **<u>B.</u>** Incorrect, as explained above the orders are legal and justified under the existing rules/Policy of Government.
- <u>C.</u> Incorrect, as the appellant is not being the regular employee of KP Police, hence there is no record available regarding his services. It is pertinent to mention that in this Para of Service appeal the appellant himself admitted

that he run away to District Charsada and left the duty in Mohmand Agency without any permission.

- **D.** Incorrect, as the appellant was not the employee of KP Police and nor he was discriminated by the respondents. The appellant salaries were paid to the Iwazi Khasadar who performed duty in place of the appellant before merger of erstwhile FATA and after merger the appellant was ineligible for absorption in kp police, hence the Iwazi Khasadar was absorbed in KP Police in accordance with rules.
- <u>E.</u> Incorrect, the reason mentioned in the order of Respondents are totally in accordance with law/rules and based on facts, because the appellant deserted from his services as Khasadar at time of militancy in the area before merger of erstwhile FATA and there is no record available regarding appellant services with answering respondents.
- <u>F.</u> The orders of Respondents are totally in accordance with law/rules and the appellant has not performed duty with answering respondents, therefor he is not entitled for any relief/back benefits.
- <u>G.</u> Incorrect, appellant being not regular employee of KP Police, the service law/rules is only applicable to KP Police employees, in fact the appellant was deserted from his services as khasadar before merger of erstwhile FATA, therefor the orders of respondents are based on facts, law/rules.
- H. Incorrect, the plea of the appellant badly barred by law, in fact he deserted from duty during active service in Mohmand Agency under the command of ex-Political Agent Mohmand Agency and appeared after merger of Mohmand Agency in KP.
- I. Incorrect, the appellant has not done duty before and after merging of Khasadar in Khyber Pakhtunkhwa Police. Appellant is not now employee of KP Police and he is not entitled for any payment under the rules. Respondents have acted in accordance with law/rules and never violated any provision of constitution.

J. Respondent may kindly be allowed to add any other grounds/ documents at the time of hearing.

#### **PRAYERS:**

Keeping in view the above stated facts it is humbly prayed that the appeal being not maintainable, barred by law/ limitation may kindly be dismissed with costs, please.

(First published after having received the assent of the Governor of the Khyber Pakhtunkhwa in the Gazette of the Khyber Pakhtunkhwa, (Extraordinary), dated the 12<sup>th</sup> August, 2020).

to amend the Khyber Pakhtunkhwa Khasadar Force Act, 2019.

WHEREAS it is expedient to amend the Khyber Pakhtunkhwa Khasadar Force Act, 2019 (Khyber Pakhtunkhwa Act No. XXXIV of 2019), for the purposes hereinafter appearing:

It is hereby enacted as follows:-

1. Short title and commencement.--- (1) This Act may be called the Khyber Pakhtunkhwa Khasadar Force (Amendment) Act. 2020.

(2) It shall come into force at once.

2. Amendment of section 2 of the Khyber Pakhtunkhwa Act No. XXXIV of 2019,--- In the Khyber Pakhtunkhwa Khasadar Force Act. 2019 (Khyber Pakhtunkhwa Act No. XXXIV of 2019), hereinafter referred to as the said Act, in section 2, after clause (c), the following new clause shall be inserted, namely:

## 166 KHYBER PAKHTUNKHWA GOVERNMENT GAZETTE, EXTRAORDINARY, 12th AUGUST, 2020.

"(e-i) "Iwazi" means a surrogate member of the Khasadar Force, who is actually performing duties in place of a member of the Khasadar Force and is getting full or split remuneration for the services rendered, whereas the salary is still drawn in name of the one in whose place he is performing such duties in the Khasadar Force;".

3. Amendment of section 3 of the Khyber Pakhtunkhwa Act No. XXXIV of 2019.--- In the said Act. in section 3, in sub-section (1), after the word "members", occurring at the end, the words and comma "or Iwazis, as the case may be" shall be inserted.

4. Repeal of the Khyber Pakhtunkhwa Ordinance No. VIII of 2020.---- The Khyber Pakhtunkhwa Khasadar Force (Amendment) Ordinance, 2020 (Khyber Pakhtunkhwa Ordinance No. VIII of 2020) is hereby repealed.

- 1. Whereas, the above captioned appeals having identical question of law and facts, have
- been clubbed together.
- 2. And whereas, appellants ex-Khassadars of Mohmand Tribal District submitted appeals for their re-instatement in service with back benefits.
- 3. And whereas, after the merger of erstwhile FATA with the Khyber Pakhtunkhwa, Home and Tribal Affairs Department Khyber Pakh Jukhwa has been entrusted with the affairs of the Levies and Khassadars.
- 4. And whereas, the competent authority has been pleased to place the above appeals before the Committee already constituted for such purpose in Home and Tribal Affairs Department Khyber Pakhtunkhwa.
- 5. And whereas, appellants were called for personal hearing on 29.04.2021 and 22.06.2021. Appellants (Rab Nawaz, Rehmat Ullah and Fazal Rabi; and Bilal Mustafa & others) averred that they had regularly performed their duties till 2008 and due to military operation in the area, they were forced to leave their native areas therefore, could not perform duties. Appellants further contended that their colleagues, who were also dismissed on desertion charges were reinstated by the respondent while they have been discriminated by not reinstating in the service.
- 6. And whereas, Representative of Department responded that appellants deserted and left their posts without getting permission of the Commandant/Administration. Further argued that appellants were time and again directed to report for duty but to no avail.

The then District Administration/Commandant Khassadar Furce had managed substitutes/Ewzi in their places.

7. And whereas, the Khassadars Force (Absorption in Khyber Pakhtunkhwa Police Rules 2019, provides absorption of Ewzi/substitute in place of the original Khassadars their substitutes, recommended by the Scrutiny Committee, have been absorbed in

Police Department.

8. Now therefore, after thorough examination of record and hearing the parties, it reveals that appellants showed cowardice and became deserters in the period when

their services were utmost required in war against terror/militancy; they are not fit to be reinstated in the Force. Hence, appeals in hand are dismissed.
