Counsel for the appellant present. Preliminary arguments heard.

The departmental appeal against the impugned order dated 12.05.2020 was filed on 05.06.2020, which was rejected on 27.07.2020, and the present appeal was filed on 27.08.2020. If the limitation is reckoned from the date of decision of appellate authority, it is time barred; because the appeal was required to be preferred within 30 days from the said date. However, it has been filed one day beyond the next 30 days. In view of particular legal position to be discussed herein-after, the bar of limitation for the time-being is immaterial. In wake of COVID, 19, the Government of Khyber Pakhtunkhwa for the first time declared Public Health Emergency in March, 2020 for three months which was extended from time to time for further term and presently it has been extended by the Government vide Notification No. SOG/HD/1-102/Covid-19/2020/3062, dated 30.06.2021 for the period from 01.07.2021 to 30.09.2021. The case of the appellant falls within the period of emergency. In view of Section 30 of the Khyber Pakhtunkhwa Epidemic Control and Emergency Relief Act, 2020, the limitation period provided under any law shall remain frozen. This appeal having been filed after promulgation of the said Act, is not affected by bar of limitation. Excluding the case of appellant from rigors of limitation, his appeal is fit for full hearing. Keeping the



NO 4652/ES DATED 27.07.2020 WHEREBY APPEAL / DEPARTMENTAL PRESENTATION OF THE APPELLANT WAS DISMISSED BY THE RESPONDENT NO. 4 WHICH WAS FILED BY THE APPELLANT AGAINST THE ORDER NO. 2265-67/DPO-M/OSI DATED 12.05.2020 OF RESPONDENT NO. 3 BY VIRTUE OF WHICH THE MAJOR PUNISHMENT OF DISMISSAL FROM SERVICE WAS IMPOSED UPON APPELLANT.

Prayer in Appeal:

On acceptance of this Appeal, the impugned Order in Appeal vide Order No. 4652/ES dated 27.07.2020, order dated 12-05-2020 and Order in Original Dismissal from service may kindly be set aside and the

appellant may please be reinstated into service with all back benefits.

Respectfully Sheweth:

1. That the appellant was induced in service as khasadar/police in the year 2007 *(Copy of Appointment "A")*
2. That due to unblemished record of service and for giving a best performance and so many family members embraced shahadat in war against terror the ~~relative~~ of Appellant malik Muhammad akbar embraced shahadat and awarded by the president of Pakistan a great national award TAMGHA E SHUJAAT. **(Copy of TAMGHA E SHUJAAT is annexed B) "B")**
3. That appellant served as khasadar/police in District mohmand till January 2016 but the Respondent No.8 illegally and forcibly stopped the appellant from duty and also received salary of the Appellant with active connivance of Respondent No 7. **(copy of pay Roll slip is annexed C) & Attendance duty annex C/I.**
4. That the petitioner approached the office concerned but no fruitful result ,thereafter the Appellant file writ petition No 5944-p/2019 titled Murad khan & others vs Govt of kpk which was decided on 13-02-2020 with certain directions **(copy of petition and order is annexed D)**

5. That the Respondent no.3 /DPO Mohmand with out following the law and directions of the high court wrongly decided case of the Appellant on 12-05-2020 (**copy of order dated 12-05-2020 is annexed E**)

6. That being aggrieved from the order dated 12-05-2020 of DPO mohmand the Appellant filed Departmental appeal before Respondent No 2. Which was also dismissed vide order No 4652/ES dated 27-07-2020(**copy of order dated 27-07-2020 is annexed F**)

7. That feeling aggrieved of the impugned order dated 12.05.2020 and Order dated 27.07.2020 whereby the departmental appeal of appellant was dismissed, the appellant is constrained to file the instant appeal on the following grounds inter-alia:-

GROUND:

A. That impugned Order No. 2265-67/DPO M /OSI dated 12.05.2020 of respondent No. 3 by virtue of which the departmental appeal / presentation of appellant was dismissed and Order dated 27.07.2020 of Respondent No. 4 whereby the

appellant was dismissed from service by imposing major penalty are coram non judice, illegal, without jurisdiction, lawful authority, against the principal of natural justice, without any grounds and basis, hence the said Orders are liable to set aside.

- B. That impugned order are illegal and unjust and in violation of rules and law applicable to the matter.
- C. That the appellant rendered unblemished services in the department and acted in accordance to law and to the entire satisfaction of high ups but due to terrorist attacks 14 members of Appellant family embraced shahadat and their houses were destroyed, therefore the Appellant with family rushed to District charsadda to temporary reside and the Appellant continued his duty with zeal and zeast.
- D. That the Respondents are making discrimination with employees, because the Appellant was illegally deprived of his salary and now depriving him from service.
- E. That the reasons mentioned in the order of Respondent No3 / DPO Mohmand dated 12-05-

2020 and Respondent No 4/RPO Mardan dated 27-07-2020 are totally against the law and true facts of the case, because the Appellant was restrained from service which is clear from available record.

- F. That the orders of both forum below are illegal which is liable to be set aside and the Appellant is entitled to allow for official duty and the Appellant is also entitled for salaries along with all back benefits.
- G. That the orders of both forum below and verbal restraining order is against the service law applicable to the matter.
- H. That neither proper inquiry has been conducted nor any show cause notice has been issued to the Appellant
- I. That act/ omission of the authority concerned regarding salaries of Appellant is based on presumption against the official principles which needs to be corrected.
- J. That any other grounds would be adduced by the appellant during arguments on the instant appeal with permission of this Hon'ble Tribunal.

It is, therefore, most humbly prayed that on acceptance of this appeal the impugned Order dated 12.05.2020 and Order dated 27.07.2020 and verbal restraining order may please be set aside and the appellant may please be reinstated in the service with all back benefits.

Malik Muhammad Akbar Mohmand, was a brave tribal elder of Khawezai Khadi Khel. He was chosen as the pioneer head of Aman Committee of his area. The Committee of Khawezai was constituted through a political process in 2008 when the law and order situation in (Sub-Division) Bazai began to deteriorate in retaliation to Government stance against the militants in the area. The peace loving residents of the area began to desert in the face of increasing brutalities of militants. Muhammad Akbar stood like a rock and played an important role in support of LEAs in combating militants and in dismantling of their hideouts in the area. Arrest of Maulvi Umar, the spokesman of TTP from Samghakhi Khawezai was his outstanding achievement. Militants managed to martyr him by exploding an IED planted along roadside on January 14, 2010.

In recognition of his exemplary courage and supreme sacrifice, the President of the Islamic Republic of Pakistan has been pleased to confer on Malik Muhammad Akbar Mohmand (Shaheed), the award of Tamgha-i-Shuja'at (Posthumously).

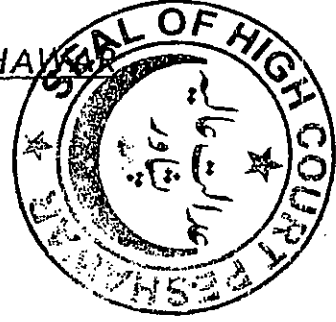

ORDER.

This order will dispose-off Petition remanded by the Honorable Peshawar High Court, Peshawar vide Order dated 13.02.2020 passed in Writ Petition No.5944-P/2019 in the following terms "respondents No.5 & 6 to have a look on the issue brought by the petitioners through the instant writ petition and try to resolve it at their ends after hearing them in accordance with the law and rules on the subject within a period of one month and till then the petitioner's salaries if any, shall not be paid to anybody else".

The petitioners namely Murad Ali s.o Haji Dilawar, Muhammad Hussain s.o Murad Khan, Muhammad Sabir s.o Ali Khan, Muhammad Sadiq s.o Noor Rehman and Ali Akbar Khan s.o Haji Dilawar Khan while serving as Khasadars in Mohmand Tribal District deserted themselves from Khasadar Service during militancy. Hence in order to maintain peace and security, the then Political Administration arranged "Ewazi" in place of these deserters who performed their duties in place of original incumbent during militancy and are to do so till date. It merits mention here that the afore-referred petitioners kept mum from the date of their desertion till the merger. However, when the erstwhile FATA was merged in Khyber Pakhtunkhwa province and the process of absorption of Khasadars in Khyber Pakhtunkhwa Police was initiated, these deserters started filing applications just to restore their service and get permanent Police jobs. Therefore, the petitioners approached the Honorable Peshawar High Court, Peshawar which was decided with the above mentioned directions.

In light of directions vide quoted above, the petitioners were summoned and heard in person but they failed to justify their desertion and approaching the competent forums at a belated stage. Besides, the entire record provided by the District Administration was meticulously perused from which it transpired that the Ewazi who were arranged by the then Political Administration are still performing duties in place of these deserters, therefore, stance taken by the petitioners is totally not based on facts because salaries are being paid to those Ewazi Khasadars who are actually performing duties in place of a member of Khasadar Force (original incumbent). Moreover, the Government of Khyber Pakhtunkhwa through No. LEGIS: 1(4) 2019-Vol-1 date 20.04.2020 has also brought amendment in Section 02 of the Khyber Pakhtunkhwa Khasadar Force Act, 2019 wherein "Ewazi" has properly been defined. The services of Ewazi Khasadars cannot be underestimated as they have rendered their services in the hour of need when terrorism was on its peak in District Mohmand.

Keeping in view the above, the stance taken by the above named petitioners is totally devoid of merit, hence, the petition in hand is filed.

ORDER.

This order will dispose-off the joint departmental appeal preferred by the following Ex-Khasadars namely Murad Khan, Muhammad Hussain, Muhammad Sabir, Muhammad Sadiq and Ali Akbar of Mohmand District Police against the order of District Police Officer, Mohmand, whereby their application, remanded by the Honorable Peshawar High Court, Peshawar vide order dated 13.02.2020 passed in writ petition No. 5944-P/2019, was filed by the District Police Officer, Mohmand vide No. 2265-67/DPO-M/OSI dated 12.05.2020. The appellants preferred the instant joint appeal. They were summoned to Orderly Room. However, one of the appellant Murad Khan claiming to represent the other appellants, appeared before the undersigned in Orderly Room held in this office on 22.07.2020 and heard him in person. He stated in a categorical manner that he is representing the other 04 appellants too. From the careful perusal of record, it transpired that the appellants, while serving as Khasadar in Mohmand Tribal District, deserted themselves from Khasadar Service in the year 2009, when militancy was on its peak. Hence, in order to maintain peace and security, the then Political Administration arranged "Ewazi" in place of these deserters who performed their duties in place of original incumbent during militancy and are performing their duties till date. It is worthwhile that the appellants remained silent from the date of their desertion till merger of erstwhile FATA. But when Mohmand Tribal District was merged in Khyber Pakhtunkhwa Province and the process of absorption of Khasadars in Khyber Pakhtunkhwa was initiated. These deserters sprang into action by filing applications just to get permanent Police Jobs. Besides, none of the appellant advanced any cogent justification regarding remaining silent for such a long time pertaining to their restoration of Khasadar Service. Moreover, the Government of Khyber Pakhtunkhwa vide No. LEGIS: 1 (4) 2019-Vol-1 dtd 20.04.2020 has also brought amendment in Section 02 of the Khyber Pakhtunkhwa Khasadar Force Act, 2019 wherein "Ewazi" has properly been defined.

Based on the appreciation of the aforementioned facts, the stance of appellants regarding restoration of their Khasadar Service is bereft of any substance.

Keeping in view the above, I, Sher Akbar, PSP S.St Regional Police Officer, Mardan, being the appellate authority, find no substance in the appeal, therefore, the same is rejected and filed, being devoid of merit.

(Copy of the Award is Annexure C)
- 3 That some time back Political agent/DC Mohmand verbally restrained the petitioners from official duty while salaries of the, petitioners, were also illegally stopped, the petitioners came to know that the same salaries were malafidely given to one Nadir-Sheer (Constable) Shoulder promoted DSP, without any legal justification.
- 4 That the petitioner approaches to the offices concerned but no fruit full result, resultantly the petitioners file writ petition NO 5944-P/2019 litted Murad Khan etc VS Government of KP etc which was decided on dated 13-02-2020 with certain directions (Copy of the writ petition and order are Annexure D,E).
- 5 That learned DPO Mohmand without following the law and Direction of the High court the case was wrongly decided on dated 12-05-2020, which sheer violation of the Constitution of Islamic Republic of Pakistan, and Services laws applicable to the matter.

- 6 That being aggrieved from the order of DPO Mohmand NO 2265-67/DPO M /OSI dated 12-05-2020, which also against the direction of Honorable Peshawar High Court Judgment dated 13-02-2020, (supra) submitting this Departmental Appeal on the following grounds inter alia:-

Grounds

- a. - b. That order of the DPO Mohmand NO 2265-67/DPO M /OSI dated 12-05-2020 verbal restraining order is against the services laws applicable to the matter.

- d. That the reasons mentioned in the order of DPO Mohmand NO 2265-67/DPO M /OSI dated 12-05-2020 is totally against the true facts of the case, and the appellants were restrained from services and which is clear from the available record.
- e. That the order of the learned DPO Mohmand NO 2265-67/DPO M /OSI dated 12-05-2020 is violating the fundamental as well as Constitutional rights, because the same salaries are illegally withdrawing by the Nadir sheer, which clear violation of the court order and other relevant laws, and no proper chance of hearing were given to the appellants

It is, therefore requested that the order of DPO Mohmand NO 2265-67/DPO M /OSI dated 12-05-2020 may kindly be set-aside being illegal, void ab-initio and the undersigned/appellants may kindly be allowed for official duty, and salaries of the prisoners/appellants may kindly also be paid accordingly with all back benefits.

Any other relief deemed just and proper by Your Honour, not specifically asked for, may also be granted in favour of the under signed, please.

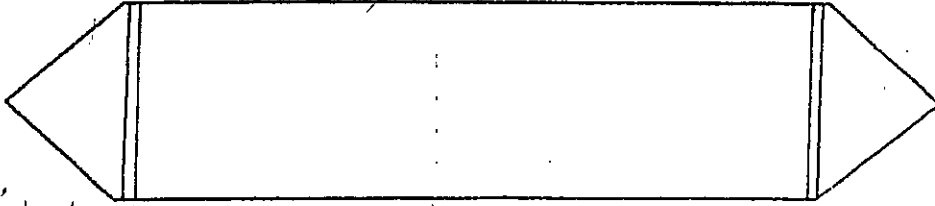

PARAWISE REPLY BY RESPONDENTS NO 1,2,3 & 4

RESPECTFULLY SHEWETH:

Preliminary Objections:-

1. That the instant service appeal is not maintainable under the law.
2. That the appeal is not based on facts.
3. That the appellant has got no cause of action and locus standi.
4. That the appellant has concealed the real facts from the honorable Tribunal.
5. That the service appeal is bad for miss-joinder and non-joinder of necessary and proper parties.
6. That the appellant is estopped to file the service appeal by his own conduct.
7. That the appeal is barred by law & limitation.

REPLY ON FACTS:-

1. Pertains to record of ex Political Agent, Mohmand Agency and record is not available with answering respondents.
2. Pertains to record of ex-Political Agent Mohmand. Appellant has not performed duty with answering respondents and remained deserter from official duty during active service.
3. Incorrect, Khasadari was in the name of the appellant but due to militancy in District Mohmand, the appellant deserted himself from khasadar service and never personally performed duties as Khasadar/Police. In facts duty was performed by substitute (Iwazi) khasadar on behalf of appellant and salary were paid to the Iwazi Khasadar who actually performing duty **(Report/Statement of DSP Nader Sher Respondent No 8 is enclosed as Annexure A)**. The term "Iwazi" was defined in THE KHYBER PAKHTUNKHWA KHASADAR FORCE (AMENDMENT) ACT, 2020 dated 12th August, 2020,

Clause (e-i) (**Annexure B**) is enclosed. When Khasadar Force was merged in KP Police the District Scrutiny Committee recommended Iwazi Khasadar (who performed duties in time of insurgency) for absorption in KP Police.

4. Correct to the extent that the petitioner approached the office concern and the judgment of Honorable Peshawar High Court in writ petition No 5944-p/2019 titled Murad Khan and others vs Govt of KPK, dated 13-02-2020, but the appellant failed to provide any cogent justification regarding remaining silent for such a long period pertaining to their restoration of Khasadar Service, hence declared unfit for absorption in KP Police service. It is pertinent to mention that the appeal of the appellant also dismissed by Home & Tribal Affairs Department Task Force, dated 23/08/2021 (**Annexure C**).
5. Incorrect, Respondent No.3/ DPO Mohmand always obeyed the law and directions of Honorable High Court and the case of appellant was decided according to rules/ laws and policies and direction of Honorable Peshawar Highcourt, because the appellant deserted from his services during peak of militancy in Mohmand Tribal district. Hence, in order to maintain peace and security, the then Political Agent Mohmand Agency arranged "Iwazi" Khasadar, who actually performed duties in place of the appellant in time of insurgency and salaries were paid to the Iwazi Khasadar. The appellant remained silent and never performed duties during militancy in the area, but when peace and order restored and Mohamand tribal district was merged in Khyber Pakhtunkhwa Province and Khasadar Force were merged in KP Police, the appellant filed application to get permanent Police job, for which he was found ineligible and iwazi Khasadar was absorbed in KP Police.
6. Pertain to record, both the orders were convincing, based on cogent reasons and in accordance with rules/Policy of Government and the Departmental Appeal being unsatisfactory, hence rejected.
7. Appellant has got no cause of action, therefore, the instant appeal may kindly be dismissed on the following grounds.

REPLY ON GROUNDS:-

- A.** Incorrect, both orders of the respondents are based on facts, justice and in accordance with law/ rules and Policy of Government.
- B.** Incorrect, as explained above the orders are legal and justified under the existing rules/Policy of Government.

- C.** Incorrect, as the appellant is not being the regular employee of KP Police, hence there is no record available regarding his services. It is pertinent to mention that in this Para of Service appeal the appellant himself admitted that he run away to District Charsada and left the duty in Mohmand Agency without any permission.
- D.** Incorrect, as the appellant was not the employee of KP Police and nor he was discriminated by the respondents. The appellant salaries were paid to the Iwazi Khasadar who performed duty in place of the appellant before merger of erstwhile FATA and after merger the appellant was ineligible for absorption in kp police, hence the Iwazi Khasadar was absorbed in KP Police in accordance with rules.
- E.** Incorrect, the reasons mentioned in the order of Respondents are totally in accordance with law/rules and based on facts, because the appellant deserted from his services as Khasadar at time of militancy in the area before merger of erstwhile FATA and there is no record available regarding appellant services with answering respondents.
- F.** The orders of Respondents are totally in accordance with law/rules and the appellant has not performed duty with answering respondents, therefor he is not entitled for any relief/back benefits.
- G.** Incorrect, appellant being not regular employee of KP Police, the service law/rules is only applicable to KP Police employees, in fact the appellant was deserted from his services as khasadar before merger of erstwhile FATA, therefor the orders of respondents are based on facts, law/rules.
- H.** Incorrect, the plea of the appellant badly barred by law, in fact he deserted from duty during active service in Mohmand Agency under the command of ex-Political Agent Mohmand Agency and appeared after merger of Mohmand Agency in KP.
- I.** Incorrect, the appellant has not done duty before and after merging of Khasadar in Khyber Pakhtunkhwa Police. Appellant is not now employee of KP Police and he is not entitled for any payment under the rules. Respondents have acted in accordance with law/rules and never violated any provision of constitution.
- J.** Respondent may kindly be allowed to add any other grounds/ documents at the time of hearing.

PRAYERS:

Keeping in view the above stated facts it is humbly prayed that the appeal being not maintainable, barred by law/ limitation may kindly be dismissed with costs, please.

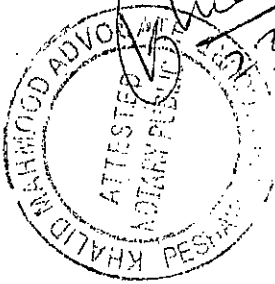

THE KHYBER PAKHTUNKHWA KHASADAR FORCE (AMENDMENT) ACT, 2020.
(KHYBER PAKHTUNKHWA ACT NO. XXX OF 2020)

(First published after having received the assent of the Governor of the Khyber Pakhtunkhwa in the Gazette of the Khyber Pakhtunkhwa, (Extraordinary), dated the 12th August, 2020).

ACT

*to amend the Khyber Pakhtunkhwa
Khasadar Force Act, 2019.*

WHEREAS it is expedient to amend the Khyber Pakhtunkhwa Khasadar Force Act, 2019 (Khyber Pakhtunkhwa Act No. XXXIV of 2019). for the purposes hereinafter appearing:

It is hereby enacted as follows:-

- 1. Short title and commencement.**--- (1) This Act may be called the Khyber Pakhtunkhwa Khasadar Force (Amendment) Act, 2020.
(2) It shall come into force at once.
- 2. Amendment of section 2 of the Khyber Pakhtunkhwa Act No. XXXIV of 2019.**--- In the Khyber Pakhtunkhwa Khasadar Force Act, 2019 (Khyber Pakhtunkhwa Act No. XXXIV of 2019), hereinafter referred to as the said Act, in section 2, after clause (e), the following new clause shall be inserted, namely:

*Assented

“(c-i) “Iwazi” means a surrogate member of the Khasadar Force, who is actually performing duties in place of a member of the Khasadar Force and is getting full or split remuneration for the services rendered, whereas the salary is still drawn in name of the one in whose place he is performing such duties in the Khasadar Force;”.

3. **Amendment of section 3 of the Khyber Pakhtunkhwa Act No. XXXIV of 2019.**--- In the said Act, in section 3, in sub-section (1), after the word “members”, occurring at the end, the words and comma “or Iwazis, as the case may be” shall be inserted.

4. **Repeal of the Khyber Pakhtunkhwa Ordinance No. VIII of 2020.**---- The Khyber Pakhtunkhwa Khasadar Force (Amendment) Ordinance, 2020 (Khyber Pakhtunkhwa Ordinance No. VIII of 2020) is hereby repealed.

ORDER.

1. Whereas, the above captioned appeals having identical question of law and facts, have been clubbed together.
2. And whereas, appellants ex-Khassadars of Mohmand Tribal District submitted appeals for their re-instatement in service with back benefits.
3. And whereas, after the merger of erstwhile FATA with the Khyber Pakhtunkhwa, Home and Tribal Affairs Department Khyber Pakhtunkhwa has been entrusted with the affairs of the Levies and Khassadars.
4. And whereas, the competent authority has been pleased to place the above appeals before the Committee already constituted for such purpose in Home and Tribal Affairs Department Khyber Pakhtunkhwa.
5. And whereas, appellants were called for personal hearing on 29.04.2021 and 22.06.2021. Appellants (Rab Nawaz, Rehmat Ullah and Fazal Rabi; and Bilal Mustafa & others) averred that they had regularly performed their duties till 2008 and due to military operation in the area, they were forced to leave their native areas therefore, could not perform duties. Appellants further contended that their colleagues, who were also dismissed on desertion charges were reinstated by the respondent while they have been discriminated by not reinstating in the service.
6. And whereas, Representative of Department responded that appellants deserted and left their posts without getting permission of the Commandant/Administration. Further argued that appellants were time and again directed to report for duty but to no avail.

The then District Administration/Commandant Khassadar Force had managed substitutes/Ewzi in their places.

7. And whereas, the Khassadars Force (Absorption in Khyber Pakhtunkhwa Police) Rules 2019, provides absorption of Ewzi/substitute in place of the original Khassadars, their substitutes, recommended by the Scrutiny Committee, have been absorbed in Police Department.
8. Now therefore, after thorough examination of record and hearing the parties, it reveals that appellants showed cowardice and became deserters in the period when their services were utmost required in war against terror/militancy; they are not fit to be reinstated in the Force. Hence, appeals in hand are dismissed.
