

APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT 1974 AGAINST THE APPELLATE ORDER DATED 2.4.2014 WHEREBY THE DEPARTMENTAL APPEAL OF THE APPELLANT HAS BEEN REJECTED BY RESPONDENT NO.2 ON NO GOOD GROUNDS AND AGAINST THE IMPUGNED TRANSFER ORDER DATED 17.03.2014 WHEREBY THE APPELLANT WAS TRANSFERRED PRE MATURELY AND ON THE BASIS OF POLITICAL INTERFERENCE

PRAYER:

That on acceptance of this appeal the impugned orders dated 17.03.2014 and 2.4.2014 may very kindly be set aside and the respondents may very kindly be directed not to transfer the appellant from the O/O SDEO(F) Mansehra till completion of his normal tenure. Any other remedy which this august Tribunal deems fit may also be awarded in favor of the appellant.

R/SHEWETH:

- 1- That the appellant is serving in the respondent department as junior clerk since 1989 quite efficiently and up to the entire satisfaction of his superiors.

- 2- That appellant while serving at the office of SDEO (F) District Mansehra the respondent No.3 transferred the appellant to GGHS Battal, District Mansehra vide order dated 29.11.2013. That in compliance the appellant took over the charge at GGHS Battal and started his duties quite efficiently and up to the entire satisfaction of his superiors. Copies of the transfer order, arrival report and pay slips are attached as annexure **A, B & C.**
- 3- That just after four months the respondent No.2 cancelled the transfer order dated 29.11.2013 vide order dated 12.03.2014. That in compliance of cancellation order dated 12.03.2014 the appellant took over the charge at SDEO (F) Office vide dated 14.03.2014. Copies of the cancellation order and charge report are attached as annexure **D & E.**
- 4- That astonishingly just after five days stay at the office of SDEO (F) Mansehra the appellant was again transferred to GGHSS Oghi vice respondent No.4 by the respondent No.3 on the directions of local MPA Mr. Wajeeh Uz Zaman. Copy of the Letter and impugned transfer order dated 17.3.2014 is attached as annexure **F & G.**
- 5- That appellant feeling aggrieved from the impugned transfer order dated 17.3.2014 filed Departmental appeal before the respondent No.2 but the same was rejected vide order dated 2.4.2014 on no good grounds. Copies of the Departmental appeal and rejection order are attached as annexure **H & I.**
- 6- That hence the present appeal on the following grounds amongst the others.

GROUND:

- A- That the impugned orders dated 17.03.2014 and 2.4.2014 are against the law, facts, norms of natural justice and materials on the record hence not tenable and liable to be set aside.
- B- That the appellant has not been treated by the respondent Department in accordance with law and rules on the subject noted above and as such the respondents violated article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.
- C- That the impugned orders dated 17.03.2014 is Pre-mature under the law and prevailing rules.

- D- That the impugned transfer order dated 17.03.2014 is politically motivated.
- E- That the impugned transfer order dated 17.3.2014 is against the clause I, II and IV of the transfer/posting policy of the Government of Khyber Pakhtunkhwa. Copy of the policy is attached as annexure J.
- F- That the impugned order dated 17.03.2014 has not been issued by the respondent No.3 in the public interest nor exigencies of service.
- G- That the appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed for.





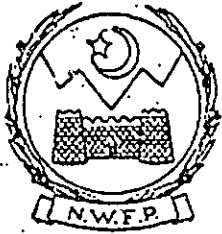

POSTING / TRANSFER POLICY OF THE PROVINCIAL GOVERNMENT

- i) All the posting/transfers shall be strictly in public interest and shall not be abused/misused to victimize the Government servants
- ii) All Government servants are prohibited to exert political, Administrative or any other pressures upon the posting/transfer authorities for seeking posting/transfers of their choice and against the public interest.
- iii) All contract Government employees appointed against specific posts, can not be posted against any other post.
- iv) The normal tenure of posting shall be three years subject to the condition that for the officers/officials posted in unattractive areas the tenure shall be two years and for the hard areas the tenure shall be one year. The unattractive and hard areas will be notified by the Government.
- v) { }
- vi) While making postings/transfer from settled areas to FATA and vice-versa, specific approval of Governor, NWFP needs to be obtained.

²While making postings/transfers of officers/officials up to BS-17 from settled areas to FATA and vice-versa approval of the Chief Secretary NWFP needs to be obtained. Whereas, in case of posting/transfer of officers in BS-18 and above, from settled areas to FATA and vice versa, specific approval of the Governor NWFP shall be obtained.
- vi (a) All Officers/officials selected against Zone-I/FATA quota in the Provincial Services should compulsorily serve in FATA for atleast eighteen months in each grade. This should start from senior most scales/grades downwards in each scale/grade of each cadre.
- vii) Officers may be posted on executive/administrative posts in the Districts of their domicile except District Coordination Officers (D.C.Os) and DPOs/Superintendent of Police (SP). Similarly Deputy Superintendent of Police (DSP) shall not be posted at a place where the Police Station (Phaana) of his area/residence is situated.
- viii) No posting/transfers of the officer's/officials on detailment basis shall be made.
- ix) Regarding the posting of husband/wife, both in Provincial services, efforts where possible would be made to post such persons at one station subject to the public interest.

All the posting/transferring authorities may facilitate the posting/transfer of the unmarried female government Servants at the station of the residence of their parents.

xiii) While considering posting/transfer proposals all the concerned authorities shall keep in mind the following:

- a) To ensure the posting of proper persons on proper posts, the Performance Evaluation Report/annual confidential reports, past and present record of service, performance on post held presently and in the past and general reputation with focus on the integrity of the concerned officers/officials be considered.
- b) Tenure on present post shall also be taken into consideration and the posting/transfers shall be in the best public interest.

xiv) Government servants including District Govt. employees feeling aggrieved due to the orders of posting/transfer authorities may seek remedy from the next higher authority / the appointing authority as the case may be through an appeal to be submitted within seven days of the receipt of such orders. Such appeal shall be disposed of within fifteen days. The option of appeal against posting/ transfer orders could be exercised only in the following cases.

- i) Pre-mature posing/transfer or posting transfer in violation of the provisions of this policy.
- ii) Serious and grave personal (humanitarian) grounds.

2. To streamline the postings/transfers in the District Government and to remove any irritant/confusions in this regard the provision of Rule 25 of the North West Frontier Province District Government Rules of Business 2001 read with schedule - IV thereof is referred. As per schedule-IV the posting/transferring authorities for the officers/officials shown against each are as under:-

3. As per Rule 25(2) of the Rules mentioned above the District Coordination Department shall consult the Government if it is proposed to:

- b) Require an officer to hold charge of more than one post for a period exceeding two months.

4. I am further directed to request that the above noted policy may be strictly observed/implemented.
