The instant Miscellaneous application, submitted by the appellant for correction of date of decision, received through office. Be entered in the relevant register. Mr. Muhammad Adeel Butt, Additional Advocate General for the respondents present. Record requisitioned and perused.

Through the instant application, the appellant is seeking correction of date of decision, which was inadvertently mentioned in the judgment as 17.01.2022 instead of 19.01.2022. On perusal of the record, it transpired that the concerned Service Appeal bearing No. 1332/2018 titled Muhammad Suleman Vs. Government of Khyber Pakhtunkhwa was decided on 19.01.2022 however due to inadvertence, the date of decision was wrongly mentioned as 17.01.2022. This Tribunal within the meaning of Subsection-(02) of Section-7 of Khyber Pakhtunkhwa Service Tribunal Act, 1974 is deemed as civil court under the Code of Civil Procedure, 1908. Section-152 C.P.C provides for amendment of the judgment, decree or orders. It provides that mistakes in judgments, decrees or orders or errors arisen therein from any accidental slip or omission may at any time be corrected by the court either of its own motion or on the application of any of the parties. In the present case, year and month are correct but the date has been written as 17.01.2022 instead of 19.01.2022 due to typographical mistake which is an accidental slip. Therefore, the case is fit for exercise of jurisdiction U/S 152 C.P.C as described before. Office is directed to make necessary correction by substituting the date 17.01.2022 with 19.01.2022 in the judgment as well as in the short order and relevant record accordingly. Copy of this order as well as copy of the application be placed on file of Service Appeal No. 1332/2018. After necessary correction in the concerned judgment, certified copies of the same be sent to both the parties. File be consigned to the record room after its completion.

#### JUDGMENT

ROZINA REHMAN, MEMBER (J): Briefly stating the facts necessary for the disposal of the lis in hand are that appellant was appointed as PST. While serving at GPS Tutial Battangi, Abbottabad, he was implicated in a case registered U/S-409/34 PPC and accordingly, he was served with charge sheet and Luqman Ali Khan was appointed as Inquiry Officer. Consequently, he was awarded major penalty of reduction in rank on 24.03.2016 against which he filed departmental appeal on 21.04.2016 which was rejected and thereafter, he filed Service Appeal No.672/2016. Vide order dated 22.02.2018 of this Tribunal, his appeal was accepted and penalty was set aside. The Department was however, left at liberty to hold de-novo proceedings. In pursuance to judgment of this Tribunal, Dr. Inayat-ur-Rehman Vice Principal GHS No.1 was appointed as Inquiry Officer to conduct de-novo inquiry under Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011 vide Notification dated 21.03.2018. Charge sheet and statement of allegations were issued to appellant. Inquiry report was submitted and final show cause notice was issued, which was replied. As per recommendation of Inquiry Officer, major penalty of reduction to lower post i.e. from BS-15 to BS-14 was imposed upon him vide order dated 08.06.2018. He filed departmental appeal which was rejected, hence, the present service appeal.

2. We have heard Choudhry Abdu Rauf Chohan Advocate learned counsel for appellant and Kabir Ullah Khattak, learned Additional Advocate General for respondents and have gone through the record and the proceedings of the case in minute particulars.


3. Choudhry Abdur Rauf Chohan Advocate learned counsel appearing on behalf of appellant, inter-alia, argued that impugned order is illegal, wrong, against the service laws and rules being premature. He contended that order of this Tribunal in respect of denovo proceedings was not complied with according to rules & regulations; that he was not afforded any opportunity of personal hearing. It was further submitted that the Anti-Corruption Department did not find any illegality after proper inquiry and scrutiny of the whole record which is evident from the order of Anti-Corruption

Department, therefore, the entire allegations leveled against the appellant are baseless. It was further submitted that the appellant followed the instructions of the ADO Circle and other high-ups for shifting the text books from GPS Tutial Battangi to GPS Kotlian, Abbottabad and in this regard, statements of responsible Members of PTC are available on file which clearly proves that appellant was falsely implicated in the case and was wrongly proceeded against departmentally for no fault on his part. He, therefore, requested for acceptance of instant service appeal.

4. Conversely, learned AAG submitted that as per report of ASDEO Circle Nathiagali, appellant was carrying text books of Government Primary School Tutial Battangi, Abbottabad in Suzuki No.3837 at Baragali Kasala Road for the purpose of illegal sale and in this regard, FIR No.217 was registered on 08.12.2015 U/S-409/34 PPC at PS Donga Gali, Abbottabad. He submitted that charge sheet and statement of allegations were served upon appellant and proper inquiry was conducted, where-after, he was awarded punishment according to law which does commensurate with the guilt of the appellant.

5. From the record it is evident that appellant Muhammad Suleman while posted as PSHT at GPS Tutial Battangi, Circle Nathiagali Abbottabad was allegedly implicated in case FIR No.217 dated 08.12.2015 registered at Police Staion Donga Gali U/S 409/34 PPC. Besides the appellant one Javid Akhtar and Daud (both serving teachers) were also implicated in the above-mentioned FIR. The record is totally silent in respect of departmental proceedings against

the other two teachers. The present appellant applied for bail before arrest in the above-mentioned FIR and his petition was allowed by a competent court of Law on 26.02.2016. It is crystal clear from the record that his Service Appeal No. 672/2016 was accepted and Department was held at liberty to hold de-novo proceedings vide judgment of this Tribunal dated 22.02.2018. In pursuance to the judgment of this Tribunal, charge sheet and statement of allegations were issued and inquiry Officer was appointed. The inquiry report is available on file which clearly shows that no evidence was recorded by the Inquiry Officer and he relied upon the inquiry report which was rejected by this Tribunal in the earlier round of litigation. The recommendations of the Inquiry Officer are hereby reproduced for ready reference:

#### **"RECOMMENDATIONS:**

On the basis of above findings/facts concluded during conducting enquiry the following recommendations are suggested for favorable consideration.

> In the light of reports of ASDEO Circle, previously inquiry report conducted by Mr. Lugman Ali Khan Principal GHSS Nagri Bala Abbottabad, rejection of appeals by competent authorities DEO(M) Abbottabad and Director Elementary & Secondary Education Khyber Pakhtunkhwa Peshawar, the undersigned is of the opinion/view that Major penalty already imposed Khyber under

Pakhtunkhwa Govt: Servants Rules (4) (b) (i), be intact/retain against Mr. Muhammad Suleman SPST and enquiry may be declared as ex-parte vide rules quoted as Annexure-U-II.

To direct all Heads of Institutions especially primary Schools, with the directions that without prior permission of the competent authority, no Govt: Property can more/shift at any cost. A general circular may please be issued in this regard."

6. From the above, it is evident that despite repeated requests by the appellant, opportunity was not afforded for personal hearing and without submission of reply to the charge sheet, inquiry report was submitted and that too, with the recommendations of earlier inquiry report. Final show cause notice was served upon appellant and a detailed reply was submitted which again was not taken into consideration and no evidence in this regard was collected and same major penalty on the strength of same (old) inquiry report was imposed upon appellant vide order dated 08.06.2018. From the entire record, it is evident that no evidence was recorded by the Inquiry Officer which could show that text books were carrying by the appellant in the Suzuki for the purpose of illegal sale. As there was no case, therefore, the subject inquiry was filed by the Anti-Corruption Establishment Khyber Pakhtunkhwa, Peshawar which report is available on file. Co-employees were not proceeded against departmentally which shows discrimination. Besides members of the PTC produced affidavits which also favor the appellant.

7. In this view of the matter, the instant service appeal is accepted as prayed for. Parties are left to bear their own costs. File be consigned to the record room.



Appellant Muhammad Suleman in person present. Preliminary arguments heard. It was contended by the appellant that he was imposed major penalty of reduction in rank from the post of Primary School Head Teacher to the post of Senior Primary School Teacher. The appellant filed service appeal which was partially accepted vide judgment dated 22.02.2018 and the respondent-department was directed to conduct de-novo inquiry. It was further contended that respondent-department has neither conducted proper inquiry as per direction of this Tribunal judgment nor provided opportunity of personal hearing and defence and he was again imposed major penalty of reduction from the post of Primary School Head Teacher to the post of Senior Primary School Teacher vide order dated 08.06.2018. The appellant filed departmental appeal on 09.06.2018 which was rejected on 30.08.2018 and received to the appellant on 26.09.2018 hence, the present service appeal. It was further contended that since the respondent-department has not conducted de-novo inquiry as per direction of this Tribunal and rule therefore, the impugned order is illegal and liable to be set-aside.

The contention raised by the appellant need consideration. The appeal is admitted for regular hearing subject to all legal objections. The appellant is directed to deposit security and process fee within 10 days, thereafter, notice be issued to the respondents for written reply/comments for 17.06.2019 before S.B at Camp Court Abbottabad.

ON ACCEPTANCE OF THE INSTANT SERVICE APPEAL, IMPUGNED ORDERS NO. 6910-14 DATED 08/06/2018 PASSED BY RESPONDENT NO.3, AND ORDER NO. 3776 DATED 30-08-2018 BY RESPONDENTD NO.2, MAY GRACIOUSLY BE SET ASIDE AND RESPONDENTS BE DIRECTED TO WITHDRAW THE IMPUGNED OFFICE ORDERS OF MAJOR PENALTY IMPOSED UPON APPELLANT OF REDUCTION TO LOWER POST OF P.S.T, BPS-15 TO BPS-14 IN THE BEST INTEREST OF NATURAL JUSTICE.

## Respectfully Sheweth,

THE FACT LEADING RISE TO THE PRESENT APPEAL ARE AS UNDER:-

- 1. That, the Appellant was appointed as P.S.T teacher in Education Department on 11.11.1989.
- 2. That, the appellant performed his duty deliberately and devotedly to the best of his abilities and to the entire satisfaction of superior.
- 3. That, appellant while serving at GPS Tutial Battangi, Abbottabad local police station lodged an bogus FIR against the appellant under Section 409/34 PPC that appellant is illegally involved in carrying of text books of Govt Primary School Tutial Battangi, Abbottbad in Suzuki

No. CL-3837 at Bara Gali Kasala road for the purpose of illegal sale. (Copies of FIR is attached as annexure "A").

That, the appellant moved an application for pre-arrest Bail in the Court of ASJ-VII, Abbottabad, the allegation leveled against the appellant are malafide and baseless, the honourable court confirmed the B.B.A of the appellant. (*Copy of the judgment of ASJ-VII, is attached as Annexure "B"*)

That, on 09.12.2015, respondent No.3, issued charge sheet against the appellant alongwith two other companions on the same date Respondent No. 3, appointed an inquiry officer namely Luqman Ali Khan for conducting departmental inquiry against appellant and other companions. X

That, on 08.01.2016, appellant and his other companions submitted an application in light of Affidavit given by the chairman of PTC alongwith a resolution passed in the meeting of PTC members, to the SSP investigation, Abbottabad for rejection of fake and bogus FIR. *(Copies of relevant documents are annexed as annexure "C")* 

That, on 21.04.2016, appellant filed departmental representation/appeal before respondent No.2, which was rejected and feeling aggrieved, appellant filed service appeal No. 672/2016, before this Hon'ble Tribunal was accepted and the major penalty was set-

aside and Hon'ble Tribunal issued direction to respondents for holding Denovo proceedings within the period of 90 days. (Copy of Judgment dated 22/02/2018 is attached as annexure "D").

That, on 21/03/2018, respondent No.3 issued notification for Denovo Inquiry in compliance with the Judgment of this Hon'ble Tribunal. (Copies of notification alongwith charge sheet are annexed as annexure "E")

That, on 16/04/2018, appellant submitted an application before the respondent No.3 for reinstatement of appellant at his original position at which, respondent No.3, issued order on 21/03/2018 for reinstatement of appellant at his original position.

That, on 24/05/2018, Deputy District Education Officer, Abbottabad, issued a letter to appellant for personal hearing and appellant appeared before the said officer on 31/05/2018 but no proper opportunity of personal hearing was given to the appellant. (Copies of order and written statement of personal hearing are annexed as annexure "I")

That, on 08/06/2018,once again respondent No.3 issued order of major penalty of reduction to lower post i.e. BPS-15 to BP-14, against the appellant. (Copy of impugned order dated 08/06/2018 is annexed as annexure "J")

That, on 09/06/2018, appellant filed a departmental appeal against the impugned order before respondent No.2 which was rejected by respondent No.2 and informed respondent No.3 in this regard who further informed the Sub Divisional Education Officer Abbottabad on 08/09/2018 vide letter No. 9944 and the appellant was informed about the rejection of departmental appeal by the SDEO (Male) Abbottabad on 24/09/2018. 16. Thus, the appellant has come to this Honourable Tribunal within time and the impugned order is liable to be set-aside, inter-alia on the following grounds:-

That, impugned order is wholly without jurisdiction and called for interference by this honourable court.

 h. That, the impugned order has been passed premature and allegations leveled against the appellant are baseless and nothing was recovered from the appellant and honourable court also confirmed the pre-arrest bail of the appellant and appellant was found innocent.

That, the performance of the appellant is self speaking as due to his better and satisfactory performance he was up-graded in BPS-15.

That, the appellant followed the instructions of the ADO Circle, Ishtiaq Khan and other high ups authorities for shifting the text books from GPS Tutial Battangi to GPS Kotlian, Abbottabad, the evidence of responsible PTC Members are available in court file. Hence the appellant is innocent and falsely charged in above mentioned

That, the inquiry officer conducted the Denovo inquiry without connecting previous accused and submitted report against the appellant, which is totally bogus and liable to be set-aside. (Copies of written statements are annexed as annexure "M")

That, the impugned order is totally illegal, against the FR-29.

That, the impugned order is time barred and issued after the stipulated period of 90 days, settled by this Hon'ble Tribunal.

That, the appellant was not provided proper opportunity of personal hearing under E&D Rules 2011.

That, appellant seeks permission of this Honorable Tribunal to agitate additional grounds at the time of hearing of this appeal.

(3) Learned counsel for accused/ petitioners argued that the accused/ petitioners are falsely charged in the instant case by the local police with the collusion of co-accused Rashid and Javed Akhtar. He further argued that the accused/ petitioners were not present on the spot and were wrongly involved in the present case.
(4). Learned Dy. PP for the state argued that the

accused/petitioners are directly charged in the FIR and no malafide has been point out by the learned counsel for the accused/petitioners on the part of prosecution.

<u>NIAZ MUHAMMAD KHAN, CHAIRMAN</u>: Arguments of the learned counsel for the parties heard and record perused.

#### **FACTS**

2. The appellant was awarded major penalty of reduction in rank on 24.3.2016, against which he filed departmental appeal on 21.4.2016 which was rejected on 23.05.2016 and thereafter, he filed the present service appeal on 14.06.2016. The charge against the appellant was transportation of some official books for sale. An FIR was also lodged against three persons including the present

appellant.

#### ARGUMENTS

3. The learned counsel for the appellant argued that in the impugned order reference was made to findings/recommendations of the enquiry report but no

charge sheet and statement of allegations were issued to the appellant.

4. On the other hand learned AAG argued that the appellant was issued show cause notice and the nature of the offence attributed to the appellant was of a severe nature and the authority rightly imposed the penalty. That the enquiry officer recorded the statements and a questionnaire was also issued to the appellant.

#### CONCLUSION.

5. Admittedly no charge sheet or statement of allegations were issued to the appellant and the enquiry was conducted without any charge sheet and statement of allegations. Without commenting on the nature of the guilt or the merits of the case, the departmental proceedings were illegal. No penalty could be imposed on the basis of such proceedings.

6. Consequently the present appeal is accepted and the penalty is set aside. The department is, however, at liberty to hold denovo proceedings within a period of ninety days from the date of receipt of this judgment. Parties are left to bear their own costs. File be consigned to the record room.





He declared him involved in illegal sale/purchase of Text Books and for disciplinary action against him (Annexure -C).

District Education Officer (M) Abbottabad in the term of rule 6 of Khyber Pakhtunkhwa Govt: Servants (Efficiency & Disciplinary) rules 2011 suspended has services for initial period of ninety(90) days vide order Endst:No.9595-9601/EB-I/enquiry/PST dated 09.12.2015 and Mr.Luqman Ali Khan Principal GHSS Nagri Bala Abbottabad was appointed enquiry officer vide Endst:No.9602-7/EB-I/enquiry dated 09.12.2015 to conduct enquiry and submit his recommendations to DEO for further proceeding and necessary action(Annexure-D)\_TI

Mr. Luqman Ali Khan enquiry officer while conducting enquiry served questionnaire to the official as well as recorded his statement (Annexure-E).

On the bases of finding/facts the enquiry officers recommend the official for major penalty reduction to lower grade/scale to the competent authority (Annexure-F).

The teacher under enquiry Mr. Muhammad Suleman PST submitted an appeal to DEO(M) Abbottabad on dated 12.02.2016 against the penalty and also submitted the PTC resolution as well as affidavits of himself and Taj Muhammad. (Annexure -H-I-II-III-IV)

District Education Officer (M) Abbottabad as competent authority rejected his appeal and imposed the major penalty as recommended by enquiry officer *"REDUCTION OF LOWER POST SPST"* in exercise the power conferred upon him under Rule 4 sub Rule(b)(i) of Khyber Pakhtunkhwa Govt: Servants Rules(Effeciency & Disciplinary) 2011 vide order Endst:No.2369-72/EB-I/Enquiry/Text Books dated Abbottabad the 24.03.2016,and No; 3491-94/F.No.14/Vol:V dasted 05.05.2016 (Annexure-I)

On 26<sup>th</sup> April 2018 he requested to contact his lawyer. I refused, that I have no concern with his lawyer. He insisted and contacted his lawyer with the undersigned. He was once again directed to be present on 27<sup>th</sup> & 28<sup>th</sup> April 2018 for submission of his reply, but he replied that he will be on leave for said days and unable to submit the reply.

He has failed to submit reply for charge sheet/allegations within stipulated period already specified in charge sheet& vide No. SO((REG-VI) E&AD/2-6/2010 of Khyber Pakhtunkhwa Government Servants(Efficiency & Discipline) Rules, 2011,(11)(2) (Annexure-U I-II).

#### FINDINGS:

From the perusal record/documents the following findings were concluded.

- To direct all Heads of Institutions, especially primary Schools, with the directions that without prior permission of the competent authority, no Govt: Property can more/shift at any cost. A general circular may please be issued in this regard.







#### PRELIMINARY OBJECTIONS:-

- 1. That the appellant has no cause of action to file the instant service appeal.

- 7. That the instant appeal is hopelessly time barred.
- 8. That the appellant has suppressed the original facts from this Honorable Tribunal hence, not entitled for any relief & appeal is liable to dismissed without any further proceeding.
- 9. That both the order passed by the authorities is per law and rules after fulfillment all the codal formalities hence, appeal is liable to be dismissed on this score alone.
- 10. That the appellant has committed a cognizable offence due to which criminal
- case was registered against the appellant under section 409/ 34 PPC at PS dounga gali Tehsil & District Abbottabad hence, appeal is liable to be dismissed.

- 4. That Para No. 4, of the instant appeal relates to judicial record.
- 5. That Para No.5, of the instant appeal is correct.
- 6. In reply to Para No. 6, of the instant appeal it is submitted that as per inquiry report all the charges which were leveled against appellant have been proved.
- 7. That Para No. 7 of the instant appeal is correct.
- 8. In reply to Para No. 8, of the instant appeal it is submitted that in pursuance to the judgment of this Honourable Tribunal dated 22-08-2018 answering respondent has set aside the penalty and posted the appellant as PSHT (BPS-15) at GPS Thunda, Abbottabad vide Notification No. 3520-23 dated 21-03-2018 and appointed an inquiry officer to conduct De-novo inquiry vide Notification No. 3514-18 dated 21-03-2018, charge sheet and statement of allegation were served upon appellant vide letter No. 3519 dated 21-03-2018. (Copy of Notification No. 3520-23 dated 21-03-2018, Notification No. 3514-18 dated 21-03-2018, Notification No. 3514-18 dated 21-03-2018, Notification No. 3514-2018, charge sheet and statement of allegation dated 21-03-2018, charge sheet and statement of allegation dated 21-03-2018,

(Copy of inquiry report is annexed herewith as Annexure "F").
- 11. In reply to Para No. 11, of the instant appeal it is submitted that there is no such provision available under E&D Rules regarding reopening of inquiry report when the accused failed to furnish his reply within the stipulated period.
- 12. That Para No. 12, of the instant appeal is correct.
- 13. That Para No. 13, of the instant appeal as composed is incorrect hence, denied appellant was provided an opportunity of personal hearing vide letter 6239 dated 24-05-2018 and same was availed by the appellant on 31-05-2018. (Copy of letter of personal hearing dated 24-05-2018 and proceedings of personal hearing on 31-05-2018 are annexed herewith as annexure "G" & "H").
- 14. That Para No. 14, of the instant appeal is correct.
- 15. That Para No. 15, of the instant appeal is correct to the extent of rejection of departmental appeal on 30-08-2018 whereas, rest of the Para as composed is incorrect hence, denied as the appeal in hand in hopelessly time barred.
- 16. That Para No. 16, of the instant appeal as composed is incorrect hence, denied.

#### GROUNDS:-

- a. That ground a, as composed is incorrect hence, denied.
- b. That ground b, as composed is incorrect hence, denied as the impugned order was issued after observing the due process of law.
- c. That ground c, as composed is incorrect hence, denied as Denovo inquiry was conducted in accordance with the prescribed manners.

- d. That ground d, as composed is incorrect hence, denied as comprehensive reply has already been given in para No. 13 of the Factual Objections.
- e. The ground e, as composed is incorrect hence, denied.
- f. In reply to ground f, it is submitted that Denovo inquiry was conducted under E&D Rules 2011 and all the allegations levelled against the appellant have been proved.
- g. That ground g, as composed is incorrect hence, denied as the impugned order was issued after observing the due process of law.
- h. That ground h, as composed is incorrect hence, denied.
- i. That ground i, as composed is incorrect hence, denied.
- j. That ground j, as composed is incorrect hence, denied as per statement of ASDEO circle dated 26-04-2018 he did not give any instruction regarding the shifting of books. (Copy of the statement of ASDEO circle dated 26-04-2018 is annexed herewith as annexure "I").
- k. That ground k, as composed is incorrect hence, denied.
- 1. That ground l, as composed is incorrect hence, denied.
- m. That ground m, as composed is incorrect hence, denied.
- n. That ground n, as composed is incorrect hence, denied.
- o. No comment.
- p. That ground p, as composed is incorrect hence, denied as instant appeal is hopelessly time barred.
- q. That the respondents seek permission of this Honorable Tribunal to advance further grounds during the arguments.

It is, therefore, very humbly prayed that in the light of forgoing comments the appeal in hand may graciously be dismissed with cost throughout.

#### NATURE OF ENQUIRY:

The genesis of enquiry was restoration of "Reduction of Appellant from scale BPS-14 to Scale BPS-15 in pursuance judgment of Khyber Pakhtunkhwa Service Tribunal Abbottabad Branch order vide Appeal No.672/2016, announced on 22.02.2018, and hold denovo proceeding into the matter.

#### **HISTORY OF ENQUIRY:**

An FIR No.217 dated 08.12.2015 under section 409/34 PPC registered at Police Station Donga Gali Abbottabad against the Official under enquiry in regarding with illegal purchase/sale of Text Books carrying from Govt: Primary School Tutial Batangi. (Annexure-A).

The accused official obtained bail from session judge-VI Abbottabad on 08.12.2015 (Annexure-B).

The ASDEO circle Ishtiaq khan submitted a report to DEO (M) Abbottabad on 09.12.2015 which is self-explanatory against the officials under enquiry.

He declared him involved in illegal sale/purchase of Text Books and for disciplinary action against him (Annexure – C).

District Education Officer (M) Abbottabad in the term of rule 6 of Khyber Pakhtunkhwa Govt: Servants (Efficiency & Disciplinary) rules 2011 suspended has services for initial period of ninety(90) days vide order Endst:No.9595-9601/EB-I/enquiry/PST dated 09.12.2015 and Mr.Luqman Ali Khan Principal GHSS Nagri Bala Abbottabad was appointed enquiry officer vide Endst:No.9602-7/EB-I/enquiry dated 09.12.2015 to conduct enquiry and submit his recommendations to DEO for further proceeding and necessary action(Annexure-D)\_T [[

Mr. Luqman Ali Khan enquiry officer while conducting enquiry served, questionnaire to the official as well as recorded his statement (Annexure-E).

On the bases of finding/facts the enquiry officers recommend the official for major penalty reduction to lower grade/scale to the competent authority (Annexure-F).

**District** Education Officer (M) Abbottabad as competent authority issue show **carse notice** to accused teacher vide letterNo.1368-70/EB-I/Enquiry dated **2202 2016(Annexure-G)** 

The teacher under enquiry Mr. Muhammad Suleman PST submitted an appeal to DEO(M) Abbottabad on dated 12.02.2016 against the penalty and also submitted the PTC resolution as well as affidavits of himself and Taj Muhammad. (Annexure –H-I-II-III-IV)

District Education Officer(M) Abbottabad as competent authority rejected his appeal and imposed the major penalty as recommended by enquiry officer "*REDUCTION OF LOWER POST SPST*" in exercise the power conferred upon him under Rule 4 sub Rule(b)(i) of Khyber Pakhtunkhwa Govt: Servants Rules(Effeciency & Disciplinary) 2011 vide order Endst:No.2369-72/EB-I/Enquiry/Text Books dated Abbottabad the 24.03.2016,and No; 3491-94/F.No.14/Vol:V dasted 05.05.2016 (Annexure-I)

Mr.Muhammad Suleman PST submitted an appeal to Director Elementary & Secondary Education Khyber Pakhtunkhwa Peshawar on dated 21.04.2016 against the order of DEO(M) Abbottabad dated 24.03.2016.

He also blamed the enquiry officer that he has not conducted the enquiry as per law and Rules. (Annexure-J)

Director Elementary & secondary Education Khyber Pakhtunkhwa rejected his appeal vide order Endst:No.5088-90/F.No.162 Appeal PST/TT/AT/Qari dated 23.05.2016. (Annexure-K)

The teacher concerned filed a service appeal No.672/2016 in Service Tribunal Abbottabad Branch for resolving his grievances. (Annexure-L) The reply of department is attached as (Annexure-M)

District Education Officer (M) Abbottabad requested Director Elementary & Secondary Education Khyber Pakhtunkhwa Peshawar for constitution of denovo enquiry vide letter No.7726-28/ADEO/lit dated 06.10.2016 and also to Senior Govt: Pleader Abbottabad vide No.8379-80/ADEO/lit dated 26.10.2016(Annexure-N-I-II)

Honorable Service Tribunal Khyber Pakhtunkhwa Abbottabad Branch announced its judgment on dated 22.02.2018 with the remarks "consequently the present appeal is accepted and the penalty is set aside. The department is however, at liberty to hold denovo proceeding with in period of ninety (90) days from the receipt of this judgment" (Annexure-O)

(Annexure-R II)

#### **PROCEDURE OF ENQUIRY:**

On Appointment by District Education Officer(M) Abbottabad as enquiry officer, the undersigned informed SDEO(M) Abbottabad & Mr. Muhammad Suleman SPST through Regd: letter & Telephonically. ASDEO Mr.Ishtiaq khan was also contacted in this connection to record his statement. (Annexure-S)

Mr. Muhammad Suleman sent an application which was submitted to DEO (M) for further necessary action.(Annexure T I-II),and the teacher concerned was contacted telephonically to submit reply for charge sheet he arrived on 23.04.2018 but not submitted the same. On 26<sup>th</sup> April 2018 he requested to contact his lawyer. I refused, that I have no concern with his lawyer. He insisted and contacted his lawyer with the undersigned. He was once again directed to be present on 27<sup>th</sup> & 28<sup>th</sup> April 2018 for submission of his reply, but he replied that he will be on leave for said days and unable to submit the reply.

He has failed to submit reply for charge sheet/allegations within stipulated period already specified in charge sheet& vide No. SO((REG-VI) E&AD/2-6/2010 of Khyber Pakhtunkhwa Government Servants(Efficiency & Discipline) Rules, 2011,(11)(2) (Annexure-U I-II).

#### FINDINGS:

From the perusal record/documents the following findings were concluded.

- An FIR No.217 dated 08.12.2015 was registered against Mr. Muhammad Suleman SPST in which Mr.Javed Akhtar admitted the charge as already annexed as Annexure-A.
- Enquiry Officer Mr.Luqman Ali Khan Principal GHSS Nagri Bala recommend the major penalty under Rule (4) (b) (i) Khyber Pakhtunkhwa Govt: Servants rules 2011. (Annexure V)
- ASDEO Circle submitted reports to DEO (M) Abbottabad vide dated 09.12.2015(already annexed as Annexure C) & on 26.04.2018(Annexure W)
- District Education Officer(M) Abbottabad rejected appeal of the accused teacher vide order No, & date already annexed as Annexure-I

**Director** Elementary & Secondary Education Khyber Pakhtunkhwa rejected **appeal vi**de No.& date already annexed as Annexure-K

The learned court in its judgment accepted appeal of the accused teacher however, advice the department for <u>denovo proceeding</u> into the matter already annexed as Annexure-0.

#### **RECOMMENDATIONS:**

On the bases of above findings/facts concluded during conducting enquiry the following recommendations are suggested for favorable consideration.

- In the light of reports of ASDEO circle, previously enquiryreport conducted by Mr.Luqman Ali Khan Principal GHSS Nagri Bala Abbottabad, rejection of appeals by competent authorities DEO(M) Abbottabad and Director Elementary & Secondary Education Khyber Pakhtunkhwa Peshawar, the undersigned is of the opinion/view that Major penalty already imposed under Khyber Pakhtunkhwa Govt: Servants Rules (4)(b)(i), be intact/retain against Mr. Muhammad Suleman SPST and enquiry may be declared as expart vide rules quoted as Annexure-U-II
- To direct all Heads of Institutions, especially primary Schools, with the directions that without prior permission of the competent authority, no Govt: Property can more/shift at any cost. A general circular may please be issued in this regard.
