APPEAL UNDER SECTION 04 OF THE KHYBER PAKHTUNKHWA SERVICES TRIBUNAL ACT, 1974, AGAINST THE ORDER/ NOTIFICATION OF RESPONDENT NO. 3, DATED JANUARY 24, 2022 WHEREBY THE APPELLANT WAS NOT PROMOTED TO THE POST OF THE CHIEF MEDICAL OFFICER {BPS 20} BY THE RESPONDENTS IN VIOLATION OF THE LAWS.

### PRAYER IN APPEAL:

On acceptance of this appeal, the Hon' ble Tribunal may very graciously be pleased to direct Respondents for proforma promotion of the Appellant in BPS 20 (as Chief Medical Officer BPS 20) w.e.f. from the date of promotion of juniors in the seniority list with all financial and other back benefits



## Respectfully submitted as under:

Summary facts that resulted into filing the instant appeal are as under:

- That Appellant is Doctor by Profession and bonafide citizen of Pakistan, and 1 belongs to a respectable family of lower Dir. He has served the Health Department for a considerable long period of almost 33 years of service with no single dot during his service.
- That the Appellant being appointment 02.09.1990 in (BPS-17) as Medical 2. Officer, thereafter Promoted on 10.09.2009 (BPS-18) as Senior Medical Officer, and Perform his duties to the entire satisfaction of their Immediate Officers with no complaint during the service.
- That based on seniority cum fitness, Appellant was then promoted on 3. 26.09.2017 (BPS-19) as Principal Medical Officer where he has performed his duties and responsibilities towards the said post with full efficiency and commitment till his retirement on February 21, 2021.

{Copy of Seniority List confirming employment of Appellant as annex A}

That prior to retirement, the appellant met the requirement, and was 4. eligible to be promoted to the next grade; however, due to the malafide and ill-will of the Respondents, Appellant was deprived of his lawful promotion to the next higher grade in his professional life.

{Copy of another seniority list is annex for consideration as annex B}

- That during the period of services, the Appellant forwarded a letter to the 5. Secretary Health for promotion from BS-19 to BS-20, dated 22-01-2021. It is pertinent mention that the Health Department 'announced final seniority list of Chief Medical Officer BSP-20, the official list stood on 15-05-2020 as 21 out of 75 seats of Chief Medical Officers of above list has been retired before 21<sup>st</sup> Feb 2021.
- {Copy of the letter is annexed as C } 6.
- That the Appellant being eligible for the said post has forwarded 7. aforementioned letter dated 21-01-2021 for promotion to the concerned authority for consideration. It is worth to mention that the total seats of BPS- 20 are 75 seats regardless only 21 of the total posts retired against the



said post while remaining 18 seats left un-occupied/ not filled in since long. It is submitted that the total occupied posts were 19.

- 8. That Respondents while ignoring the seniority of the Appellant in BPS 19, through impugned Notification dated January 24, 2022 promoted juniors to the Appellant to the next higher grade/posts in utter violation of principle of merit and transparency as envisaged by the land laws as enshrined in Constitution of Islamic Republic of Pakistan, 1973 as well as in other laws. **(Copy of impugned Notification is annex as D)**
- 9. It is worth to mention that Respondents were duty bond to process the promotion of the appellant without any delay, however, due to malafide intention; the Respondents did not timely process the matter of the appellant just to deprive the appellant from his lawful benefits in term of promotion to the next grade.
- The appellant feeling aggrieved of the Notification dated January 24, 2022 preferred Departmental Appeal dated February 09, 2022 to Respondent No. 1 being the competent authority, however till date no response/ reply.
   {Copy of Departmental Representation/ appeal is annex as E}
- 11. Hence no any other effective or alternate remedy, the appellant prefer the instant appeal for redressal of his grievances on the following amongst other grounds inter alias:

## Grounds for Consideration:

- A. That the acts of the Respondents while not considering the appellant for promotion is unlawful, illegal, void ab-initio and in disregard of law applicable to the matter.
- B. That the Appellant being appointment 02.09.1990 in (BPS-17) as Medical Officer, thereafter Promoted 10.09.2009 (BPS-18) as Senior Medical Officer and Perform his duty with no complaint, and thereafter appellant was promoted 26.09.2017 (BPS-19) is entitled for promotion to the next higher grade/ scale however due to the ill-will of the Respondents he has been deprived of his lawful right. This Hon' ble Tribunal has got ample powers to direct the respondents for proforma promotion of the appellant in the best interest of justice and fair play without any more delay.

,



That there is most specific provision which precludes or debars the board to consider the case of Appellant for promotion after his retirement, moreover, the promotion of the appellant was due before his retirement, and was also recommended for promotion to BPS 20, however, due to the negligence of the Respondents, the meeting was not held timely. Therefore negligence on the part of Respondents can't be attributed to the appellant.

- D. That there is no cavil with the settled law that the promotion be included proforma promotion cannot be claimed as of right, however, to be considered for promotion by the Board especially once the appellant has met the requirement for promotion. If there is delay on the part of the department while conducting PSB, appellant may not be suffers for the wrong of others.
- E. That much before retirement of the petitioner, the Respondent a working paper was prepared by the department with regard to the promotion but the matter was delayed without any justification reason in the meanwhile the petitioner attend the age of superannuation, the petitioner cannot made suffer on account of departmental lapse and the petitioner would not punished/ deprived by the act and conduct of the department which is liable to the declared illegal and the respondents be directed to promote the Appellant in BPS 20 from the date when juniors to the appellant have been promoted.
- F. That after consequent upon the above mentioned PSB meeting and recommendation Respondent No 1 issued a final promotion list on dated 24/01/2022 the Appellant was much prior retired from his service and the name of petitioner is not entitled for the promotion, which is against law, facts and circumstances and liable to be declared void ab initio.
- G. That the impugned inaction of the respondents is actually denying the appellant's vested right, and keeping his promotion case pending for an unreasonable length of time is a clear violation of the policy on the subject. Appellant has been suffered at the hands of Respondents for no reasons. Hence the Hon' ble Tribunal may direct the respondents for proforma promotion of the appellant.



That appellant has been discriminated as juniors to appellant have been promoted and the appellant has been ignored. Hence the Tribunal may pass an order in favour of the appellant to meet ends of justice.

I. Further grounds may be argued at the time of arguments with the permission of the Hon' ble Tribunal, and once the stance of the Respondents comes fourth.

In view of the foregoing facts and grounds, it is therefore most respectfully submitted that on acceptance of the instant appeal, Respondents may very graciously be directed to promote the appellant {Proforma Promotion}to the next grade/ scale i.e. BPS 20 {as Chief Medical Officer BPS 20} w.e.f. from the date of promotion of juniors in the seniority list with all financial and other back benefits.

Any other relief which this Hon' ble court deem fit and appropriate in the facts and circumstances of the case may also be granted.


