APPEAL UNDER SECTION 4 OF THE SERVICE TRIBUNAL ACT, 1974 AGAINST THE IMPUGNED ORDER DATED 22/12/2021 WHEREBY THE PENALTY OF REDUCTION TO TO ASI FROM THE RANK OF OFFICIATING SI UNDER POLICE RULES 1975 AND AGAINST THE REJECTION ORDER DATED 06.07.2022 WHEREBY THE DEPARTMENTAL APPEAL OF THE APPELLANT HAS BEEN REJECTED FOR NO GOOD GROUNDS.

PRAYER:

THAT THE ACCEPTANCE OF THIS APPEAL, THE IMPUGNED ORDER DATED 06.07.2022 AND 22/12/2022 MAY BE SET ASIDE AND THE APPELLANT MAY BE RESTORED TO HIS ORIGINAL SCALE OF OFFICIATING SI AND FURTHER CONFIRMATION AS SI WITH ALL BACK AND CONSEQUENTIAL BENEFITS W.E.FROM JUNIOR WAS CONFIRMED. ANY OTHER REMEDY WHICH THIS

AUGUST TRIBUNAL DEEMS FIT AND APPOPRIATE THAT MAY ALSO BE AWARADED IN FAVOUR OF APPELLANT.

RESPECTFULLY SHEWETH:

FACTS:

- 1. That the appellant was recruited as constable with effect from 23.08.1999, qualified the lower school course in term ending 20.09.2006 and intermediate college courses in term ending 20.03.2014 successfully from PTC, Hangu. Copy of Document is attached as annexure-A.
- 2. That vide letter No. 898-923E-III dated 13.02.2017 the appellant was included in successful candidates against the (in service quota 9%) and his other colleagues against the general quota 25% in direct recruitment as ASI through Public Service Commission, Khyber Pakhtunkhwa. They were appointed as PASIs vide RPO Bannu Region, Bannu order No. 32-36EC dated 23.02.2017 (Annexure A &B are attached) both quotas have been maintained by the Public Service Commission/CPO Peshawar separately. (copy of the appointment order is attached as annexure-B.
- 3. That appellant's other colleague of general quota were selected for Basic PASI course at PTC Hangu, whereas the appellant was exempted from PASI course being already qualified the lower school course and intermediate college course vide PTC Hangu Memo No. 573/EC dated 27.04.2017. copy of letter is attached as annexure-C.
- 4. That a separate practical training program, A, B, C & D under Police Rules 19-25 was chalked out for the appellant respectively. The Commandant PTC Hangu was also granted NOC to continue A,B,C & D Training Program. copy of NOC is attached as annexure-D.
- 5. That during the above mentioned courses an implementation on standing order of Elite Course for PASI was started and successfully completed the 06 months Elite Course.
- 6. That after completion of all courses satisfactorily and fulfilling on all the codal/legal formalities, the DPO, Bannu vide his Memo No. 7490 dated 22.06.2020 recommended the appellant for confirmation bring his

name on promotion list E". (Copy of letter is attached at Annexure E).

- 7. That on recommendation of DPO, Bannu, the RPO Bannu issued appellant's confirmation order and brought his name on promotion list E vide his order endorsement No. 2264/EC dated 20.07.2020 (copy pf confirmation order is attached at Annexure F).
- Bannu Region, Bannu Senior and junior Colleagues along with the applicant was called in the said DPC meeting for consideration of appellant name for promotion to the rank of officiating Sub Inspector and accordingly appellant name was approved for the said promotion RPO Bannu Region, Issued promotion order vide his order endorsement No. 4442-45EC dated 17.12.2020. (Copy of DPC meeting and promotion order is attached as annexure-G).
- 9. That after the promotion of Sub Inspector, the applicant was transferred to Elite Force, Khyber Pakhtunkhwa for the completion of one year other unit posting tenure which is compulsory for confirmation as Sub inspector and Still serving in elite force.
- 10. That RPO, Banu Region issued a Show Cause Notice against appellant alleging appellant promotion 'as wrong' and appellant submitted proper reply to the Show Cause Notice thereafter it was alleged that appellant was summoned to the orderly room held on 21.12.2021 but actually the applicant was not informed in this regard. (Copy of show cause notice and reply is attached as Annexure-H).
- 11. That ex-parte action was taken against appellant on the pretext of not attending the orderly room held on 21.12.2021 in spite of the fact that no such information was conveyed to appellant through any way and issued impugned order dated 22.12.2022 of reversion without any plausible cause. Without unearthed the real facts That since appellant was already senior from his colleagues according to Police Rules 12-2 (3) and appellant was awarded regular promotion by the competent authority in DPC meeting after fulfilling all the basic criteria as devised for the promotion, he did not affect seniority of colleague or cross them, as seniority list É' is worth perusal. It is pertinent to mentioned here that junior most colleagues of appellant have been promoted as officiating SI and some of they were confirmed who affected the seniority while the appellant was reverted without any reason which is

injustice. Copy of the impugned order and seniority list is attached as annexure-I & J.

- 12. That the appellant preferred departmental appeal against the order dated 22.12.2021 which was rejected vide order dated 06.07.2022 for no good grounds. (Copy of Departmental appeal and rejection order are attached as annexure-K & L).
- 13. That now the appellant come to this august Tribunal on the following grounds amongst others.

GROUNDS:

- A) That the impugned order dated 22.12.2021 and 06.07.2022 is against the law, facts, norms of justice and material on record, therefore not tenable and liable to be set aside.
- B) That my illegal reversion affected my one year other unit posting tenure in Elite Force and also from the date of reversion my junior colleagues were granted substantive promotion as Sub Inspector in different occasions. Further it is added that the deptt takes the stance that reversion from officiating rank is not a punishment, which is totally wrong in the light of standing order dated 28/02/2022 and 03/2015, because without promotion to officiating Sub-inspector further promotion to SI cannot be possible, so the appellant was reverted as punishment which effect his promotion and seniority. (Copy of documents attached as annexure-M).
- That ex-parte action was taken against appellant on the pretext of not attending the orderly room held on 21.12.2021 in spite of the fact that no such information was conveyed to appellant through any way and issued impugned order dated 22.12.2022 of reversion without any plausible cause. Without unearthed the real facts That since appellant was already senior from his colleagues according to Police Rules 12-2 (3) and appellant was awarded regular promotion by the competent authority in DPC meeting after fulfilling all the basic criteria as devised for the promotion, he did not affect seniority of colleague or cross them, as seniority list É' is worth perusal. It is pertinent to mentioned here that junior most colleagues of appellant have been promoted as officiating SI and some of they were confirmed who affected the seniority while the appellant was reverted without any reason which is injustice. Copy of promotion order is attached as annexure-N.
- D) That appellant have appointed as PASI on the recommendation of Public Service Commission under (in service graduate constable/Head constable 19% quota) vide letter & order are quoted above.

- E) That appellant have exempted from the Basic PASI course as appellant have already qualified lower School Course and Intermediate College Course vide Commandant PTC Hangu letter quoted Above.
- That according to Police Rules 19-25 (2) on successfully completing the basic PASDI course i.e Lower School Course & intermediate College Course at Training College. The officer will be posted in district for practica training A,B,C & D, as i was already qualified and exempted from the basic course was chalked out the said practical program for e. I was also granted NOC to continue the said program by the Commandant Police Training College Hangu vide his letter No. 1489-EC, dated 02.12.2017.
- That appellant was completed successfully satisfactorily A,B, C & D and also qualified Elite Basic Training of 06 months for PASI, after completion of 3 years probation period comprising of the said course successfully. he was recommended for confirmation to the Regional Police Officer Bannu region, Bannu vide DPO letter No. 1490 dated 20.06.2020 as mentioned in laid down Police Rules 19-25 (5).
- H) That no one of appellant colleagues objected his promotion which showed that he has not over taken his colleagues and it is also worth mentioning in promotion list E. but all senior and junior colleagues who were promoted with appellant at the same date as officiating sub SI were granted regular promotion to the rank substantive Sub Inspector and other junior most were promoted as Officiating SI, the substantive promotion over took appellant in seniority.
- That on 04.06.2021 a letter was issued for DPC meeting for the substantive promotion of officiating Sub inspector vide Region office Memo No. 2132-41EC dated 04.06.2021 and appellant name was mentioned at S. No 54 for the said promotion. Later on issued show cause notice and reverted illegally while other colleagues mentioned in the said letter were promoted to the rank of substantive promotion of SI to the S. No 61 who are junior to appellant.
- J) That appellant name was put in orderly room scheduled on 21.12.2021 but intentionally was not informed which is clear from the call letter issued from Regional Office vide . 5987-90EC dated 21.12.2020 the SP/EF Bannu region was not addressed and also his name was not put in DPO urdu Parwana issued for control room bannu (both are attached). appellant also stated solemnly that appellant was not informed on any way by the anyone.
- K) That appellant was illegally reverted without any plausible grounds and affected his other unit posting tenure in elite Force which is compulsory for confirmation in the Rank of Sub Inspector. Further it is added that the deptt taken the plea that appellant superseded 15 colleagues which is illegal and wrong presumption because the colleges of the appellant was

appointed under initial quota and appellant was appointed in service quota. And appointed order was not issued according to merit.

- L) That one year officiating period is also mandatory for promotion to the Substantive rank SI and such like illegal step can affect the service career and future o officer.
- M) That during appellant reversion period appellant junior colleagues granted promotion to the substantive Sub Inspector who over took appellant seniority, as worth clear from the promotion list E.
- N) That appellant service career badly affected and mentally tortured by taking illegal step against appellant.\
- O) That no proper regular inquiry was conducted if any then the appellant was not associated with the inquiry, neither the statement recorded in presence of appellant nor was the chance of cross-examination provided to the appellant and also not provided the inquiry report to the appellant and without final show cause notice the impugned order was passed which is against the law, rules and norms of justice.
- P) That the appellant has been condemned unheard in violation of Article 10-A of the Constitution of Islamic republic of Pakistan and in violation of maxim "Audi Alterum Partum" and has not been treated according to law and rules.
- That proper procedure was provided in Rule-5 Read with Rules -6 in of the Police Rules 1975, which were totally ignored before imposing punishment i.e no proper regular inquiry was conducted if any then the appellant not associated with the inquiry, neither the statement recorded in presence of appellant nor was the chance of cross examination provided to the appellant and also not provided the inquiry report to the appellant, so the impugned order was passed in violation of law and rules and norms of justice.
- R) That the penalty order of the appellant is the violation of basic law and rules as in the penalty order it was not mention the period of reversion to the rank of constable to be effective.
- S) That the appellant was condemned unheard and has not been treated according to law and rules.
- That the opportunity of personal hearing and personal defense was not provided to the appellant.



U) That the appellant seeks permission to advance others grounds and proofs at the time of hearing.

It is, therefore most humbly prayed that the appeal of the appellant may be accepted as prayed for.







My this order will dispose off departmental proceedings initiated against OSI Dilabaz Khan No.36/B of Bannu District Police, presently posted in Elife Force, Khyber Pakhtunkhwa, under Police Rule 1975 (with amendment 2014) on the following grounds;

- That after perusal of the relevant record, it was found that during "D" Course he OSI Dilabaz Khan No.36/B was posted as Focal Person/Incharge Complaint Cell in contravention of the laid down rules. Record further reveals that he has superseded his 16 colleagues by manipulating his confirmation as ASI; bringing his name on promotion list "E" and promotion as Offg: SI after collusion with the dealing hands of DPO and RPO Offices Bannu while his other colleagues total in number 16 are still under probation.
- He was therefore required to show cause as to why the order with regard to his Offg: promotion as SI and bringing his name on promotion list "E" should not be withdrawn/set aside.

The said police officer was proceeded against departmentally under Police Rule 1975 and RPEO, Range Office Bannu was appointed as Enquiry Officer who conducted inquiry in the subject proceedings and submitted his findings, wherein, the E.O concluded that the said police officer OSI Dilabaz Khan is recommended to be reverted from the officiating rank of SI to the substantive rank of ASI as his colleagues are in the substantive rank of ASIs, being officiating promotion is not a regular promotion and can be withdrawn any time without any departmental proceedings and no appeal in this regard can be filed by the officer concerned. APPEAL AGAINST THE ORDER OF DIG/BANNU ISSUED VIDES ENDORSEMENT

R/Sir,

With due reverence the applicant submit the following submissions against the impugned order passed by the Regional Police Officer, Bannu Region, Bannu, Bannu vide his order endorsement No. 6032-33/EC dated 22.12.2021, wherein the applicant has been reverted to the substantive rank of ASI with immediate effect.

FACTS.

- 1. The applicant was recruited as constable with effect from 23.08.1999, qualified the lower school course in term ending 20.09.2006 and Intermediate College courses in term ending 20.03.2014 successfully from PTC, Hangu.
- 2. That vide letter No. 898-923/E-III dated 13.02.2017, the applicant was included in successful candidates against the (In service quota 19%) and his other colleagues against the (General quota 25 %) in direct recruitment as ASI through Public Service Commission, Khyber Pakhtunkhwa. They were appointed as PASIs vide RPO, Bannu Region, Bannu order No. 732-36/EC dated 23.02.2017 (Annexure A & B are Public Service attached). Both quotas have been maintained by the Commission/CPO, Peshawar separately.
- 3. That my other colleague of general quota were selected for Basic PASI course at PTC/Hangu, where as the applicant was exempted from PASI course being already qualified the lower school course and intermediate college course vide PTC/Hangu Memo No. 573/EC dated 27.04.2017.
- 4. That a separate practical training program A, B, C & D under Police Rules 19-25 was chalked out for the applicant respectively. The Commandant PTC/Hangu was also granted NOC to continue A, B, C & D training program.
- 5. That during the above mentioned courses an implementation on standing order of Elite Course for PASI was started and successfully completed the 06 months Elite
- 6. That after completion of all courses satisfactorily and fulfilling on all the codel/legal formalities, the DPO, Bannu vide his Memo No. 7490 dated 22.06.2020 recommended the applicant for confirmation/bring his name on promotion list "E" (copy is attached at annexure C).
- 7. The on recommendation of DPO, Bannu, the RPO, Bannu Region, Bannu issued my confirmation order and brought my name on promotion list "E" vide his order endorsement No. 2264/EC dated 20.07.2020. (Copy is attached at annexure D)
 - That in December 2020, DPC meeting was scheduled by the RPO, Bannu Region, Bannu, senior and junior colleagues along with the applicant was called in the said DPC meeting for consideration of my name for promotion to the rank of officiating Sub Inspector and accordingly my name was approved for the said promotion. The

RPO, Bannu Region, Bannu issued promotion order vide his order endorsement No. 4442-45/EC dated 17.12.2020 (Copy is attached at annexure E).

- 9. After the promotion of Offt: Sub Inspector, the applicant was transferred to Elite Foce, Khyber Pakhtunkhwa for the completion of one year other unit posting tenure which is compulsory for confirmation as Sub Inspector and still serving in Elite Force.
- 10. That RPO, Bannu Region, Bannu issued a Show Cause Notice against me alleging my promotion "as wrong" and I submitted proper reply to the Show Cause Notice. Thereafter it was alleged that I was summoned to the orderly room held on 21.12.2021 but actually the applicant was not informed in this regard (copy of letter and Parwana are attached at Annexure F & G).
- 11. That an ex-parte action was taken against me on the pretext of not attending the orderly room held on 21.12.2021 in spite of the fact that no such information was conveyed to me through any way and issued impugned order of my reversion without any plausible cause.
- 12. That I also submitted a review petition against the said order which was also turned down by the authority (Copy is attached at Annexure F).
- 13. That since I am already senior from my colleague according to Police Rules 12-2(3) and I was awarded regular promotion by the competent authority in DPC meeting after fulfilling of the basic criteria as devised for the promotion, he did not affect seniority of colleague or cross them, as seniority list "E" is worth perusal. It is pertinent to mentioned here that junior most colleagues of me have been promoted as Officiating SI and some of them were confirmed who affected my seniority while I was reverted without any reason which is injustice.
 - 14. That my illegal reversion affected my one year other unit posting tenure in Elite Force and also from the date of reversion my junior colleagues were granted substantive promotion as Sub Inspector in different occasions. (Attached promotion List E is worth perusal).

GROUNDS:

- That I have appointed as PASI on the recommendation of Public Service Commission under (In Service graduate constable/Head constable 19% quota) vide letter & order are quoted above.
- That I have exempted from the basic PASI course as I have already qualified lower School Course and Intermediate College Course vide Commandant PTC Hangu letter No. quoted above.
- 3. That according to Police Rules 19-25 (2) on successfully completing the basic PASI course i.e. Lower School Course & Intermediate College Course at Training College, the officer will be posted in district for practical training A, B, C & D, (as I was already qualified and exempted from the basic course was chalked out the said practical program for me. I was also granted NOC to continue the said program by the

Commandant Police Training College, Hangu vide his letter No. 1488/EC dated 07.11.2017. (Copy is attached).

- 4. That I was completed successfully/satisfactorily A, B, C & D and also qualified Elite Basic Training of 06 months for PASI, after completion of 3 years probations period comprising of the said courses successfully, I was recommended for confirmation to the Regional Police Officer, Bannu Region, Bannu vide DPO letter No. 7490 dated 20.06.2020 as mentioned in laid down Police Rules 19-25 (5).
- 5. That on recommendation of DPO, Bannu, the Regional Police Officer, Bannu Region, Bannu issued confirmation order and brought his name on promotion list "E" vide his order Endst: No. 2264/EC dated 20.02.2020. The DPO, Bannu also issued notification vide Endst: No. 9181-85 dated 22.07.2020.
- 6. That on 25.11.2020 a DPC meeting for promotion to the rank of Officiating Sub-Inspector was scheduled at Region Office, Bannu and I along with my Junior and senior colleagues on promotion list "E" was called vide RPO Office letter No. 4060-65/EC dated 19.11.2020, on fulfilling the required criteria my name was approved and promoted to the rank of Offt: Sub Inspector vide RPO Order Endst: No. 4442and promoted to the rank of Offt: Sub Inspector vide RPO Order Endst: No. 4442-45/EC dated 17.12.2020 and DPO, Bannu notification No. 16040-43 dated
 - 7. That no one of my colleagues objected my promotion which showed that I have not over taken my colleagues and it is also worth mentioned in promotion list "E" but all senior and junior colleagues who were promoted with me on the same date as Offt: Sub SI were granted regular promotion to the rank substantive sub inspector and other junior most were promoted as Offt: SI, the substantive promotion over took me in seniority.
 - 8. That on 04.06.2021 a letter was issued for DPC meeting for the substantive promotion of Officiating Sub inspector vide Region office Memo No. 2132-41/EC dated 04.06.2021 and my name was mentioned at S/No. 54 for the said promotion, later on I was issued show cause notice and reverted illegally while other colleagues later on I was issued show cause notice and reverted illegally while other colleagues mentioned in the said letter were promoted to the rank of substantive promotion of SI to the S/No. 61 who are junior to me. (letter is attached)
 - 9. That in view of the above circumstance on what ground I was issued Show Cause Notice and reverted as I was promoted by the competent authority after fulfilling on the required criteria.
 - 10.
