Mr. Hamza Amir Gulab, Advocate for the appellant present. Preliminary arguments heard.

Learned counsel for the appellant argued that the appellant is working in the respondent department since 08.11.1990 when he joined the service as Forest Guard. He while posted as incharge Darorra Forest Check Post was issued Show Cause Notice on 29.07.2021, on the ground that surprise inspection/checking of the said Forest Check Post was carried out, on 29.07.2021, the appellant was found absent from duty and the Check Post had been left at the mercy of timber Smugglers. The appellant was directed to submit his reply to the Show Cause Notice within 03 days. However, astonishingly respondent No. 2 without waiting for reply of the appellant to Show Cause Notice, issued the impugned original order on 29.07.201 i.e. on the same date Show Cause Notice was issued and his absence period w.e.f. 16.07.2021 to 28.07.2021 was ordered to be leave without pay. His departmental appeal against the impugned order submitted to respondent No. 1 on 23.08.2021, was decided vide impugned appellate order dated 08.11.2021 and his departmental appeal was rejected. It was further contended that no regular enquiry has ever been conducted against the appellant. No proper charge sheet/statement of allegations was issued to the appellant. The laid down and prescribed procedure as per Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011 has not been followed and the impugned order against the appellant is therefore illegal, unjustified issued in a whimsical manner, is therefore not tenable on the touchstone of legal formity.

SERVICE APPEAL U/S 4 OF THE KHYBER PAKHTUNKHWA SERVICES TRIBUNAL ACT, 1974 AGAINST THE IMPUGNED ORIGINAL ORDER DATED 29.07.2021 PASSED BY RESPONDENT NO.2 WHEREBY APPELLANT WAS DECLARED ABSENT FROM DUTY AND THE SAID PERIOD WAS TREATED AS LEAVE WITHOUT PAY & AGAINST APPELLATE AUTHORITY (RESPONDNET NO 1) ORDER DATED 08.11.2021 WHEREIN THE DEPARTMENTAL APPEAL/ REPRESENTATION OF THE APPELLANT REJECTED.



By accepting this Appeal, the impugned orders of Respondent No I dated 08.11.2021 and Respondent No.2 dated 29.07.2021 may graciously be set aside.

Respectfully Sheweth:

- 1. That the Appellant was inducted in Forest Department as Forest Guard on 08.11.1990, and now serving as Forester, and thus he has more than 30 years of service in his credit.
- 2. That Appellant is a law abiding citizen of Pakistan and having a long carrier of service with the said department, no complaint has ever been reported against him and thus he is having an unblemished service record.
- 3. That all of sudden on 29.07.2021, Respondent No.3 issued a show cause notice to the Appellant and levelled the frivolous allegations against the Appellant regarding the absence from duty.

(Copy of Show Cause Notice dated 29.07.2021 is annexed as annexure "A").



That on the same day of show cause notice i.e. dated 29.07.2021 Respondent No 2 imposed penalty and ordered to treat absence of Appellant as leave without pay from the period of 16.07.2021 to 28.07.2021. Appellant submitted appeal to Respondent No 2 on 01.08.2021 but no order was passed on the said Appeal.

That aggrieved from the Order of Respondent Mo 2 the Appeal/Representation to Respondent Mo. 1 on 23.08.2021. But the appeal of Appealant was rejected on 08.11.2021

6. That aggrieved by the said Order the Appellant is constrained to file the instant service appeal before this Hon'ble Tribunal on the following grounds:

That the impugned Order of Respondents is illegal, ultra vires, unfounded, void an initio, unlawful and thus ineffective upon the rights of the Appellant.

- B. That without conducting enquiry and affording an opportunity to Appellant to produce evidence in his favour, the frivolous allegation the penalties vide the impugned order has been passed.
- C. That the very Order is against the norms of justice, exparte and against Article 10-A of the Constitution of Pakistan and against the natural justice.
- D. That issuing show cause notice and impugned Order on the same day clearly suggests that the entire proceedings is an illegality in the eye of law and justice.
- E. That the Appellant performed his duty during the said period but without considering the plea of Appellant and conducting inquiring, the entire proceedings being void ab initio and liable to be set aside on this score alone.

F. That the impugned order has been passed in vacuum without having solid, cogent and convincing evidence and is the result of colorable exercise of powers.

G. That the impugned order has been passed without any regular inquiry, which is against Khyber Paktunkhwa Government Servants (E & D) Rules 2011, therefore the same has no legal footing to stand upon.

II. That any other ground will be raised at the time of arguments with the prior permission of this Hon'ble Tribunal.

It is, therefore most humbly prayed that by accepting this appeal, the impugned orders of Respondent No 1 dated 08.11.2021 and Respondent No.2 dated 29.07.2021 may graciously be set aside **OR** any other relief this Honourable Court may deem just and proper be also passed in favour of Appellant.




