



APPEAL UNDER SECTION 4 OF THE SERVICE TRIBUNAL ACT, 1974 AGAINST THE ORDER DATED 28.02.2022 VIDE WHICH THE APPELLANT WAS REMOVED FROM SERVICE ON ACCOUNT OF UNAUTHORIZED ABSENCE W.E.F 01.10.2018 AND



### **Prayer in Appeal:**

On acceptance of this Appeal, the impugned order dated 28.02.2022 issued by respondent NO. 2 may kindly be declared to be illegal thus set aside and the appellant may be reinstated in service with all back benefits.

### Respectfully Sheweth:

- 1. That the appellant was appointed vide Order dated 17.11.2014, in a project called "IT/Computer Science Teachers and Computer Labs Project in Khyber Pakhtunkhwa" as IT Teacher BPS-16 on contract basis and his contract period was extended vide Order dated 14.02.2017 uptil 30.06.2017. Copy of the Orders are attached a annexure "A" & "B", respectively.
- That the appellant performed his duty diligently, with devotion and to the entire satisfaction of his superiors and there was not a single complaint against the appellant.



- 3. That the appellant performed his duties from the date of his appointment i.e. 17.11.2014 to 01.10.2018 and was paid his salary uptil 30.06.2017. As the project expired 30.06.2017, therefore, his salary was stopped. That since the salary of the appellant was stopped and there was no instructions from the department for the performance of duty, therefore, he discontinued his duty onward i.e. 01.10.2018.
- 4. That as the respondents were not accepting the appellant to be his employee, therefore, he discontinued his duty onward from 01.10.2018 which fact is apparent from the letter dated 31.10.2018 issued to one Muhammad Kashif Lab Incharge (co-employee of the appellant) wherein the respondents denied the fact that the appellant is the employee of the respondents. (Copy of the letter is attached as annexure "C").
- 5. That on 15.01.2019, show cause notice was issued to the appellant due to his absenteeism from duty which was replied by the appellant accordingly. (Copy of the show cause notice)

and reply are attached as annexure "D" & "E").

- 6. That in the light of Appointment and Regularization of Services Amended Act, 2018 (Khyber Pakhtunkhwa Act No. II of 2019), the services of the appellant were regularized w.e.f 17.11.2014 i.e. from the date of initial appointment. (Copy of the regularization order is attached as annexure "F").
- 7. That the appellant in the light of Regularization Order, taken charge of the post on 21.03.2019.
  (Copy of the charge report is attached as annexure "G").
- 8. That the appellant applied for leave without pay w.e.f 01.04.2019 to 31.03.2021 through his application dated 01.04.2019 which was processed accordingly and the appellant was under the impression that his leave without pay is sanctioned, therefore, leave the station. (Copy of the application is attached as annexure "H").
- 9. That surprisingly, the appellant was issued show cause notice which was not received to the appellant and the appellant after expiry of the

leave period, submitted his arrival report on 01.04.2021 (Copy of the show cause notice and arrival report are attached as annexure "I" & "J").

- 10. That principal of the school through his letter dated 05.04.2021, submitted his report seeking guidance from respondent No. 3 regarding the assumption of the charge of the appellant. (Copy of the letter dated 05.04.2021 is attached as annexure "K").
- 11. That respondent No. 3 after woke up from deep slumber, submitted his report dated 15.07.2021 to respondent No. 2 regarding absentee of the appellant. (Copy of the report dated 15.07.2021 is attached as annexure "L"). In the said report, respondent No. 3 has malafidely concealed the assumption of the charge of the appellant.
- 12. That respondent No. 2 in the light of the earlier show cause notice issued to the appellant through notification dated 17.08.2021, imposed penalty of One Day Salary Deduction and absented period was converted into leave without pay.

  (Copy of Notification dated 17.08.2021 is attached as annexure "M").



- That the appellant in the light of Notification 13. dated 17.08.2021 issued by respondent NO. 2 has taken charge of his post vide arrival report dated 11.09.2021, and was performing his duty diligently, till the issuance of impugned Notification from the removal of the service of appellant. The factum of service of the appellant is apparent from his attendance register. Further the appellant was paid salary till removal from service. During this period, the appellant has also performed election duty as CCTV Supervisor. (Copies of the arrival report 11.09.2021, attendance register, salary slips and Notification dated 08.02.2022 are attached as annexure "N", "O", "P" & "Q").
- 14. That to the utter surprise of the appellant, respondent No. 2 through his office order dated 28.02.2022 imposed penalty of removal from service upon the appellant on account of his unauthorized absence w.e.f 01.10.2018 in the light of respondent No. 3 report dated 15.07.2021. (Copy of the impugned order dated 28.02.2022 is attached as annexure "R").



(Annexed-S) on 28.03.2022 to respondent No.

1 which was un-responded, hence the appellant feeling aggrieved from the above impugned order, prefers the instant service appeal before this Hon'ble Tribunal, on the following grounds:

#### **GROUNDS:**

- A. That the appellant has not been treated in accordance with law and rules on the subject and the rights guaranteed to the appellant under the constitution have been violated flagrantly.
- B. That on the face of it, the impugned order dated 28.02.2022 is illegal because from the period i.e. 01.10.2018 onward, the appellant was not on service and the project life has expired on 30.06.2017. The appellant could not be held countable for the period for which he was not paid salaries and there was no specific orders from the respondents to serve. Further, as is clear from the letter dated 31.10.2018, that the respondents were not accepting the appellants and his co-employees be to the employees of the respondents.



- C. That the services of the appellant were regularized under Appointment and Regularization of Services Amended Act, 2018 (Khyber Pakhtunkhwa Act No. II of 2019) from 17.11.2014 through Notification dated 08.03.2019 and during the intervening period i.e. from 01.07.2017 to 07.03.2019, there was no specific instruction to the appellant for performance of the duties, because the project life was expired on 30.06.2017.
- D. That no departmental inquiry was conducted against the appellant and the appellant was removed from service only on the basis of report of respondent No. 3 which amount to condemned unheard.
- E. That fundamental rights of the appellant have been violated because to the report submitted by respondent no. 3 at the back of the appellant, no show cause notice was issued to the appellant and he was proceeded illegally and major penalty of removal from service was imposed upon the appellant.
- F. That the respondent has passed the impugned order in a slipshod manner and ignored the fact that after passing of the impugned order, the appellant was promoted to SSIT BPS-17 vide Notification dated 15.04.2022 and his services were placed through notification dated 30.05.2022 in GHSS Nari Panoos



Karak. (Copy of the Notifications dated 15.04.2022 and 30.05.2022 are attached as annexure "T").

- G. That double punishment was imposed upon the appellant, which is against the norms of justice because a person cannot be vexed twice for the same offence.
- H. That any other ground in respect of the instant appeal will be raised at the time of arguments with permission of the worthy Tribunal.

#### PRAYERS:

It is, therefore, most humbly submitted that on acceptance of this Appeal, the impugned order dated 28.02.2022 issued by respondent NO. 2 may kindly be declared to be illegal thus set aside and the appellant may be reinstated in service with all back benefits.
