Learned counsel for the appellant stated that the appellant submitted appeal/application dated 04.07.2009 to the respondent No.2/CCPO Peshawar, for the conversion of penalty of forfeiture of two (02) years service into minor punishment, which appeal/application was simply filed vide the final impugned order dated 27.09.2009. Learned counsel for the appellant argued that the final impugned/rejection order dated 27.09.20009 is not a speaking order and the appellant would feel contended if the respondent department/respondent No.2 is directed to decide his departmental appeal/application dated 04.07.2009 with speaking order.
