



APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 AGAINST THE IMPUGNED INACTION OF THE RESPONDENTS WHEREBY JUNIORS TO THE APPELLANT HAS BEEN PROMOTED TO THE POST OF ASSISTANT (BPS-16) AND THE APPELLANT HAS NOT BEEN CONSIDERED FOR PROMOTION AT PAR WITH HIS JUNIOR COLLEAGUES IN UTTER VIOLATION OF LAW & RULES AND AGAINST THE INACTION OF THE RESPONDENTS BY NOT DECIDING THE DEPARTMENTAL APPEAL WITH IN THE STIPULATED PERIOD OF NINETY DAYS.

PRAYER:

That on acceptance of this appeal the impugned action and inaction of the respondents whereby juniors to the appellant have been promoted to the post of senior clerk (BPS-14) and assistant (BPS-16) respectively may kindly be declared as illegal and unlawful and may also please be set aside and the appellant be promoted to the post of senior clerk (BPS-14) and assistant (BPS-16) respectively w-e-f when his other junior colleagues were promoted with all back benefits including seniority. Any other remedy which this august Tribunal deems fit that may also be awarded in favor of the appellant.

R/SHEWETH:
ON FACTS:

- 1-** That appellant was initially appointed as junior clerk in the respondents department on 30.08.1994. Copy of the service book having entry of the appointment is attached as annexure**A.**
- 2-** That vide DPC held on 17-09-2020 the appellant was promoted to the post of senior clerk (BPS-14) vide promotion notification dated 13.02.2021. Copy of the notification dated 13.02.2021 is attached as annexure**B.**
- 3-** That as per the tentative seniority list dated 31.05.2021 the private respondents at serial No. 138, No. 139 and No. 141 have been promoted to the post of senior clerk (BPS-14) and Assistant (BPS-16) respectively in utter violation of the law and rules on the subject. That the appellant was entitled to be promoted to the post of senior clerk (BPS-14) earlier than the private respondents but the appellant was ignored with no reasonable justifications. Copy of the tentative seniority list dated 31.05.2021 is attached as annexure**C.**
- 4-** That it is important to mention here that vide NWFP District Government Rules of Business 2001 the District Nazim under the ibid rules exercising the powers, not so conferred, promoted some junior to the appellant by violating the hyber Pakhtunkhwa APT Rules, 1989. Copy of the Rules of Business 2001 is attached as annexure**D.**
- 5-** That appellant feeling aggrieved from the unlawful action of the respondents preferred departmental appeal before the respondent No. 1 on 11.10.2021. Copy of the departmental appeal is attached as annexure**E.**
- 6-** That the departmental appeal of the appellant was properly forwarded to the appellate authority vide letter dated 11.01.2022 but till date no response has been given by the appellate authority. Copy of the letter dated 11.01.2022 is attached as annexure**F.**
- 7-** That appellant feeling aggrieved and having no other remedy but to file the instant service appeal on the following grounds amongst the others.

GROUND:

A- That the impugned action and inaction of the respondents whereby juniors to the appellant have been promoted to the post of senior clerk (BPS-14) and assistant (BPS-16) and ignoring the appellant having preferential right being senior to the private respondents are against the Law, facts, norms of natural justice and materials on the record hence not tenable and liable to be set aside.

B- That appellant has not been treated by the respondent Department in accordance with law and rules on the subject noted above and as such the respondents violated Article-4 and 25 of the Constitution of Islamic Republic of Pakistan-1973.

C- That the respondents acted in arbitrary and malafide manner by promoting the private respondents and ignoring the appellant without any justifiable reasons is against Norms of Natural Justice.

D- That the appellant has been highly discriminated with the act of the respondents while promoting the private respondents and ignoring the appellant without any justifiable reasons.

E- That by promoting the private respondents and ignoring the appellant without any justifiable reasons being senior to the private respondents is the violation of section-8 of Khyber Pakhtunkhwa Civil Servant Act, 1973 read with Rule-17 of the Khyber Pakhtunkhwa APT rules, 1989.

F- That action of the respondents with the connivance of the District Nazim by placing junior to the appellant as senior under the Rules of Business 2001 is the utter violation of the law and rules relating to the subject.

G- That appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed for.

1. Short title and commencement:

- a. These rules may be called the N.W.F.P. District Government Rules of Business, 2001.
- b. It shall come into force on 14th August, 2001.

2. Definitions:

The words used shall have respectively the same meaning as assigned to it in section 2 of the ordinance or in the relevant Provincial law for the time being in vogue.

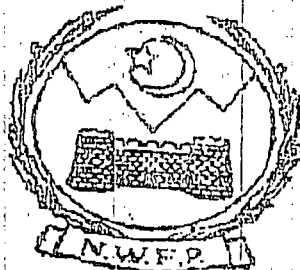
3. Deputation of Civil servants and Power of District Coordination Officers:

- a. The civil servants posted in the decentralized departments shall continue to be civil servants for all intent purposes of the relevant civil servants laws and the rules framed there under with the modification that:-

(1) All civil servants in BPS-16 to BPS-20 shall be appointed by the Provincial Government or Federal Government as the case may be and posted in the decentralized Departments from time to time.

(2) The district Coordination Officer shall have the powers of the appointing authority in respect of the officers/officials in BPS-1 to BPS-15, provided that no vacancies are to be filled in by way of direct recruitment or transfers and the officers/officials of the surplus pool are to be absorbed/adjusted against the vacancies, provided further that even after the said period ban on recruitment shall remain continue till the ban is lifted by the Governments in the Finance Department.

(3) In case of disciplinary actions, the Zila Nazim in case of officers in BPS-19 and District Coordination Officer in the case of officers in BPS-16 to BPS-18 shall refer the cases to the competent authority for decision under the N.W.F.P. Removal from Service (Special Powers) Ordinance, 2000 (N.W.F.P. Ordinance No: V of 2000), through the administrative Secretary concerned.

(4) The District Coordination Officer shall have the powers of competent authority in respect of the officers/officials in BPS-1 to BPS-15 under N.W.F.P. Removal from Service (Special Powers) Ordinance, 2000.

(5) The Nazim shall exercise the powers of transferring authority within the district in respect of officers in BPS-19 and BPS-20.

(6) The District Coordination Officer shall exercise powers of the transferring authority respect of the civil servants in BPS-16 to BPS-18.

(7) The executive District Officer subject to the approval of the District Coordination Officer shall exercise the powers of the transferring authority in respect of the officers/officials in BPS-1 to BPS-15.

(8) The District coordination Officer will be the controlling officer of Traveling Allowance bill for himself, all the Executive District Officers and all heads of the institutions in the District in BPS-19 and BPS-20.

The Executive District Officer will be controlling officer in respect of the District Officers of the group of decentralized departments under him.

The District Coordination Officer shall be competent to sanction leave to any civil servant under the N.W.F.P. Civil Servants (Leave) Rules, 1981, provided that if a substitute of the officer proceeding on leave may be required the leave shall be sanctioned in prior consultation with the head of the attached department or administrative Secretary concerned, as the case may be.

The District Coordination Officer shall exercise the powers of the head of attached department in respect of the officers posted in the decentralized departments under following rules:

- (1) Fundamental Rules and Supplementary Rules.
- (2) Powers of the head of attached department under the rules framed or saved under the N.W.F.P. Civil Servants Act, 1973, provided that in case of the officers of the All Pakistan Civil Servants or Federal United Service posted in the decentralized departments, shall be governed by the rules applicable to them in the original department and their cases are to be forwarded to the Provincial Chief Secretary for necessary action.

The following reports when received or issued shall be submitted to Zila Nazim for his information.

- a: All periodical reports of District Coordination Officer, District Police Officer and Executive District Officers.
- b: Press notes issued by District Coordination Officer, District Police Officer and Executive District Officers.
- c: All periodical and special reports relating to law and order such as fortnightly situation reports submitted by the police.
- d: Intelligence reports.
- e: Report of Committees of inquiry appointed by District Government.

Secretariat of District Government:

There shall be a secretariat of the district Government head by the District Coordination Officer and comprising of the decentralized departments or group of departments as shown in Schedule-I appended to the rules.

The business of District Government shall be distributed amongst groups of District offices in the manner indicated in Schedule-II appended to the rules.

Each decentralized group of departments shall be headed by an Executive District Officer appointed or nominated by the Government for the purpose.

Each Executive Officer shall be responsible to Zila Nazim through the District Coordination Officer and shall channelize his correspondence through him.

The orders of the District Government shall be expressed in the name of the District Government and shall be signed by a Nazim, a District Coordination Officer, an Executive District Officer or any other officer specifically authorized by the Zila Nazim for the purpose and such signature shall be deemed to be the proper authentication of such order or instrument and shall not be questioned in any court on the ground that was not made or executed by the District Government.

Operation of Provincial account:

The Provincial account funds shall be operated according to the civil account code applicable to all Provincial officers, General Financial Rules and Federal Treasury Rules as adopted by the Government coupled with N.W.F.P. Delegation of Financial Powers and Powers of Re-appropriation Rules, 1981 (as amended from time to time) as if:-

a. A District Coordination Officer was an officer of Category-I under Part I of the First Schedule for all the decentralized departments in a district government.

b. An Executive District Officer was an officer of Category-II under Part-II of the First Schedule for the group of departments under him.

District Officer in BPS-18 was an officer of Category-III of Part III of First Schedule for the department headed by him or the institutions, as the case may be.

- d: All the officers mentioned in the preceding sub rules shall be drawing and disbursing officer for the funds placed at their disposal for all intent and purposes of the Federal Treasury Rules as adopted by the Government provided that if before the commencement of the rules any District Officer or a head of institution of the decentralized departments was already declared as drawing and disbursing officer by the department concerned with any of the powers under the N.W.F.P. Delegation of Financial Powers and Powers of Re-appropriation Rules, 1981, as revised in 1992. He shall continue to exercise the powers conferred on him as if the same powers were delegated to him under these rules.

Office administration and record.

The manual of instructions for Provincial Civil Secretariat issued by the Chief Secretary of the Provincial Government from time to time shall, mutates mutandis be applicable to the secretariat of the District Government and the District Coordination Officer shall have the powers to issue instructions in addition there to and not in derogator of the instructions already issued.

District Coordination Office:

- a: The District Coordination Office shall be responsible for:
- (1) the coordination of the policy of all district offices with respect to the services under their control so as to secure consistency of treatment.
 - (2) securing to all Government servants the rights and privileges conferred on them by law for the time being in force;
 - (3) determining the strength and the terms and conditions of services of the personal staff of Zila Nazim and Naib Nazim; and
 - (4) serving as Secretariat of the Zila Nazim.

No District Office shall without the concurrence of the District Coordination Office, authorized any order other than an order passed in pursuance of any general or special delegation made by the District Coordination Office.

Executive District Committee:

- a: There shall be constituted E.D.O. Committee with the District Coordination Officer as its Chairman, to facilitate coordination among the departments, to provide avenue for the consideration of matters of common interest and to tender advice on any case that may be referred to the Zila Nazim.
- b: Conclusions reached at, the meeting of the E.D.O. Committee shall not be taken as decision of the District Government, unless approved by the District Coordination Officer or Nazim as the case may be.

Relations with Provincial Government:

- a: Zila Nazim may seek the advise of any Provincial Government for the training guide lines for the running of the smooth administration of District Government through the District Coordination Officer of the district and shall be binding on the Government departments to provide timely assistance and guidance to him.

Relations with Provincial Local Government Commission:

- a: Between any department of the Government and the District Government or between two District Government, the Nazim shall cause to prepare a complete case with all the documents required and require the district Coordination Officer to forward the same to the secretariat of the Provincial Local Government Commission. Provided that if the dispute is not amicably resolved, the aggrieved party may move the case before the Chief Executive of the Province for resolution through the Chief Secretary of the Provincial Government and the decision of the Chief Executive thereon shall be final.
