





- 1) That the respondent No.2 advertised different posts in various disciplines including PST (BPS-12) in four Tehsil in District Orakzai on 15.10.2012. It is important to note that four posts of PST BPS-12 were properly advertised for tehsil Ismailzai, District Orakzai. (Copy attached as Annex "A")
- 2) That accordingly the petitioners applied for the posts of PST for Tehsil Ismailzai.
- 3) That the petitioners being fit in eligible candidates applied for the same, but they were not consider without any justified reason. it is worth to mention here that the petitioners were top on the merit list at S.No.1 & 2, but despite the fact the respondent No.3 appointed S.No.3 of the merit list, namely, Rehmat Ullah, which was later on dismissed from his service due to production of fake and bogus documents. (Copies of the merit list and dismissal order is attached as Annex "B & C")
- 4) That the petitioners challenged their refusal for not appointment on the said posts, through WP No.2055-P/2016, before Peshawar High Court, which ultimately decided in favour of the petitioners vide order dated 20.12.2016. (Copies attached as Annex "D & E")
- 5) That on the compliance of the order of Peshawar High Court in the above writ petition, accordingly both the petitioners were appointed on the said post vide order No.130-36 dated 11.01.2017. (Copy attached as Annex "F")
- 6) That after that, the respondent No.__ issued a seniority list dated 06.01.2020, wherein, the petitioners seniority were considered from the date of their appointment i.e. 11.01.2017, instead of 19.11.2014, i.e. (from 1st appointment as their

other colleagues were appointed on 19.11.2014) which is impugned before this hon'ble Tribunal. (Copy attached as Annex "G")

- 7) That the petitioners being aggrieved from the impugned seniority list dated 06.01.2020 submitted an appeal to the respondent No.1 for their back financial benefits and seniority w.e.f. 19.11.2014, it is worth to mentioned here that the said appeal was marked to the respondent No.2 for submission of his comments on the above subject. (Copy attached as Annex "H")
- 8) That accordingly the respondent No.3, submitted reply to the above appeal, wherein he categorically stated that their seniority and financial back benefits were not considered for unspecified reason, and he further submitted in his reply to the respondent No.3 for his guidance and perusal. (Copy attached as Annex "I")
- 9) That the petitioners being aggrieved from the impugned seniority list, wherein they were not considered from the date of 1st appointment i.e 19.11.2014, and come to this hon'ble Tribunal from the following amongst other grounds:-


GROUND

- A. That the impugned seniority list, wherein service of the appellants were considered from the date of their appointment is totally illegal, unlawful and circumstances of the case.
- B. That the respondent No.3, while issuing the impugned seniority list ignored the guideline given by the superior Courts in their various judgments.
- C. That the impugned seniority list is not legal and is issued on flimsy grounds.

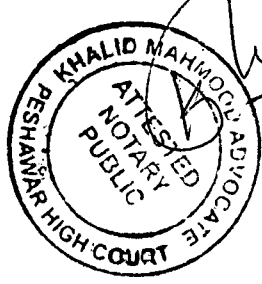
- D. That as stated in body of the appeal, that the respondent NO.3, not appointed the appellants as they were having requisite qualification and experience, but with due malafide intention they were not considered as the respondent appointed his own blue eyed person.
- E. That the office of the respondent No.2 serving under the umbrella of the political figure, and he wants to promote only his blue eyed person.
- F. That any additional ground will be raised at the time of arguments.

It is therefore, humbly prayed that, on acceptance of this appeal, names of the appellants may kindly be considered from their initial appointment, and they also entitled to get financial benefits from their initial appointments i.e. 19.11.2014 and consequently the respondent No.3, may kindly be directed to enlist/ consider the names of the appellants in the impugned seniority list from the date of 1st appointment order dated 19.11.2014 alongwith all financial back benefits.
