The instant appeal has been filed by the appellant under Section-4 of the Khyber Pakhtunkhwa Service Tribunal Act-1974 against the impugned order dated 30.01.2014 whereby the appellant was transferred from GGPS Sher Khan Ghari, Nowshera to GGPS Mera Wazir Ghari, Nowshera and the departmental appeal of the appellant was rejected vide appellate order dated 17.02.2014. She prayed that on acceptance of the instant appeal, the impugned transfer orders dated 30.01.2014 and 17.02.2014 may graciously be set aside and appellant be allowed to serve at GGPS, Sher Khan Ghari, Nowshera.</p>

Brief facts giving rise to the instant appeal are that the appellant was serving as Primary School Teacher (PST) at Govt: Girls Primary School, Dag Basud, District Nowshera. That vide order dated 13.05.2013, the appellant was promoted/upgraded from BPS-12 to BPS-15 and adjusted as Head Primary Teacher at Govt: Girls Primary School, Sher Khan Ghari, Nowshera. That on 30.08.2013 the appellant was again transferred from GGPS, Sher Khan Ghari, to GGPS Mera Wazir Ghari, Nowshera just after almost three months of her previous transfer order. That the appellant submitted departmental appeal against the said order dated 30.08.2013 of respondent No.3 to the respondent No.2 which was accepted by the respondent No.2 vide order dated 24.10.2013. That again on 30.01.2014 the appellant was transferred and withdraw the transfer order dated 24.10.2013 of respondent No.2 on the directions of Chief Minister, Khyber Pakhtunkhwa. That the appellant preferred departmental appeal against the order dated 30.01.2014 which was not accepted, hence this appeal.</p> <p>4. Counsel for the appellant argued that impugned transfer order dated 30.01.2014 and appellate order dated 17.02.2014 were illegal, unlawful and without jurisdiction hence liable to be set aside. He further argued that impugned order was not in the public interest but as a result of undue and illegal political pressure and the appellant was punished with no fault on her part. He further argued that impugned order was made in deviation of the posting/transfer policy which restricted political pressure in service matter and was</p>

also in defiance of the apex Court verdicts. He prayed that impugned order dated 30.01.2014 and appellate order dated 17.02.2014 may graciously be set aside and the appellant may be allowed to serve at GGPS Sher Khan Ghari, Nowshera..

5. The learned GP argued that the appellant wanted to stick to a particular post and particular station of duty which is not permissible under the law as Section-10 of the Khyber Pakhtunkhwa Civil Servants Act, 1973 requires the Civil Servants to serve anywhere and everywhere. He further argued that impugned order had since been implemented by the appellant hence the principle of estoppels was in operation against the appellant. He prayed that the appeal being devoid of any merits may be dismissed.

6. Arguments of learned counsels for the parties heard at length and record perused with their assistance.

7. From perusal of the record and hearing of the arguments of the counsels for the parties it transpired that at the relevant time the appellant was serving as PST in GGPS Dag Besud where on her promotion as PSHT (BPS-15) she was adjusted at GGPS Sher Khan Ghari on 13.05.2013. She was however transferred through a corrigendum order dated 30.08.2013 to GGPS Mira Wazir Ghari. She preferred representation against the said transfer to the Director Elementary & Secondary Education and on acceptance of the same the corrigendum order was cancelled vide order dated 24.10.2013 wherein she was restored to her original place of

posting i.e GGPS Sher Khan Ghari. The said order was however withdraw vide impugned order dated 30.01.2014 transferring her again at Mira Wazir Ghari. Departmental appeal made by her against the impugned order was rejected on 17.02.2014. A perusal of the record reveals that impugned order dated 30.01.2014 was made in pursuance of the direction of the Chief Executive of the Province who had no jurisdiction under the law in posting/transfer of the categories of the Government Servant to which appellant belong to. Such orders are also not provided for in the posting/transfer policy and are declared illegal and unlawful in plethora of the Supreme Court Judgments. In the circumstances the Tribunal is constrained to intervene in the case and directs to set aside the appellate order dated 17.02.2014. The case is remitted to the appellate authority with direction to revisit the same strictly in accordance with law/rules and verdicts of the superior Courts and decide the departmental appeal of the appellant on its merits within a period of one month of the receipt of this judgment failing which the instant appeal shall be deemed to have been accepted. Parties are left to bear their own costs. File be consigned to the record.






SERVICE APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNALS ACT, 1974 AGAINST THE IMPUGNED ORDER DATED 30/1/2014 WHEREBY THE APPELLANT HAS BEEN TRANSFERRED FROM GOVT. GIRLS PRIMARY SCHOOL SHER KHAN GHARI, NOWSHERA TO GOVT. GIRLS PRIMARY SCHOOL, MERA WAZIR GHARI, NOWSHERA AND THE DEPARTMENTAL APPEAL OF THE APPELLANT HAS BEEN REJECTED VIDE APPELLATE ORDER DATED 17/02/2014.

PRAYER:

On acceptance of the instant appeal, the Impugned Transfer Orders dated 30/1/2014 and 17/02/2014 may graciously be set aside and appellant be allowed to serve at Govt. Girls Primary School, Sher Khan Ghari, Nowshera.

Respectfully Sheweth,

1. That the Appellant was serving as Primary School Teacher (PST) at Govt. Girls Primary School, Dag Basud, District Nowshera.
2. That on 13/05/2013 vide Office Order No. 1953-58(DEO)F, the Appellant was

promoted/upgraded from BPS-12 to BPS-15 and adjusted as Head Primary Teacher at Govt. Girls Primary School, Sher Khan Ghari, Nowshera. Copy of the Office Order dated 13/05/2013 is enclosed as (Annexure-A).

3. That the Appellant took over the charge of the said post in the same school as Head Primary Teacher.
4. That on 30/8/2013 vide Office Order No. 400-61/DEOF, the Appellant was again transferred from Govt. Girls Primary School, Sher Khan Ghari, Nowshera to Govt. Girls Primary School Mera Wazir Ghari, Nowshera just after almost three months of her previous transfer Order. Copy of Office Order dated 30/8/2013 is enclosed as (Annexure-B).
5. That the Appellant submitted Departmental Appeal against the said Transfer Order dated 30/8/2013 of Respondent No. 3 to the Respondent No. 2 which was accepted by the

Respondent No. 2 vide Office Order No. 4582-88/DEOF dated 24/10/2013 and cancelled the Transfer Order dated 30/8/2013 and the Appellant again took over the charge at Govt. Girls Primary School, Sher Khan Ghari, Nowshera. Copies of the Departmental Appeal and Office Order dated 24/10/2013 and are enclosed as (Annexure-C & D) respectively.

6. That again on 30/1/2014 vide Office Order No. 277-81 issued by the Respondent No. 3, the Appellant was transferred and withdraw the Transfer Order dated 24/10/2013 of Respondent No. 2 on the directions of Honourable Chief Minister, Khyber Pakhunkhwa, just after three month of her previous transfer. Copy of the Office Order dated 30/1/2014 are enclosed as (Annexure-E).
7. That the Appellant submitted Departmental Appeal against the impugned Transfer Order dated 30/1/2014 issued by Respondent No.

3 to the Respondent No. 2 which was not accepted by the Respondent No. 2 vide letter No. 2452-53 dated 17/2/2014. Copies of the Departmental Appeal dated 14/2/2014 and letter dated 17/2/2014 are enclosed as (Annexure-F & G) respectively.

8. That the Appellant aggrieved from the impugned Office Order dated 30/1/2014 and Appellate Order dated 17/2/2014, having got no other efficacious/adequate remedy, now approaches this Honourable Tribunal on the following grounds amongst the others:-

GROUNDS:

- A. That the said impugned Transfer Order dated 30/1/2014 and Appellate Order dated 17/2/2014 of the appellant is quite illegal, unlawful, without authority/jurisdiction, hence, is liable to be set aside.
- B. That the said order is not in the public interest but as result of undue and illegal

political pressure and the Appellant has been punished with no fault at her part.

- C. That it has also been mentioned therein the transfer policy that no civil servant will be allowed to exert any political pressure in the matters with regard to the posting/transfer matters whereas the Respondent's department itself has defied and bulldozed the above said policy by making the transfer of the Appellant on the political pressure.
- D. That the Respondent's department must follow the observations/decisions passed by the Apex Court that in the matters of the Civil Servants posting/transfer, no political pressure should be admitted, however, in the present case, it has clearly been mentioned in the Office Order dated 30/1/2014 that the Appellant has been transferred on the undue/illegal pressure of the Chief Minister, Khyber Pakhunkhwa.

- E. That if the said practice of the interference of the political figures including the Chief Minister is not stopped, the whole structure of the departments will fall on the ground and each and every civil servant will be turned as political servant of the political figures, thereby losing interest to perform their real duties.
- F. That there is no complaint against the Appellant and they have served the Respondents' department to the entire satisfaction of superiors.
- G. That all the above said acts of the department authorities are against the prevailing rules and are based on malafide and unjust attitude of the concerned authorities.
- H. That Respondents have not treated appellant in accordance with law, rules and policy on subject and acted in violation of Article 4 of the Constitution of Islamic

Republic of Pakistan, 1973 and unlawfully issued the impugned transfer order, which is unjust, unfair and hence not sustainable in the eye of law.

It is, therefore, humbly prayed that On acceptance of the instant appeal, the Impugned Transfer Order dated 30/1/2014 and Appellate Order dated 17/2/104 may graciously be setaside and the Appellant may please be allowed to serve at Govt. Girls Primary School Sher Khan Ghari, Nowshera.

Any other relief as deemed appropriate in the circumstances of case not specifically asked for may also be granted to appellant.

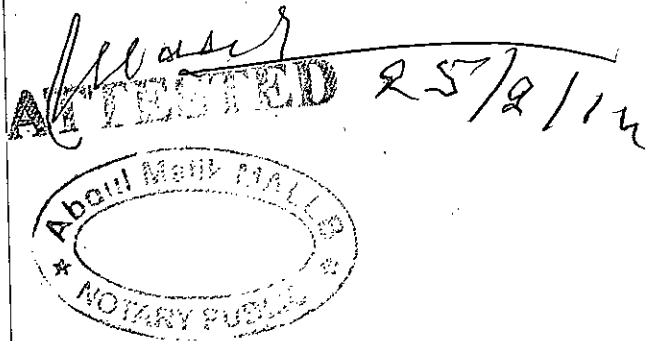


APPLICATION FOR INTERIM RELIEF
