





Respectfully Sheweth,

That the appellant submits the following facts, regarding the instant appeal.

1. That the appellant was induct into service on as chowkidar on dated 16.12.1998 (Copy of service book is attached as annexure "A").
2. That the appellant perform his duty with due diligence and no complaint whatsoever were made against time to highups.
3. That the appellant duties were upto 12 Hrs on daytime, but being an obedient Govt. official he was watch full even there was close hours from the schools.
4. That it is pertinent to mention here that solar system was installed in the school and appellant was also take care of the solar plates as well as the whole solar penal. But unfortunately on of the solar plate was damaged from unknown sources.
5. That the appellant has immediately informed the high ups, and for that purpose he also filed written application to the respondent No.2 (Copy of application is attached as annexure "B").
6. That later on the same of the solar system, equipment were stolen by unknown persons. The appellant immediately

reported the matter to the respondent No.2, who was immediate boss of the appellant (Copy of application is annexed as annexure "C").

7. That the appellant was made responsible for the damaging the solar all the without any
8. That the appellant was surprised to know that without giving any proper opportunity of personal hearing and without any inquiry imposed penalty of recovery.
9. That the appellant was imposed penalty of recovery while show cause notice No. 2786-69 dated 06.07.2021 and No. 3313 dated 11.08.2021 and appellant was made responsible (Copy of order is attached as annexure "D").
10. That appellant filed departmental appeal against the penalty and order but the same was turned down. (Copy of departmental appeal is attached as annexure "E")
11. That the departmental appeal of the appellant was not decided within the statutory period in the following grounds amongst others.

GRUNDS:-

④

- A. That the act and omission of the respect to impose the law and Hence not tenable in the eye of law.
- B. That the appellant was implicated with instant case without any inquiry and recovery was effected from the appellant.
- C. That the appellant was punished and recovery was effected from him and moreover he was transferred to for flunged area. It means that the appellant is punished twice from the same offence, which he has not committed.
- D. That the appellant has unblemished service record of 24 years and the appellant also informed the high ups regarding the occurrence but the respondents No.1 has passed the impugned without giving him any opportunity.
- E. That the respects have melafidely made responsible the appellant just only to save their skin respondents were duty bound to report the matter to the local police to inquire into the matter but they did, not so.
- F. That the impugned order is the violation of article 10-A of the constitution of Pakistan 1972, which gives the right of trial
- G. That the impugned order is against the natural justice and the appellant has made scope goat in the instance case.

It is, therefore, most humbly prayed that on acceptance of this appeal the impugned order dated 21.09.2021 may kindly be set aside and recovery effected from the appellant may kindly be re-inbured.

Any other relief not specifically asked for may also graciously be extended in favor of the Appellant in the circumstances of the case.






