> Appeal U/S 4 of the Khyber Pakhtunkhwa Service Tribunal Act 1974 against the impugned Office Order No. GCC(W)/MRD/1192(1-5) Dated 12.04.2022 of the Office of the Principal Govt. College of Commerce for women Mardan, whereby the Appellant was dismissed from service and departmental appeal dated 20.04.2022 of the appellant was not considered.

### **Respectfully Sheweth:**

- That the Appellant is a naturally born bona-fide citizen of Islamic Republic of Pakistan and hails from a respectable
   family of district Mardan. (Copy of CNIC is annexure "A").
- 2. That the appellant is qualified up to Master of Arts in Islamiyat (M.A. Islamiyat) and has also got her Primery Teaching Certificate (PTC) from Allama Iqbal open University Islamabad. (Copies of credentials/ degree is annexure "A-1 to A-10").
- 3. That the appellant has got her Diploma in Information Technology from Govt. of Khyber Pakhtunkhwa, Khyber Pakhtunkhwa Trade Testing Board Peshawar. (Copy of diploma in Information Technology is annexure "B").
- A. That the appellant was registered at the Employment Exchange Mardan on dated 26.11.2018 as essential personnel and her registration number is EP/TS/223/2018, which was issued by respondent No.5. (Copy of Employment Exchange Mardan registration number EP/TS/223/2018 issued by respondent No.5 is annexure "C")
- 5. That after going through mandatorily required criteria, and after being envisaged with the ordeals and inquisition of selection process, the Appellant was appointed as **Cook** in BPS-03 plus usual allowances as admissible under the rules and posted at Government College of Commerce for Women, Mardan, through Endst. No.GCC/W/MRD/CLASS-IV/659(1-5) dated 20.12.2018 by Respondent No.4. (Copy of appointment letter Endst. No.GCC/W/MRD/CLASS-IV/659(1-5) dated 20.12.2018 is annexure "D").
- 6. That thereafter the appellant submitted her arrival report on dated 24.12.2018 to the respondent No.4. and after conduction of her medical, her medical certificate was issued to her. (Copy of Arrival Report dated 24.12.2018 is

annexure "E" while copy of office order dated 24.12.2018 of respondent No.4 regarding Appellant arrival report is annexure "F" and medical certificate is annexure "G").

- 7. That thereafter the Appellant took charge & with her most sincere and pragmatic way, performed her duties with full zest and devotion & never left any stone unturned in performance of her duties and has always won felicitations and appreciations of her High-up at certain junctures due to her Mantle whetted skills, punctuality and behavior.
- 8. That before parting with the facts of the instant case and to make and vesicate out a case for the Appellant, it would equally be important to mention here that the present principal Respondent No.4 has compelled the Appellant by performing the duties of sweeper and bearer forcefully.
- 9. That respondent No.4 has stared personal grudges with the appellant and issued an explanation letter No.GCCW/(MRD)/2021/9281 dated 09.05.2021. (Copy of explanation letter No.GCCW/(MRD)/2021/9281 dated 09.05.2021 is annexure "H").
- 10. That on dated 09.06.2021 the appellant replied to the explanation letter wherein she mentioned in detail that due to Corona Vaccination she got some diseases and was on leave for two days.(Copy of reply dated 09.06.2021 is annexure "I" ccpy of Vaccination card is annexure "J" while copy of Doctor medical report is annexure "K").
- 11. That due to personal acrimony, respondent No.4 again issued an explanation letter No.942 dated 06.08.2021, but on same day dated 06.08.2021, the appellant submitted her reply along with attendance sheet. (Copy of explanation letter No.942 dated 06.08.2021 is annexure "L", reply is annexure "M" while attendance sheet is annexure "N").
- 12. That the respondent No.4 continued her personal animosity and on dated 22.10.2021 another explanation

letter No.GCC/(W)/2021/975 was issued wherein respondent No.4 blamed the appellant for threatening her in the office during performing of her official duty, but the same was again explained/replied by the appellant.(Copy of explanation letter No.GCC/(W)/2021/975 dated 22.10.2021 is ennexure "O" while reply is annexure "P").

- 13. That on the direction of Respondent No.4 one Mst. Rukhsana Begum filed a complaint in the office of Director Anti-Corruption Khyber Pakhtunkhwa Peshawar dated 11.11.2021 and another application to respondent No.4 on dated 12.11.2021 against the appellant wherein they have challenged the appointment of the appellant after a lapse of more than 03 years.(Copy of complaint to Director Anti-Corruption dated 11.11.2021 is annexure "Q" while copy of application to respondent no.4 dated 12.11.2021 is annexure "R").
- 14. That on the complaint of Mst. Rukhsana Begum, the Superintendan: for Deputy Commissioner, Mardan issued a letter No.1786/DC(M)/EA-32 dated 19.11.2021 to Respondent No.4 for further necessary action against Appellant.(Copy of letter No.1786/DC(M)/EA-32 dated 19.11.2021 of Superintendant for Deputy Commissioner, Mardan is annexure "S").
- 15. That from January 2022, salary of the appellant was discontinued through a letter No.Nil dated Nil by the <sup>r</sup> Respondent No.4 without any cogent reason. It is pertinent to mention here that appellant performed her duties with full devotion and zest. (Copy of the Salary Discontinuation letter No.Nil dated Nil is annexure "T" while reply to the letter is annexure "T/1".
  - <sup>56.</sup> That an illegal Audit Report No.278-82/ACE/dated 24.03.2022 was prepared by respondent No.6, where <u>in the</u> <u>conclusion parces Respondent No.6 arrived to the conclusion</u> <u>that Mst. Bibi Asma was appointed as Cook in BPS-03 but</u> <u>her name was not included in the list provided by the office</u>

of Manager Employment Exchange Mardan.(Copy of the Audit Report No.278-82/ACE/dated 24.03.2022 of Respondent No.6 is annexure "U").

17. That an enquiry was conducted who was assigned two task .1. Appointment of Appellant. 2. Harassment part of the case. This enquiry was conducted in the absence of the appellant and no chance of personal hearing was provided to the appellant, at the end the enquiry committee concluded that the name of the Appellant was not among the registered candidates provided by Respondent No.5. (Copy of enquiry report of the committee is annexure "V")

18. That during performing of her duties, on dated 26.03.2022, through letter No.GCC/(W)/2022/1176, a show cause notice was suddenly issued by Respondent No.4 and some charges were mentioned by respondent No.4 in that show cause notice and has tentatively decided to imposed major penalty of "Dismissal from service" upon appellant. (Copy of Show cause Notice along with charges are annexure "W" & "W/1")

19. That on dated 02.04.2022, the appellant submitted her reply to the show cause notice wherein she rejected the allegations level against her in the show cause notice. It is pertinent to mention here that Respondent No.4 has some relation and sympathy with one Mst. Rukhsana Begum, who applied for bearer Post but was not selected in the year 2018. (Copy of the reply to show cause notice dated 02.04.2022 is annexure "X")

20. That without conducting any departmental enquiry against the letter No.GCC/(W)/2022/1176 dated 26.03.2022, and without providing any chance of personal hearing the Appellant was straight away dismissed from her service vide: impugned Office Order No: GCC(W)/MRD/1192(1-5) dated: 12.04.2022 in a classical, cursory and whimsical manner. (Copy of impugned dismissal Office Order No: GCC(W)/MRD/1192(1-5)

dated: 12.04.2022 of Respondent No.4 is Annexure "Y").

21. That feeling aggrieved from impugned Dismissal from Service Order, the Appellant preferred a Departmental Appeal dated 20.04.2022 to the Deputy Director as well as the Principal Govt. College of commerce for Women Mardan (Respondent No.4) which was received on dated 23.04.2022 but the same was not considered. (Copy of Departmental Appeal dated 20/04/2022 is annexure "Z" while receiving is annexure "Z/1")

22. That feeling aggrieved from the impugned Dismissal Order and impugned Appellate Order the Appellant approaches this Hon'able Tribunal for his reinstatement into service with all back benefits upon the following grounds, inter-alia:

#### **GROUNDS**:

- A. That the impugned dismissal order is wrong, illegal, unlawful, voic hence the same is liable to be set aside.
- **B.**That the act of the respondents in so called circumstances is purely baseless, unlawful, void ab-initio, corum non judice and is not warranted by the law.
- C. That no fair Departmental inquiry against the Appellant was ever conducted, nor any inquiry dispensation order was ever passed & nor was given any opportunity to be heard, to defend, clear her position hence was deprived of her right to be heard, which is against the principles of natural justice.

**D.** That neither the Appellant was ever served with any Show Cause Notice, nor was ever issued any Final Show Cause Notice & thus mandatory instruments are glaringly missing, which renders the impugned order as illegal & void. E.That the Appellant has thoroughly been condemned unheard which under the law is not allowed.

F.That no opportunity of cross examining any witness was ever extended to the Appellant, hence main ingredients are missing in case of the Appellant.

G. That the impugned dismissal order is unlawful, illegal and liable to be cancelled because the Respondent utterly violated the service law, rules, regulations and policy of the Government for Civil servants while passing the impugned dismissal order.

H. That the impugned dismissal order is the violation of the fundamental rights of the Appellant which is guaranteed and protected by the constitution of Islamic Republic of Pakistan 1973.

I. That under the mandate of Article 4 of the Constitution, no one should be treated otherwise than in an accordance with law, wherein Article 25 postulates that alike are to be treated alike, but here a different discriminative approach has been used to treat the Appellant.

J. That discrimination in any form is highly abominable and bete-noire and is always checked down in derisorous manner by the Superior Courts of the land. Reason behind checking it down and chucking it away is to ensure equality and equal treatment of its citizens and to remove any sense of discrimination.

**K.** That the law and law courts of the land have always preferred and encouraged that rules and policies are to be followed and have always discouraged, deplored, and depreciated any variation from the rules or policies.

L.That where an action is taken on the complaint of such person who applied for Bearer Post after lapse of three

years and without providing a chance of personal hearing to the appellant and not conducting the same departmental proceedings, then how and from where the Appellant has been penalized with the major penalty?

M. That from every angle the impugned dismissal Order is null and void and not sustainable hence is liable to be set aside.

N. That any other ground not raised here may graciously be allowed to be raised at the time of arguments.

It is, therefore, most humbly prayed that on acceptance of the instant Service Appeal, the impugned dismissal Office Order No. GCC(W)/MRD/1192(1-5) Dated 12.04.2022 of the Office of the Principal Govt. College of Commerce for women Mardan, whereby the Appellant was dismissed from service, may very graciously be set aside and by doing so the Appellant may very graciously be reinstated into service with all back benefits and the enquiry conclucted by Respondent No.6 may kindly be declared null and void and also be quashed.

Any other relief not specifically asked for may also graciously be extended in favor of the Appellant in the circumstances of the case.

A complaint submitted by MSt. Rukhsana. Begum containing allegations of Corruption, illegal appointment and mis-use of official power by the subject officers/officials etc (Annes A).

### PREAMBLE:

On the direction of the worthy Director, Anti-Corruption Establishment. Khyber Pakhtunkhwa. Peshawar an audit was conducted by the undersigned in presence of Investigation Officer and concerned staff of the office of Principal Govt: College of Commerce for Women Mardan. The concerned staff produced the relevant record which was audited in their presence.

During the course of an audit it was revealed that the office of Principal Govt: College of Commerce for Women Mardan vide letter No.GCC/WOMEN/PF(MRD)/578 dated 22.11.2018 addressed to the Manager Employment Exchange, Mardan for provision list of suitable unemployed registered class-IV candidates (Amex-B). The office of Manager Employment Exchange Mardan vide No.EE/Mdn/Recr:/1-13/210(1-2) dated 27.41.2018 depicted that a list of suitable unemployed registered class-IV candidates sent to the office of Principal Govt: College of Commerce for Women Mardan (Amex-C). The Office of Principal Govt: College of Commerce for Women Mardan constituted a Departmental Selection Committee vide No.GCC/W/(MRD)/2018/612 dated 01.12.2019 (Amex-D).

On probing the matter, it was revealed that MIst-Bibi Asma D/O Meher Muhainmad was appointed as Cook in BPS-03 but her name was not included in the list provided by the office of Manager Employment Exchange Mardan vide No.EE/Mdn/Recr:/1-13/210(1-2) dated 27.11.2018 which is violation of "The Khyber Pakhtunkhwa Common Servants (Appointment, Promotion and Transfer) Rules, 1989". (Americ D). For appointment of Class-IV employees, in the Province under the Civil Servants (Appointment, Promotion and Transfer) Rules, 1989 have provided two modes. The reading of the Rule-10 relevant for the purpose would be imperative in the given circumstances which read as under:-

-O Muldar Rule-10. Appointment by initial recruitment. (1) Initial appointment to posts in various pay scales shall be mide-

(a) If the posts falls within the purview of the Commission, on the basis of Examination or test to be conducted by the Commission; or

# ACCUSATIONS:

A complaint submitted by Mst. Rukhsana Begum containing allegations of Corruption, illegal appointment and mis-use of official power by the subject officers/utileials etc (Annex-A).

# PREAMBLE:

On the direction of the worthy Director, Anti-Corruption Establishment, Khyber Pakhtunkhwa. Peshawar an audit was conducted by the undersigned in-presence of Investigation Officer and concerned staff of the office of Principal Govt: College of Commerce for Women Mardan. The concerned staff produced the relevant record which was audited in their presence.

# AUDIT EXTRACT:

During the course of an audit it was revealed that the office of Principal Govt: College of Commerce for Women Mardan vide letter No.GCC/WOMEN/PF(MRD/)/578 dated 22.11.2018 addressed to the Manager Employment Exchange, Mardan for provision list of suitable unemployed registered class-IV candidates (Annex-B). The office of Manager Employment Exchange Mardan vide No.EE/Mdn/Recr:/1-13/210 (1-2) dated 27.11.2018 depicted that a list of suitable unemployed registered class-IV candidates sent to the office of Principal Govt: College of Commerce for Women Mardan (Annex-C). The Office of Principal Govt: College of Commerce for Women Mardan constituted a Departmental Selection Committee vide No.GCC/W/(MRD)/2018/612 dated 01.12.2018 (Annex-D).

On probing the matter, it was revealed that Mst Bibi Asma D/O Mehor Muhammad was appointed as Cook in BPS-03 but her name was not included in the list provided by the office of Manager Employment Exchange Mardan vide No.EE/Mdn/Recr:/1. 13/210(1-2) dated 27.11.2018 which is violation of "The Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion and Transfer) Rules, 1989". (Annex-E). For appointment of Class-IV employees, in the Province under the Civil Servants (Appointment, Promotion and Transfer) Rules, 1989 have provided two modes. The reading of the Rule-10 relevant for the purpose would be imperative in the given circumstances which read as under:-

Rule-10. Appointment by initial recruitment. (1) Initial appointment to posts in various pay scales shall be made-

(a) If the posts falls within the purview of the Commission, on the basis of Examination or test to be conducted by the Commission; or

(b) If the post does not fall within the purview of the commission, in the manner determined by Government. Initial recruitment to the post which does not fall within the purview of the Commission, shall be as may be made on the recommendation of the Departmental Selection Committee vacancies have been advertised in newspapers? Provided that nothing contained in this sub-rule shall apply to the household staff of aso3/ yo2the Chief Minister's House Peshawar, Frontier House Islamabad, Frontier Rest House Bannu. Swat and Abbottabad, Frontier House Nathiagali and Shahi Mehman Khana. Peshawar and any other House to be established by the Government. Provided further

that the appointment in Basic Pay Scale 3 to 5 shall be made on the recommendations of the Departmental Selection Committee through the District Employment Exchange concerned, or, where in a district the office of the Employment Exchange does not exist after advertising the post in leading newspapers.

The above, rule clearly reflects that firstly, if the post falls within the purview of the commission, is to be filled in through the commission i.e. Public Service Commission and secondly if the post does not fall within the purview of the commission in the manner as may be determined by Government. According to the second provision of the above rules, the initial appointment in the pay scales 3 to 5 (amended vide notification No SO (R-VI) E&AD / 1-3 / 2015 dated 19.4.2016) previously it was BPS 1 to 4, was to be made on the recommendations of the Departmental Selection Committee through the District Employment Exchange concerned, or when in a district the office of the Employment Exchange does not exit, after advertising the post in the leading newspaper.

A letter of Mis Navab Gul addressed to the enquiry committee revealed that they conducted interviews of female applicants only, they were provided a computerized attendance sheet on which Names of 7 females candidates were typed. They interviewed 6 of them and one was absent. At the end of the interview, the committee agreed upon Ms Rukhsana Begum to be appointed as cook. She also declared that her signature on attendance sheet is fake (Annex:F): A letter of Ms Hejab Rahman addressed to the Principalities GCMS (W) Mardan shows that the committee decided to hire Mst. Rukshana Begum. Later on by the instruction of the then Director Administration Mr. Tayyab appointment letter of the Mst. Asma Bibi was signed. Oral objection was raised by her to the then Director Administration as Mst. Bibi Asma was neither interviewed in her presence nor any call letter was sent to her, even her name was not mentioned in the list of employment exchange Mardan. She was told by the then Director Administration that she has been selected and her details would be provided shortly by the directorate. Despite her calls no detail was provided to her. Moreover, the complete hiring file of all the class IV was not provided just to show their hegemony. Furthermore, the females' attendance list shows the name of Mst Bibi Asma entered manually afterward and without her knowledge. The list include her signature and Ms Nayab Gul signature only and those are fake (Mining G):

Moreover, in order to authenticate the appointment & recommendation of Departmental Selection Committee; duly signed minutes of meeting of the selection committee, was not provided and missing from the office record. A Departmental enquiry is also conducted in which the enquiry committee concluded that the appointment was made illegal and void ab initio as the candidate Mst Bibi Asma was not from the amongst the list of registered candidate provided by the manager employment exchange: (August H).

# CONCLUSION:

Keeping in view the above scenario and scope of an audit, the signatory arrived to the conclusion that Mst Bibi Asma was appointed as Cook in BPS-03 but her name was not included in the list provided by the office of Manager Employment Exchange Mardan. The available records indicate nepotism, favoritism, negligence, violation of rules & ' regulation and non-observance of merit in selection process.

# LOSS TO GOV'T EXCHEQUER:

The available record reveals that Rs. 507,173 /- financial loss occurred to Government Treasury at this stage.

# RESPONSIBLE:

- 1. Mst Bibi Asma being direct beneficiary
- 2. The Concerned Officer/Officials involved in illegal appointment and stealing duly signed minutes of meeting of the selection committee
- 3. Other persons if found involved later on during the course of investigation.

# RECOMMENDATION:

- 1. Circle Officer/Investigation Officer initiate legal proceedings against the responsible under the rules.
- 2. Just may be providing to the complainant under the relevant law/rules.

That the appellant has neither committed any misconduct, nor she was inefficient but despite the fact your worthy office has sent the appellant with a show cause notice, without any cogent reason and violating the law by ignoring the performance of the appellant, which is a clear violation of law and fundamental rights.
- 4. That even the enquiry committee did not observe the real facts of the appellant who was legally appointed for the said by fulfilling all legal formalities.



- 5. That despite the fact that appellant worked for more than three years and 4 months for the said post hence entertaining a complaint from an outsider Mst. Rukhsana at this stage is against appellant basic rights.
- 6. That your August office has not observed the appellant dismissal in accordance with her present and previous better performance and for the betterment of the public interest So Appellant has not been treated in accordance with law, and appellant rights secured and guaranteed under the law and constitution have been violated.
- 7. That the discrimination as observed by this office with Appellant is highly deplorable and condemnable, being unlawful, unconstitutional, without lawful authority, without jurisdiction, against the norms of natural justice, equity and against the law on subject, hence liable to be declared void ab initio.
- 8. That the act of your good office not considering the best performance of the appellant and her selection on merit is against law and is based on malafide, and ulterior motive.
- 9. That the action on the part of your good office has been affecting adversely appellant good performance and her good character as protected by the constitution and the Appellant may not be dismissed from the current post of Cook in the best public interest and as such to equally deal in accordance with the law and rules.

It is therefore, most humbly prayed that on acceptance of the instant appeal an appropriate direction may please be issued and the dismissal order of the Appellant may kindly be cancelled and any other relief not specifically prayed and to which the Appellant is found entitled may also be granted:
