APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTOON KHWA SERVICE TRIBUNAL ACT 1974 AGAINST THE IMPUGNED NOTIFICATION /ORDER 60/E-II DATED 12-02-2020 IN WHICH THE APPELLANT SENIORITY HAS NOT BEEN CORRECTED AND THE APPELLANT WHO IS SENIOR ACCORDING TO SENIORITY LIST WERE NOT CONSIDERED SENIOR HENCE FEELING AGGRIVED APPELLANT PREFER REPRESENTATION WHICH WAS NOT ENTERTAINED NOR CONSIDERED TILL DATE.

Pray:

In view of above submission it is requested that , by accepting of instant service appeal the impugned Notification may graciously be corrected and the name of the appellant may kindly be brought forward in the seniority list and the name of appellant be placed according to the rules to his own seniority list along with his colleagues.

Respectfully Sheweth,

With great veneration the instant appeal is preferred by the appellant on the following grounds:-

Facts:

- 1). Brief facts are that the appellant has been appointed in police department on 25-03-1987 and after qualifying the mandatory courses and secured 1st positions in recruit, upper and advance/DSP courses, there after the appellant promoted to the rank of Officiating Assistant Sub-Inspector on 15-03-2000 and after confirmation in the rank of A.S.I , the name of the appellant was brought on promotion list "E" of the Sub-Inspector on 15-03-2003 under purview of Police Rules 13.10 and promoted to the rank of Sub -Inspector on dated 10-01-2005. (Copy annexed as annexure A).

2) That the appellant was promoted to the rank of Inspector vide notification No-18418/E-II dated 30-07-2010. (Copy annexed as annexure B)

3) That the appellant name was brought on promotion list "E" w.e.f 15.3.2003 vide D.I.G Kohat order No.759-62/EC dated 26.3.2005 which is contained in seniority list issued by Deputy Inspector General of Police Kohat Region Kohat vide his office order No.2288-2300/EC dated 21.3,2009 , therefore an accordance with Police Rules 13.10 (list "E" promotion to sub: Inspector) which lays down that half-yearly reports on all men entered in the list maintained under this rule shall be furnished in form No. 13.9(3) by the 15 October, In addition to the annual report to be submitted by the 15th January in accordance with P.R 13.17(1), but in the case of appellant, his name was required to be considered at C.P.O for inclusion into list "F" (list of the Inspectors) on the basis of confirmation into the rank of A.S.I and promotion to list "E" seniority (Sub: Inspector seniority) w.e.f 15.03. 2003 but the appellant has been ignored and un-due seniorities have been assigned to other police officers junior to the appellant in promotion list "E" time to time for not good reason.(copy of impugned notification annexed at annexure "C")

4) That in the case of Inspector Munawar Khan, his name mentioned at Serial No. 1 in the seniority list "F" , his name was brought on promotion list "E" on 01.01.1996 and subsequently his name was brought on promotion list "F" (list of the Inspector) on 04.01.1996 and promoted to the rank of Inspector accordingly vide seniority list was issued by Worthy Provincial Police Officer Khyber Pakhtunkhwa Peshawar vide No. 5843/E-II dated 20.03.2012 .(Copy annexed as annexure D)

5) Similarly in the seniority list "F" (list of the Inspectors) issued by the C.P.O vide No. 4899/E-11 dated 31.01.2010, the name of Inspector Mohammad Nadeem No. D/2 of D.I.Khan District mentioned at serial No, 68, whose name was brought on promotion list "E" on 08.01.2007 and his name was included into promotion list "F" (list of the Inspectors) on 31.05. 2007 and he was promoted as Inspector on 19.07.2007. (Copy of list annexed as annexure E)

6) That the name of Muhammad Sharif No. K/23 was brought on promotion list "E" on 18.5.2002 and his name was sent by DIG Kohat for inclusion into list F, which was brought on list promotion "F" by the C.P.O on 17.12.2003 vide Seniority list No. 3984 /E-II dated 10.2. 2011, while the appellant has been kept deprived from assigning his due seniority.

7) That the appellant was promoted to the rank of D.S.P on 18.8.2015 vide Notification No.3806/SE-1 dated 18.8.2015 and as evident from different Revised seniority lists of "F" (Inspectors) and DSPs, which are attached, the seniorities have been assigned to many Police officers time to time by the Provincial Police Officer, Khyber Pakhtunkhwa, Peshawar but the appellant has been kept deprived of his basic legal right of due service seniority for not good reason.

8) That as per record and seniority promotion list-"F" issued, by the Provincial Police Officer, Khyber Pakhtunkhwa, Peshawar vide No.3985-4000/E II dated 18.2.2011, the name of Waqar Ahmed No. P/173 of Nowshera district has been mentioned in list "E" on 09.2.2003 and in the same year, his name was included into list "F" i.e. on 17.12.2003 and similarly the name of Muhammad Shafiq No. B/17 of Bannu district has been mentioned in promotion list "E" on 31.3.2003 and his name was brought on promotion list "F" on 17.12.2003, the appellant was on promotion list "E" w.e.f 15-3-2003, therefore the appellant due service seniority comes between the above DSsP.

9) That recently the following DSP have been declared senior from the appellant in light of Notification No. 60/E-II/Notification dated 12.2.2020, although they are also junior to the appellant in all terms and service record and rules.

10) That the respondent No-1, in light of the above recommendations of committee issued new revised seniority list in which again junior's other officials were considered senior and the appellant has not been blessed the same with colleagues for no good reason, which is contrary to the police rules as well as against the service rules, hence appellant feeling aggrieved having no alternate remedy for correction of seniority list and therefore, the appellant approached to honourable tribunal in shape of service appeal on the following grounds .

Grounds:-

- a) That the impugned notification/order is not based on sound reasons and same is not sustainable in the eyes of law, the same is based on wrong assumption of facts.
- b) That after submitting several requests to the respondent No-1 for remedy and to re-visit the impugned notification and giving due seniority with colleagues to the appellant and to make a decision afresh in light of provisions contained in Police Rules 1934, general principles about service seniority and equality under purview of the Constitution of Islamic Republic of Pakistan but in vain.
- c) That according to seniority list dated 19-03-2019 referred above, the names of DSP Shah Mumtaz was at serial No- 193 and now placed at serial No. 96 and the rest names of DSP Zafar Ahmad placed from No. 194 to 97, DSP Farmanullah placed from serial: No. 195 to 98 and DSP Muhammad Sattar placed form serial No-139 to 58, which is injustice at all.
- d) That the appellant is requesting for his due service seniority from the date of promotion on list "E" , which took place on 15.3.2003, (of the Sub-Inspector list) like others officers mentioned in CPO seniority lists of the Inspectors with consequential service benefits including promotion as Deputy Superintendent of Police as per seniority and rules i.e. name of Waqar Ahmed No.P/175 of

Nowshera district mentioned at serial No. 40 was brought on Promotion list "E" on 9.2.2003 and the name of Inspector Muhammad Shafiq No. B/17 mentioned at serial No.41 was brought on promotion list "E" on 31.3.2003 in the seniority list of "F", vide No.3985-4000/E II dated 18.2.2011, issued by the Provincial Police Officer, Khyber Pakhtunkhwa Peshawar, because the appellant was also on promotion list "E" w.e.f 15.3.2003 as described above in detail and after assigning this basic right of due seniority, the appellant name needs placing between these DSsP in the seniority list of the DSsP of Khyber Pakhtunkhwa.

- e) That the impugned notification /order is outcome of surmises and conjecture.
- f) That as per the Judgment of Superior Apex Court that the respondent department dragged the employee unnecessary into the litigation then the respondent department held responsible for the cost SCMR -2008 -725)
- g) That the bias of the respondent No-1 clearly shows by not entertaining the representation of the Appellant, keeping in view the decision of apex court the respondent No- above were duty bound to record reason of rejection "when departmental appeal was submitted the competent authority was duty bound to decide same within reasonable time after application of independent mind ,by giving reason such was a requirement of law as well as of the principal of natural justice "2009 (PLC) (CS) 77.
- h) 6:- That the Petitioner never ever remains absent from his duties till date.
- i) 7:- That it is clearly mention in 2003 PLC CS 1468 that any instruction issued in violation of Rules would be illegal and void.
- j) That the impugned notification/order is suffering from perversity of reasoning, hence liable to be set aside.
- k) That some other grounds will be offered at the time of arguments with the prior permission of the Honorable Judge highness.



Prayer:-

It is therefore humbly requested that the appellant name may graciously be placed between the names of DSP Waqar Ahmed No.P/175 who was on promotion list "E" 09.2.2003 mentioned at serial No. 40 and DSP Muhammad Shafiq No. B/17 who was on promotion list "E" 31.3.2003 mentioned at serial No.41 in the seniority of promotion list "F", issued by C.P.O Peshawar vide No.3985-4000/E II dated 18.2.2011 and subsequently in DSsP seniority list below the name of Waqar Ahmed No. P/175 and above the name of Muhammad Shafiq No.B/17 in the seniority list vide No. 347/E-I dated 19.3.2019 Khyber Pakhtunkhwa and in fresh seniority list of 2020 accordingly, because the appellant was confirmed and his name was brought on promotion list "E" w.e.f 15.3.2003 please.
