A Departmental Committee was constituted under the chairmanship of Dr. Zahid Ullah (PSP) District Police Officer, Haripur to unearth the real facts in connection with his deferment including his other colleagues in the DPC held on 23-05-2018.

The committee mentioned in his minutes that both the SIs namely Muhammad AnwarNo.346/H & Anas No.116/H were only deferred in the DPC held on 23-05-2018 due to punishment awarded to them by DPO Mansehra & Haripur respectively but their punishments were set aside on 21-06-2018 by then RPO Hazara vide order No. 2791/PA & 2813/PA dated 21-06-2018. A letter vide No. 113/CPB dated 07-05-2018 issued by CPO, according to which old criteria for the confirmation of SIs was extended its validity till 30-06-2018 and on set-a-siding the punishment both of above named SIs were eligible for the confirmation in the rank of SIs alongwith their colleagues, as they were fulfilling the required criteria and police rules.

PRAYER: ON ACCEPTANCE OF INSTANT SERVICE APPEAL IMPUGNED ORDER DATED 24-05-2018 OF REGIONAL POLICE OFFICER HAZARA REGION ABBOTTABAD AS WELL AS ORDER NO. 160 DATED 11-07-2018 OF PROVINCIAL POLICE OFFICER KPK PESHAWA MAY GRACIOUSLY BE SET ASID AND APPELLANT BE CONFIRMED ALONGWITH HIS COLLEAGUES AT RIGHT PLACE WITH ALL CONSEQUENTIAL SERVICE BACK BENEFITS.

 That the appellant was inducted in the Police Department as constable on 26-04-1993. Ever since his

appointment the appellant always performed his assigned duties with zeal, zest, devotion and honesty.

- 2. That in the year 2003 the appellant was selected for Intermediate Course in the year 2003 which he successfully completed from Police Training College Hungu. The appellant was promoted as Assistant Sub Inspector on 25-03-2008. Subsequently the appellant was confirmed as Astt. Sub Inspector and brought on promotion List "E" with effect from 08-04-2010 vide order No.5279-96/E dated 21-04-2012. The name at appellant stands at Serial No. 85 of the said order. (Copy of order dated 21-04-2012 is attached as Annex-"A").
- 3. That thereafter the appellant alongwith his Batch Mates was promoted to the rank of Sub. Inspector under Regional Police Officer Hazara Region Abbottabad order No.18506-12/E dated 21-11-2014. The name of appellant stands at Serial No. 13 of the order. (Copy of the order dated 21-11-2014 is attached as Annex-"B").
- 4. That appellant and his colleagues/batch mates i.e. Abdul Hameed No. 334/H and Waris Khan No. 335/H confirmed as A.S.Is with effect from 08-04-2010 vide Regional Police Officer Hazara Region Abbottabad order dated 21-04-2012 (copy placed as Annex-A) and subsequently promoted as SUB INSPECTOR the

same day vide order dated 21-11-2014 (copy placed at Annex-B) have been confirmed as Sub Inspector vide order dated 10-10-2017 ignoring the appellant and copy of the said order was not issued to him which the appellant has now obtained on 16-06-2018 through his specific written request. The name of both the colleague's of appellant stands at Serial No. 40 and 41 of the said order. (Copy of the orcler dated 10-10-2017 is attached as Annex-"C").

- 5. That in a DPC held on 23-05-2018 wherein the appellant's juniors have been confirmed as Sub Inspectors ignoring the appellant without any reason and justification vide Regional Police Officer Hazara Region Abbottabad order No.15100-120 dated 24-05-2018. (Copy of the order dated 24-05-2018 is attached as Annex-"D").
- 6. That appellant was promoted as Sub Inspector on 21-11-2014 and he had successfully completed 02 years probation period on 21-11-2016. Not anyly that the appellant has passed Upper Class Course from Police Training College Hungu in the year 2016. Further, the appellant has already been tested as \$1/OII in the department.
- 7. That during the period since his promotion as Sub-Inspector on 21-11-2014 to till date there is nothing adverse against the appellant on record to prevent

the DPC to deprive the appellant of his legitimate right of confirmation alongwith his collections/batch mates. Even the appellant was never reverted from the rank of Sub Inspector during the period of probation. Thus appellant fulfilled all the requirements for confirmation as Sub Inspector but have not been without any reason and rhyme against the law and departmental rules and regulations.

- 8. That appellant challenged the aforementioned order with non-confirmation alongwith his regard to colleagues/juniors before the worth**y** Inspector General of Police KPK Peshawar through departmental appeal which appeal w(\$ forwarded by the Superintendent of Police (Investigation) Upper Kohistan vide covering letter dated 11-06-2018. (Copies of departmental appeal and covering letter dated 11-06-2018 are attached as Annex $\stackrel{\text{d. E}}{\leftarrow}$ E & F").
- 9. That his above mentioned departmental appeal has been returned by the Inspector General of Police Khyber Pakhtunkhwa to the Regional Police Officer Hazara Region Abbottabad without Consideration and giving any decision vide letter No. 165. However when copy of the said letter No. 165 was issued, the appellant found that it did not bear and date on it for the reason best known to the issuing authority. (Copy of letter No. 168 is attached as Annex-"G")

- 10. That appellant under compulsion filed an application dated 04-08-2018 before the Regional Police Officer Hazara Region Abbottabad for issuing of copy of letter No.165 of the Inspector General of Police KPK Peshawar having its date and also attested copies of other relevant documents for filing appear before this Honourable Service Tribunal thereupon on 16-08-2018 the appellant was issued the copy of said letter having its date as 11-07-2018. (Copies of the application dated 04-08-2018 of letter dated 11-07-2018 are attached as "H & I").
- 11. That as the appellant fulfilled all the requirements for confirmation as Sub Inspector alongwith his colleagues (SI Abdul Hameed No. 334/H and SI Waris Khan No. 335/H) whose name stands at Sarial No.40 & 41 of the order dated 10-10-2017 issued by the Regional Police Officer Hazara Region Abb ottabad.
- 12. That the appellant has been deprived of legitimate right of confirmation on due and right place alongwith his colleagues/batch mates by the Regional Police Officer Hazara Region Abbottabad firstly vide order dated 10-10-2017 when his colleagues were confirmed as Sub Inspectors and secondly while confirming appellant's juniors vide order dated 24-05-2018 and thirdly when the Inspector General Police KPK Peshawar has returned appellant's departmental appeal undecided vide letter dated 11-07-2018,

hence the instant service appeal, inter alia, on the following:-

GROUNDS:

- That both the impugned orders dated 10-10-2017 and 24-05-2018 of the Regional Police Officer Hazara Region Abbottabad as well as order dated 11-07-2018 of the Inspector General of Police KPK Peshawar are void-abinitio, illegal, unlawful, non-speaking without lawful authority and have been passed perfunctory, arbitrarily, whimsical, and slipshod in manner, against the facts and circumstances of the case, without any reason and proof, hence are liable to be set aside.
- b) That respondents have not treated the appellant in accordance with law, departmental rules of regulations and policy on the subject and have acted in violation of Article-4 of the constitution of Islamic of Pakistan 1973 and unlawfully issued the impugned orders, which are unjust, unfair and hence not sustainable in the eyes of law.
- c) That neither proper scrutiny of the record Pertaining to confirmation of appellant was made nor was his record considered by the competent as well as appellate authority while passing impugned ordes whereby appellant has been badly affected in Service and deprived of his legitimate and lawful right of Confirmation



alongwith his colleagues at right place without any justification, reason and rhyme.

- d) That even the law, departmental rules and regulations have not been followed by the departmental authorities while carrying out the confirmation process Sub Inspectors who are colleagues/batch mates of the appellant and passing impugned orders ignoring the appellant without any reason and rhyme.
- e) That the appellant authority has also failed to abide by the law and even did not take into consideration the grounds taken in the memo of apped. Thus the impugned order of the appellate authority contrary to the law as laid down in the KPK Police Rule 1934, other departmental rules regulations read with section 24-A of the General Clause Act 1897 read with Article 10A of the Constitution of Islamic Republic of Pakistan 1973.
- f) That appellant fulfils the criteria and all requirements of confirmation as Sub Inspector and fully deserves to be confirmed from the date of promotion as SUB Inspector alongwith his colleagues at the right place in seniority.

PRAYER:

It is therefore, humbly prayed that on acceptance of instant appeal the impugned orders dated 22017 & 24,-

O\$-2018 of the Regional Police Officer, Hazara Region, Abbottabad as well as impugned order dated 11-07-2018 of the Inspector General of Police, KPK, Peshawar may graciously be set aside and the appellant be confirmed as Sub Inspector from the date of his promotion at right place alongwith his colleagues with all consequential all back benefits of service.

Any other relief which this Honour Tribunal deems fit in the circumstance of the case may also graciously be awarded.



Parawise Comments on behalf of Respondents

Respectfully Sheweth:

PRELIMINARY OBJECTION:-

- 1. That the appellant has no cause of action.
- 2. That the appellant has not come to this Tribunal with clean hands.
- 3. That the appeal is bad for mis-joinder and non-joinder of necessary parties.
- 4. That the appellant is estopped by his own conduct.
- 5. That the appeal is barred by law.
- 6. That the appeal is time barred.
- 7. That the appellant has suppressed the material facts from the Honourable Tribunal hence not entitled for any relief and appeal is liable to be dismissed without further proceeding.

FACTS.

- Para No.1. Pertains to record. However, the service record bears adverse entries.
- Para No.2. Incorrect, he was promoted as officiating ASI on 08-04-2008 and after completion of 02 years officiating period he was confirmed as ASI and his name was brought on promotion list "E" on 08-04-2010.
- Para No.3. Pertains to record.
- Para No.4. Incorrect, he was deferred from confirmation as Sub-Inspector in the DPC held in the office of RPO Hazara on 09-10-2017 as he

failed to perform duty as SHO / OII for one year as per mandatory criteria laid down in Police Rules 13-10 (2). He had served only 05 months & 13 days at the time of DPC. His colleagues have completed the period of posting before confirmation.

- Para No.5. Incorrect, he was deferred from confirmation as Sub-Inspector in the DPC held in the office of RPO Hazara as he was awarded major punishments i.e. reduction in pay for 03 stages and reduction in service for 04 years on 26-04-2017 as per Police Rules 13-14 (2).
- Para No.6. Correct, he has qualified the Upper College Course in PTC Hangu in the year, 2016 but he was deferred by the DPCs for confirmation as Sub-Inspector as he has not fulfilled the mandatory tenure of posting as OII and due to award of major punishments.
- Para No.7. Incorrect, as explained in Para "4 & 5".
- Para No.8. Pertains to record.
- Para No.9. His departmental appeal was sent back by the Inspector General of Police Khyber Pakhtunkhwa Peshawar to RPO Hazara as the confirmation in the rank of Sub-Inspector was the competency of Regional Police Officer.
- Para No.10 Pertains to record.
- Para No.11. Incorrect, he was deferred from confirmation as Sub-Inspector in the DPC held in the office of RPO Hazara on 09-10-2017 as he failed to fulfill the criteria laid down in Police Rules 13-10 (2) and due to major punishment.
- Para No.12. Incorrect as explained in Para "4,5 &11".

GROUNDS

- a. Incorrect, he failed to perform duty as SHO / OII for one year as per Police Rules 13-10 (2). He served only 05 months & 13 days period of posting as OII at the time of DPC.
- b. Incorrect. The act of Respondents is in accordance with law & rules.
- c. Incorrect, case of each officer was discussed for confirmation as provided vide Police Rules 13-1, 13-10 (2), 13-18 of Police Rules 1934 and relevant Standing Orders received from CPO Peshawar.
- d. Incorrect, as explained in Para "a & c".

- e. Incorrect, as briefly explained in Para 4 and 5 above, the appellant failed to fulfill the mandatory criteria laid down in the rules to consider him for confirmation.
- f. Incorrect, as explained in Para "a" as he has not fulfilled the criteria as laid down in Police Rules 13-10 (2).

PRAYER.

It is therefore, humbly requested that the appeal of the appellant may graciously be dismissed being meritless and not maintainable.
