ANY OTHER REMEDY WHICH THIS AUGUST TRIBUNAL DEEMS FIT AND APPROPRIATE THAT MAY ALSO BE AWARDED IN FAVOUR OF APPELLANT.

### **RESPECTFULLY SHEWTH:** FACTS:

- 6

- 1. That the appellant is appointed in the respondent in the year 1992 and since his appointed he is performing his duty with great devotion and honesty, whatsoever assigned to him and also have good service record throughout.
  - 2. That the appellant while posted as in-charge PP Hathian, a charge sheet along with the statement of allegations were issued to the appellant in which the following allegation was leveled against the appellant,

Whereas ASI Javed Khan while posted as in-charge PP Hathian, self generated the remarks of Mr. Ali Bin Tariq the then SDPO of Tahkht Bhai in his ACR for the year 2017 vide Regional Office Mardan Endst: No.358/PA dated 05.10.2018.

The appellant submitted his reply to charge in which he denied the allegation and gave facts about the situation, however he did not keep the copy of reply to show cause notice which may be requisite from the department. (Copy of charge sheet along with statement of allegations is attached as Annexure-A)

- 3. That inquiry was conducted against the appellant in which the inquiry officer gave his finding that the character and the public dealing of the appellant is right, performing his duty with devotion and no allegation of corruption has been filed against the appellant and due to the excellent performance of the appellant the ASP might be give good remarks if he did his ACR form the ASP. (Copy of inquiry report is attached as Annexure-B)
- 4. That denovo inquiry was conducted against the appellant in which inquiry officer mentioned in recommendation that the progress made by the defaulter officer (appellant) in the year 2017 was verified and found satisfactory, but despite that the inquiry officer found him guilty. (Copy of denovo inquiry report is attached as Annexure-C)
- 5. That show cause notice was issued to the appellant which was replied by him and denied the allegation and again mentioned in his reply that Mr. Ali Bin Traiq was the SDPO of the Tahkt Bhai Sub Division and

on his transfer to FC Headquarter Peshawar, the appellant went to FC Head Quarter Peshawar for getting his ACR report, whereby due non availability of Ali Bin Tariq (reporting officer), he handed over the original copy of his ACR to on duty FC Official, deputed on the security at his Bungalow and relieved him to put up the ACR before the officer for getting his report. After three days he was informed to receive his ACR. The appellant to went to collect his ACR and had not knowledge that either ASP Ali Bin Tariq has given remarks on his ACR or some FC official by himself on which the competent authority recommended to send the signature to FSL for establishment of truth, but despite that ACR was not send to FSL for authenticity. (Copies of show cause notice and reply to show cause notice are attached as Annexure-D&E)

- 6. That on the basis above mentioned allegation, respondent No.3 passed an order dated 11.03.2019, whereby minor punishment of forfeiture of two (02) years approved has imposed upon the appellant without sending the ACR of the appellant to know the authenticity of signing on the ACR of the appellant. (Copy of order dated 11.03.2019 is attached as Annexure-F)
- 7. That the appellant field departmental appeal which was rejected on 03.03.2020 for no good grounds, however ever he did keep the copy of departmental appeal which may be requisite from the department, the appellant then filed revision on 29.01.2022, which also rejected on 03.03.2022 for no reason. (Copies of order dated 03.03.2020, revision and order dated 03.03.2022 are attached as Annexure-G,H&I)
- 8. That now the appellant has no other remedy except to file the instant in this Honourable Service Tribunal for redressal of his grievance on the following grounds amongst others.

### **GROUNDS:**

- A) That the impugned orders dated 11.03.2019, 03.03.2020 and 03.03.2022 are against the law, facts, norms of justice and material on record, therefore not tenable and are liable to be set aside.
- B) That the inquiry was not conducted according to the prescribed procedure as no opportunity of defence was provided to the appellant as neither statements were recorded in the presence of the appellant nor gave him opportunity of cross examination, which is violation of

law and rules and as such the impugned orders are liable to be set aside.

- C

- C) That two inquiries were conducted on the issue, but both the inquiry officers did not bother to conduct proper inquiry to dig out the authenticity of the remarks and signature on the ACR of the appellant by sending his ACR to FSL, which means that the appellant has not been treated in accordance with law and rules and has been punished without conducting proper inquiry, which is against the norms of justice and fair play.
- D) That the appellant clearly mention in his replies to charge sheet and show cause notice that reporting officer Ali Bin Tariq on transferring to FC Head Quarter Peshawar, he went there for getting his ACR report, but he was not present at his bungalow and handed over his ACR to FC official deputed for security on and after there days he was informed to receive his ACR and has no knowledge that either ASP Ali Bin Tariq has given remarks on his ACR or some FC official by himself on which the competent authority remarks on the reply to show cause notice that send the signature to FSL for establishment of truth, but despite that the ACR of the appellant was not sent to the FSL to know the authenticity that whether the appellant himself gave remarks on his ACR of 2017 or not and without authenticity of the remarks mentioned on the ACR of the appellant minor punishment of forfeiture of two (02) years approved has imposed upon the appellant, which shows that the appellant has been punished for no fault on his part as such the impugned orders are liable to be set aside.
- E) That the inquiry officer mentioned in his first inquiry report that the character and the public dealing is of the appellant is right, performing his duty with devotion and no allegation of corruption has been filed against the appellant and due to the excellent performance of the appellant the ASP might be gave good remarks if he reported his ACR form the ASP and if the highs ups admitted the performance of the appellant excellent in the year 2017 from the record of the appellant, then why the appellant needed to self generate the remarks of reporting authority (Ali Bin Tariq SDPO of Takht Bhai) in of his ACR of 2017.





### LLEGATIONS:

The subject enquiry proceeding against ASI Javid Khan, was antiated under the allegations that he while posted as In-charge PP Hatyan, self generated the remarks of Mr. Ali Bin Tariq then SDPO Takh Bhai in his ACR for the year 2017 vide regional office Mardan endorsement No. 358 dated /PA-ACR dated 05.10.2018.

### PROCEEDING:

During course of enquiry, ASI Javid Khan was called in the office. He was heard at length and examined his flow of conversation (His) statement reflecting his progress made in the year 2107 is placed on the file. The already conducted enquiry file and correspondence made in this regard was thoroughly period. ASI Javid Khan stated that on transfer of Ali Bin Tariq then SPDO Takht Bhar to FC headquarter he himself proceeded to FC Headquarters, for getting his ACR report, whereby due to unavailability of the officer, he handed over the ACR to on duty FC personnel deputed on security duty at bungalow and relieved him to put up the ACR before the officer for getting comments/report. After three days he was informed to receive his ACR.

The defaulter officer pleaded that regarding the signature /remarks of ASP Ali Bin Tariq he had no knowledge that either officer/ASP TBI has get signed the ACR or the P.C official whom the ACR was relieved has signed the same by him: elf. During cross questioning the defaulter officer was asked to provide the Name Mobile No. of the mentioned F.C officials but he did not provide any information regarding the said FC official.


### HON:

Vide letter No. 326/PA/ACR dated 25.09.2018, the comments/ recorded on the annual confidential report in r/o of ASI Javid No. 661/MR eriod from 01.01.2017 to 31.12.2017 was send /routed to the reporting ASP Ali Bin Tariq) for verification, whether these were given by him or se. In response, vide letter Memo: No. 5166 /ACCTT/FC/OGHI/2018 the ng officer, reported that 'he (ASI Javid) never got his ACR signed from him i the signature /remarks are self generated'. Furthermore, the impression of uure/remarks itself reveals the facts that the same is self generated. Besides, iding him ample opportunity for his defense he has nothing to offer except more from his side. However, progress made by the defaulter officer in the year was verified and found satisfactory, but in the instant matter he acted with ala-fide intention and he himself managed/self generated signature/remarks of the ' porting officer.



In this connection, the alleged official was served with a Final Show Cause Notice, under K.P.K Police Rules-1975, issued vide this office No.9796/PA dated 31-12-2018, to which, his reply was received & was heard in OR on 15-01-2019, but failed to submit any plausible reasons in his defense, therefore, a De-novo Enquiry was conducted through Mr. Mushtaq Ahmad SP/Operations Mardan, who in Finding Report vide his office letter No.5743/PA (Ops) dated 22-01-2019, concluded that the allegations leveled against the alleged official stands proved, so another Final Show Cause Notice was also issued to the alleged official vide this office No.45/PA dated 13-02-2019, to which, his reply was received. ### <u>ORDER.</u>

This order will dispose-off the departmental appeal preferred by ASI Javed Khan No. 661/MR of Swabi District against the order of District Police Officer, Mardan, whereby he was awarded minor punishment of forfeiture of two years approved service vide District Police Officer, Mardan OB: No. 55 dated 11.03.2019. The appellant was proceeded against departmentally, on the allegations that he while posted at Police Station Lund Khwar, wrote down self generated remarks as well as forged the signature of Mr. Ali Bin Tariq, the then ASP/City, Mardan in his ACR for the year 2017) vide endorsement No. 358/PA-ACR dated 05.10.2019 being his reporting Officer.

Proper departmental enquiry proceedings were initiated against him. He was issued Charge Sheet alongwith Statement of Allegations and the then Deputy Superintendent of Police Security, Mardan was nominated as Enquiry Officer. The Enquiry Officer after fulfilling codal formalities, submitted his findings wherein he recommended the delinquent Officer for minor punishment of withholding his promotion.

He was issued Final Show Cause Notice to which, his reply was received and found unsatisfactory. He was also provided opportunity of self defence by summoning him in the orderly Room held in the office of District Police Officer, Mardan on 15.01.2019. The appellant failed to justify his innocence. However, the competent authority did not agree with the recommendations of Enquiry Officer. Hence, de-novo enquiry was initiated which was entrusted to Superintendent of Police Operation, Mardan. The Enquiry Officer after fulfilling codal formalities, concluded that the allegations leveled against the appellant stood proved, so another Final Show Cause Notice was also issued to the delinquent Officer to which his reply was received and found unsatisfactory.

The delinquent Officer was again provided opportunity of self defense by summoning him in the Orderly Room held in the office of District Police Officer, Mardan'on 26.02.2019. But he failed to produce any evidence in his defense. Hence, he was awarded Minor Punishment of forfeiture of his two years approved service by the District Police Officer, Mardan vide his office OB: No. 55 dated 11.03.2019.

Feeling aggrieved from the order of District Police Officer,

Mardan, the appellant preferred the instant appeal. He was summoned and heard in person in Orderly Room held in this office on 25.02.2020. From the perusal of the enquiry file and service record of the

appellant, it has been found that allegations leveled against the appellant have been proved beyond any shadow of doubt and the competent authority has already treated him leniently although the misconduct of appellant deserved a harsher punishment. Besides, the appellant approached this forum at a belated stage without advancing any cogent reason regarding such delay. Hence, order passed by the competent authority does not warrant any

Keeping in view the above, I, Sher Akbar, PSP S.St Regional interference. Police Officer, Mardan, being the appellate authority, finds no substance in

the appeal, therefore, the same is rejected and filed, being time barred.


The DPO Mardan had issued charge sheet + Summary of allegations No. 8241-42/PA dated 01/11/2018 to the appellant with the following allegations.

"Where is ASI Javed Khan, while posted as Incharge PP Hatiyan, self-generated the remarks of Mr. Ali Bin Tariq the then SDPO Takht Bhai in his ACR for year 2017 vide Regional Office Mardan Endst No. 358/PA dated 05/10/2018".

It is submitted that in the light of above charge sheet a departmental inquiry was initiated against the appellant. Mr. Sher Rahman DSP Security was nominated as EO. The appellant produced a detailed and comprehensive reply in response to the charge sheet before the E.O regarding his innocence, but his version was not considered. The E.O recommended the appellant for the award of minor punishment. Later on DE novo inquiry was also conducted in to the matter through SP / Operation Mardan. SP / Operation submitted his finding report mentioning therein that the allegations against the appellant stand proved.

That in the light of the inquiry finding submitted by SP Operation, the DPO Mardan issued final Show Cause Notice No. 45/PA dated 13/02/2019 to the appellant. The appellant again submitted his reply in response to the FSCN but the request for filing of FSCN was not attended.

That on 26/02/2019 the appellant was heard in person. The appellant explained his position before the DPO Mardan but the DPO Mardan awarded minor punishment of forfeiture of 02 years approved service to the appellant vide OB No. 551 dated 11/03/2019. HENCE

THE PRESENT APPEAL. (Copy of OB No. 551 dated 11/03/2019 is enclosed)

#### BRIEF FACTS

During the year 2017 Mr. Ali Bin Tariq was the SDPO of Takht Bhai Sub Division. Later on he was transferred to FC Headquarter Peshawar. The appellant proceeded to Peshawar in order to get signed his ACR for the year 2017 from him. On reaching of the FC Headquarter Peshawar Mr. Ali Bin Tariq was not available. The appellant handed over the original copy of the ACR to the on duty FC official, deputed on Security Duty at his Bungalow and relieved him to put up the ACR before the officer for getting his comments / report. After 03 days the appellant was informed to receive his ACR. The appellant again went to FC Headquarter Peshawar and collected his ACR. The appellant had no knowledge that either ASP Ali Bin Tariq has got signed the ACR or some FC Official has signed the same by himself. Later on the appellant was blamed that remarks / signature in the ACR are self-generated.

# DELAY IN FILING OF APPEAL

There is no denying that the appeal is time barred but this was not intentional. The appellant faced to some domestic problems, on account of which the appellant was in mental agony. The appellant would like to state that it is will settled principle of law that procedural technicalities should not be allowed to prevail on dispensation of substantial justice. Procedure laws are meant to advance the cause of justice and not to thwart it. The SUPREME COURT OF PAKISTAN in criminal original petition No.

90/2009 has further emphasized that while deciding a case, principles of natural justice "audi altream partem" and other fundamental rights should be observed which guarantee the right of the appellant.

# GROUND OF APPEAL

- 2

- 1. The appellant is innocent and has not generated him-self any remarks / signature in his ACR of 2017. The appellant can never imagine to involve himself in such like mal practices.
- 2. From the inquiry finding submitted by SP operation Mardan, it is crystal clear that no any kind of evidence in support of the allegation mentioned in the charge sheet was brought on inquiry file during the course of inquiry. Hence sub-standard inquiry.

3. Beside the statement of the appellant no other independent

- Witness was examined by the E.O during the course of inquiry. Hence an incomplete inquiry.
- 4. The E.O has expressed his opinion only on imagination and not on the availability of any proof / evidence which is against the norm of justice.
- 5. The E.O has described in the inquiry finding that the progress made by the appellant during the year 2017 was verified and found satisfactory but even then the appellant was not granted any relief.
  - 6. That in the seniority list the name of the appellant falls after ASI Jamshed and before ASI Ghazanfar. Both ASIs Jamsheed and Ghazanfar were promoted to the Rank of Sub-Inspectors but the name of the appellant was dropped from the promotion in the

rank of Sub-Inspect r for the reason that a departmental inquiry is pending against the appellant.

- 7. The appellant was enlisted in Police Department as Constable on 15/03/1992 and since then the appellant was not dealt departmentally.
- 8. That the appellant is qualified and wishes to get further promotion. The instant punishment so awarded to the appellant phad certainly ruined the service carrier of the appellant and was dropped from the promotion.

9. The appellant on account of his lengthy period of service and poor family background deserve for lenient view.

Keeping in view the above facts and circumstances, it is humbly requested that by the acceptance of the present appeal, the order of DPO Mardan issued vide OB No. 551 dated 11/03/2019 may kindly be set-aside. The appellant be promoted on his own Seniority Number which falls amongst SI Jamsheed Khan & SI Ghazanfar Mehmood.
