Service Appeal under Section 4 of Service Tribunal Act, 1974, against the order No. F.No.1 (17)/admn/2020-21/4398/403 dated Swat, the 24/02/2022, whereby the appellant has been removed from service by way of major penalty.

#### Prayer:

On acceptance of this service appeal, the order No. F.No.1 (17)/admn/2020-21/4398/403 dated Swat, dated 24/02/2022, may kindly be struck down and the appellant may kindly be re-instated with all back benefits.

Any other relief not specifically prayed but this august court deems proper may also be granted.

#### Respectfully Sheweth:

1. That appellant is the bonafide resident of Village Jambil, Kokarai Tehsil Babozai, District Swat and was initially appointed as Family Welfare Assistant



(project post) vide order dated 31.10.2016 and after promulgation of the Khyber Pakhtunkhwa Regularization Act, 2018, her services were regularized vide order dated 17-09-2018. (Copies of CNIC, Order dated 31.10.2016, Arrival report and order dated 17-09-2018, are annexed as **ANNEXURE** "A")

- 2. That appellant was serving on the subject post with zeal and zest, to the best of her abilities and to the satisfaction of her high-ups at family welfare Centre jambil.
- 3. That in the year 2021, the appellant suffered from COVID-19 therefore absented from her duties w.e.f 03/04/2021 to 30/04/2021 and an inquiry was initiated against her, which was culminated in to minor punishment for "stoppage of one annual increment for two years" (Copies of inquiry proceedings are annexed as ANNEXURE "B")
- 4. That brother in law of the appellant got involved in a criminal case u/s 295-B of Pakistan Penal Code dated 17/08/2021 P.S Kokarai, Distt Swat, as the allegations were very sever and shocking, therefore due to public threats, the appellant along with other family members moved to Karachi, so appellant was once again absented from her duties with unwilling heart and again an inquiry was initiated against the appellant in last of 2021, wherein the appellant due to special circumstances of the aforementioned criminal case couldn't appear before the inquiry officer and the inquiry was proceeded exparte against the appellant. It is pertinent to mention herein that after conclusion of the ex-parte inquiry she was removed from service vide impugned order dated 24-02-2022. (Copies of F.I.R, inquiry proceedings & order dated 24.02.2022 are annexed as **ANNEXURE "C"**)
- 5. That the appellant when came to her abode, inquired about her service from the local official of the department, she was informed that her services have been terminated, therefore she appeared before the respondent No.2 on 28/04/2022, to know about her status of service, wherefrom she got copy of the impugned order dated 24/02/2022. (Copy of order dated 24.02.2022 is annexed as **ANNEXURE "D"**)

6. That the appellant preferred a departmental appeal before the worthy respondent No.1 on 12.05.2022 (well within time as the appellant got copy of the impugned order on 28/04/2022) which has not been responded in its statutory period, therefore the appellant having no other option but to file the instant appeal in its statutory time limitation on the following grounds: (Copies of memo of representation dated 12.05.2022 and receipt of courier service are annexed as **ANNEXURE "E"**)

#### Grounds:

- i. That, actions and inactions of respondents are illegal, ultra vires, ultra Shariah and against the established norms of administration, therefore, are not tenable in the eyes of law.
- ii. That, appellant has not been dealt with in accordance with law, which is the worst example of discrimination, therefore, is against the fundamental rights of the appellant, as enshrined in Articles 4, 25 & 27 of the Constitution of Islamic Republic of Pakistan, 1973.
- iii. That, appellant has been deprived of her legal right of service, safeguarded by constitution of Islamic republic of Pakistan, 1973.
- iv. That the appellant has neither been absented willfully, rather absentia was beyond her control, as her whole family was under sever threats of the locals of the area due to involvement of her brother in law in the criminal case U/S 295-B PPC and it was impossible for her to attend her due at the stake of her life.
- v. That punishment extended to the appellant is harsh one as per facts and circumstances of the case mentioned above, as the appellant time and again requested respondent No. through various applications the she may be transferred to another station or be granted leave but respondent No.1 neither allowed her leave request nor transferred her of the station wherein she and her family was under sever life threats. (Copies of applications are annexed as **ANNEXURE "F"**)

- vi. That the appellant is the sole bread earner of her family having a jobless husband and three siblings to maintain.
- vii. That inquiry proceeding have not been conducted in accordance with law and rules on the subject and the appellant has been condemned un-heard, which is against the golden principles of natural justice i.e "audi alterem partem"
- viii. Any other ground not specifically raised will be argued with the prior permission of this August Court.

In view of the above, it is therefore very humbly prayed that, on acceptance of this service appeal, the order No. F.No.1 (17)/admn/2020-21/4398/403 dated Swat, dated 24/02/2022, may kindly be struck down and the appellant may kindly be re-instated with all back benefits.

Any other relief not specifically prayed but this august court deems proper may also be granted.

Meanwhile, Mr. Najeeb Ullah, handed over the charge sheet, where she had one-week time for submitting her statement/reply to the enquiry committee. Within stipulated time, she provided COVID-19, Anti bodies test and her reply/statement.

#### **Ground Realities**

The overall record of Mrs. Nabeela (FWA- Female BPS-07) FWC Jambil is unsatisfactory, however, in present case she has provided her medical test and written statement/reply which shows that she really suffered from COVID-19. She also claimed/stated that she had submitted her application to the Incharge FWC Jambil but, unfortunately, it is misplaced.

#### **Recommendations**

Departmental Appeal against the Order Reference No. F.No. 1(7)/Admn/2020-21/4493/403 Dated. 24-02-2022, whereby the appellant has been removed from service by imposing a harsh and major penalty.

Respectfully sheweth,

- 1. That the appellant was appointed as family welfare assistant in the year 2016 and since then the appellant has performed her duties to the best of her abilities and the is no iota of complaint against the appellant at any forum rather the services rendered by the appellant received appreciation from the high ups for her devotion and commitment to the department.
- 2. That it is worth to mention here that, the allegations levelled against the appellant for which, received a show cause notice from the respondent department for her absence from duty vide letter dated F.No.(1)/Admn/2021-22/18005-09, to which the appellant replied through a written application dated 15-09-2021 by mentioning the reason for the absence from duty, which was accepted by the department.
- 3. That it is also worth to mention here that, the incident which took place in the house of the appellant was of serious nature for the which the appellant along with her entire family was displaced for a long period of time by receiving life threats from the violent inhabitants of the village.



(Copy of FIR and application dated. 15/09/2021 is attached here with this appeal).

- 4. That a show cause notices have allegedly been served upon the appellant by the respondent department for absence from duty, which have never received to the appellant, nor the appellant know about the issuance of any of such notices, as the appellant in the meanwhile has moved another application to the department for granting leave as the appellant was unable to join her duty in such a serious circumstances.
- 5. That the respondent department has proceeded ex-parte against the appellant and removed from service by imposing a harsh and major penalty upon the appellant and was condemned unheard, which act of the appellant is not intentional and deliberate but due to the reason mentioned in the application and an FIR of serious nature which was registered against one the family member of the appellant which caused the entire family of the appellant for displacement has not been considered.
- 6. that for the reasons mentioned in the proceeding para, the appellant got the impugned order very late. i.e. 28/04/2022.
- that the appellant is not a habitual absentee and has always been served the department with zeal and vigor and by imposing such harsh penalty of removing the appellant from service is against the law and justice. The allegations levelled against the appellant have no footing, hence instant departmental appeal before your good self inter alia on the following grounds.

#### Grounds

- a) That the impugned order dated. 24/02/2022 is illegal, unlawful and has been passed without appreciating the real facts and the decision has been taken in real haste.
- b) That the appellant was not called for personal hearing and was condemned unheard while violating the Latin Maxim Audi Alterm Partem. The impugned order was passed in haste during the absence of the appellant



without hearing the version of the appellant and against the article 10-A of constitution of Islamic Republic of Pakistan,1973.

- c) That it was the primary duty of the authority to first prove the allegation by holding a regular inquiry as has been held by the honorable Tribunal and supreme court of Pakistan in many cases, i.e. PLD 2008 SC 451,1997 SCMR 1543. No inquiry was held in the case of the appellant.
- d) That the appellant was deprived from her bread and butter to herself and her family, which is against the provision of the constitution of Islamic Republic of Pakistan 1973, hence a magnanimous view of the matter may kindly be taken, In the best interest of justice.

Prayer

In aforementioned circumstances, it is humbly prayed that the departmental appeal in hand may kindly be accepted and the impugned order dated. 24-02-2022 passed by the district population welfare officer district swat, may kindly be set aside and the services of appellant may graciously be restored 4 to its original place in the best interest of justice.

Any other relief the authorities may deem fit and proper may also be awarded to the appellant.


