



PRAYER

On acceptance of the instant service appeal the impugned seniority list 31.12.2019, may be modified/ rectified to the extent that the Appellant be placed on right position of the seniority list and be made senior to the private respondents.

Any other consequential relief which this Honourable Tribunal deems fit and proper under the circumstances of the case may also be granted in favour of the Appellant.

Respectfully Sheweth,

Appellant humbly submit as under:-

- I. That Appellant joined her service as Subject Specialist Teacher in the Elementary & Secondary Education Department Mardan, on contract basis, Later on her service was regularized vide notification NO. SO (G) E&S/1-85/2009/SS/CONTRACT Dated Peshawar, the 31-05-2010. **(Copy as Annex "A")**

- II. That the respondents No. 02 & 03, without informing and notice the appellant, display the seniority list, which came to know to the appellant on 12th of July 2020, wherein junior candidates (Private respondents) were placed senior to the appellant. **(copy of the Seniority list as annexure "B")**

- III. That appellant preferred departmental appeal against, the impugned seniority list dated 31.01.2019, before the Appellate Authority but the same was not redressed within the statutory period. **(Copy of departmental appeal & Postal Receipt annexure-"C & D")**

- IV. That impugned seniority list and not considering the departmental Appeal, is unjustified, illegal, against the principles of natural Justice, ultra vires and the same challenged before this Honourable Tribunal on the following grounds inter alia;

Grounds


1. Because the impugned seniority list dated 31.12.2019, wherein junior candidates (Private respondents) were placed senior to the appellant, is against the law, facts, principal of natural justice, hence not tenable in the eye of law. Therefore needs rectification/ correction.
2. Because the appellant has not been dealt with according to law and rules on subject noted above and as such the respondents violated article 04, and 25 of the Constitution of the Islamic Republic of Pakistan, 1973.
3. Because the impugned seniority list is utter violation of rule 17(a) of APT rule 1989, which states that seniority, shall be determined in accordance with the order of merit assigned by public service commission.
4. Because the respondents have acted malafidly by not maintaining seniority of the appellant according to order of merit assigned by commission.
5. Because placing junior Officers as senior from appellant in the seniority list, the appellant was not afforded a fair opportunity of personal hearing. Thus she, was condemned unheard.
6. Because the respondents discriminated the appellant on the subject noted above and as such violated Article 38(e) of the Constitution of Pakistan 1973.
7. That the Appellant seeks leave of this august Tribunal to claim further grounds also; with the permission of this Honourable Tribunal.

It is, therefore, humbly prayed that the instant appeal of the Appellant may kindly be accepted as prayed for.




