**P RAYER:-** ON ACCEPTANCE OF INSTANT APPEAL, THE IMPUGNED NOTIFICATION ISSUED UNDER ENDST: NO.2503-12/Prom o SPST to PSHT/21-22 DATED 29-04-2022 ISSUED BY RESPONDANT NO.3 MAY GRACIOUSLY BE SET-ASIDE TO THE EXTENT OF POSTING/ADJUSTMENT OF APPELLANT AND

RESPONDENTS MAY GRACIOUSLY BE DIRECTED TO BE POSTED/ADJUSTED THE APPELLANT IN HIS OWN UNION COUNCIL AS PER GUIDELINES FOR POSTING DATED 18-01-2013, AND ANY OTHER RELIEF WHICH THIS HONOURABLE TRIBUNAL DEEMS PROPER IN THE CIRCUMSTANCES OF THE CASE BE GRANTED.

**Respectfully Sheweth:-**

1. That the appellant was appointed as PTC/PST vide appointment order dated **21-12-2010**. (Copy of appointment order is annexed herewith as Annexure "A").
2. That the appellant was promoted from the post of SPST BPS-14 to PSHT BPS-15 vide Notification issued under Endst: NO.2503-12/Promo SPST to PSHT/21-22 dated 29-04-2022 (Copy of the promotion Notification dated 29-04-2022 is annexed as Annexure "B").
3. That respondent No. 03 totally ignored the guidelines/instructions of the department dated 18-01-2013 and illegally posted/adjusted the appellant out of his own union council in order to accommodate the respondents Nos. 04 & 05 which belong to union council Richben & Banda Pir Khan. (Copy of guidelines is annexed herewith as Annexure "C").
4. That respondent No. 3 himself accepted the appeal of the other candidate and adjusted them. (Copy of orders are annexed herewith as Annexure "D")
5. That appellant took over the charge and submit arrival report under protest. (Copy of charge report and arrival report is annexed herewith as Annexure "E").

6. That being feeling aggrieved from the act of the respondents appellant filled departmental appeal on 07-05-2022 but in vain. (Copy of the departmental appeal is annexed herewith as annexure "F").
7. That now appellant seeks indulgence of this Honourable Tribunal for setting aside the impugned order dated ~~29~~ 04-2022, to the extent of posting/adjustment of the appellant inter-alia on the following grounds:-

**GROUND:-**


- a) That the impugned order dated ~~29~~ 04-2022 against the law, facts and circumstances hence liable to be set-aside as prayed for.
- b) That as per guidelines for posting on promotion to the post of PSHT BPS-15 the impugned order dated ~~29~~ 04-2022 to the extent of appellant is liable to be set-aside and appellant is entitled to be posted/adjusted in his parent union council.
- c) That the parent union councils of the respondents Nos. 04 & 05 is Richben & Banda Pir Khan whereas, appellant belongs to union council Baldheri and appellant is entitled to be posted in his union council.
- d) That respondent No. 3 violated the basic Principle of Law, that when an act is to be done in particular manner that act must be done in that manner if otherwise that is nullity in the eye of Law hence, impugned Notification is liable to be corrected.
- e) That respondent No. 3 have not treated the appellant in accordance with Law, Rule and Policy on the subject and acted in violation of Article of the Constitution and

unlawfully acted upon hence, impugned notification is liable to be corrected.

- f) That under section 24-A of the General Classes act 1897. Where authority is vested with the power to make any order, such shall be exercised reasonably, fairly, justly and the advertisement of the purpose of the enactment under which the power is conferred but in instant case the power was not exercised as such, rather the same was misused, arbitrarily to the detriment of appellant without any rhyme or reason hence, the impugned notification is liable to be corrected.
- g) That the valuable rights of the appellant are involved.
- h) That the instant service appeal is well within time.
- i) That the appellant seeks leave of this Honourable Tribunal to raise additional grounds during the course of arguments with the permission of Honourable Tribunal.

It is, therefore, very humbly prayed that on acceptance of instant appeal, the impugned notification issued under Endst: no.2503-12/prom o SPST to PSHT/21-22 dated 29-04-2022 issued by respondent No.3 may graciously be set-aside to the extent of posting/adjustment of appellant and respondents may graciously be directed to be posted/adjusted the appellant in his own union council as per guidelines for posting dated 18-01-2013, and any other relief which this Honourable Tribunal deems proper in the circumstances of the case be granted.

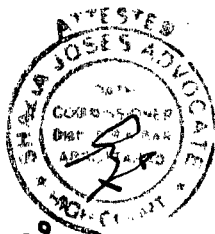

1. The appointees will get initial allowance as admissible to them under the Rules. They will be entitled for annual increments as per relevant Govt Policy, however, they will not be eligible for pension and gratuity as per current policy of the Govt. of KPK.

2. Their services will be considered/dealt as per rules and regulations of the Govt. of KPK.

3. Their services will liable to be terminated on one month's prior notice from either side, in case of resignation without prior notice their one month pay/allowances, if any shall be forfeited to the Govt. treasury through challan.

4. Contribution of C.P. Fund will be as per rules and regulations of the Govt. of KPK.

5. The appointees of summer vacation areas/schools should join their posts within 15 days of the issuance of this appointment order positively, otherwise the appointment shall stand cancelled. However, the appointees of winter vacation areas/schools will take over charge of their posts at the end of winter vacations within 15 days.

6. Their services will liable to be terminated at any time provided their performance is found unsatisfactory and they will be proceeded against as per rule/policy invoked.

7. The ADOs/Clusters incharge concerned should personally check their original certificates / diplomas / degrees and Donnellie prior to handing over the charge. The average appointees if any should not be handed over charge, as the prescribed age limit will be considered as per PS to appointment policy/criteria.

8. Any request/appeal in this regard shall not be entertained.

9. Charge reports should be submitted to all concerned.
