Mr. Fazal Shah, Mohmand, Advocate for the appellant present. Preliminary arguments heard.

Learned counsel for the appellant contended that the appellant is aggrieved of the impugned order dated 25.03.2022 whereby the respondents department accorded leave without pay w.e.f. 10.11.2014 and 10.11.2018. He challenged the impugned order through departmental appeal on 28.03.2022 which was not responded within the statutory period hence the instant service appeal was filed on 01.07.2022 for redressal of his grievances. It was further argued that the appellant was posted at Govt. Higher Secondary School Ghallani District Mohmand. when the appellant came back from duty he was arrested by Mohmand Rifles on suspicion on 10.11.2014. The appellant was suspended who remained in custody/internment center and after been proved innocent he was handed over to the District Administration Mohmand on 20.08.2018 and was also issued clearance certificate vide order dated 16.09.2019 issued by Assistant Commissioner Upper Mohmand. It was further contended that the appellant has served 17 years of service with unblemished service record but he has not been treated in accordance with law, rules and in violation of Article 4 and 25 of the constitution. The impugned order 25.03.2022 being illegal, unlawful and void abinitio, may be set aside, he concluded.

Points raised need consideration. The appeal is admitted to regular hearing, subject to all just and legal objections. The appellant is directed to deposit security and process fee within 10 days. Thereafter, notices be issued to the respondents for submission of written reply/comments. To come up for reply/comments before the S.B on 14.09.2022.

- 1. That the appellant was appointed as Lab Attendant on 08-02-2005 and was posted to Govt. Higher Secondary School Ghallanai District Mohmand and since then the appellant performed his duties with honesty and full devotion and to the entire satisfaction of his high ups.
- 2. That in the year 2014 the appellant while lastly posted to Govt. Higher Secondary School Ghallanai District Mohmand, the appellant while coming for duty was arrested by Mohmand Rifles on suspicion on 10-11-2014 and was suspended who remained in custody/internment center and after being proved innocent was handed over to the District administration on 20-08-2018 for further process and was finally released on 20-11-2018 and was also issued clearance certificate vide letter dated 16-09-2019 by the Assistant Commissioner Upper Mohmand. (Copy of handing/taking dated 20-08-2019 & Letter dated 16-09-2019 is enclosed as Annexure A & B).

- 3. That soon after release the appellant approached respondents for the release of his salaries on 28-11-2018 which request was duly processed vide letters dated 06-12-2018, 28-12-2018, 08-01-2019, 15-05-2019 etc and routed through various offices but with no response. (Copies of Letters dated 06-12-2018, 28-12-2018, 08-01-2019 & dated 15-05-2019 are enclosed as Annexure C).
- 4. That finally sanction was granted to the grant of leave without pay for the period with effect from 10-11-2014 to 20-11-2018 vide order dated 25-03-2022, thus treating the arrest/interment period as leave without pay illegally. The appellant preferred departmental appeal which has not been responded so far despite the lapse of more than the statutory period of ninety days. - **5.** That the impugned Order dated 25-03-2022 thereby treating the period of arrest/interment as leave without pay, is against the law, facts and principles of justice on grounds inter-alia as follows:-

GROUNDS:-

- **A.** That the impugned Order dated 25-03-2022 is, illegal, unlawful and void ab-initio.
- **B.** That mandatory provisions of law and rules on the subject have been badly violated by the respondents and the appellant has not been treated according to law and rules in violation of Article 4 and 25 of the Constitution.
- **C.** That the appellant is entitled to the salaries of his arrest/internment period as per Civil Service Regulations besides Fundamental Rules and Esta Code Instructions.
- **D.** That in case of arrest/detention a civil servant there is automatic suspension as per the Fundamental Rules, CSR besides Esta-Code Instructions and as such too the impugned order is not tenable in the eyes of law.
- **E.** That there is no omission or commission on part of the appellant and the appellant could not be punished for the fault of others if any.
- **F.** That the impugned is not speaking order and as such too liable to be set at naught.
- G. That it has been held/proved on record that the appellant has done nothing illegal and that he is innocent, thus too

- **H.** That proceedings of any sort were taken against the appellant, ex-parte action has been taken against him and he has been condemned unheard.
- I. That in case of suspension, the employee is entitled to the salary of such period, on this score alone the appellant could net be deprived of the benefits of such period.
