JUDGMENT

AHMAD HASSAN, MEMBER:- Arguments of the learned counsel for the  
parties heard and record perused.

ARGUMENTS.

02. Learned counsel for the appellant argued that he was promoted as ASI vide  
order dated 18.05.2012. After rendering 25 years service and due to some ailment,  
he submitted an application for early retirement, which was considered and notified  
vide order dated 07.10.2016. On reaching the age of superannuation was on  
07.10.2017, he stood retired from service. That while on LPR a meeting of  
Departmental Promotion Committee was held to consider promotion cases of ASI's  
to the post of S.I on adhoc basis. The appellant through application dated

25.08.2017 requested respondents to consider him for promotion but his request was not honored. Promotion were notified through impugned order dated 29.08.2017. Feeling aggrieved, he filed departmental appeal on 03.10.2017 which was not decided within the stipulated period, hence, the instant service appeal. Being on LPR, he had every right to be considered for promotion. Action on the part of respondent was arbitrary and without support of law.

03. Learned Assistant Advocate General argued that record of the respondents regarding filing of application by the appellant before respondent no.2 was silent. He proceeded on LPR w.e.f 15.10.2016 and after availing the same got retired from service on 07.10.2017. Adhoc promotion of ASI to the post of SI's were considered by the DPC and notified on 29.08.2017. Neither, the promotees could claim seniority or any financial benefits on the basis of said promotion. No regular vacancy of SI's was filled while the appellant was on LPR.

**CONCLUSION.**

04. After rendering 25 years satisfactory service as ASI, the appellant fell ill and was not in a position to perform duty. He submitted an application for grant of 365 days LPR and the same was notified on 07.10.2016. He stood retired from government service on 07.10.2017. While on LPR, the respondents through order dated 29.08.2017, promoted some ASI's to the post of SI's on adhoc basis. The appellant also moved an application to be considered for the same but was not considered by the respondents. It is clarified that these promotion were made on adhoc basis and in para-one of memorandum dated 29.08.2017, it was categorically mentioned that this promotion will not counted as officiating promotion and the promotees were liable to be reverted to their substantive rank and they will not claim any financial benefits on the basis of this promotion. The stance of learned

counsel for the appellant was that financial benefits were extended by the respondents to the promotes on the basis of order referred to above. However, he could not produce any documentary evidence to this effect. As he was unable to convince this Tribunal on the point of receipt of financial benefits on the basis of adhoc promotion so we did not find any force in his pleadings and appeal deserved to be dismissed.

05. In view of the foregoing, the appeal is dismissed. Parties are left to bear their own costs. File be consigned to the record room.

- II) Incorrect, the Establishment Department (Regulation wing) has modified the policy of promotion of civil servants and held those civil servants availing LPR entitled for promotion, but during the period of LPR of the appellant, no vacancy of SI has been filled by regular promotion. All the promotion to the rank of SI made by respondent No.02 vide dated 29-08-2017 have been made on adhoc charge basis and period served on adhoc charge basis can neither be counted as officiating nor probation toward substantive rank. No ASI has been promoted to the rank of SI on regular basis during the period of LPR of the appellant, therefore he was not entitled for promotion as SI.
- III) Incorrect, the order was passed in accordance with rules/merits and no Violation of the constitution of Islamic Republic of Pakistan has been committed by respondents.
- IV) The respondents also seek leave of this Honorable Tribunal to rely on additional arguments at the time of hearing.
10. Incorrect, the honorable service tribunal has got no Jurisdiction to entertain the present service Appeal, as the promotion order dated 29-08-2017 issued by respondent No. 02 is in accordance with rules/ merit. The departmental appeal was processed and it was concluded that, all the promotion to the rank of SI made by respondent No.02 vide dated 29-08-2017 have been made on adhoc charge basis and period served on adhoc charge basis can neither be counted as officiating nor probation toward substantive rank. No ASI has been promoted to the rank of SI on regular basis during the period of LPR of the appellant.

**PRAYER:**

It is therefore humbly prayed that on acceptance of this Para-wise reply, the service appeal may graciously be dismissed with cost.
