







WHICH HE ACTUALLY PERFORM ALONG WITH T.A AND D.A WHICH ARE NOT PAID, UP TO DATED THOUGH BILLS ARE SANCTIONED, FURTHER REQUESTED THAT AS PER A VACANT POST OF THE DRIVER FOR WHICH THE RESPONDENTS ALREADY HAS QUALIFIED, MAY GRACIOUSLY BE ORDERED TO BE POSTED ALONGWITH THE PAY OF DRIVER I.E. BPS-6 ACCORDINGLY.

*That the facts of the appeal are submitted as under:-*

1. That the appellant was selected as driver in Bps-04 in Siran Kaghan Forestry Project Abbottabad vide office order No.09 dated 10.04.1993. *(Copy of the order No.09 dated 10.04.1993 is annexed as Annexure "A")*
2. ✓ That after that the appellant transfer and posted in different branches and projects, as per order No.80 dated 17.04.1999. *(Copy of order No.80 dated 17.04.1999 is annexed as Annexure "B")*

3. That similarly the appellant was transferred as driver vide office order 0.0 No.194/WP-II dated 23.05.2009 in the office of the Divisional Forest Officer, working plan, unit-II Abbottabad. (*Copy of the order No.0.0 No.194/WP-II dated 23.05.2009 is annexed as Annexure "C"*)
4. That after the defunct of Siran-Kaghan Forestry Project, Abbottabad, and the appellant was adjusted vide office order No.197, dated 10.09.2009. (*Copy of the order No.197 dated 10.09.2009 is annexed as Annexure "D"*)
5. That further under office order No. 0.0.No.198/ WP-II dated 15.09.2009, the appellant was ordered to work as Naib-Qasid cum driver of Government, vehicles No.A-1138 of working plan unit-II, Abbottabad. (*Copy of the said order is annexed as Annexure "E"*)
6. That being served in the Forest Department as a driver, the appellant shifted as a Naib-Qasid cum driver as per office order No.167 dated 08.05.2001 and No.168 dated 31.10.2009. The appellant served



in the department in working plan unit-II being a driver, but it is strange to say, that being a regular driver since 10.04.1993 the appellant is not being considered a regular employee of Forest Department **further, that the appellant is appointed as Naib-Qasid cum driver.** While the Naib-Qasid post of BPS-03 and the job of driver is of BPS-06. Hence, the appellant is badly treated, by the respondents. *(Copy of his service book in this regard is annexed as Annexure "F")*

7. That a departmental appeal in this regard was submitted to respondent No.2 for redressal of his injustice, but the respondent did not act any kind of justice till the statutory period. Hence, this appeal is submitted in this Honourable tribunal, inter-alia on the following grounds. *(Ann: G)*

**GROUND OF APPEAL:-**

- a. That it is a clear injustice, that the appellant has been appointed as Naib-Qasid cum driver, while the post of driver is of BPS-06 and post of Naib-Qasid is of BPS-03, in this way, it is clear

injustice on the part of respondents because all this period since 15.09.2009 up till now. The appellant is performing his duty as driver and he is paid the pay of Naib-Qasid in BPS-03 scale i.e. basic pay scale No.3 is Rs.12310/- and basic pay is No.6 is Rs.20324/- hence, it is a clear injustice and against the all norms of services Rules and Regulations.

- b. That two seats of driver were became vacant during this period. A junior chowkedar has been appointed instead of the appellant which is glaringly injustice done with appellant. Hence, the appeal of the appellant is legally justified.
- c. That the order of Naib-Qasid cum driver is extraordinarily illegal. Hence, is not justified and needs to rectified.
- d. That in unit-IV of the Working Plan lying vacate and the respondents can easily adjust the appellant.
- e. That the appellant may graciously be adjusted as a driver in BPS-06 w.e.f 15.09.2009, alongwith all

back benefits and other ancillary benefits throughout of this period through the period.


f. That, the instant appeal is well within time.

It is, therefore, humbly prayed that on acceptance of instant Appeal, the respondents may graciously be ordered to the post of driver i.e. according to the duties of driver which he actually perform along with T.A and D.A which are not paid, up to dated though bills are sanctioned, further requested that as per a vacant post of the a driver for which the respondents already has qualified, may graciously be ordered to be posted alongwith the pay of driver i.e. BPS-6 accordingly.

3. That the employee shall not be entitled to any pension or gratuity for the service rendered by him.
4. That in case he wishes to resign at any time one month notice will be necessary or in lieu thereof one month pay will be forfeited.
5. It is understood that they have joined this Project on 01.4.1999 They should produce medical fitness certificate from the Medical Superintendent District Headquarters Hospital Abbottabad.
6. That the appointment is purely on contract basis against the Support Staff and can be terminated at any time without assigning any reason.






