#### **PRAYER:**

On acceptance of appeal, both the impugned orders dated 28/06/2011 vide annexure 'A' and the final impugned order dated 10/08/2018 as annexure 'B' may kindly be set aside and the appellant may kindly be reinstated on his

post from the date of his discharge, along with all back benefits.

#### Respectfully Sheweth:

Brief facts leading to the instant appeal are as under:-

- 1. That the appellant was appointed as Constable in Police Department at District Swat on 09/11/2008 and was allotted belt No. 1920.
- 2. That after appointment the appellant was selected and recommended for the required training.
- 3. That the appellant joined the training at Police Training Center Mardan but due to a mishap just before two months of the completion of the training, he became victim of Malaria and Muscular disorder.
- 4. That keeping in view, the physical condition, the appellant was sent on leave on presentation of his medical reports to the concerned officer.
- 5. That after recovering from the illness, the appellant joined the services and was performing his duties in Police Line Swat where once again he was recommended and sent by the department for required training to Hangu.

- 6. That the appellant again joined the training but he faced the misfortune again and only before one month of completion of training, the same disease of Muscular disorder caught the appellant.
- 7. That the concerned officer at Police Training School Hangu was fully aware of the previous and present critical physical condition of the appellant, therefore, on presentation of his medical reports, the appellant was recommended for leave.
- 8. That the appellant once again after recovering from illness rejoined his service at Police Line Swat where he performed his duties for about a month but due to his physical weakness the concerned DSP namely Mubarak Khan sent the appellant on leave for three days.
- 9. That after completion of leave the appellant resumed his duty but just after 11 days, when on date due the appellant's salary was blocked. He approached the concerned officer who very surprisingly handed over the appellant, the impugned order of discharge from service.
- 10. That it is pertinent to mention here that the appellant has served in the department, received salaries upto

May 2011, duly recommended for medical leave but he was given the impugned order of discharge from service, without any show-cause notice, service of statement of allegations upon him or conducting his personal hearing, hence no proper departmental proceedings were taken against him and the mentioned departmental inquiry in the impugned order was never conducted against the appellant.

- 11. That it is also pertinent to mention here that the appellant served the department in the days which were critical and there was terrorism specially in the district Swat.
- Terrorists and the appellant was also one of those misfortune people who became the victims of the terrorism, because immediate after discharge from service he was abducted by some miscreants / terrorists and remained in their illegal custody for a long period since 30 June 2011 to 1<sup>st</sup> August 2018 and by the grace of Almighty Allah he was succeeded to run away from the clutches of the terrorists.
- 13. That after release from the clutches of the terrorists the appellant has recorded his statement of release from the illegal custody of Taliban in the concerned

Police Station and also brought the same in the notice of the competent authority.

- of the terrorists the appellant approached the competent authority and filed departmental appeal on 06/08/2018 which was rejected hopelessly on 10/08/2018.
- 15. That feeling aggrieved of the acts and omissions of the respondents the appellant has approached this Hon'ble Tribunal for the redressal of his grievance on the following amongst other grounds:-

#### **GROUNDS:**

- A. That neither any show cause notice, statement of allegations etc has ever been served upon the appellant nor he has been personally heard before discharging him from service which was necessary under the law. So both the impugned orders to this effect are illegally under the law and are liable to be set aside.
- B. That both the impugned orders at annexure 'A' and 'B' are illegal, malafide, without justification and without lawful authority hence liable to be set aside.

C. That as the impugned order of discharge from service of the appellant is illegal, void ab-initio and unjustifiable, therefore as per law and precedents of the apex courts, no period of limitation run against it.

D. That the appellant may kindly be allowed to present the additional grounds to support his version at the time of arguments if required.

It is, therefore, most humbly prayed that on acceptance of this appeal, both the impugned orders dated 28/06/2011 at annexure 'A' and the final impugned order dated 10/08/2018 at annexure 'B' may kindly be set aside and the appellant may kindly be reinstated in his service with all back benefits in the best interest of justice.



#### PARAWISE COMMENTS BY RESPONDENTS

#### Brief facts of the Applicant's case:

Applicant Muhammad Ali Ex-Constable No.2122 while posted at Javed Iqbal Shaheed Police Lines absented from duty without prior permission or approved leave of competent authority vide Daily Diary Report No.91 dated 06/05/2011. DSP Head Quarters Swat was appointed as Enquiry Officer to conduct departmental enquiry against the applicant. He was charges sheeted and issued Show Cause Notice to explain his position. His reply to Show Cause Notice regarding willful absence of 21 days in initial probation period was found unsatisfactory, furthermore the Constable willful absented from basic mandatory recruit course. After observing all codal formalities he was discharged under 12.21 Police Rules-1934 vide OB No. 130 dated 20/06/2011. Applicant has 08 bad entries (willful absence from official duty) in his record and his departmental appeal was badly time barred for about 07 years.

#### FACTS:

- 1. Pertain to the record of Honorable KPK Service Tribunal Peshawar. The Service Appeal of the applicant is barred by Law and limitation.
- 2. Incorrect. The applicant has no Locus Standi to file time barred appeal to the Honorable Court. He has willfully absented from the official duty for 21 days during initial probation period without any cogent or reasonable cause, therefore the order dated 22/11/2018 of Honorable Tribunal is justified and in

accordance with facts and rules. The appellant has wrongly challenged the legal order of the respondents as well as Honorable tribunal through unsound reasons.

#### **GROUNDS**

- A. Incorrect. There is no need of issuing Notice/Summon to the applicant under the rules. Applicant and his counsel were well aware about their appeal pending in the Court but they intentionally did not appear before the Tribunal despite the facts the service appeal was several times called on 22/11/2018.
- B. Incorrect. As stated above, the order dated 22/11/2018 of the Honorable Tribunal is well reasoned and justified under the rules. The applicant and his counsel have willfully absented from the hearing of the case without any justified cause, therefore the restoration application of applicant is not maintainable under the rules.
- C. Incorrect. No valuable rights of the appellant are involved in the time barred service appeal and the applicant has no right to file the instant application for willful mistake on his part.
- D. Incorrect. As stated above, the applicant has no right to file application for restoration of service appeal due to his willful mistake and badly time barred issue.
- E. Incorrect. There is no law/rule for restoration of dismissed appeal due to mistake of applicant and his counsel. The process of restoration is amount to wastage of precious time of Court as well as of the respondents.

#### **PRAYER:**

Keeping in views the above facts and circumstances, it is humbly prayed that he restoration application of applicant is devoid of legal force, may kindly be filed/dismissed with costs.






