





RESPECTFULLY SHEWETH:

1. That the appellant joined the police department as Constable and performed his duties with entire stratification of superiors.
2. That the appellant was served charge sheet and statement of allegation. The appellant submitted detail reply to the charge sheet and denied all allegations leveled against him. **(Copy of charge sheet and reply to charge sheet are attached as Annexure-A&B)**
3. That inquiry was conducted but none of the statement was recorded or record examine in presence of the appellant, which is against the law and rules. **(Copy of inquiry report is attached as Annexure-C).**
4. That the show cause notice was served upon the appellant. The appellant properly replied and again denied the entire allegation **(Copy of showcause and reply is attached as Annexure-D & E).**
5. That thereafter, without personal hearing the appellant was dismissed from the service vide order dated 26.03.2018. Against the order dated 26.03.2018, the appellant filed departmental appeal, but the same was also rejected on 22.05.2018 for no good grounds. **(Copies of impugned order, departmental appeal and rejection order are attached as Annexure-F, G & H).**
6. That now the appellant come to this august Tribunal on the following grounds amongst others.

GROUND:

- A) That the orders dated 26.03.2018 and 22.05.2018 are against the law, facts, norms of justice and material on record, therefore not tenable and liable to be set aside.
- B) That the appellant has been condemned unheard and has not been treated according to law and rules.
- C) That in inquiry neither the statement recorded in presence of appellant nor was the chance of cross examination provided to the appellant and also not provided the inquiry report with final show cause notice which is violation of rule 11 subclause-1(4) and rule 14 sub-clause-4(c) and norms of justice and the impugned order on basis of that inquiry cannot be sustainable.


- D) That the whole exercise has nullity in the eye of law as the appellate authority issued charge sheet & statement of allegation. Which is under the law is required to be issued by the competent authority, i.e Superintendent of police who issued impugned order. So. The whole impugned action of the respondents is void ab initio and not sustainable in the eye of law.
- E) That the opportunity of personal hearing and personal defense was not provided to the appellant.
- F) That the penalty of dismissal from service is very harsh which is passed in violation of law and, therefore, the same is not sustainable in the eyes of law.
- G) That the appellant has not been treated according to law and rules.
- H) That the appellant seeks permission to advance others grounds and proofs at the time of hearing.

It is, therefore most humbly prayed that the appeal of the appellant may be accepted as prayed for.

STATEMENT OF ALLEGATION

Kindly refer to the attached enquiry papers received from your good office vide Endst: No.01/PA, dated 28.02.2018 on the following allegations:-

That HC Asad No. 296 (I/C miscellaneous store), DFC Habib Ullah No. 3528, FC Alamdar No. 983 & FC Zia Ullah No. 2085 while posted at miscellaneous store (Police Lines), Peshawar carried scraps in official Truck No. A-3532 from Police lines for selling without taking permission of any officer. They were caught red handed at scraps Godown near Tableeghi Markaz Peshawar.

PROCEEDINGS.

To probe into the matter, all the concerned were called to this office and their statements have been recorded, they were heard in person. The statements recorded from all concerned, placed on the enquiry file, detail is as below.

1. Statement of HC Asad Muhammad No. 296 (F/A)
2. Statement of Driver Constable Habib Ullah No. 3528 (F/B)
3. Statement of Constable Alamdar No. 983 (F/C)
4. Statement of Constable Zia Ullah No. 2085 (F/D)

1. **Statement of HC Asad Muhammad No. 296**

Statement of HC Asad Muhammad No.296 I/C miscellaneous has recorded, who stated that he was the I/C of miscellaneous Store since one year. During this period, he performed his duty very efficiently and earned commendation Certificates from senior officers. He further stated that in his possession some scraps was placed near MT Workshop. He was advised/directed to clear-up the place of scraps by the seniors. He perceived to sell it out thoroughly. Upon selling out the scraps, how-so-ever, amount received would be spent on petty nature purchase like purchase of electric Wires & Bulbs. He realized his blunder as he was bound to take permission from his seniors (Statement of HC Asad No. 296 is appended).

Q No. 1. You have described in your statement that you were directed to clear up the place of scraps by the senior. What sorts of direction were given and by whom?

Ans: DSP Hqrs directed to clear the spot but not directed to sell out the scraps.

Q No. 2. Do you accept your wrong doing?

Ans: yes I accept my wrong doing but I did with good intention to clear the scraps and utilized the proceed for Govt: purpose.

Q No. 3. Did you bring the matter into the notice of Senior Officer?

Ans: Not it all.

2. **Statement of Driver Constable Habib Ullah No. 3528**

Statement of Driver Constable Habib Ullah No. 3528 has recorded, who stated that he was directed by the MTO Zar Khan to take the Truck No. AA3532/Peshawar in the company of I/C miscellaneous from Police Line. He further stated that he is just obeyed the order of his senior. He is seeking for giveness. (Statement of Driver Constable Habib Ullah No. 3528 is appended).

Q No. 1. Did you know that you were doing an illegal task?

Ans: Yes I did.

Q No. 2. Had you informed senior officers regarding activity?

Ans: Sorry I failed.

3. **Statements of Constable Alamdar No. 983.**


Statement of Constable Alamdar No. 983 has recorded, who stated that he was performing duty at miscellaneous Store as Telephone Mechanic under the supervision of Misc: I/C Asad No. 296. He was directed by HC Asad No. 296 I/C Misc: that scraps lying at MT Workshop should be collected and bundled into official Truck. In compliance of my senior order i.e. HC Asad No. 296 I/C Misc: I did my level best and took the scraps alongwith Constable Zia Ullah No. 2085 to the Bashir Abad. Where we snapped by the SP Hqrs and put us in the Quarter Guard for 7 days. FC Alamdar No. 983 further stated that he is sinless he just obeyed the order of his senior i.e. I/C Asad No. 296. He is seeking forgiveness. (Statement of Constable Alamdar No. 983 is appended).

Q No. 1. Weather you were of the knowledge that illegal activity is going?

Ans: I was not aware about the proceeding.

Q No. In the past weather you have done the same or not?

Ans: Not, I was commissioned/ordered by the senior and I was not aware by the consequences.

On 22.02.2018 I/C Misc: HC Asad Muhammad No. 296 told him that on the directions of high ups, he was collected scrapped chairs from all the branches/offices for repairing and after repair, he distributing the same to all offices. For this purpose he needs a vehicle. Accordingly, MTO dispatched a truck bearing Reg No. 3532 through driver constable Habib Ullah No. 3528 and entry to the effect was entered in the Log Book. Moreover, The MTO pleaded the ignorance about movement the truck

Q No.1. Weather you aware about the vehicle is being use in illegal activity?

Ans: I was not aware about it.

Q No. 2. Are you aware about the record of MT have been forged after the incident?

Ans: I have not.

Statement of Constable Tehseen Ullah No. 1894 Muharrir MT

Statement of Constable Tehseen Ullah No. 1894 Muharrir MT has recorded, who stated in his statement that on 22.02.2018 at about 12:40 hrs, MTO directed me a Truck bearing Reg: No. AA 3532 under the possession of Driver Constable Habib Ullah No. 3528 may be transit in the company of I/C Misc: HC Asad Khan No. 296. He (Muharrir) did/performed as directed by the MTO and turned the transaction of Truck at 12:40 hrs in the Log Book. Laps: of 10/15

From the statement of Muharrir MT Roznamcha Constable Tehseen Ullah No. 1894, it transpired that the vehicle was given to Incharge miscellaneous store HC Asad Muhammad No. 296, which shows that Asad Muhammad No. 296 drawn the vehicle for one purpose and meafidely used for other. He however abetted in the offence by forging the record of MT Roznamcha.


6. **MTO SI Zar Khan (witness, additionally included in enquiry).**
Statement of MTO transpire that he authorized the vehicle as demanding by the misc: store I/C. As I/C MT he failed to keep a check on misuse of vehicle as well as forgery in the record. This he is found negligence in duty.

RECOMMONDATIONS.

The allegation leveled against have been found well founded HC: Asad Muhammad No. 296 I/C Misc:, Driver HC Habib Ullah No. 3528, Const: Alamdar No. 983 and Const: Zia Ullah 2085 have been found guilty of mis-appropriating the Govt: property, mis-conduct and theft liable to Major punishment of **Dismissal from service** under Police Rules.



The Enquiry Officer further stated that they may be exonerated of the charges and re-instated in service the interim period may be treated as leave of the kind due vide Enquiry Report No.5092/PA, No.5093/PA and No.5094/PA dated 04.09.2018.

In the light of recommendations of E.O, Ex-DFC Habib Ullah No.3528, Ex-FC Alamdar No.983 & Ex-FC Ziaullah No.2085 are hereby re-instated in service with immediate effect. Hence, the period they remained out of service be counted as leave kind of due.
