HENCE, THE CASE OF THE APPELLANT WAS DEFERRED. NOW. THE APPELLANT HAS BEEN RETIRED FROM SERVICE ON 05/03/2018 ON SUPERANNUATION ON 06/03/2018. THEREFORE, THE APPELLANT IS ELIGIBLE TO BE GRANTED PROFORMA PROMOTION FROM OFFICE ASSISTANT BPS-16 TO SUPERINTENDENT BPS-17 W.E.F 05/03/2018 ON THE ANALOGY OF SIMILAR EMPLOYEES WHO HAVE BEEN PROMOTED WITHOUT AMENDMENT IN THE RULES. THE APPELLANT IS ALSO REVISION OF PENSION/ ENTITLED FOR COMMUTATION AFTER THE GRANT OF PROFORMA PROMOTION.

PRAYER: ON ACCEPTANCE OF THE INSTANT SERVICE APPEAL RESPONDENT MAY DIRECTED ISSUE PROMOTION ORDER APPELLANT FROM OFFICE ASSISTANT BPS-16 TO SUPERINTENDENT BPS-17 W.E.F 05/03/2018 AND THEREAFTER PENSION AND COMMUTATION CASE OF THE APPELLANT MAY BE ORDERED TO BE REVISED W.E.F THE DATE OF PROFORMA PROMOTION. ANY OTHER RELIEF WHICH THIS HONOURABLE ' COURT MAY DEEM APPROPRIATE MAY ALSO BE ALLOWED TO THE APPELLANT.

Respectfully Sheweth:-

The facts forming the background of instant service appeal of the appellant are arrayed as under:-

1. That the appellant was serving in the respondents' department as office Assistant and got retirement on superannuation on 06/03/2018. Copy of promotion order and retirement order dated 04/04/2018 on superannuation are attached as

Annexure "A" & "B". That the effective date of retirement is 06/03/2018.

- 2. That as per seniority list of office Assistant BPS-16 maintained at provincial level, issued by respondents' department on 20/03/2017, wherein, the name of the appellant is mentioned at serial No. 2 in the seniority list of office Assistant. Copy of seniority list 20/03/2017 is attached as annexure "C".
- Office Assistant to post of superintendent BPS-17.

 In this regard, respondents' department prepared working paper of the appellant for promotion to the next higher scale. The name of appellant has been shown at serial No. 2 of the working paper for promotion to the next Higher Scale. In this regard departmental promotion committee meeting was held on 05/03/2018.
- 4. That departmental promotion committee deferred the promotion case of the appellant alongwith others due to the reason that there were discrepancies in seniority and the requisite rule on

the subject are yet to be amended. Copy of working paper for promotion of the appellant, minutes of the meeting of DPC dated 05/03/2018 are attached as Annexure "D" & "E".

- 5. That the appellant attained 60th year of his age on 06/03/2018. Therefore, the appellant has been retired on superannuation. Copy of retirement order dated 04/04/2018 is already attached in para 1 above.
- departmental appeal regarding grant of proforma promotion from BPS-16 to BPS-17 on 22/03/2018.

 Copy of departmental appeal is attached as Annexure "F", which is yet to be replied by the department. Hence, the instant service appeal is filed on the following grounds:-

GROUNDS:-

a. That promotion case of the appellant was deferred by respondents' department vide minutes of the meeting dated 05/03/2018 due to no fault of the appellant. Once promotion of

any employee is deferred, right of promotion to the next Higher Scale remains as it is. Therefore, appellant is entitled for proforma promotion only for the purposes of revision of pension and commuted value of pension etc.

- b. That the act of respondent departments' towards appellant is absolutely discriminatory because as per practice and routine, promotion from office Assistant to the post of superintendent BPS-17 were granted to some similar employees on the basis of service Rules in-vogue. Now, at this juncture, question of amendment in the promotion rule does not arise. The appellant is to be granted promotion on the analogy of similar employees. Copy of similar employees who have been granted promotion in the year 2015 & 2018 are attached as Annexure "G" & "H".
- c. That Article 25 of the constitution of Islamic republic of Pakistan envisages that all the employees are to be treated alike on the principle of equality. Hence, the appellant has been discriminated which is against the

- fundamental rights as enshrined in the constitution of Pakistan 1973 as well as dicta of precedent case laws settled by the Apex courts.
- d. That when law prescribe something which is to be done in a particular manner that must be done in that manner and not otherwise.

 Respondents' department are supposed to grant proforma promotion to the appellant as previously the case of the appellant was deferred being eligible for promotion due to no fault of the appellant.
- deferred, the appellant is to be promoted from BPS-16 to BPS-17 w.e.f 05/03/2018 i.e the date of holding of departmental promotion committee meeting. Respondents' department has led the appellant to the place which is utterly unknown to the principle of jurisprudence, natural justice cannons of ethics and good governance.
- f. That the matter relates to the terms and condition of service therefore under article 212

of the constitution this tribunal has got jurisdiction to entertain the instant appeal.

It is therefore, humbly prayed that on acceptance of the instant service appeal respondent may directed to issue promotion order of the appellant from Office Assistant BPS-16 to Superintendent BPS-17 w.e.f 05/03/2018 and thereafter pension and commutation case of the appellant may be ordered to be revised w.e.f the date of proforma promotion. Any other relief which this Honourable Court may deem appropriate may also be allowed to the appellant.

Kindly refer to my appeal regarding promotion as Superintendent BPS-17 forwarded vide Medical Superintendent DHQ Teaching Hospital Haripur vide 631-32/Ms/DHQ(H) Dated: 30.01.2018. The same was marked to Director General Health services Khyber Pakhtunkhwa Peshawar by the Office of Honorable Secretary Health (Copy attached as Annex-I).

In this regard, the Departmental Promotion Committee met on 05^{th} March 2018 under the Chairmanship of Special Secretary Health Department Peshawar whereby the case as per seniority list of Assistants maintained at Provincial Level was discussed as reflected in the working paper. According to Seniority list the applicant was falling at serial No. 02.

The Committee observed as under:

committee agreed defer the promotion Assistant/Stenographer/Auditor from BPS-16 to the post of Office Superintendent BPS-17 in Health Department on account of Discrepancies ϕ und in working paper as seniority list was found disputed and the existing service rules for the subject posts have not been amended since 22.06.1983 while Finance Department has already upgraded the existing positions. (Copy of Minutes of Meeting attached as Annex-II).

n this connection it is submitted that the Seniority Rules titled appointment/promotion and transfer rules 1989 are still intact, according to the provision of said rules, the promotions are made in all the departments of the Provincial Government. The seniority list placed before the committee was / is undisputed to the extent of Assistants. As precedent, the promotions made by the Health Department vide Government of Khyber Pakhtunkhwa Health Department Notification No. SOH-III/10-4/2015 Dated: 25.06.2015 through which the Assistants were promoted as Superintendent BPS-17 and DGHS office order No.440-49/Personal/Promotion Cell Dated: 04.01.2018 under the application of same rules. (Copies attached as Annex-III & IV).

Since I have been retired on 06.03.2018, my promotion was due before the date of retirement. The deferment of promotion case by the committee in its meeting held on 05.08.2018 is causing financial loss to the applicant as his legal right has been infringed / infracted.

It is therefore requested that the meeting of DPC may be held at the earliest so as to consider the case of applicant for promotion as Superintendent BPS-17 with retrospective effect. It is pertinent to mention here that the necessary documents comprising ACRs/Synopsis have already been submitted through proper channel.


