
Counsel for the appellant present.



SUPERINTENDENT BPS-17 ON THE PRINCIPLE OF SENIORITY CUM FITNESS BEING AT SERIAL NO. 2 OF THE SENIORITY LIST OF OFFICE ASSISTANTS. THAT DEPARTMENTAL PROMOTION COMMITTEE HELD ON 05/03/2018 WHEREIN, IT WAS NOTED BY THE DPC THAT THERE ARE DISCREPANCIES RELATING SENIORITY IN WORKING PAPER AND RELEVANT RULES ON THE SUBJECT ARE YET TO BE AMENDED. HENCE, THE CASE OF THE APPELLANT WAS DEFERRED. NOW, THE APPELLANT HAS BEEN RETIRED FROM SERVICE ON 05/03/2018 ON SUPERANNUATION ON 06/03/2018. THEREFORE, THE APPELLANT IS ELIGIBLE TO BE GRANTED PROFORMA PROMOTION FROM OFFICE ASSISTANT BPS-16 TO SUPERINTENDENT BPS-17 W.E.F 05/03/2018 ON THE ANALOGY OF SIMILAR EMPLOYEES WHO HAVE BEEN PROMOTED WITHOUT AMENDMENT IN THE RULES. THE APPELLANT IS ALSO ENTITLED FOR REVISION OF PENSION/ COMMUTATION AFTER THE GRANT OF PROFORMA PROMOTION.

**PRAYER:** ON ACCEPTANCE OF THE INSTANT SERVICE APPEAL RESPONDENT MAY DIRECTED TO ISSUE PROMOTION ORDER OF THE APPELLANT FROM OFFICE ASSISTANT BPS-16 TO SUPERINTENDENT BPS-17 W.E.F 05/03/2018 AND THEREAFTER PENSION AND COMMUTATION CASE OF THE APPELLANT MAY BE ORDERED TO BE REVISED W.E.F THE DATE OF PROFORMA PROMOTION. ANY OTHER RELIEF WHICH THIS HONOURABLE COURT MAY DEEM APPROPRIATE MAY ALSO BE ALLOWED TO THE APPELLANT.

**Respectfully Sheweth:-**

The facts forming the background of instant service appeal of the appellant are arrayed as under:-

1. That the appellant was serving in the respondents' department as office Assistant and got retirement on superannuation on 06/03/2018. Copy of promotion order and retirement order dated 04/04/2018 on superannuation are attached as

Annexure "A" & "B". That the effective date of retirement is 06/03/2018.

2. That as per seniority list of office Assistant BPS-16 maintained at provincial level, issued by respondents' department on 20/03/2017, wherein, the name of the appellant is mentioned at serial No. 2 in the seniority list of office Assistant. Copy of seniority list 20/03/2017 is attached as annexure "C".
3. That the appellant was eligible for promotion from Office Assistant to post of superintendent BPS-17. In this regard, respondents' department prepared working paper of the appellant for promotion to the next higher scale. The name of appellant has been shown at serial No. 2 of the working paper for promotion to the next Higher Scale. In this regard departmental promotion committee meeting was held on 05/03/2018.
4. That departmental promotion committee deferred the promotion case of the appellant alongwith others due to the reason that there were discrepancies in seniority and the requisite rule on

the subject are yet to be amended. Copy of working paper for promotion of the appellant, minutes of the meeting of DPC dated 05/03/2018 are attached as Annexure "D" & "E".

5. That the appellant attained 60<sup>th</sup> year of his age on 06/03/2018. Therefore, the appellant has been retired on superannuation. Copy of retirement order dated 04/04/2018 is already attached in para 1 above.
6. That the appellant feeling aggrieved filed departmental appeal regarding grant of proforma promotion from BPS-16 to BPS-17 on 22/03/2018. Copy of departmental appeal is attached as Annexure "F", which is yet to be replied by the department. Hence, the instant service appeal is filed on the following grounds:-

**GROUNDS:-**

- a. That promotion case of the appellant was deferred by respondents' department vide minutes of the meeting dated 05/03/2018 due to no fault of the appellant. Once promotion of

any employee is deferred, right of promotion to the next Higher Scale remains as it is. Therefore, appellant is entitled for proforma promotion only for the purposes of revision of pension and commuted value of pension etc.

b. That the act of respondent departments towards appellant is absolutely discriminatory because as per practice and routine, promotion from office Assistant to the post of superintendent BPS-17 were granted to some similar employees on the basis of service Rules in-vogue. Now, at this juncture, question of amendment in the promotion rule does not arise. The appellant is to be granted promotion on the analogy of similar employees. Copy of similar employees who have been granted promotion in the year 2015 & 2018 are attached as Annexure "G" & "H".

c. That Article 25 of the constitution of Islamic republic of Pakistan envisages that all the employees are to be treated alike on the principle of equality. Hence, the appellant has been discriminated which is against the



fundamental rights as enshrined in the constitution of Pakistan 1973 as well as dicta of precedent case laws settled by the Apex courts.

d. That when law prescribe something which is to be done in a particular manner that must be done in that manner and not otherwise. Respondents' department are supposed to grant proforma promotion to the appellant as previously the case of the appellant was deferred being eligible for promotion due to no fault of the appellant.

e. That once the case of the appellant has been deferred, the appellant is to be promoted from BPS-16 to BPS-17 w.e.f 05/03/2018 i.e the date of holding of departmental promotion committee meeting. Respondents' department has led the appellant to the place which is utterly unknown to the principle of jurisprudence, natural justice cannons of ethics and good governance.

f. That the matter relates to the terms and condition of service therefore under article 212

of the constitution this tribunal has got jurisdiction to entertain the instant appeal.

It is therefore, humbly prayed that on acceptance of the instant service appeal respondent may directed to issue promotion order of the appellant from Office Assistant BPS-16 to Superintendent BPS-17 w.e.f 05/03/2018 and thereafter pension and commutation case of the appellant may be ordered to be revised w.e.f the date of proforma promotion. Any other relief which this Honourable Court may deem appropriate may also be allowed to the appellant.
